**WORKER ID & IMMIGRANT

As the immigration reform debate begins to heat up again, some observers expect that one of the biggest and most controversial new elements will be a proposed national worker identification card for all Americans. A "forgery-proof" worker ID card, secured with biometric data such as fingerprints, is an idea favored by Sen. Charles E. Schumer (D-N.Y), the new chairman of the immigration subcommittee. Schumer, who will lead the effort to craft the Senate's comprehensive immigration overhaul legislation, called the card the best way to ensure that all workers were authorized.

The number of U.S. border apprehensions dropped for a third consecutive year, falling to a level not seen since 1973, new government data shows. The U.S. Border Patrol last year had 724,000 apprehensions, falling more than 17 percent from 2007, according to the Department of Homeland Security's Office of Immigration Statistics.

**HATE CRIME LEGISLATION

A leading civil rights coalition says there has been an increase in white supremacist activity since the election of the first African-American president. The Leadership Conference on Civil Rights Education Fund reported Tuesday that the economic downturn and fear of immigrants also contributed to the increase. The report comes a week after a white supremacist killed a security guard at the U.S. Holocaust Museum. The coalition reported the country now averages a hate crime nearly every hour of every day. A special concern is the rising number of hate crimes committed against Hispanics and gays.

**VETERAN COLONOSCOPES

A trip to the Veterans Affairs hospital -- may have exposed thousands of veterans to diseases like HIV and Hepatitis B and C. Veterans who went for routine preventive tests, like colonoscopies, have been called back for follow up exams. Ass of last week -- six tested positive for HIV. 34 tested positive for Hepatitis C, and 13 tested positive for Hepatitis B. They were victims of the mistakes highlighted in a report released today by the inspector general at the Department of Veterans Affairs. Nistakes like theone at a Florida VA hospital, where a colonoscopy tube that was supposed to be sterilized after "each" use, was only cleaned at the end of the day. Timothy Chisholm is one of the veterans who could have been sickened.

**OBAMA FINANCIAL RESCUE

Many lawmakers fear President Barack Obama's plan to prevent another financial meltdown might end up turning the Federal Reserve into an all-powerful monster -- a friction that could slow down a major overhaul of banking and market regulations. In a speech on Wednesday, Obama is expected to propose that the Fed take on a role as America's financial supercop. Already the nation's central bank, the Federal Reserve would supervise large financial institutions that are considered so big that their failure could undermine the economy.

#### **CA WHITE HOUSE HELP**

The White House Tuesday dashed hopes that the federal government would help California overcome a mammoth budget crisis that has brought the state dangerously close to an economic meltdown, saying the state will have to solve the problem on its own. "It's obviously not an easy time for the state of California," White House spokesman Robert Gibbs told a briefing when asked if the administration would provide emergency financing for the state."

#### **MAY HOUSING JUMP**

Construction of new homes jumped in May by the largest amount in three months, an encouraging sign that the nation's deep housing recession was beginning to bottom out. The Commerce Department said Tuesday that construction of new homes and apartments jumped 17.2 percent last month to a seasonally adjusted annual rate of 532,000 units. That was better than the 500,000-unit pace that economists had expected and came after construction fell in April to a record low of 454,000 units.

President Barack Obama is offering a broad-scale overhaul of the financial system, saying hard times struck largely because a post-Depression era business regulatory scheme couldn't keep up with an increasingly global economy. In remarks readied for the unveiling of new rules to govern business, Obama attributed much of the country's current problem to "a cascade of mistakes and missed opportunities" which happened over several decades. His plan would bestow vast new powers on the Federal Reserve, authorizing it to oversee the entire financial system. It also would create a new consumer protection agency to guard against the types of abuses that played a big role in the current crisis.

President Barack Obama signaled to gay-rights activists Wednesday that he's listening to their desire for greater equality in "a more perfect union." But he didn't give them even close to everything they want, bringing to the surface an anger that's been growing against the president. "We all have to acknowledge this is only one step," Obama said in the Oval Office, where he signed a memorandum extending some benefits, such as visitation or dependent-care rights, to the same-sex partners of gay federal employees.

A legal aid program designed to protect undocumented workers from deportation was announced at a news conference held by immigration reform advocates.

**HATE CRIMES SENTENCE****BLANCA ROSA VILCHEZ / POTTSVILLE, PENNSYLVANIA****PKG 2:26**

Two Pennsylvania teens acquitted of the most serious charges in the beating death of an illegal Mexican immigrant will each spend at least six months in prison for lesser charges. A Schuylkill County judge sentenced 17-year-old Brandon Piekarsky and 19-year-old Derrick Donchak on Wednesday on charges related to the fatal beating of Luis Ramirez on July 12, 2008 in Shenandoah. Piekarsky was acquitted of third-degree murder and Donchak acquitted of aggravated assault by an all-white jury last month. Both teens were acquitted of ethnic intimidation.

**MORE POWER ICE AGENTS****LOURDES MELUZA-WASHINGTON, DC****PKG 2:05**

The Obama administration ended a years-long turf war between the Justice and Homeland Security departments yesterday, giving more U.S. Immigration and Customs Enforcement agents authority to investigate drug crimes. Leaders of ICE and the Drug Enforcement Administration replaced a 1994 agreement that capped the number of customs agents who could investigate federal drug crimes and limited it to those who make seizures at border crossings. When the Department of Homeland Security was created in 2003, ICE's size and national presence were expanded. However, DEA and the Justice Department refused to lift the cap, set at 1,475 agents, citing the potential for poor coordination. ICE has about 5,000 agents overall, and the DEA has about 4,800.

**LAPD IMMIGRATION RAIDS****JAIME GARCIA / LOS ANGELES, CALIFORNIA****PKG 2:02**

A city can prohibit its police from stopping or arresting people to find out if they are illegal immigrants, a state appeals court ruled Wednesday in a Los Angeles case with implications for San Francisco's sanctuary ordinance. A taxpayer represented by the conservative group Judicial Watch challenged a 30-year-old Los Angeles Police Department rule barring officers from either arresting anyone for entering the United States illegally or taking any action solely to determine someone's immigration status. The suit claimed the policy conflicts with a 1996 federal law that requires state and local governments to let their employees share information about someone's immigration status with federal authorities. If a city bars police from obtaining immigration information from people they arrest, Judicial Watch argued, it frustrates the purpose of the law. But the Second District Court of Appeal in Los Angeles upheld a judge's decision that found no conflict between the local policy and the federal law. The restriction on police conduct during arrests "has no effect on the voluntary flow of immigration information" between local officers and federal authorities, the court said.

**MEDICARE FRAUD****LOURDES DEL RIO- MIAMI, FL****PKG 2:08**

Last year, Medicaid reimbursed more than \$1.4 million for oxygen concentrators provided to patients in Miami-Dade County. That figure represents 17 percent of the statewide total of \$8.5 million. But just how much of it was medically necessary? That's what the Agency for Health Care Administration is trying to determine. On Thursday, the agency announced that in recent weeks a team of state investigators conducted site visits at 12 providers and visited more than 120 individuals who received equipment. The agency said investigators found that Medicaid paid for equipment that is missing, unused or never received by the patient. They are now trying to determine if their findings are the result of billing errors, abuse of the system, or outright fraud. Any cases of suspected fraud are turned over to the Attorney General's Medicaid Fraud Control Unit.

President Barack Obama said Friday he is committed to a comprehensive immigration overhaul that includes a way for illegal immigrants to become U.S. citizens. Obama told the Esperanza National Hispanic Prayer Breakfast and Conference that U.S. borders must be strengthened to thwart illegal immigration. But he also supports giving the millions of people now in the U.S. illegally the chance to become citizens. He said they must pay a fine and taxes, learn English and "go to the back of the line" of people trying to enter the United States from their home country. **UNEMPLOYMENT INCREASE**

The West reported the highest regional jobless rate for May: 10.1 percent -- the first time in more than 25 years that a region of the United States has suffered double-digit joblessness. In California, the jobless rate jumped to 11.5 percent last month. In Nevada, it rose to 11.3 percent, and in Oregon, to 12.4 percent. The government report showed employment conditions deteriorating in 48 states and the District of Columbia last month. Eight states had record-high jobless rates. Only two -- Nebraska and Vermont -- reported no increases. Nebraska's jobless rate dipped, and Vermont's was flat. The five other states that set new unemployment highs were North Carolina, Oregon, Rhode Island, South Carolina, Florida and Georgia.

U.S. Senator Charles E. Schumer will call on all New Yorkers to take advantage of the "Cash for Clunkers" program approved by the Senate last night. The program allows New York City drivers to trade in their older, less fuel efficient cars, trucks and SUVs for more fuel efficient vehicles. Schumer said that New York City drivers can save up to \$4,500 cash on the purchase of a new car but they need to move fast because funding for the program is limited and vouchers are given out on a first come, first serve basis. Schumer released a report earlier this year showing that 94,300 cars on the road in New York City would qualify for the "Cash for Clunkers" program.

Obama is using his weekly radio and Internet address to defend a proposal that would impose and enforce new rules for the nation's embattled financial system. In his address, Obama focuses on a part of the plan intended to appeal to everyday Americans: a new consumer watchdog office that would take over oversight of

mortgages, requiring that lenders give customers the option of "plain vanilla" plans with straightforward and affordable terms, among other changes. Obama calls it "essential," saying the impact of the financial crisis has been felt by "ordinary Americans who rely on credit cards, home loans and other financial instruments."

#### **GOVERNMENT AND PHARMACEUTICAL IND. DEAL**

The pharmaceutical industry agreed Saturday to spend \$80 billion over the next decade improving drug benefits for seniors on Medicare and defraying the cost of President Barack Obama's health care legislation, capping secretive negotiations involving key lawmakers and the White House. "This new coverage means affordable prices on prescription drugs when Medicare benefits don't cover the cost of prescriptions," Sen. Max Baucus, chairman of the Senate Finance Committee, said in a statement announcing the accord. The deal marked a major triumph for Baucus as well as the administration. Obama praised the deal.

#### **LAWMAKER FAVORS DEPORTING ILLEGAL IMMIGRANT INMATES**

**VO:25**

An Oklahoma lawmaker who wrote one of the strongest state immigration laws in the nation is continuing his fight against illegal immigration with legislation that authorizes the deportation of illegal immigrant prison inmates. A measure authored by Republican Rep. Randy Terrill authorizes state prison officials to hand over nonviolent illegal immigrants in state prisons who have served at least one-third of their sentences to federal immigration officials for deportation. Terrill said the program, crafted after successful programs in other states, will save the state millions of dollars in incarceration costs and free up prison beds for more violent offenders at a time when the state faces a \$900 million budget shortfall and a prison population that is almost at capacity.

#### **NEW YORK-ANOTHER DEATH H1N1 SWINE FLU**

School officials in Buffalo, N.Y., say a middle-schooler has died of swine flu, and a union leader says a second pupil is hospitalized in critical condition. Schools Superintendent Dr. James A. Williams released a statement of sympathy yesterday, but officials would not say more about the student who died. City teachers union president Philip Rumore had said a 15-year-old boy attending Harvey Austin was gravely ill with swine flu. Rumore says a young girl attending the Charles R. Drew Science Magnet School is in critical condition with the virus. Hundreds of children in the state have been hospitalized with the illness, and some children have died.

**IMMIGRATION COMPREHENSIVE REFORM MEETING-OBAMA

Launching a fresh effort toward a comprehensive immigration overhaul, President Barack Obama said Thursday that a bipartisan bill on the "sensitive and volatile political issue" will be difficult but must get under way this year. "It's going to require some heavy lifting," Obama said as he hosted a meeting of about 30 lawmakers whose views on immigration span the ideological spectrum. "It's going to require a victory of practicality and common sense and good policy making over short-term politics. That's what I'm committed to doing as president." Much of the debate centered on how to deal with the roughly 12 million illegals already living in the United States. Some believe Republicans are more motivated this time to get on board, as immigration helped energize turnout toward Obama and other Democrats in the 2008 election. Among the attendees Thursday was Obama's opponent in the presidential election, Sen. John McCain, R-Ariz., who was a high-profile supporter of immigration reform, a position that cost him support within his own party.

Swine has infected more than a million Americans, federal health officials said Friday, and is infecting thousands more every week even though the annual season is well over. That total of those who have already been infected is "just a ballpark figure," said Dr. Anne Schuchat, director of adding, "We know we're not tracking every single one of them." Only a tiny fraction of those million cases have been tested, Dr. Schuchat said. The estimate is based on testing plus telephone surveys in New York City and several other locales where the new flu has hit hard. A survey in New York City, she said, showed that almost 7 percent of those called had had flu symptoms during just three weeks in May when was spreading rapidly through schools. If that percentage of the city has had it, then there have been more than 500,000 cases in the city alone, though most have been mild enough that doctors recommended nothing more than rest and fluids.

Only white firefighters scored well enough on the test to be promoted. No blacks. So New Haven, Conn., threw out the test. In an important reverse discrimination ruling Monday, the Supreme Court rejected that decision, cautioning employers nationwide against changing the rules once the game has begun. New Haven discriminated against its white firefighters by ignoring the results of a promotion exam on which they did well but no African-Americans scored high enough to be promoted to lieutenant or captain, the justices said in a 5-4 ruling. High court nominee Sonia Sotomayor had endorsed the city's position as an appeals court judge -- ammunition for both supporters and foes in her upcoming confirmation hearing.

**TROOPS WITHDRAWAL

President Barack Obama's top security adviser has told U.S. military commanders there are no plans to send more troops to Afghanistan for now and that the focus instead will be on economic development and reconstruction, The Washington Post reported Tuesday. National Security Adviser James Jones delivered that message last week in Afghanistan, where Marine Brigadier General Lawrence Nicholson hinted he could use more "thousands more" troops, the newspaper said. Jones' message seemed designed to cap expectations that more troops might be coming, although the Obama administration has not ruled out additional deployments in the future, the Post said.

Government experts called for sweeping safety restrictions Tuesday on the most widely used painkiller, including reducing the maximum dose of Tylenol and eliminating prescription drugs such as Vicodin and Percocet. The Food and Drug Administration assembled 37 experts to recommend ways to reduce deadly overdoses with acetaminophen, which is the leading cause of liver failure in the U.S. and sends 56,000 people to the emergency room annually. About 200 die each year. "We're here because there are inadvertent overdoses with this drug that are fatal and this is the one opportunity we have to do something that will have a big impact," said Dr. Judith Kramer of Duke University Medical Center.

### **GM BANKRUPTCY**

**VO: 25**

General Motors filed for Chapter 11 bankruptcy protection Monday as part of the Obama administration's plan to shrink the automaker to a sustainable size and give a majority ownership stake to the federal government. GM's bankruptcy filing is the fourth-largest in U.S. history and the largest for an industrial company. The company said it has \$172.81 billion in debt and \$82.29 billion in assets.

### **CHRYSLER FIAT**

**VO: 26**

A federal bankruptcy judge late Sunday approved the sale of most of Chrysler's assets to Italy's Fiat, moving the American automaker a step closer to its goal of a quick exit from court protection. Judge Arthur Gonzalez said in his ruling that a speedy sale - the centerpiece of a restructuring plan backed by President Barack Obama's automotive task force - was needed to keep the value of Chrysler from deteriorating and would provide a better return for the company's stakeholders than if it had chosen to liquidate.

### **GAS PRICES**

In every region, fuel prices are up compared against the week before Gasoline is increasingly more expensive than diesel fuel per gallon. The national gasoline average is now about a \$1.45 below the price this time last year. Despite the increase in price, diesel fuel is now \$2.35 *below* this time last year.

### **TEENS WIRED CAFFEINATED WELL**

Caffeine-fueled teens are texting, Web-surfing and gaming for hours into the night, which is affecting their alertness and ability to function during the day, a new study in Pediatrics shows. "They're up at night and they're doing a lot less homework than we thought and a lot more multitasking," Dr. Christina J. Calamaro of Drexel University in Philadelphia, the lead researcher on the study, told Reuters Health. She and her colleagues found that the more multitasking a teen did, the more likely he or she was to be dozing off during the day, while the kids who nodded off were also the heaviest caffeine consumers.

### **IMMIGRATION PUSH**

Immigrant rights advocates on Monday launched the Georgia arm of the national Reform Immigration FOR America campaign. ### **OBAMA HEALTHCARE**

**VO: 27**

A White House report concludes that fixing the economy goes hand-in-hand with overhauling the U.S. health care system. The report by the White House Council of Economic Advisers says health care costs will rise to 34 percent of the gross domestic product in 30 years if left unchecked. Costs are now about 18 percent of GDP. Administration officials, urgently seeking to build momentum for health care legislation, plan to discuss the report at the White House today with leaders of the key Senate committees drafting bills. Critics were quick

to dismiss the report. House Minority Leader John Boehner says President Barack Obama's administration hasn't offered a credible plan. Obama wants legislation that would hold down costs, guarantee choice and extend coverage to the 50 million Americans who don't have it now.

## **US SWINE FLU NY**

**VO: 21**

A child has become the fifth person in New York City to die with swine flu. The medical examiner is conducting tests to determine what role the virus played in the child's death. The Health Department has refused to release the victim's name or say what borough the child lived in. However, the Daily News identified the child on Monday as 11-week-old Steven Montanez of the Bronx. The family told the newspaper that the baby had the flu when his aunt found him unconscious Thursday and he died shortly afterward.

## **WEIGHT-LOSS SURGERY, TYPE OF INSURANCE COUNTS**

**VO:24**

People with private health insurance lose more weight after having weight-loss surgery than those covered by the Medicare health insurance program for the elderly and disabled, U.S. researchers said Monday. Medicare patients tend to weigh more before having gastric bypass surgery, they said, and are more likely to be depressed, have high blood pressure, heart disease, diabetes, cholesterol and sleep apnea.

The governor said government must become more efficient and learn to provide services for less.

## **TV EXPOSURE MAY NOT INCREASE BABY'S INTELLIGENCE**

**VO:26**

A 2003 report from the Henry J. Kaiser Family Foundation found that each day, 68 percent of American infants viewed some type of electronic medium: TV programming, DVDs or video tapes, computers or video games. To determine the impact of infant TV watching, the Christakis group recruited parents who agreed to equip their 2- to 24-month-old kids with a wire for one day a month in order to record every sound for a 12- to 16-hour period. Using noise-detection software that analyzed at least one recorded session from each of the 329 youngsters, files were sorted into sounds the kids heard and sounds the kids made. The researchers used a statistical model to determine the association between audible television and the number of words spoken by each adult and each child. They also examined how many meaningful vocal interactions were shared by the child and adult while the TV was on. They found that each hour spent with a TV was associated a significant reduction in a child's own attempts to talk. Likewise, for each hour in front of the tube, the child heard 770 fewer words from an adult. That's 7 percent fewer than the average number of words a child hears in a household when the television is off.

President Barack Obama's speech in Egypt was aimed at the world's Muslims, but its messages also were carefully tailored to international audiences from Afghanistan to the Middle East and domestic factions in the United States. Obama aimed some of his words at the broader Middle East and South Asia, defending U.S. military action in Afghanistan as necessary but saying it "led us to act contrary to our traditions and our ideals." That was a careful reference to the treatment of prisoners and the U.S. detention facility at Guantanamo Bay, Cuba.

A national campaign to help President Obama make good on his promise to pass comprehensive immigration reform in 2009 was unveiled at a press conference in Washington today. The event was part of a week-long series of activities across the country to demonstrate broad national support for comprehensive immigration reform and a commitment to win the legislative battle expected later in the year. The campaign announcement comes just days before the President is slated to meet with Congressional leaders at the White House on June 8 to discuss plans to move legislation forward this year.

**AUTOMAKERS - CONGRESS****VO: 22**

Top executives from General Motors and Chrysler face tough questions from lawmakers about sweeping plans to close hundreds of car dealerships as the auto companies undergo government-led bankruptcies. The executives will appear before a Senate committee Wednesday to talk about their dealership plans. Lawmakers contend the dealership closings will put thousands of people out of work and offer few savings to GM or Chrysler, which have received billions in federal aid as they attempt to restructure and return to profitability.

**GAY MARRIAGE NEW HAMPSHIRE****VO: 18**

The New Hampshire legislature approved revisions to a same-sex marriage bill on Wednesday, and Gov. John Lynch promptly signed the legislation, making the state the sixth to let gay couples wed. The bill had been through several permutations to satisfy Mr. Lynch and certain legislators that it would not force religious organizations that oppose same-sex marriage to participate in ceremonies celebrating it. Some groups had feared they could be sued for refusing to allow same-sex weddings on their property. Mr. Lynch, who previously supported civil unions but not marriage for same-sex couples, said in a statement that he had heard "compelling arguments that a separate system is not an equal system."

**PLAYGROUND SAFETY****VO: 23**

Concerns raised by Connecticut are playing a role in the federal government's decision to study whether the use of synthetic turf for playgrounds is harmful. Connecticut asked the Environmental Protection Agency to study the matter shortly after the EPA's Denver regional office raised the issue of using ground-up tires. The EPA is concluding a limited study of air and surface samples at four fake-surface fields and playgrounds that use recycled tires. EPA scientists now have pointed to research suggesting potential hazards from repeated exposure to bits of shredded tire that can contain cancer-causing substances and other chemicals.

**TAXING DRINKS****VO: 22**

Groups on both sides of the issue are taking notice of a push for new taxes on soda, beer and wine to help pay for Americans' health care. The Senate Finance Committee considering this so-called "lifestyle tax" says the levies would slow sales of unhealthy products that contribute to rising medical costs. Soft drink and alcohol lobbyists have snapped quietly into action to oppose it. Other industries also are on alert, worried that the idea of "lifestyle taxes" could spread to other products deemed unhealthy. The Center for Science in the Public Interest, a consumer advocacy group, has been a leading proponent of the taxes.

**CHYSLER - BANKRUPTCY****VO: 23**

.S. Judge Robert Gerber approved the automaker's first-day motions, allowing the company to continue its normal business operations while under bankruptcy protection. Gerber also approved GM's access to \$15 billion in government-provided bankruptcy protection financing to fund its operations for the next few weeks. On Friday, GM continued reshaping its future, announcing a tentative deal to sell its Saturn brand to auto racing magnate Roger Penske's dealership chain, Penske Automotive Group Inc.

**US ECONOMY EMPLOYMENT****VO: 20**

The May job losses, the lowest since September, indicated a sharp decline in cuts and were lower than the 550,000 some economists expected, reported Forbes, raising the hopes of some analysts. "This tide is turning," Richard Yamarone, an economist at Argus told the Associated Press. "We expect this trend of slower job loss to continue throughout the year." However, unemployment rate jumped to 9.4 percent up from 8.9 percent in April. There are about 14.5 million unemployed in the United States.

**ANTIDEPRESANT CURBS CANCER****VO: 18**

Cancer-related cognitive dysfunction is a common and serious problem that can be alleviated by treatment with a selective serotonin reuptake inhibitor (SSRI), according to results of a National Cancer Institute-supported study reported this week at the American Society of Clinical Oncology's annual meeting in Orlando. "Cancer and its treatment impact important areas of cognitive function such as attention and memory, which are essential to patients' effective psychosocial functioning and quality of life," Dr. Pascal Jean-Pierre, from the University of Rochester, New York, and colleagues point out in a meeting abstract. Prior studies have shown that between 17% and 75% of patients experience cognitive dysfunction during and after cancer treatment.

**OBAMA STIMULUS****VO: 19**

Eager to show action on the ailing economy, President Barack Obama promised Monday to speed federal money into hundreds of public works projects this summer, vowing that 600,000 jobs will be created or saved. Surrounded by his Cabinet, Obama emphasized what has become a dominant issue of public concern - an economy that keeps bleeding jobs - on the day after returning from a week of diplomacy and sightseeing in the Middle East and Europe.

**OBAMA HEALTHCARE****VO: 23**

In the president's weekly address, released Saturday while he was in France for the 65th anniversary of D-Day, Mr. Obama focused on health care, citing the crippling effect soaring costs have on the nation's economy as the reason why reform cannot be delayed. "The status quo is broken," he said, while warning that the current system could collapse if nothing is done to control spiraling costs. "[If] we do nothing, everyone's health care will be put in jeopardy."

**US WILL LET SOME BANKS REPAY AID****VO: 21**

The Obama administration plans to announce as soon as today that some of the nation's largest banks can repay billions in federal aid, but some officials caution that the show of progress is being underwritten by multiple layers of less visible government support. Through cheap loans, debt guarantees and a promise that big banks will not be allowed to fail, these officials say the government has created an artificial environment in which profits and stock prices have rebounded, helping banks in recent weeks to raise about \$50 billion from private investors. The money allows the strongest banks to return federal aid provided at the peak of the fall financial crisis, but few banks have expressed eagerness for the government to end the other forms of support, creating concern that these programs will be habit-forming and more difficult to terminate.

**AP STRESS INDEX CONFIRMS EASING RECESSION****VO: 23**

The recession's grip appears to be loosening as seasonal hiring picked up this spring. That's the conclusion of the Associated Press' monthly analysis of the economic pain in more than 3,100 U.S. counties. The latest results of the AP's Economic Stress Index show the free fall that marked the autumn of 2008 and winter of 2009 gave way in April to a more controlled descent, possibly even a bottom. Still, the analysis found that pain remains high compared with year-ago levels. The AP calculates a score from 1 to 100 based on each county's rate of unemployment, foreclosure and bankruptcy, with lower numbers indicating less economic pain.

**DIABETES HEART****VO: 16**

For people with diabetes and stable heart disease drug therapy works just as well as immediate bypass surgery or angioplasty to open clogged arteries a study suggests. The results show that such patients were no more likely to die or to have a heart attack or stroke over a five-year period if they took medications to control blood sugar, blood pressure, and cholesterol levels than if they underwent prompt bypass surgery or angioplasty with or without stents. But for some patients, immediate bypass surgery may cut the risk of heart attacks, the study shows.

**IMMIGRATION RAID****BLANCA ROSA VILCHEZ - NEW YORK****PKG 2:00**

A federal judge has ruled that immigration agents violated the constitutional rights of four illegal immigrants during a series of controversial raids in New Haven in 2007. The sweeps on June 6, 2007, came two days after New Haven approved issuing identification cards to illegal immigrants, and critics have accused Immigration and Customs Enforcement of using the early morning raids as retaliation for the adoption of the ID program -- a charge the agency has denied. Immigration Judge Michael Straus, in a decision last week, said the ICE agents went into the men's apartments without warrants, probable cause or their consent, and he put a stop to deportation proceedings against the four Latino defendants.

**OBAMA STIMULUS****VO: 28**

President Obama billed it as an adrenaline jolt -- a \$787-billion stimulus package that not only would put people back to work, but also underwrite construction and energy projects the country had long neglected. But with the economy still sputtering and some experts doubting the program was meeting its goals, Obama vowed Monday to accelerate stimulus spending with the goal of creating or saving 600,000 jobs by summer's end.

**CHRYSLER BANKRUPTCY****VO: 24**

Chrysler LLC won court approval on Tuesday to cut a quarter of its U.S. dealerships and the bankruptcy court judge overruled requests to delay the order until the U.S. Supreme Court rules on the sale of the company. Judge Arthur Gonzalez said his order, which allows Chrysler to reject 789 dealer contracts, was effective immediately. "No dealer wants to be rejected. We understand that," Chrysler lawyer Kevyn Orr told the judge, adding that the bankruptcy law did give dealerships special protections.

**HEALTH OVERHAUL - MINORITIES****VO: 55**

Black, Latino and Asian lawmakers warned Democratic leaders that any health care overhaul that ignores health gaps between whites and minorities will face stiff opposition. The lawmakers said they would be hard-pressed to support a bill without a new program providing access to health care for all Americans. "The public health option has to be there," Rep. Mike Honda, a California Democrat who chairs the Congressional Asian Pacific American Caucus, said at a news conference. "If we don't have a public option, there's no discussion."

**AIRLINES INSPECTIONS****VO: 30**

Federal officials said Tuesday they will beef up inspection of pilot training programs at regional airlines in response to safety concerns raised by the crash of a regional airliner in New York in February. Transportation Secretary Ray LaHood and Federal Aviation Administrator Randy Babbitt said in a statement they will also hold a meeting with the airline industry - both regional and major carriers - next week to seek better pilot training, cockpit discipline and other safety improvements. Babbitt said it was clear from the crash of a regional airliner near Buffalo, N.Y., on Feb. 12 that safety needs to be improved. "My goal is to make sure that the entire industry, from large commercial carriers to smaller regional operators, is meeting our safety standard," Babbitt said in a statement. James May, president of the Air Transport Association, which represents large airlines, called the meeting "an important step." He compared it to a government-industry collaboration two years ago to reduce dangerous runway incidents.

## **COLLEGE CHOICES**

### **VO: 20**

In a survey to be released today, 71 percent of high schools reported that more of their students are forgoing their "dream schools" this year than in previous years. And there is little doubt money is a big reason. "With the exception of one or two students, it was THE determining factor in their decision," one high school official wrote. Said another: "Parents were willing to pay for prestige in the past. This year they wanted prestigious schools IF the financial aid packages would work for them."

## **FDA - TOBACCO**

### **VO: 23**

A key Senate vote Monday put Congress in sight of fulfilling a decade-old quest to put the content and marketing of tobacco products under the control of the federal government. The legislation would for the first time give the Food and Drug Administration legal authority to regulate cigarettes and other tobacco products. The 61-30 Senate vote to move forward on the bill sets up possible passage of the measure this week. Sixty votes were needed to keep the bill on track. The House has already passed a similar bill and resolution of minor differences would send it to President Barack Obama, who supports it.

## **OIL PRICES**

### **VO: 19**

Oil prices soared above \$71 a barrel Wednesday to reach a 2009 high, as investors poured money into crude markets to protect themselves against the inflation risks posed by a weakening U.S. dollar. Oil, which typically trades inversely to the dollar, has more than doubled in price in three months as traders also cheered news showing the worst of a severe U.S. recession is likely over. They brushed off data -- such as a 9.4 percent U.S. unemployment rate in May -- that suggest crude demand will remain weak. Even growing inventories have not checked oil's stellar rise.

## **OBAMA IMMIGRATION. Christian Leaders to Call on President Obama to Assert Commitment to Immigration Reform**

## **U.S. TEMPORARILY SUSPENDS POLICY OF DEPORTING WIDOWS OF CITIZENS**

### **VO: 30**

The Department of Homeland Security said Tuesday it is temporarily freezing a policy of deporting widows and widowers of U.S. citizens, a sign of the Obama administration's interest in new approaches to immigration. Only a few hundred people were at risk of deportation under the policy, but critics viewed it as one of the most painful consequences of President George W. Bush's immigration crackdown. Under the current interpretation of federal law, some immigrants whose American spouses had died faced possible deportation because their legal status was in limbo.

**FDA TOBACCO****VO: 18**

The Senate could vote as early as today on legislation that for the first time would give the FDA powers to regulate the sale, manufacturing and marketing of tobacco products. The House has passed a similar bill. President Barack Obama, who is struggling with his own smoking habit, supports it. The Senate cleared the way for passage when it defeated, 60-36, an alternative offered by North Carolina's two senators. The alternative would have created a new agency, instead of the FDA, to regulate tobacco and would have been more open to development of new, less harmful tobacco products.

**OBAMA HEALTH OVERHAUL****VO: 25**

President Barack Obama, facing challenges to his ambitious health care overhaul from Congress, is visiting supporters outside the capital and turning to them to muster up momentum for one of his top legislative priorities. Obama on Thursday readied to fly to Green Bay, Wis., to talk directly with voters about his proposals to spend \$1.5 trillion over the next decade to cover uninsured Americans. Administration aides said the visit was designed for Obama to build support for a health care overhaul that has eluded Democrats for decades, as well to inject a personal angle into a debate that affects some 50 million Americans without insurance.

**FORECLOSURE RATES****VO: 25**

It doesn't signal a quick end to the foreclosure crisis -- but the numbers may be leveling off a bit. According to RealtyTrac, the number of U.S. households on the verge of losing their homes to foreclosure is still rising -- but the year-to-year increase in May was the smallest in nearly three years. From May of last year, foreclosure filings were up nearly 18 percent. And while that may sound like a big gain, it's the smallest since June of 2006.

**SCHWARZENEGGER THREATENS TO SHUT DOWN STATE GOVERNMENT****VO: 27**

Gov. Arnold Schwarzenegger vowed Wednesday to let California government come to a "grinding halt" rather than agree to a high-interest loan to keep the state afloat if he and the Legislature do not close the yawning budget gap in coming weeks. At the same time, the governor reversed himself on a proposal to end health insurance for families of police officers and firefighters who died in the line of duty. The proposed cut was tucked away in a list of regulations that would be suspended if Schwarzenegger's latest budget revisions are adopted. It would have saved the state \$1 million in 2009-10. State finance officials say California coffers will be empty in late July unless the projected \$24-billion budget shortfall is resolved quickly. Schwarzenegger said that emergency borrowing would be too expensive and that his threat to block it was necessary to prod lawmakers into swift action.

**SWINE FLU PANDEMIC****VO: 26**

The World Health Organization has told its member states it has decided to declare a full pandemic of the new H1N1 swine flu, a U.S. health official confirmed Thursday. Sweden's Health Ministry earlier confirmed that WHO was preparing to go to a pandemic phase 6, meaning the new swine flu virus was spreading in several regions around the world and unlikely to be stoppable.

**DIGITAL TV TRANSITION**

Starting in the morning and going into the night, TV stations across the U.S. planned to cut their analog signals Friday, ending a six-decade era for the technology and likely stranding more than 1 million unprepared homes without TV service. The Federal Communications Commission put 4,000 operators on standby for calls from

confused viewers, and set up demonstration centers in several cities. Volunteer groups and local government agencies were helping elderly viewers set up digital converter boxes that keep older TVs functioning.

## **OMS PANDEMIA & FLU VACCINE**

**VO: 21**

A Swiss drug company says it's succeeded in producing a first batch of swine flu vaccine, weeks ahead of expectations. Novartis AG says the vaccine was made in cells, rather than grown in eggs as is usually the case with vaccines. The announcement comes a day after the World Health Organization declared swine flu a pandemic. The move indicates that a global outbreak is under way. The WHO says drugmakers will likely have vaccines approved and ready for sale after September. Novartis says it would use the first batch of vaccine for pre-clinical evaluation and testing. It is also being considered for clinical trials.

New Hampshire legislators have approved a measure that would make the state the sixth to allow gay marriage. Gov. John Lynch is expected to sign the legislation Wednesday afternoon. He had promised a veto if the law didn't clearly spell out that churches and religious groups would not be forced to officiate at gay marriages or provide other services. The Senate passed the measure Wednesday, and the House followed later in the day. The House vote was 198-176. Massachusetts, Connecticut, Maine, Vermont and Iowa already allow gay marriage. ### **UNEMPLOYMENT LATEST**

With companies in no mood to hire, the unemployment rate jumped to 9.4 percent in May, the highest in more than 25 years. But the pace of layoffs eased, with employers cutting 345,000 jobs, the fewest since September. The much smaller-than-expected reduction in payroll jobs, reported by the Labor Department on Friday, adds to evidence that the recession is loosening its hold on the country. It marked the fourth straight month that the pace of layoffs slowed. Still, the increase in the nation's unemployment rate from 8.9 percent in April underscores the difficulties that America's 14.5 million unemployed are having in finding new jobs. Economists had expected the rate to hit 9.2 percent last month.

The sweeps on June 6, 2007, came two days after New Haven approved issuing identification cards to illegal immigrants, and critics have accused Immigration and Customs Enforcement of using the early morning raids as retaliation for the adoption of the ID program -- a charge the agency has denied. Immigration Judge Michael Straus, in a decision last week, said the ICE agents went into the men's apartments without warrants, probable cause or their consent, and he put a stop to deportation proceedings against the four Latino defendants.

The Obama administration ended a years-long turf war between the Justice and Homeland Security departments yesterday, giving more U.S. Immigration and Customs Enforcement agents authority to investigate drug crimes. Leaders of ICE and the Drug Enforcement Administration replaced a 1994 agreement that capped the number of customs agents who could investigate federal drug crimes and limited it to those who make seizures at border crossings. When the Department of Homeland Security was created in 2003, ICE's size and national presence were expanded. However, DEA and the Justice Department refused to lift the cap, set at 1,475 agents, citing the potential for poor coordination. ICE has about 5,000 agents overall, and the

DEA has about 4,800.

## **CA-IMMIGRATION RAIDS**

A city can prohibit its police from stopping or arresting people to find out if they are illegal immigrants, a state appeals court ruled Wednesday in a Los Angeles case with implications for San Francisco's sanctuary ordinance. A taxpayer represented by the conservative group Judicial Watch challenged a 30-year-old Los Angeles Police Department rule barring officers from either arresting anyone for entering the United States illegally or taking any action solely to determine someone's immigration status. The suit claimed the policy conflicts with a 1996 federal law that requires state and local governments to let their employees share information about someone's immigration status with federal authorities. If a city bars police from obtaining immigration information from people they arrest, Judicial Watch argued, it frustrates the purpose of the law. But the Second District Court of Appeal in Los Angeles upheld a judge's decision that found no conflict between the local policy and the federal law.

### **US WARNS TRAVEL TO HONDURAS**

### **TYLENOL SAFETY FDA**

Government experts are scheduled to vote Tuesday on whether Nyquil and other combination cold medications should be pulled from the market to help curb deadly overdoses. The Food and Drug Administration has assembled more than 35 experts for a two-day meeting to discuss and vote on ways to prevent overdose with acetaminophen, the pain-relieving, fever-reducing ingredient in Tylenol and dozens of other prescription and over-the-counter medications. The FDA says that despite years of educational campaigns and other federal actions, acetaminophen remains the leading cause of liver failure in the U.S., sending 56,000 people to the emergency room annually. There are about 200 acetaminophen-related deaths each year.
