CIVIC AND COMMUNITY INVOLVEMENT

4th Quarter 2019 Community Events:

October 2, 2019- National Night Out

KHPT was on-site in League City and Baytown, TX to support first responders and the community for National Night Out.

November 10, 2019- VetsAid

KHPT was on-site and broadcasted live from the Toyota Center for a concert put on by the non-profit VetsAid organization supporting veteran's charities.

November 11, 2019- Veteran's Day Parade

KHPT was on-site showing support for our military and interacting with attendees of the Houston Veteran's Day Parade.

November 15-25, 2019- Snowdrop Foundation's Delivering Hope Run

KHPT showed on-air, onsite and in-house support to KKBQ's Kevin Kline of the Q Morning Zoo in his 302-mile run along the Dalton Hwy in Alaska raising awareness and funds for pediatric cancer research. We broadcasted live at off-site watch parties in the community and employees also did virtual runs in support of the cause.
