These two dynamic women are both survivors of breast cancer and have each launched individual organizations to further educate and create a consistent proactive action in their communities and beyond. Afro Pink and Survive Her have participated in the past two years, and convened over 20 community organizations, corporations, and brands for this health-driven mission. We provided free mammograms on-site to women who were eligible and met the criteria via our partners at ScanVan and will do so again this year. To raise awareness of breast cancer and the disparities among African American women, the necessity of genetic testing, and to encourage the community to live healthy lifestyles.

They are excited to announce the return of the Breast Cancer & Wellness Awareness Block Party themed "Mammos and Genetics Matter: Pink Party on the Plaza, " Saturday, October 14, 2023! This event is open to the community and will give the opportunity to engage with the hundreds of people from all walks of life who we expect will traverse the 'pink' plaza. Both women discussed the importance of early detection, being vigilant about mammograms, and even MRI's and the critical importance of selecting a physician who listens to your health concerns.

These personal experiences were highly challenging for them both, but through faith and prayer, and leaning into the medical education of their journey, they made it through and are now advocates to help others in the cancer fight.

Domestic violence takes place in our nation every minute of every day, occurring just about every 15 seconds. Most Americans don't realize just how real domestic violence is and how many lives are a ected by it. Every October, there is strong advocacy from our partners, supporters, and allies across the country to recognize Domestic Violence Awareness Month (DVAM). However, DV has a longstanding impact on lives and can never be designated to just one month.

Angle Martinez, a survivor of a horrific experience that led to her and her daughter being abducted for 7 months, today is thankful for a second chance at life.

The mother who endured seven months of pure hell when she and her 2-year-old daughter were kidnapped, burned with cigarettes and starved by an ex-boyfriend confronted her "monster".

Yohannes Anglin, who was convicted of kidnapping and torturing her and the tot in 2012, has since been convicted to 60 years in prison and is also registered as a sex offender.

Angie states that she was looking for love instead of understanding what she needed was to understand self-love. She ignored the red flags in the relationship, until she realized that she was in a very dangerous situation where she had no control of her and her daughter's safety. In her testimony during the trial "I never thought you would hurt me and my baby the way you did," she told Anglin through tears. "You knew I'd do anything for my kids and family, so you ran away with it ... which almost cost me and my daughter our lives."

Today, after years of therapy, she is still working on getting back to herself, and very thankful that her daughter has no recollection of the incident. However, within the last several months, she did disclose the horrific story to her daughter.

She celebrates May 29th every year as her 2nd birthdate because that is the day in which she was rescued by the police, and it was as she says, "her second chance at life".

Most of these cases are left behind closed doors. That's why Domestic Violence Awareness Month is critical to educate and raise that awareness and bring the support and strength that domestic violence victims need. Angle is now an advocate in this space supporting organizations like Sisters In Purple, and other arenas where she can push the message of self-love.

For more than 40 years, the Coalition has developed and implemented. humane, cost-e ective solutions to New York's homelessness crisis. This has been done through a myriad of programs o ered by the Coalition for the homeless. -Food Programs, Crisis Services, Housing, Job Training, and advocacy.

The Coalition for the Homeless is overwhelmed by the current situation and does not believe that the Mayor and Governor are e ctively working together for a productive solution. David states that Governor Hochul refuses to acknowledge that New York State is right to shelter, not just NYC>

With no right to shelter, thousands of homeless New Yorkers each year were forced to fend for themselves on the streets. In 1979 the founders of Coalition for the Homeless brought a class action lawsuit called Callahan v. Carey against the City and State arguing that a constitutional right to shelter existed in New York. In particular, the lawsuit pointed to Article XVII of the New York State Constitution, which declares that "the aid, care and support of the needy are public concerns and shall be provided by the state and by such of its subdivisions...." The lead plainti□ in the lawsuit, Robert Callahan, was a homeless Korean War veteran who had been sleeping on the street like many other men.

The right to shelter protects thousands of homeless New Yorkers every day. The fundamental legal protections won by Callahan v. Carey and subsequent cases ensure that individuals and families in need have access to shelter from the elements as they regain stability in their lives and seek permanent housing.

I want to leave you with some myths and facts from the Coalition of The Homeless M: Homelessness is a permanent problem. We will never solve it.

F: The Fact is there are proven solutions to the problem of homelessness and many of them were pioneered in New York City. They are just not being implemented at a scale large enough to solve the crisis. Permanent supportive

housing — a model of housing developed in New York City that combines a ordable housing with support services for individuals and families living with mental illness or other disabilities — has been proven to reduce homelessness AND save taxpayer dollars otherwise spent on costly shelters and hospitalizations.

M. Homelessness is not a housing problem, it's only a jobs problem – and homeless people simply don't want to work.

F :The Fact is the major cause of homelessness is the severe lack of a \Box ordable housing, both in New York City and across the United States. By every measure, the housing a \Box ordability gap — that is, the gap between incomes and housing costs — has grown dramatically over the past four decades.

Ariana discussed her ten-step checklist for business entrepreneurs on the show which is a published resource. Below are some of the listed steps discussed.

CHOOSE THE BUSINESS NAME

Think about what you want to name your business and how that name relates to the products or services you're o ering. Check the availability of the name on the Secretary of State website of the state where you intend to do business to make sure that the name is not already taken and in use by another business. If the search does not reveal any businesses with the name, then the name is yours to use!

DRAFT A BUSINESS PLAN

Your business plan should lay out exactly how you intend to run your business. There is no right or wrong way to write your business plan. It just needs to be suited to your business needs.

DESIGNATE BUSINESS ENTITY

Decide which business entity is best suited for the organization of your business. The most common entities are Limited Liability Company (LLC), Partnerships, and Corporations. An LLC will allow you to limit your personal liability while allowing for the most flexibility with legal requirements. A partnership will also limit your personal liability but will allow you to share in the profits and losses with business partners. A corporation provides the strongest personal liability protection but also has more formal requirements. A business

entity will help give your business legitimacy, credibility, and a professional identity faster! OBTAIN APPROPRIATE BUSINESS LICENSES

Some occupations or businesses require licensing or permits to conduct business. Contact the appropriate city/state agency to determine which licensing and permits you will need.

PROTECT YOUR BRAND & CONTENT

Your brand - your business name and logo - is how you present your products/services to the world. You want your brand to be associated with a certain product or service. After spending time marketing and building your brand, it would be devastating if another business started using your name or logo. Or even worse, if another business trademarked it before you did! It is best to protect your brand by trademarking your name and your logo so that no one else will be able to use it without being subject to infringement. Similarly, protect your content (ex. website, photos, designs, songs, etc.) by registering the copyright so that no one else can copy and use your content without being subject to infringement.

PROTECT YOUR WEBSITE

Your website should generally be protected by 3 website policies privacy policy, website disclaimer, and terms & conditions. You want customers to visit your website to learn about and purchase your products/services,but you also want customers to understand the terms of engagement while browsing your website. A privacy policy will explain how personal information is collected and why. A website disclaimer explains who you are,what you do, and disclaims liability. The terms and conditions set the rules for using your website.

CONTRACTS

A contract is a legally binding agreement between two or more parties. Contracts are the best way to clearly lay out terms between two parties. A contract will strengthen your legal claim for relief if one party fails to fulfill their obligations. Make your business a party to the contract, not yourself. Remember, YOU are separate from YOUR BUSINESS.

Bakeman Global represents the Bedford Stuyvesant section of Brooklyn. Bake has put in a considerable workload which has allowed him to be identified as a promising act on the NYC indie circuit. Lyrically gifted, his pursuits in the Hip Hop genre of music date back to 2009, when he transitioned from a successful professional basketball career which a orded him the opportunity to travel the world. A studio rat as many would call him, his dedication to his craft and personable mannerism has him placed on a compact list of potential breakout stars.

Your Problem Is Our Problem LLC is dedicated to contributing to the "It Takes a community" way of thinking when it comes to raising our youth. We take pride in molding and shaping lives through sports, music, arts, and conversation.

He runs his program with the implementation aimed at promoting restorative justice among children through the transformative power of music, sports, and arts. This innovative initiative seeks to address behavioral issues, conflict resolution, and community building among young individuals.

When you look around and listen to the temperature of Hip Hop music, although there are many bright spots of positivity, the majority of the music seems to be driven by destruction or content not suitable for children. The messages are negative and, in his opinion, this is not a coincidence. During the FYPG program, M. Small shifts the focus is on being equipped with a more extensive vocabulary while learning basic song structure on the way to creating a positive piece of material. The use of profanity, disrespectful lyrics, and violence in the music are prohibited. At the end of the program, the students will either perform the created work in front of friends and family, or we will take a field trip to the Universal Hip Hop Museum in The Bronx to experience the exhibit and learn a bit more about the history and origin of Hip Hop music. It's evident that the youth in our communities grow up facing many challenges. Being able to have open discussions about a lot of the common obstacles is necessary. During the Table Talk Discussions program, we talk about some of the top issues like Bullying, Peer Pressure, Family, Police and Community Engagement, Self Esteem and much more. Within each topic, there are trigger questions that force them to think and speak about how they would manage dealing with these situations. During selected topics, there are scripted lines that are put together in a short scene format where they act out the issue, locate

the conflict, and demonstrate what it would look like when they make the right or wrong decisions.

Dancing is universal and we all love to do it. Since the boom of social media, dance trends have become more popular and it's directly connected to music. During this program, we introduce the youth to some of the popular faces in the dance culture of NYC. The program is conducted by Harlem Shake and LIGHTFEET giant K'sean "K Shakes" Nurse who is one of the top faces of today's dance culture. As co-creator and the face of the extremely popular "All In" dance which has almost 1.5 million plus views on World Star Hip Hop to date, he takes the youth on a tutorial of some specific dance moves that he created, as well as other moves that are universally recognized. K Shakes has danced for artists like Busta Rhymes, Praya, Rich The Kid, Maino, Jim Jones, Fivio Foreign, K Goddess, Neek Bucks and many more. Because of all of the hard work, he has also been recognized by artists like Fabolous, Chris Brown, Beyoncé, Dj Khalid, Lloyd banks, and Ru Endz, who all have either shared or commented on his videos. At the end of the program, the youth are paired up into bracket style dance battles where they must use some of the moves that they learned in the program. The program also consists of a video documentary on the LIGHTFEET dance culture, as well as surprised special guests that are brought in to speak to the youth.

By combining these restorative justice approaches with music, sports, and arts, we aim to foster empathy, teamwork, and emotional resilience among participating children. Through "Your Problem is Our Problem," we aspire to empower the next generation with the tools they need to build harmonious communities and become responsible, compassionate citizens.

There are many members of this community that are still being unfavorably treated and not included in basic human rights opportunities.

Sean believes strong advocacy for change starts with elected o cials and leaders who have platforms to share information and advocate as allies.

Allyship is something that can be an education opportunity for the community and o ers support to the LGBTQ+ community to share information in spaces, that do not open their doors for transgenders.

As an advocate for the specific needs of the Transgender and gender nonbinary/nonconforming

(TGNC) community, Sean and Destination Tomorrow work to provide the support that takes individuals o the path of requiring emergency care, emphasizing economic, social and mental empowerment on a holistic level.

The organization has served over 80,000 individuals through community programming. Some of its most notable projects include but are not limited to:

- Operating 16 apartment units in the Bronx that serve as transitional housing for TGNC.
 - individuals who are former sex workers or victims of sexual violence
 Partnering with community organizations to provide meals for lower income LGBTQ+ families via food pantry services.
- Securing a grant by the City of Atlanta to pilot a first-of-itskind mentorship program for
- TGNC youth, marking the first investment made by the city to an LGBTQ+ center.
