To Whom It May Concern:

On March 28, 2013, the FCC released a consent decree in connection with an alleged violation by KCETLink of the FCC's public file rules ("Rules"), 47 C.F.R. § 73.3527 of the Communications Act of 1934 (the "Consent Decree"). The Consent Decree terminated the investigation and ordered KCETLink to implement a Compliance Plan in connection with the decree. This letter serves as the third Compliance Report pursuant to the terms of the Consent Decree.

The Consent Decree requires the following:

- the designation of a Compliance Officer within 30 days;
- the creation of Operating Procedures to ensure compliance with the Rules set forth in 47 C.F.R. § 73.3527 within 60 days;²
- the creation of a Compliance Checklist to explain the Rules and to set forth the Operating Procedures for Covered Employees within 60 days;
- the creation of a Compliance Manual explaining the Rules and setting forth the Operating Procedures that Covered Employees must follow within 60 days;
- the establishment and implementation of a Compliance Training Program in compliance with the Rules and the Operating Procedures within 60 days; and
- the submission of three Compliance Reports: 90 days, 12 months, and 24 months.

² The time periods in this section are in relation to the Effective Date of the Consent Decree, March 28, 2013.

As reported in the second compliance report dated March 26, 2014, KCETLink has undertaken several steps to comply with the terms and conditions of the Consent Decree. These include the following actions.

On or before April 27, 2013, KCETLink made a voluntary contribution in the amount of 6,000 as required by 14 of the Consent Decree.

On or before April 27, 2013, KCETLink designated June M. Baldwin, Esq. as the Compliance Officer as required by ¶ 8 of the Consent Decree.

On or before May 28, 2013, KCETLink developed and implemented a written Compliance Plan, including Operating Procedures, Compliance Plan, and Compliance Checklist, and distributed the Compliance Manual to all Covered Employees as required by ¶ 9 of the Consent Decree.

On April 29, 2014, Ms. Baldwin conducted the second annual one (1) hour Compliance Training Program for the Covered Employees as required by ¶ 9 of the Consent Decree. KCETLink conducted the third and final compliance training programs on March 12, 2015 and March 23, 2015.

In connection with preparation of this report, Ms. Baldwin has reviewed the Compliance Manual and Compliance Training Materials to ensure that the information set forth therein remains current and complete.

This third Compliance Report will be filed on or before March 28, 2015, as required by ¶ 11 of the Consent Decree.

Please also see the Certification of Compliance attached hereto as Exhibit "A" and incorporated herein by this reference.
