Notice is hereby given that on August 14, 2013, Bonneville Holding Company filed an application with the Federal Communications Commission for a new FM translator station to serve Pocatello, Idaho. The application seeks authority to operate the new FM translator station on Channel 262 with a maximum effective radiated power of 0.075 kW from a transmitter site located at 042-57-47.0 North Latitude, 112-29-59.0 West Longitude. The new FM translator station proposes to rebroadcast FM station KCVI(FM), which serves Blackfoot, Idaho on Channel 268.
