Cumulus Licensing LLC ("Cumulus") is the licensee of Station KEHK(FM), Brownsville, Oregon (Fac. ID No. 7989), which appeared on the list associated with the February 25, 2021, FCC Public Notice that identified stations randomly selected for an EEO audit. KEHK is part of the Cumulus-Eugene, Oregon station employment unit ("SEU") with commonly-owned Stations KSCR(AM), Eugene, OR; KUGN(AM), Eugene, OR; KUJZ(FM), Creswell, OR; KZEL-FM, Eugene, OR; and, KNRQ(FM), Harrisburg, OR.

Cumulus respectfully requests an extension of time to respond to the FCC's EEO Audit Letter "(Letter"). Assembling an EEO audit response in the midst of the COVID-19 pandemic has been challenging at best. Out of concern for the safety of its many employees during this unusual and difficult time, Cumulus made the business decision to require its employees to work from home until July 1, 2021 (and possibly longer). This has had a significant impact on the SEU's ability to gather the documents necessary to complete its response to the Letter.
