Re: Election of Retransmission Consent Status



TVL Broadcasting of Rhode Island, LLC ("Licensee"), licensee of television station WPRI-TV, Providence, Rhode Island (the "Station"), located in the Providence, RI-New Bradford, MA DMA, hereby gives notice to Charter Communications, Inc. that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. 
