## ISSUE: Chavez Appears In Court On Murder And Robbery Charges

| All Day News | 10/23/19 | :30               | The suspect in the October 11th murder on the west side of Fort Dodge appeared in court Wednesday. Fort Dodge resident Damion Lamont Chavez made his initial appearance on charges of first degree murder and first degree robbery. Chavez is accused of killing 28 year old Sioux Falls, South Dakota resident Mohammed Yaqoub. Chavez was captured October 13th during a routine traffic stop in South Georgia. Bail has been set for Chavez at 6 million dollars. He is scheduled for a preliminary hearing on Friday November 1st. |

According to court documents the murder trial of Fort Dodge resident Joshua Pendelton has been pushed back and will not start in April instead of December as it was originally scheduled. Pendelton pleaded not guilty of the murder of Reverend Henderson. On October 2nd police officers responded to a call at St. Paul Lutheran Church here in Fort Dodge and found Henderson outside unresponsive. He later died from injuries suffered in the incident. |

The accident occurred around 8 PM Saturday night, on U.S. Hwy 130 near mile marker 181 just west of Marshalltown. Officials say 58 year old Kim Pfnatz of State Center was driving eastbound in the westbound lanes. Pfnatz crashed into a vehicle driven by 36 year old Kyle Dana of Fort Dodge. Pfnatz died as a result of the accident, Dana was taken to the hospital for treatment of his injuries and since has been released. The investigation into the accident is still ongoing. |

views very public. He did just that with a two story tall mural of President Donald Trump. Boone city councilman Terry Moorem said " I just thought it was pretty divisive and it has been just that pretty divisive". Another Boone councilman Elijah Stines said he has gotten calls from residents upset by the mural. The mural is next to the new Boone Greenspace which is a \$100,000 project with a bandshell that is intended to be a downtown gathering spot. The city of Boone does not have a city ordinance against public art, thus the mural will likely stay up until election day.
