To Whom It May Concern:

On behalf of iHM Licenses, LLC, licensee of WPKF(FM), Poughkeepsie, NY (Fac ID # 72380) and WRWB-FM, Ellenville, NY (Fac ID # 63525), I am writing to request an exemption from the requirements outlined in the March 21, 2022 Public Notice Commencing 2022 EEO Audits ("Public Notice"). We note that the Public Notice incorrectly identifies CC Licenses, LLC as the licensee of WPKF(FM). The correct licensee of the call sign, as shown in the Commission's Licensing & Management System, is iHM Licenses, LLC.

We respectfully request an exemption based on a recent audit of the stations' EEO program. WPKF(FM) and WRWB-FM are part of a larger station employment unit based in the Mid-Hudson Valley, NY. The Mid-Hudson Valley SEU last submitted an audit response on April 26, 2021. The Mid-Hudson Valley SEU's 2020 and 2021 EEO Public File Reports, both ending January 31<sup>st</sup>, were filed as part of that response. The Commission responded favorably to the Los Angeles SEU's audit filing on August 4, 2021. A courtesy copy of the Commission's response is attached for convenience.
