Amendment

Mercy's Bridge Media, LLC, licensee of WTNG-CD, Rockfish, North Carolina, Facility Id. No. 167158, hereby files this amendment to Children's Television Programming Reports filed for WTNG for the years 2020 and 2021, File Nos. 0000130586 and 0000178745, respectively. It is not possible to file amendments to these reports. However, it is possible to amend the Report that Mercy's Bridge filed for WTNG for the year 2022, File No. 0000206547 and this amendment is filed for the 2022 Report. Further to avoid any confusion, the information to be amended is contained in this attachment; no changes are made to the actual Report itself.

This amendment clarifies two of the questions set forth in the Digital Core Programming portion of the 2020 and 2021 Reports.

First, this amendment corrects the info in response to the question "State the total number of hours of regularly scheduled weekly Core Programming broadcast per quarter by the station on its main program stream" for each quarter from 5.0 hours per quarter to 65 hours per quarter.

Second, the amendment corrects the info in response to the question "State the total number of hours of regularly scheduled weekly Core Programming broadcast per quarter by the station on a multicast stream" for each quarter from 8.0 hours to 104 hours per quarter.
