

pyramid scheme. By the time Gold Unlimited was closed down in March of 1995 it is estimated that 96,000 people joined Gold Unlimited, investing nearly 48 million dollars. Much of the money was seized by government officials but they believe nearly 10 million dollars is still missing. In January of 1996, David and Martha Crowe were convicted of Money Laundering and Mail Fraud by a federal court in Owensboro, Kentucky. David had been sentenced to eleven years and Martha was given ten years. The judge allowed the husband and wife to go home and get their affairs in order. They were allowed to "voluntarily" turn themselves over to prison authorities, however, neither David or Martha showed up for their first day in prison. David and Martha were last seen driving their son's black Jeep Cherokee and a U-Haul trailer days before they were to report to jail. David Crowe has a "U.S. Navy" tattoo on his right shoulder. He is a sharp dresser who likes to wear gold jewelry. Martha Crowe also likes jewelry, and frequently wears wigs. both Crowes speak with marked Kentucky accents, and both trained as x-ray technicians. They are confident, with winning personalities. David Crowe is 54, 5'8" and 160 pounds. Martha Crowe is 50, 5'2" and 130 pounds. (See Show #519, OAD 11/21/98)

**Edward Mathis** (Murder, Narcotics Violations) -- Four days before Christmas in 1994, 12-year-old Chris Valdez made a discovery that will stay with him for the rest of his life. While he was away at school, someone broke into his home and murdered his mother and stepfather. He couldn't get inside, but he didn't have to. He could already see the blood. It was everywhere. Chris' mother, Millie Espinal, was found in the bedroom belonging to Chris' 4-year-old brother. Millie had been shot in the face nine times while the child cowered in his closet. In the basement was another body - Chris' stepfather, Ari Espinal. He was lying in a pool of blood from 16 gunshot wounds. Police and federal agents soon had a motive and a suspect for the horrific killings. They say that Ari Espinal had been dealing drugs, and had a large store of cash in his home. Word of his riches had fallen on the ears of a man US Marshals call one of the most ruthless outlaws they have ever put on their 15 Most Wanted List: Eddie "Lucky" Mathis. Marshals say that Mathis made a career out of violence as a drug enforcer. Even his associates in the ruthless narcotics underworld, agents claim, were shaken by his stories of pistol-whippings, robberies, and getaways. Mathis is alleged to routinely carry as many as five handguns at once, and he never leaves home without his bulletproof vest. Law enforcement thought they had Mathis when they stormed an apartment in Atlanta, Georgia, but he made his getaway through the back. Now that he has gotten used to life on the run, officials fear that his next victim may be an unsuspecting police officer who stops him for a traffic violation. "Lucky," they say, is unlikely to ever believe his luck has run out. Mathis has used the aliases Eddie Whitson and John Whitson. He has a tattoo of a chain around his left biceps and may have a mustache or goatee. He is believed to be heavily armed. Mathis is 35, 5'9" and 190 pounds. (See Show #488, OAD 4/4/98)

**Markeith Lamar Braxton** (Murder, Armed Robbery) -- On the morning of January 11, 1997, Igor Razilov, a hard-working Russian immigrant with a wife and two children, was sitting behind the safety of bulletproof glass in a South Central Los Angeles pawn shop. His boss, Tony, had gone to the bank, and Igor was working alone. That's when, police say, Markeith Braxton and his partner in crime walked through the front door. The scene that unfolded that morning was caught on a disturbing video surveillance tape. Posing as customers, the two suspects asked for assistance with a television set, and Igor left his cage. After he helped them and returned, they called for help again. Again, the unsuspecting victim exposed himself to danger, and it came. The robbers tried to wrestle him to the ground and get behind the counter, and when Igor fought back, police say, Braxton pulled his 9mm Glock pistol and shot him through the head. The suspects immediately panicked and ran out the door empty-handed, only to find that their getaway driver had panicked as well, and had left without them. They fled on foot and disappeared into the vast Los Angeles metropolis. Police had plenty of evidence, but they had no suspects until a year later, when someone caved in. In January 1998, one of the accomplices was identified by a former jailhouse informant arrested on a narcotics charge. Police soon had the suspected accomplice and the driver in custody, and then the name of the alleged shooter - Markeith Braxton. After Braxton's profile was aired on America's Most Wanted, one of the citizens who came forward was his own mother, who, after watching the video tape, pleaded with her son to turn himself in. The other important call that came in to AMW was from someone who reportedly grew up with Braxton and knew where his family could be found. This sent police to Kansas City, Missouri, to the home of Braxton's grandmother. There, they found another fugitive from California - the suspect's uncle, Bruce Williams. Williams, who had an outstanding warrant for drug possession, was arrested and gave police their next clue. Braxton's father, Jessie Braxton, would know where his son was hiding, the fugitive reportedly told detectives. The search moved back to California, where, after a little digging, police learned that Jessie Braxton also had an outstanding warrant and was now living in Los Angeles under an assumed name. After he was arrested, it wasn't long before he agreed to cooperate with police in finding his son. He reportedly was convinced that the cops would kill his 19-year-old son in a shootout if he didn't lead the LAPD to his hideout. Wearing a wire, Jessie Braxton reportedly visited a friend of Markeith Braxton and got a phone number. When he called his son, the murder suspect wouldn't give his exact location, but gave him enough information about his surroundings for police to spring into action. Markeith Braxton was arrested near 42nd and Kansas Streets in Los Angeles. He was discovered walking casually toward the back door of an apartment complex, where police say he planned to make his getaway. Ironically, Braxton was sentenced to life without the possibility of parole by Judge

Lance Ito. Judge Ito also handed out life sentences to Braxton's accomplices. (See Shows #460, #488 and #493, OADs 8/2/97, 4/4/98 and 5/2/98)

**Madalyn Murray-O'Hair**

**Jon Garth Murray**

**Robin Eileen Murray-O'Hair** - On August 28, 1995 Madalyn Murray-O'Hair, her son, Jon and her granddaughter, Robin disappeared from their home in Austin, Texas. To this day, no one knows whether they left voluntarily, or under duress. Their half-eaten breakfast was still on the table. Madalyn's medicine was left on the kitchen counter. Their beloved dogs were abandoned. So - it looks like an abduction - right? Well here's the other side of the equation. Missing along with the Murray-O'Hair trio was \$600,000 from the bank accounts of the American Atheists. Police records show that the money was wired to New Jersey, where Helen Johnson, the successor to Madalyn's organization, The American Forum, was living. Though they say Helen has refused to speak about the matter, police say that Jon Murray flew from San Antonio to New Jersey on September 21, 1995. He was accompanied by a man using the alias Conrad Johnson. Who was this man? Some speculate that it could be a man named Danny Fry. In August 1995, Fry became the roommate of David Waters. An ex-con convicted of a 1964 murder, Waters had been employed by the O'Hairs until he was accused of stealing money from Madalyn. Police don't know if there's a direct link between Fry and the O'Hairs, but oddly, he disappeared around the same time as the family. Is it coincidence? Or connection? Records indicate that Jon and his mysterious accomplice returned to San Antonio on September 22. This is where police believe the Murray-O'Hair clan had stayed since their disappearance. Their cellular phone records show activity in San Antonio throughout September. Police believe they stayed at the Warren Inn. Whether some or all of the family was being kept there as hostages or whether they were staying of their own free will hasn't been determined. A few days after police believe the Murray-O'Hairs arrived in San Antonio, an unidentified person sold the family's Mercedes for \$15,000 - CASH. The transaction took place in a strip mall parking lot - right next to the Warren Inn. Oddly, the Warren Inn is one of the last confirmed locations for Danny Fry. On September 30, Danny Fry phoned his daughter from a pay phone there and told her that he was headed home to Austin. He reportedly had one other message for her: get ready for a shopping spree. One day earlier - on September 29, police say a San Antonio coin dealer transferred \$500,000 into gold coins for Jon Murray. The dealer told authorities that he actually received \$600,000 to exchange, but only had \$500,000 on hand. They conducted the exchange in the parking lot of a Frost Bank branch. Murray agreed to return in several days for the remainder, but he never did. Who would voluntarily give up \$100,000? Is it a sign that the family got spooked and ran? Or that they were acting under orders from some abductor? Investigators just don't know. There's another baffling piece to the puzzle - the Murray-O'Hairs had access to a lot more money in various bank accounts. But those accounts weren't touched.



On November 2, 1995, Waters phoned police and informed them that his roommate, Danny Fry was missing; that call was a full month after Fry was last heard from. Though there's no direct link between Fry and the Murray-O'Hairs, investigators believe the coincidences are too great to ignore. Danny Fry's nude and mutilated body has been found. His body had been dumped in a river east of Dallas after his head and hands had been severed. Police suspect that the body of O'Hair and her two adult children have been dismembered, put into 55-gallon metal drums, and buried in Real County, Texas. Police are still looking for the bodies. David Waters has been arrested and implicated in the murder. Gary Karr has also been arrested and admitted involvement in O'Hair's disappearance, though he denies any part in their deaths. **Ira Einhorn** -- It's no wonder Ira Einhorn is so pleased by the French judicial system. Even though he was convicted of murder in America, after several dates in French courts, he remained a free man. Here's his story from the beginning: In his native Philadelphia, Pennsylvania, Ira Einhorn was an all American teenager. He played football on the varsity squad and excelled in academics. But after high school, Einhorn changed. On a trip to San Francisco, Einhorn was introduced to the new 'hippie movement.' Back in Philadelphia, he became a counter-culture leader - a psychedelic guru for the City of Brotherly Love. In 1970, Einhorn was the official host for Philadelphia's Earth Day. The message he preached was peace and love, but underneath his hippie ideology friends say there was a far different message. He was a notorious womanizer, a man who delighted in taking women under his spell. For Holly Maddux, Einhorn was the embodiment of new age ideals. Once they moved in together, however, she soon realized what Einhorn was all about. He demeaned and humiliated her repeatedly, and soon took up with other women. In 1977, Holly finally left Einhorn, and began seeing another man. Snubbed, Einhorn became furious. He told Holly that unless she came back to his place to collect her belongings, he would dispose of everything. But it was only a ploy to get Holly back in his grasp. When she arrived, he killed her, then stashed her body in a steamer trunk. The next day, Einhorn convinced two friends to help him move a trunk from his apartment. He told them the trunk was full of papers about Russian psychic research and that he wanted to throw it in the river. It turned out the trunk was too big for the car, so it was left in a closet in Einhorn's apartment. Meanwhile, Holly's family and friends grew worried when they didn't hear from her. Einhorn began telling people that Holly had left the apartment to run an errand and never returned. Downstairs, Einhorn's neighbors noticed a terrible odor, but visitors to Einhorn's apartment actually assumed it was the hippie guru's own notorious body odor. Einhorn didn't appear to be at all concerned by Holly's 'disappearance.' He was more visible than ever - he lectured at Harvard, and he became recognized as an expert in both computer science and para-psychology. But Holly's family suspected Einhorn in their daughter's disappearance and they hired investigators. When they'd gathered enough evidence, they went to Philadelphia

Police, who in turn went to visit Einhorn. In the closet, they found the steamer trunk. Einhorn was arrested and charged with the murder of Holly Maddux. Einhorn was represented by another famous Philadelphian, Arlen Specter - now a Republican senator. Specter did well for his client. Einhorn was released on bail to await his trial. But on the appointed day in January 1981, Einhorn was a no-show. It turns out that wealthy friends had helped the killer slip out of the US. Throughout the next decade, there were Einhorn sightings all over Europe. America's Most Wanted was able to track him to former addresses in both Sweden and Ireland, but the homicidal hippie was always one step ahead of the law. In 1993, Einhorn was convicted in absentia and sentenced to life in prison. Some thought Einhorn would never be found. But, in 1997, Philadelphia authorities finally tracked Einhorn down - he was hiding in Southwest France. Since Einhorn was convicted in absentia, French officials refused to extradite him to America. That might have been the end of the road for justice, but Pennsylvania officials refused to give up. Pennsylvania governor, Tom Ridge, signed a law into effect that would give Einhorn a new trial - an unprecedented move that should have cleared the way for extradition. In September 1998, Einhorn was rearrested. When he stood before the French Court of Appeals, the notorious fugitive was actually released on bail. French courts finally decided to extradite Einhorn to the US, provided he gets a new trial and does not face the death penalty. Einhorn's appeal of the French court's decision has been denied. #### **Mikelle Diane Biggs**

Age: 11

Height: 4'8"

Weight: 65 pounds

According to detectives with the Mesa Police Department, 11-year-old Mikelle Biggs disappeared from her neighborhood Saturday, January 2, 1999. Police say she was only four houses from her home when she vanished. Around 5:30pm that evening, Mikelle asked her mother for money for the ice cream man and then left the house. At the time she and her sister Kimber heard only the truck's music and thought it was nearby. Mikelle rode her bike with 9-year-old Kimber walking along side her down to the corner and waited. About ten to six Kimber was getting cold so she went home leaving Mikelle behind. Their mother immediately told Kimber to go get her sister because it was getting late. About four to five minutes later Kimber returned telling her mother Mikelle was gone but her bike and two quarters were left by the road. Right now police are treating the case as a missing person because they don't have enough

evidence to call it a kidnapping. But Mikelle's parents believe she was abducted. Police cannot confirm that an ice cream vendor was in the area that evening but they are looking for a cooper-colored CJ-5 Jeep that witnesses say was seen in the neighborhood around the time Mikelle disappeared. Mikelle has noticeably prominent front teeth. She is an honor roll student who likes to draw and play the clarinet and is a member of the student counsel. When last seen, she was wearing a red t-shirt, bell-bottom blue jeans and white canvas tennis shoes. (See Show #524, OAD 1/9/99)

**Ricky Lane Thomas**

Ricky Lane Thomas disappeared from Bristow, Indiana on November 6, 1997. Police say Ricky's stepfather saw him at around 11:30 a.m. Around 1 p.m. Ricky phoned his cousin and told her he was walking to her house - about a mile away. He was planning to spend the night there, but he never made it. Ricky left home with two backpacks and his wallet. Mysteriously, his two 13-week-old puppies also are missing. Ricky has behavioral problems at school. He was last seen wearing a black pullover jacket with "Route 66" on the front, denim shorts, and black and white hightop sneakers. **Kristin Denise Smart**

Age: 22

On May 25, 1996, 19-year-old Kristin Smart disappeared under very mysterious circumstances from the campus of California Polytechnic in San Luis Obispo. While her body has never been found, sadly, her family can only assume that she was murdered. In fact, the Smarts believe they know the identity of Kristin's killer - yet they cannot find justice. On May 24, 1996, Kristin and her friends attended a party in the quiet suburb of San Louis Obispo, where Kristin was a freshman at California Polytechnic. There, according to partygoers, she met fellow student, Paul Flores. Kristin had reportedly been drinking, and at about 1:30 a.m., one of her female friends offered to accompany her on the short walk back to the dorms. Flores, witnesses say, joined them as they were leaving. As they arrived at the dorms, Kristin's friend split off from the other two, as her dorm was in the opposite direction. She says she was assured by Flores that he would get Kristin home safely. But Kristin never made it home. Despite a search by authorities and an enormous effort by Kristin's own family, police still haven't uncovered enough information to

name a suspect. However, they say, all leads point to the man who saw her last - Paul Flores. Flores was reportedly seen with bruises on his face the next day, including a mild black eye. When questioned by police, they report that he provided inconsistent statements, and then suddenly refused to cooperate, communicating only through his lawyer. Weeks after Kristin disappeared, Flores reportedly dropped out of school and moved off campus. Then came, police say, the most damning piece of evidence yet - cadaver-sniffing dogs were brought on campus to inspect mattresses throughout the school. Handlers claimed that the only one they were in the least drawn to was the one used by Paul Flores. But that was a full month after Kristin disappeared, and when a search warrant was served on his parents' home, no evidence was found. Flores remains a free man. Despite the fact that police are convinced that he either did something or knows something, their hands are tied. Meanwhile, the Smart family suffers one unbearable day after another, unsure that they will ever know the full story of what happened to their daughter. Rachel Newhouse disappeared in November of 1998, and Aundria Crawford in March of 1999. In April of 1999 Newhouse's and Crawford's bodies were found near the secluded home of 33-year-old Rex Crebs who was arrested for their murders. ### **Erica Lee Fraysure**

On October 21, 1997, 17-year-old Erica Fraysure disappeared from Brooksville, Kentucky. She was last seen around 9:00 p.m. that evening, driving her 1988 black Pontiac through town. The next day Erica's car was found abandoned in the middle of a hayfield. The keys were missing, but her purse, wallet, and checkbook were inside. Police say there were no signs of foul play at the scene. Erica was a twelfth grade honor student and police don't believe she ran away. Erica was last seen wearing a purple sweater with two white stripes, blue jeans, white kid shoes, and a Winnie-the-Pooh watch. (See Show #472, OAD 11/1/97)

**Karen Marie Mitchell**

On November 25, 1997, Karen Mitchell was helping her aunt, who owns a shop in the Bayshore Mall, Eureka, California. From there, Karen intended to walk to her daycare job at the Coastal Family Development Center, about one mile away. Due to arrive at work at 3:30 PM, she never showed up. Police and relatives believe she was abducted along the way. The only tip received by investigating authorities has been from a former detective, who says he saw a girl matching Karen's description on near the mall. He added that he also saw a blue car with front end damage parked on the street in front of the girl. Her family and friends say that it is entirely out of character for Karen to miss work, and that she was happy and preparing for the future. She was in the process of applying to Humboldt State University and College of the Redwoods, both nearby institutions. When last seen Karen was wearing a tan long-sleeve shirt, dark brown pants, tan shoes, and carrying a Nalgene water bottle. (See Show #477, OAD 12/13/97)

**Peter Kema**

In August 1997, Peter Kema's father reportedly ran out of money. In his reports to police, he says he and Peter left their home in Hilo, Hawaii, for Honolulu, where Peter's father hoped to find a job. But while he was out pounding the pavement, he wanted Peter to be safe, and allegedly left him with a family friend, Rose Makuakane. The practice of allowing a friend or family member to temporarily take over raising a child is common in Hawaiian culture - it even has a name. But authorities say that in this case it may have been taken too far. Makuakane and Peter haven't been seen since August 1997, and police believe that she may have moved to Florida. However, they say, they haven't been able to confirm the father's story, and aren't ruling out any possibilities. (See Shows #493 and #507, OADs 5/2/98 and 8/15/98)

**Vanessa Dawn Smith**

**Morgan Nick**

Morgan Nick was abducted from Alma, Arkansas on June 9, 1995. Morgan went to a local baseball game with her mother and grandmother. Morgan and other children went to play in a sand pile nearby. On their way back, Morgan stopped to empty sand out of her shoes. The other children kept walking. That was the last time the children saw Morgan. Witnesses told police they saw a man put Morgan into a dull red colder model Ford pick-up truck with a red-and-white shell camper which has damage to the right rear side. He was described as a white male, six feet tall, with a medium build. He is 25-40 years old and has a dark mustache and beard. The Alma, Arkansas Police Department and other agencies are now investigating two other abductions, apparently by the same suspect. Police say Morgan's abductor tried to kidnap other area children on June 9th and 10th. Witnesses said that on Friday, June 9, 1995 at 10:30am the suspect enticed a 4-year-old girl into the same red truck at a local Alma laundry. The abductor released the child when her mother approached him and screamed. The second incident occurred in Fort Smith, Arkansas, approximately 15 miles from Alma. A man fitting the same description as Morgan's abductor tried to entice a 9-year-old into a men's restroom at a local convenience store. The little girl pulled away and the suspect backed off. Arkansas State Police have announced that they are now searching for a serial abductor. When last seen, Morgan Nick had shoulder-length hair and was wearing blue denim shorts, white tennis shoes, and a green t-shirt with the words "Girl Scouts" printed on the front. Jacob, his 10-year-old brother Trevor, and a school friend, Aaron Larson, 11, were about a half a mile away from the Wetterling home when they were stopped by a burly white male at about 9:15pm. The man approached the three boys with a gun and told them to get off their bikes. The man grabbed Jacob and let the other two boys go. Trevor and Aaron ran for help. Jacob was last seen wearing a red St. Cloud hockey jacket which featured a large St. Cloud Police Department logo on the back. He was also wearing an orange vest, blue sweatpants and white Nike high-top running shoes with a gray stripe. Jacob wears contacts or glasses for nearsightedness. Jacob's abductor is described as 5'8" with broad shoulders. The abductor spoke in an authoritative manner with a low, raspy voice.

**Jolene Riendeau**

Jolene Riendeau has been missing from the Pointe Saint-Charles neighborhood of Montreal, Quebec, Canada since April 12, 1999. On that Monday Jolene came home from school, walked her dog, did some chores and went out to play between 4:00pm and 4:30pm. Witnesses who know Jolene told police they saw her at 5:30pm with a bag of chips outside a local convenience store. A little while later Jolene was seen roller-blading on the corner of Wellington and Livermore Streets. Jolene's friend Karine saw her at approximately 6:05pm when Jolene stopped to talk to her on Knox Street. After that, police don't know what happened to the little girl. Jolene speaks both French and English. She has a scar on her forehead, and a dark-colored scar on her right ear surrounding an old earring hole. She is very friendly and outgoing. When last seen, she was wearing blue Addidas sports pants with a white line from top to bottom and a blue

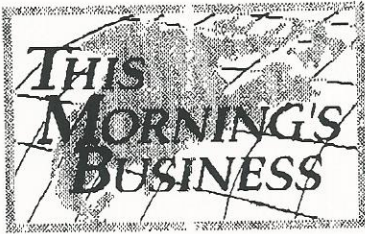

**Shon Allen Ashton (Armed Robbery)**

**Angela Joy Porter (Wanted for Questioning)** - Ashton is wanted for a home-invasion robbery on May 7, 1999 in St. Charles, Missouri. On that day at around 10:00pm, Ashton and Gregg Porter, the brother of Ashton's girlfriend, burst into the home of 71-year-old Ed Alexander. The two men were wearing masks to hide their identity, toting pistols and they were yelling "Police! This is a drug raid!" Ashton and Porter were also wearing dark colored clothing with the word "Police" on the front of their shirts and caps. The two intruders handcuffed Ed and a live-in nurse, Polly Tiujillo, and pushed them into a small office. Ashton and Porter yelled at Ed and Polly to open the safe that sat in the corner of the small room. When Ed couldn't get the combination correct, one of the gunmen pistol-whipped him on the back of the head. Ed finally got the combination correct and opened the safe. After the alleged robbers stole thousands of dollars in cash and jewelry from the safe, the men pushed the two victims into the basement and handcuffed them. Before they left Alexander's home, the two men also stole Ed's "long guns" and handguns. They then took off in Alexander's 1999 Lincoln Town Car. The Lincoln was recovered the next morning about a half a mile from the victim's house. Suspicion quickly fell on Ashton because detectives learned that he was the current boyfriend of Angela Porter, a nurse who had worked for the victim the week before the break-in. An investigation of Ashton's house turned up the material used to make the masks that were worn by the robbers. A search of Gregg Porter's house turned up some of the stolen cash from the robbery. Gregg Porter was arrested and led police to the stolen guns and then admitted that he and Ashton split the cash and jewelry. Ashton has several known aliases, including John Martinez, Christopher Shawn Phillips, Christopher Paul Phillips, Shane Brown, Paul Phillips, Shannon R. Martinez, Mario Victor Martinez, Jonathan C. Martinez, and Phillip Ray Schultz. He has scars on both cheeks, and an unknown tattoo on his upper right arm. He may have cut his hair close on the sides and dyed the top blond. He has worked as a home health aide and as a short order cook, and has previous records for burglary. Ashton is 29, 5'7" and 155 pounds. Angela Porter, who has used the alias Angela Skoba, has a tattoo of a heart on her derriere. She has waist-length bleached-blond hair. Porter was going to nursing school, and has also worked as a waitress and as a

stripper. Porter is 28, 5'4" and 130 pounds. The pair are probably traveling together in a white 1993 Honda Del Sol with Missouri tags 408-DKT.

**Rafael Resendez-Ramirez** (Wanted for Questioning) -- Rafael Resendez-Ramirez is wanted for questioning in the 1998 murder of Dr. Claudia Benton in West University Place, Texas. Claudia Benton, a doctor with the Genetic Research Department at Baylor Medical Center, was home alone on December 16, 1998. Police say sometime that night or early the next morning someone broke into the house and sexually assaulted and stabbed Dr. Benton to death. When she didn't show up for work the next day her co-workers became concerned and called the authorities. West University Place police discovered Claudia's battered body in her bedroom. Her assailant took her red Jeep Cherokee which was later found in a parking lot in San Antonio, Texas. Fingerprints taken at the crime scene were later determined to be those of Rafael Resendez-Ramirez. Police would like to question him about the crime. Resendez-Ramirez has used many aliases, including Jose Reyes-Resendez, Angel Reyes, Jose R. Angel, Antonio Martinez, Carlos Rodriguez and Pedro Jaramillo. He has a one-inch scar on his left forearm, a half-inch scar on his forehead, and a small scar on his right ring finger. He has a faded tattoo of a snake on his left forearm. He may be wearing glasses. Resendez-Ramirez is a drifter who gets around by "riding the rails". He has been arrested previously for trespassing on railroad property. Since the original broadcast, Resendez-Ramirez has become a suspect in the bludgeoning murder of Skip Sirnic, a minister, and his wife Karen as they slept in their home in Weimar, Texas. DNA evidence found at both crime scene indicates that Resendez-Ramirez committed both murders. Police in Lexington, Kentucky believe that Resendez-Ramirez may be linked to another crime in their community. Resendez-Ramirez is 38, 5'6" and 150 pounds. (See Show #534, OAD 3/20/99)

**Ricardo Londell Harris** (Escape, Armed Robbery) -- Ricardo Londell Harris is wanted by Michigan police for escape and by Oaklawn police for questioning in a double homicide and robbery. Michigan police say Harris escaped from Genesee Prison on May 7 by overpowering a deputy. Harris was returning from a medical examination when he hijacked the deputy's car and stole her 40-caliber semi-automatic. Police believe he then ditched the car and hijacked another man. No one saw or heard from Harris until he showed up in the Chicago area days later. A witness said he tried to pawn the deputy's weapon outside a hotel in Chicago. The next day Harris and his brother Roderick drove to Extra Value Liquor where Roderick waited in the car as Ricardo Harris entered the store. Police believe Ricardo then opened fire in the store, killing two people. When police arrived they found four injured civilians and an empty cash register. Roderick turned himself in to Michigan police days later. However Ricardo is still on the run and authorities believe he is armed and dangerous. Harris has a scar on his right cheek and parts his hair in the middle. He usually wears dark clothing. Harris is 34, 6'1" and 180 pounds. (See

**Stephen Basil Toussaint (Murder)** -- Bob Ivens and Stephen Toussaint worked with the dead. For over twenty years, they were technicians in the University of Toronto's anatomy department - Toussaint was in charge of preparation of cadavers for dissection by medical students. He was known as a happy, jovial man at work, and as a responsible, God-fearing man in his community. Toussaint is father of two, and treasurer and Sunday school teacher at his church. But, police say, Toussaint was looking for more, and eventually found it in a bottle of vodka. Police say that vodka came to rule Toussaint's life - shots for breakfast, nips for lunch, and late nights at run-down bars. In his department, colleagues say the embalmer was constantly bombed and becoming little more than dead weight. Eventually, investigators claim, Bob and another department member, Susan Hausmann, went to complain about his work. Toussaint was reportedly reprimanded several times, and when he returned from vacation, he found the entire department restructured by Bob and Susan. He could see the writing on the wall, police say, but even that didn't pull him out of his daily drinking. When Susan quit, Bob was left carrying the entire department, police say, and without Toussaint's help, the cadavers were piling up. Tempers were running high in the cooling room. On April 15, 1998, Bob was last seen at 3:00 p.m. At four, the chairman of the anatomy department came looking for him, and was told by Toussaint that Bob had headed for the storage unit. The chairman went to look, but couldn't find him anywhere. That's because, police say, Toussaint had bludgeoned Bob to death in a fit of rage and [ ]hidden his body not far from the cadavers. But, police say, Toussaint wasn't done yet. While Bob's body lay undiscovered in the storage locker, investigators claim Toussaint left a message on his boss' answering machine: "Hey Doc, come on down. I've got some bones I wanna show you." Police say if his boss hadn't left just minutes before, or had gotten the message a little earlier, he would have been placed alongside Bob. Instead of killing again, police say Toussaint went out drinking with coworkers, acting the part of the happy drunk that everyone knew. But that same night, Toussaint's church was burned to the ground. Investigators believe it was arson, and Toussaint is on their list. If this rampage of murder and arson was due to Toussaint, he's keeping it to himself. He hasn't been seen since 11:00 on the night of the murder, and police believe he may have left the country. Toussaint has a small scar on his chest and a similar scar on his back. He is a Canadian national who wears his hair short cropped, though he may dye it to look younger. He also has freckles on his cheek and may be wearing a mustache. He has partial dentures, upper and lower, and sometimes wears sunglasses. He has a muscular build and likes to be the center of attention. He speaks some Portuguese, knows the Bible well, and has an extensive knowledge of human anatomy. He is a serious alcoholic who drinks daily, often vodka and Johnny Walker. He has worked as an anatomy technician, preparing bodies for dissection. Toussaint is 56, 5'11" and 200 pounds. **Delvin T. Groat** (Rape of a Child, Child Molestation) -- Delvin Groat is wanted by the Aberdeen, Washington police department for raping and molesting children in the community of Grays Harbor, Washington. Groat systematically raped and photographed two girls, ages six and four, while they were placed in his home for foster care. Groat was arrested on March 29, 1996, but was released to await trial a couple of days later. He fled the jurisdiction shortly afterward and has remained at large. Groat is a deeply religious member of the Pentecostal faith, and has served as a youth minister in church. He has worked as a millwright in lumber factories. Groat is 40, 5'9" and 160 pounds. Following the initial broadcast, tipsters informed authorities that Groat may be headed to Mexico. He has dyed his hair blond, and one other interesting tip: He can't grow a beard. (See Show #544, OAD 5/29/99)

**Hazel Leota Head** (Murder, Arson) -- Hazel Leota Head is wanted for the murder of Charles Barker on September 2, 1998 in Benton, Louisiana. Barker was shot in the back of the head as he sat at his trailer counter. Police found a murder weapon and say physical evidence points to Hazel Head. Hazel had met Barker at a local casino under the name Deiana Ray. She subsequently moved in with him. When Barker's body was found, his cash and his car were gone. Upon further investigation, police found that there was an outstanding warrant for Hazel's arrest in Nebraska, where she is accused of burning down a boyfriend's trailer. Police also learned that Hazel has a history of moving around. She has been married multiple times, to as many as ten different men. She has lived all across the country. Head has many aliases, including Hazel Morgan, Willow Shields, Hazel Foley, Kelly Morgan, Hazel Spurbeck, Hazel Haynes, Hazel Vincent, Deiana Ray, Hazel Woodman, Hazel Fautch, Treasa "Tess" Jean Coyle, and Treasa "Tess" Venable. She has a noticeable gap between her front teeth. She is a smoker and drinker, favoring vodka. She often works as a waitress, and hangs out at truck stops, often traveling with truckers. She frequents casinos and places personal ads looking for men. A truck driver believes the woman he picked up in Madisonville, Kentucky and drove to a truck stop in Woodhaven, Michigan was Head. The woman told the trucker she was trying to get to Las Vegas. Head is 49, 5'2" and 120 pounds. (See Shows #527, #528 and #533, OADs 1/30/99, 2/6/99 and 3/13/99)

**Jose Luis Saenz** (Murder) -- Jose Saenz is wanted for triple homicide. In July of 1998 Saenz shot and murdered two rival gang members in the Aliso Village housing project. Several weeks later Saenz became paranoid that the mother of his child, Sigredez Fernandez, would go to police and expose him as the triggerman. In the early morning hours of August 5, he went to Sigredez's apartment and abducted her at gunpoint in front of their own baby daughter. He then forced her into his car and drove to his grandmother's house in East Los Angeles. He then took Sigredez inside where she was raped and shot execution style. Saenz's grandmother found her

body several hours later. No one has seen Saenz since and authorities say he is armed and dangerous. Saenz has used the nickname Joe Louie Saenz and goes by the nickname "Smiley". He is a member of the Quarto Flats street gang. Saenz is 23, 5'6" and 160 pounds.

**CAPTURED:**

**Oscar Thrash (Fraud)** - Thrash was a con man who would follow elderly women home from the supermarket, produce a phoney police badge, and tell his marks that they had give the store counterfeit money. He was captured by alert neighbors who heard the commotion from their elderly neighbor's home, but he escaped before he could be brought to trial. AMW tipsters located Thrash at a Greyhound bus station in Huntington, West Virginia, where he was apprehended.

**Michas Angelo Taitano (Murder, Robbery)** -- Michas Taitano is wanted for the murder and robbery of Tarkegne Worku, a Seattle parking attendant on July 5, 1998. Worku's wife prepared his dinner and was delivering it to him when she returned to their car for a fork. While she was walking away from her husband, Michas Taitano shot Worku and robbed his booth of approximately \$200. Taitano confessed to a friend the next day. INS Inspector Eric West was working the border crossing between Mexico and Arizona when he checked out a suspicious car returning to the US. When a small quantity of marijuana was found, the driver and passenger were arrested. The passenger, Taitano confessed his identity. If convicted, he may spend the rest of his life behind bars. (See Show #528, OAD 2/6/99)

**Darrin "Bumper" Mills (Murder, Attempted Murder, Armed Robbery, Arson)** -- Mills is wanted by the Battle Creek Police Department and the Michigan State Police Fugitive Team for murder, attempted murder, and armed robbery on January 27, 1999. Mills and Jamie Maclam heard that there was a lot of cash to be had at the Kings Garden Health Spa. At midnight on January 27, Mills and Maclam entered the small massage parlor and found four Asian women inside, including the owner, two employees and a friend. The two men became upset when they could not find any money except for a \$5 bill. The women were beaten with sticks, pistol whipped, and cut with kitchen knives. Bleach was then poured on the women. To cover up the crime Mills and Maclam burned the business to the ground. Two of the victims were able to crawl away from the burning building to safety. The other two victims, Chin Jo Broderick and Sum Mi Cox, died of smoke inhalation. AMW tipsters found Mills in Nashville, Tennessee where he was arrested. (See Show #536, OAD 4/3/99)

**Kenneth Sorrell Williams** (Armed Robbery, Conspiracy to Traffic Cocaine) -- Miami-Dade Police are engaged in a dangerous showdown with well-armed soldiers in a multi-gang drug war. It's a war with over 100 casualties; and too often innocent citizens are the victims. Investigators say most of the violence can be attributed to a ruthless gang which goes by the street name, The Boobie Boys. Doesn't sound like a bunch of tough guys, but police say the Boobies alone are responsible for at least 30 murders. So why the name? Boobie? The accused leader of the gang is Kenneth Sorrell Williams. By reputation, he's as mean as a Florida gator, but by nickname, he's Boobie. Boobie has been in serious trouble since he was a teenager. The accused drug lord with the laughable nickname first went to prison for a homicide case when he was still a juvenile. When Williams finished doing his time, he was a young man with a mission; detectives say he set up business making money any way he could - that usually meant drug ripoffs and burglaries. Boobie muscled in on other dealers' territory and methodically rose to the level of drug lord, showing no mercy along the way, say detectives. Boobie seized his authority through force and graphic violence: One crime scene was littered with 99 bullet casings. The gang's signature weapon were AK-47s - a firearm so deadly that the victim is literally pulverized. And when the Boobies were squeezing the trigger, police say everyone in sight was fair game. Five-year-old Michael Frasier was sitting on his mother's lap in her boyfriend's car when the police say the Boobies opened fire on the boyfriend. No one in the car survived. That ruthless style pushed Boobie's empire beyond Miami. DEA agents now say the Boobie Boys have business outlets through most major cities in Florida, into Georgia, through the Carolinas, into Virginia and as far north as Detroit. They believe they are also establishing trade in Las Vegas. In February 1998, police were able to tie the Boobie Boys to actual murders and put together an iron-clad case. AMW viewers found Kenneth "Boobie" Williams living in Atlanta, Georgia, where authorities took him into custody. (See Shows #513, #515, #516 and #524, OADs 9/26/98, 10/10/98, 10/31/98 and 1/9/99)

**MISSING:**

**Kathlyn Elizabeth Poirier**

Age: 19

Height: 5'4"

Weight: 115 pounds

Investigators are searching for Kathlyn Elizabeth Poirier, who was abducted in Moose Lake, Minnesota by an unknown man. Poirier was abducted at approximately 11:30pm on Wednesday, May 26, 1999 from D.J.'s Expressway, a combination Conoco station and Subway sandwich shop on Interstate 35. Poirier was the only employee working at the time. A video surveillance



tape captured the abduction on film. The tape revealed an unknown man as he wrapped his hands around Poirier's neck and forced her out of the store. Witnesses came up with a composite of a suspicious man seen in the area when Poirier was kidnapped. He is described as a white male in his late teens or early 20's, with a slim build and strawberry blond curly hair. He wore a New York Yankees jersey with number 23 on the back, light colored pants and walking or gym shoes. He drove a dark colored pickup truck with an extended cab. When last seen, Kathryn "Katie" Poirier was wearing a white short sleeve t-shirt with a Minnesota State Lottery emblem on the left shoulder, black and white Nike cross trainer pants, a silver hoop and black ball navel ring, two silver hoops earrings in her right ear and two silver hoops plus another hoop on the upper side of her left ear. She has a scar on her left inner arm from surgical staples used to repair a broken arm, and a large tattoo in black and red on her lower back. She has shoulder-length brown hair.

#### **FEATURE:**

**Shock Treatment** -- "If we could distill an essence of what it's like to work on a kid and have him die right in front of you, and then to have to go out and tell their family that they've died, if there was some way people could take a pill and experience that, this would go away right now." Dr. Linda Erwin, trauma surgeon at Portland, Oregon's Legacy Emmanuel Hospital, deals with the deadly mix of youth and firearms every day. One day she was at the head of a stretcher that contained yet another young victim of a bullet : "This kid looked up," she says, "and said with complete genuine shock, 'I didn't know this would hurt.' I realized that this child was completely unequipped to make a safe choice with respect to guns because he's not even clear that it hurts to get shot." Dr. Erwin saw clearly that day the root of the problem. Too many kids have access to firearms, but haven't a clue about what damage these guns can do to themselves and others. They need a serious dose of reality - before that reality kills them. On her own time, with her own money, Dr. Erwin has devised a "shock treatment" program to teach children that what they see on TV and in movies - glamorous, painless deaths - isn't the real deal. Children have been desensitized by these and other media, Dr. Erwin says, and need a brutal wake-up call. Dr. Erwin's program is a graphic, bloody, and painful display of the damage guns will do. To an audience of young minds raised on video violence, her collection of slides from the emergency room ward is shocking and unexpected. They haven't seen anything like this before. Her real-life pictures of exit wounds are a stark contrast to glossy TV killings that show, at most, a little blood on a white shirt. Her pictures of a belly-shot patient, with a horrifically swollen abdomen, are more intense and frightening than anything her audience sees in our media. What is Dr. Erwin trying to accomplish? She says that if she can reach just one young mind, convince just one potential killer or victim, that guns mean business, then all her hours of work
