*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Bobby Reno Livingston** (Sale of Unregistered Securities) -- No one knows who this man is. When allegedly working his scam in Houston, Texas, he went by "Bobby Reno Livingston," but officials have since learned that the real Bobby Livingston died years ago! FBI agents say that the fake Livingston is the epitome of the confidence man, with the persuasive power of a cult leader and the ruthlessness of a bank robber. His alleged scam was elaborate and carefully planned, but without his charisma, they say it never could have worked. Investigators say Livingston had no trouble posing as a self-made millionaire - after bilking more than \$3 million from hard-working Houstoners, he was one. But the rest of the stories victims say he told were incredible. He reportedly found an audience through late-night TV spots, showing an infomercial that claimed investors could clear a guaranteed 30 percent in three months by purchasing his "Godey Girl" merchandise. Livingston allegedly professed he owned the exclusive international rights to buy and sell all things Godey Girl, and hawked porcelain figures, coins, and lithographs with their graceful 19th century images. Victims say they were led to believe he would buy back the items after three months at a set price. But what they got for their \$350 was a \$10 coin - \$4,000 would get you a lithograph worth \$20. According to officials, Livingston had his suckers so well-strung that he often didn't even bother producing the coins and lithographs - instead, agents report, he assured them that the non-existent items would be much more safe in his vault. All the victims got was a certificate of ownership. Investigators say Livingston was so slick he even got a printing company to allow him to shoot his pitch inside their plant, and boldly told the cameras that the factory was his. No doubt he would have gone on plucking his hapless victims, but one day a suspicious citizen sent an anonymous fax to the Houston D.A.'s office, and the game was up. Livingston was arrested in February 1977, but due to a clerical error, he was allowed to post bond. Livingston didn't stand around to correct their mistake. With his wife and five children, Livingston vanished. He may be traveling with his wife, Jan Benton Livingston, 38-40 years old. He carries large amounts of cash and drives luxury automobiles, sometimes using a chauffeur. Livingston speaks with a southern accent. He patronizes strip clubs, claims to have organized crime connections, and professes an extensive background in collectibles and antiques. He is most likely using a new identity. Livingston is

**Jesse Carl McAllister** (Aggravated Murder - 2 Counts)

**Bradley Charles Price** (Aggravated Murder - 2 Counts) -- "I'm leaving town. You'll know why in the morning." It was a phone conversation in the dead of night, and that was the last word from one of two accused thrill-killers. Now a video store clerk and a fast food cashier are on the run - considered armed, dangerous, and desperate. Jesse Carl McAllister and Bradley Charles Price worked dead-end, low-wage jobs and lived a dead-end, low-rent life. They shared an apartment not far from the beach in Seaside, Oregon. On the night of July 13, 1997, police say that after watching the film "In Cold Blood," the two men chose a new career path - as killers. They allegedly spent the night tossing back beers and wandering the beach - drifting from one campfire party to another. Almost everyone who was on the beach that night remembers the boisterous duo. Almost everyone who encountered them feared them. At 5:30 a.m. on Monday July, 14, some beach walkers found the bodies of 37-year-old Frank Nimz and 26-year-old Gabriella Goza. They had each been shot in the head by a 9 mm military pistol. Seaside police say it was an unmitigated thrill kill. They put the evidence together fast: officers say a tipster told them that McAllister foolishly boasted of the murders at a local convenience store - he didn't know he was caught on videotape. Then there's the farewell call that police say he made to a friend. Later that morning McAllister didn't show up for his job at a fast food restaurant; Price was a no-show at the video store where he worked. Neither man has been seen since, though police have recovered their 1977 gray Chevrolet Impala near La Paz, Mexico. He is known to have the following tattoos: Left forearm - unidentified tattoo; Left shoulder - red and black weave pattern. He is outgoing, smokes Camel filtered cigarettes, and drinks Busch beer. He served time in prison on 1996 assault charges, on probation for 1995 burglary charges. McAllister is 20, 5'11" and 170 pounds. Price is very quiet. He wears prescription glasses or contact lenses. He is a former smoker and also drinks Busch beer. Price is 23, 5'10", and 160 pounds. (See Shows #459 and 462, OADs 7/26/97 and 8/16/98)

**Melissa Polonio** (Murder, Conspiracy) -- Jany Pujol and her friend Merlyn moved to New York from Puerto Rico, looking for a better life, and settled in the north Manhattan community of Washington Heights. Federal agents say it was there that Jany's path crossed that of Melissa Polonio, who cut that life short. Polonio had been under investigation for allegedly managing her convicted husband's \$2 million crack cocaine enterprise - a venture agents say was as successful as it was ruthless. During their surveillance, they say that Polonio fell into the clutches of the powerful drug; her original beauty eroded, and her temper became vicious. Two days before she was indicted for conspiracy, her sister told her to come to a children's birthday party. The party had been organized by Jany and Merlyn for Merlyn's two daughters. Polonio's sister, Cathy, was a familiar face in the neighborhood, and told them that the basement in her building was available to rent. Cathy was invited to the party, but she brought an uninvited guest - Melissa Polonio. They arrived with friends at around 2:00 a.m., as the party was winding

down. Witnesses say they were already staring down Jany before they attempted to leave with several bottles of alcohol. Jany spoke up, and the group reportedly jumped her. Melissa, according to witnesses, was the most vicious - she brought a knife to the fray, and stabbed Jany through the heart. Melissa Polonio has used the alisas Melissa Garcia and Melissa Figueroa. Polonio is 28, 5'6" and 125 pounds. (See Shows #397 and 416, OADs 2/10/96 and 7/6/96)

**Mario Peraza-Armenta (Murder)** -- Police say that Mario Peraza-Armenta is living proof that violent terror can strike at any time. For Diane Purper and Fred Jensen, it struck at around 2:00 a.m. on January 3, 1996. Diane, 39, was driving home with her 22-year-old nephew Fred after a night of socializing at the Port-O-Call nightclub. They stopped at the corner of 300 and 500 south at the I-15 onramp, and waited for a break in traffic to make a right turn. A driver behind them in a brown Ford Taurus couldn't wait, and started honking. Fred opened his car door and motioned for the driver to pull around. When the light turned green, Diane made her turn. Suddenly, the Taurus was beside her, and six shots from a 9mm automatic were sent buzzing into her red Dodge Stealth. Three of those shots struck Diane, who slumped over as Fred grabbed the steering wheel. Diane died en route to the hospital. Police say the shooter was Mario Peraza-Armenta, a suspected gang member. They also say that in the car were four others including his 18-year-old girlfriend, a 12-year-old male and a 15-year-old female. Peraza-Armenta has a tattoo on his upper left arm. He is a Mexican national. He has a speech impediment and speaks English with a broken accent. He has worked as a laborer and is a suspected member of the La Raza street gang. Peraza-Armenta is 24, 5'3" and 130 pounds.

**Donald Dyer (Kidnapping, Weapons)** -- On January 23, 1998, Sandra Keller received a phone call, asking if she was available to babysit. Police now say that this call was a ruse to lure Sandra out of the house - she was picked up by her caller, who drove her across the Oregon-Idaho border where his friend was waiting to steal her away. Investigators believe that Sandra's abductor is Donald Dyer - a friend of Sandra's family who recently developed a disturbing romantic interest in the 14-year-old girl. Dyer was reportedly like a father to her after Sandra's own father passed away several years ago. Authorities believe Dyer is a heavy drug user and a firearms fanatic, wanted for several weapons violations and for accessory to murder. Sandra, they say, will remain in grave danger until Dyer is captured. When last seen Sandra was wearing five rings, an opal necklace, a black wrist band, Levi jeans, white t-shirt and black shoes, and was carrying a black leather backpack and "Indian-style" purse. **Sandra Keller**

**FBI'S TEN MOST WANTED LIST:**

**Harry Joseph Bowman** (Murder, Drug Trafficking, Extortion, Robbery) -- On February 13, 1998, after a long-running investigation, officials unsealed a federal grand jury indictment that they say has exposed one of the underworld's most violent, mysterious, and powerful organization - the Outlaw Motorcycle Club. Agents say that the key to dismantling this gang is the capture of its alleged leader - Harry Joseph "Taco" Bowman. The Outlaw Motorcycle Club was founded near Chicago in 1959, and soon had chapters throughout the midwest and southeast. Today, agents claim, there are more than 30 chapters in the continental U.S. alone, and more in Australia, Canada, England, Norway, and France. Bowman allegedly joined the Outlaws in 1970, when he was in his early 20s. Agents say it is the only life he has known, and his large and colorful tattoos speak to his dedication. Officials say he served as the president of the Detroit chapter, and has been the overlord of the Outlaws since 1984. The indictment says that Bowman has ruled with an iron fist. The indictment accuses Bowman of an assorted list of violent actions of enforcement and warfare with rival gangs, including the 1982 murder of Outlaw member Arthur "Good Old Speed" Vincent, the assassination of the president of the Warlocks biker gang in 1995, conspiracy to murder various officers of the notorious Hell's Angels gang, and distribution of opium and Valium. The Outlaws seem to have no shortage of automatic weapons, and even allegedly used high explosives to destroy the clubhouses of at least two rival gangs - the Warlocks and the Hell's Henchmen. The feds are confident that the Outlaws will fall - they have even secured cooperation from several high-ranking members

including their former vice-president. But they also claim that taking "Taco" off the streets is the only way to finish the Outlaws once and for all. Bowman has used the aliases Taco, David Bowman, David Charles Bowman, Harry Douman, and Harry Tyree. He is known to have the following tattoos: Right arm - Outlaw club logo; inside left forearm - wizard; outer right forearm - swastika; left outer forearm - unknown design with initials; back - large Outlaw Motorcycle Club Detroit chapter logo. He has scars on his chin, right forearm, and abdomen. He usually wears prescription glasses or sunglasses. An occasional drinker, Bowman becomes talkative when drunk. Bowman is 48, 5'10", and 190 pounds.

**CAPTURED:**

**Tony Ray Amati (Murder)** - Police in Las Vegas believe they have solved, but not yet closed, a case with no easy answers. Why were Michael Matta, John Garcia, and Keith Dyer killed in cold blood on three separate occasions? Why were they shot up to twenty times each with no provocation by multiple weapons? And how did suspect Tony Ray Amati go from the high school honor rolls to AWM's fugitive list? Investigators say that the Las Vegas bloodbath began when Amati, Troy Sampson, and Eddie James broke into a local gun store and made off with 75 firearms. A day later, the homeless Michael matta was found dead. Police were aghast at the number of guns and bullets used to take Michael's life - they now believe he was just a test for the stolen weapons and a sick thrill for the killers. Seventy-five guns meant a lot of testing. Two months later, 49-year-old John Garcia was gunned down in his driveway. The overkill was chillingly similar. Then, less than four weeks after the Garcia killing, another barrage of bullets felled 22-year-old Keith Dyer. Keith was walking his co-worker, Stacey Dooley, back to her apartment when three men dressed in black approached them. One of them had a laser sight fitted to his pistol, which he fixed on Keith. Stacey survived the attack, but watched in horror as the killers pumped round after round into Keith's prone body. She says the gunmen were laughing as they fled the scene. On October 3, 1996, Amati, Sampson and James were all arrested after allegedly attempting to sell stolen weapons to undercover detectives. The arrest prompted the search of Amati's home, where they found a handgun fitted with a laser sight. Police say ballistics testing would later determine that it had been used in all three of these heinous crimes. But by that time, Amati had posted bail and disappeared. Even more inexplicable than these random slayings Amati's alleged involvement. Incredibly intelligent, organized, and motivated, Amati's friends and family are still reeling from the allegations. Police believe that this obsessively neat and tidy young man has now become obsessed with being a wise-guy gangster, which makes him all that much more ruthless. Minutes after the original broadcasts, a tipster in Knoxville, Tennessee identified Amati as "Jeff". Although Amati had dyed his hair and was wearing glasses, his anally-neat behavior was something he couldn't conceal. The tipster said "Jeff" was in Atlanta, Georgia working as a door-to-door magazine salesman. Six days later another viewer tip led authorities to a motel in Marietta, Georgia where he was captured. Amati's capture marks the twelfth member of the FBI's Ten Most Wanted List

**UPDATE:**

**Eric Robert Rudolph** (Causing the Death of a Person, Use of an Explosive) -- A moonlighting police officer becomes the first fatality of anti-abortion bombings. Friends of slain Officer Robert Sanderson of the Birmingham Police Department, Alabama, can't see his death as part of a political action. Even though he was moonlighting as a security guard for a family planning clinic, they say he was outside of the abortion controversy - that he was just doing his job, that he was enforcing the law. But on January 29, 1998, someone took his life with a cowardly and indiscriminate homemade bomb loaded with nails - a bomb designed to kill and maim, not just to damage property. The same bomb seriously injured nurse Emily Lyons as she opened the clinic, depriving her of sight in her left eye and leaving her with several broken bones and burns. Authorities now say that man is Eric Robert Rudolph, a mysterious and reclusive man from the rugged mountains of North Carolina. Immediately after the bomb went off, witnesses saw a man wearing a wig fleeing the scene. Three witnesses saw his truck pull away, and were able to provide a description and a license plate number. The truck was then traced to Rudolph, but he had already made his escape. Police found Rudolph's truck in a pasture near Murphy, North Carolina on February 7, 1998. They believe the experienced woodsman may be hiding out somewhere in the Great Smokey Mountains, but they also believe that his rage, now unleashed, will cause him to strike again. Rudolph has used the alias Bob Randolph. He is estranged from his family. He spent 18 months in the US Army, but has a reputation for anti-government views. He is an experienced woodsman who completed army survival training. Rudolph is 31, 5'11", and 150 pounds. The case is now being pursued by a task force called "Sandbomb". They now believe he may have joined a cult, possibly The Army of God, who claims responsibility for the Birmingham bombing. Authorities have now offered a \$100,000 reward for information leading to Rudolph's arrest. (See Show #483, OAD 2/21/98)

Now the Officers Need Help Foundation is trying to

find a match for Kimberly Juarez. Kimberly Juarez is eighteen years old. She dreams of growing up to be a veterinarian. But that dream may never come true, because Kimberly has Acute Lymphoma Leukemia. Since her diagnosis six years ago, she has tried all possible cures. Nothing has worked. To live, Kimberly needs a bone marrow transplant. To register as a bone marrow donor, just stop by an NDMP-approved donor center or a recruitment drive site, and they'll take a small sample of blood. If you are a potential match, you may be asked to give another small blood sample. If all of your antigens match a patient's, you will be counseled about donating marrow. Donation is a simple procedure; the marrow is extracted from the hips using a specialized needle. Your marrow will replenish itself completely in four to six weeks. **AMW ALL POINTS BULLETIN:**

**Carl Douglas Consolvo (Rape, Carjacking, Robbery, Abduction)** -- Carl Douglas Consolvo has had enough experience to be comfortable living outside the law - police say he started stealing when he was only five, and was picked up for grabbing candy from a local convenience store. His later rap sheet lists convictions for larceny, auto theft, and armed robbery. Now, police say, he has graduated to rape and aggravated assault, and he runs frantically from one crime scene to the next as the FBI and twelve different local law enforcement agencies work together to track him down. They say it is only a matter of time before Consolvo kills an innocent citizen - that is, if he hasn't already. In 1996, after two terms in the Virginia State Pen, Consolvo was back in the courtroom, but this time it wasn't for theft. "Charlene," a former waitress in a club frequented by Consolvo, charged that he had stalked her for several months before he attempted to abduct her. When he was stopped, he was carrying marijuana, and convicted for possession. In court, he laughed as the judge told him to stay away from Charlene, and again threatened her. Three months later he was back on the streets. Following the brutal gunpoint rape of a real estate agent in Chesapeake, Virginia, police wanted Consolvo back in jail. The agent, who had been raped while showing a property, told police that her assailant, like Consolvo, was compulsively neat, folding his clothes crisply next to the bed where the crime took place. Also, like Consolvo, he had a distinct stutter. Agents say Consolvo felt he was on a roll, and started a wild crime spree that has so far stretched from Virginia to Las Vegas. First, officials say, he kidnapped a woman in Virginia, and released her unharmed. He allegedly used her Chevy Blazer, however, to move his special brand of mayhem to Lake Worth and Waco, Texas, where police claim he kidnapped a 16-year-old boy, robbed a dry cleaner, and carjacked two women. When the Blazer was recovered, police say they found a mountain of evidence that linked him to three Fort Worth robberies. Consolvo's alleged contribution to U.S. crime patterns next took him to Apex, North Carolina, where agents say he eluded police during a high-speed chase, broke into one home, stole two cars, and shot a man in the leg during a carjacking. The Toyota Avalon agents say he stole from his injured victim later was reported to be in Las Vegas, where Consolvo apparently attempted to get it repaired. There's no telling where this will lead, but police fear the worst. In the recovered Blazer, they say they found local real estate listings - a chilling suggestion of plans similar to the rape that sparked this alleged spree. They also found a pair of jeans and shirts that were far too small for Consolvo, and are hoping these aren't clues in a case they haven't yet discovered. Consolvo stutters when nervous and is an alleged manic depressive/schizophrenic. His left ear is double-pierced, and he wears

two sterling hoops. Consolvo plays golf, drinks green tea, and is an alleged marijuana user. He also patronizes strip clubs. Consolvo may be driving beige Toyota Avalon, North Carolina license # ERZ-3631. Consolvo is 38, 6'1" and 180 pounds.

**CAPTURED:**

**Patrick Heaps** (Bank Robbery, Forgery, Weapons Charges, Escape) -- Patrick Heaps, former professional boxer, self-proclaimed Rastafarian, and convicted bank robber made his way onto America's Most Wanted after he and two other inmates of the Salt Lake County Sheriff's Office escaped on November 13, 1997. The trio found a weak spot of concrete in the cell block's showers, and with the determination and persistence only found in desperate, prison-hardened convicts, they chipped away at the ceiling with their regulation toothbrushes until they formed a hole large enough to climb through. From the floor above the showers, they kicked their way into a utility closet, and then had an unobstructed path down five flights of stairs and right out the front door. Heaps' two accomplices were soon captured, but with the Rastafarian bank robber still at large, America's Most Wanted stepped in with a profile on November 22, 1997. A month later, the tips started coming in: Heaps was back in the Salt Lake City area. A tip led detectives to an apartment complex in the suburb of Midvale, where the Salt Lake County Sheriff's Office, working with U.S. Marshals, set up a video camera in an unmarked car in the parking lot. On January 10, 1998, Detective Bertram viewed the day's tapes from the location, and noticed a man who resembled Heaps driving a car with stolen license plates. The next day, he got a warrant for the apartment and rushed to the location with a SWAT official. Suddenly, he received a call on the radio: Heaps was on the move. Bertram spotted the car and followed him, undetected. When Heaps pulled into a convenience store, Bertram and the SWAT official blocked his car and drew their weapons. The suspect was clearly surprised, and although he put his hands on his head, he refused to lie on the ground as ordered. Instead, he began walking toward Bertram, who noticed a bulge in his coat. "He's got a gun," shouted Bertram, and again ordered Heaps to the ground. The standoff lasted about forty seconds and Heaps finally gave in when other cars swarmed the parking lot. Police discovered that Heaps was carrying a fully-loaded Sig Saur 3-80 with an extra clip. In his car were two boxes of ammo, two high-end police scanners, a guide to police radio frequencies, and an all-black outfit including a ski mask and gloves. Police believe that they got him just in time-that he was preparing for another bank robbery, and soon. (See Show #475, OAD 11/22/97)

**UPDATES:**

**Unknown** (Armed Bank Robbery) -- Three banks in New Orleans have been rocked by an armed robber who has borrowed the hairstyle and cool of legendary musician Little Richard. But after AMW aired his story, and the real Little Richard made a plea asking the robber to turn himself in, police say he has shed his disguise, and they now have a better picture, and a license plate number. The robber, who wore a hair-raising wig, smoothly waited in line for an available

teller, then showed his 9mm pistol, coolly giving instructions to have his shaving bag filled with large bills. The Little Richard look-alike then calmly left three banks without drawing attention or harming anyone. The whole operation took just over a minute. On one occasion the rock-star wannabe was tailed by two customers, who watched him casually walk down a New Orleans street before losing the rockin' robber a few blocks away. So far, the robber has hit banks on October 31, 1997, November 14, 1997, and December 3, 1997. The latest robbery, where he traded in his wig for an athletic nose strip, took place on January 31, 1998. As for the robber's apparent inspiration, the real Little Richard thinks the robber "wanted to be affiliated with somebody that was strong and long and had a tone and was real gone," but isn't impressed with this sort of imitation. "I want to tell him. He need to give it up. Get out of what you're doing and get yourself straight. And stop robbing those banks, leave that money alone. It's not yours!" The suspect may slick back his "hair" with styling gel. He wears a neatly trimmed goatee and glasses, carries a small shaving bag, and is armed with a 9mm pistol. He appears calm, cool and collected, and is a sharp dresser with a deep voice. The suspect is 30-35, 5'9"-6'0" and 160-175 pounds. (See Show #482, OAD 1/31/98)

**Gary Joseph O'Brien (Child Abduction)** -- Each year more than 350 thousand children are abducted by a family member in divorce custody battles. Constables in Torbay, Newfoundland, Canada say Gary Joseph O'Brien has abducted his three sons. But they say it's much more volatile than most child custody cases. On November 9, 1996, O'Brien picked up his three sons - 5-year-old Mitchell, 11-year-old Trevor, and 14-year-old Adam from his estranged wife, Diana. He was supposed to bring the boys home by 9:30 p.m. At 8:30 p.m. Diana received a phone call from O'Brien. He told her the boys would not be coming home. He also told her he had her house rigged to explode. Constables say they rushed to the scene to discover that O'Brien had pumped hundreds of gallons of propane into the house and wired it to a timer. The house itself was a giant bomb. Explosives experts were able to diffuse the device and a major catastrophe was averted. Constables say O'Brien's bomb would have taken out a large part of the neighborhood. About a week after the abduction, O'Brien and the boys were spotted in New Brunswick, Canada. They may have crossed the border into the US. New information was uncovered by divers from the Canadian Coast Guard sent to Red Head, Newfoundland to look for clues. Against all odds, divers found the engine block from O'Brien's car, but unfortunately, the rest of the vehicle had been swept into deeper waters by strong currents. Authorities are, however, assuming that the boys are still alive. Gary O'Brien has a gray mustache and may have a gray beard. He is smoker who usually wears jeans and t-shirts, and is an electrician by trade. (See below) (See Show #458, OAD 7/19/97)

**Unknown (murder)** -- In the early morning hours of March 9, 1997, music industry heavyweights were winding up a party hosted by VIBE Magazine in Los Angeles. Twenty-four-year-old Christopher Wallace - or Notorious B.I.G., as his fans knew him - was sitting in his GMC Suburban with his bodyguard and a friend. Suddenly a dark, late-model sedan pulled up and shots rang out. When it was all over Christopher Wallace was dead. It was clearly a hit job, but police don't know what the motive was. On March 15, America's Most Wanted picked up the case. A tip to the hotline led the Los Angeles Police to a videotape shot outside the party at the exact moment of the shooting. On March 27, police held a press conference and released the first

real clue: a composite sketch drawn from the memories of several eye witnesses. Meanwhile police are analyzing the videotape, though they're tight-lipped about what it reveals. In desperation, Canadian officials sent divers from the Canadian Coast Guard to Red Head, Newfoundland to look for clues. Against all odds, divers found the engine block from O'Brien's car, but unfortunately, the rest of the vehicle had been swept into deeper waters by strong currents. However, O'Brien's ex-wife, Diana, rejects the suggestion that he drowned himself or the boys - he would never harm them, she said. When last seen, Mitchell was wearing a navy blue turtle neck and sweatshirt, blue jeans, and white high top sneakers. Adam was wearing a black Adidas nylon windbreaker and pants with white stripes on the arms. Adam usually wears a baseball cap and has clear braces on his top teeth. Trevor was last seen wearing a "Georgetown University" blue/gray winter parka and black low-top Adidas shoes. (See above) (See Show #458, OAD 7/19/97)

**Katheryne Lugo**

Age: 9

Katheryne Lugo was just four years old when agents say she became an innocent pawn in a bitter struggle between her mother and a ruthless and manipulating man. Unlike so many missing

child cases, there's strong evidence that Katheryne may be alive and well - but her life could depend on her rescue. Katheryne's complicated case began in 1994 when her mother, Francis Moya, discovered that she was pregnant with another child. The father was her live-in boyfriend, Misbah Kazi. Investigators say that Kazi is a Bangladeshi illegal immigrant with a heart as cold as an assassin's. When Francis began to sense that their relationship was not going to last, she told Kazi that their unborn child wouldn't keep them together, and that the child would never carry his family name. That was when, officials say, Kazi's vicious side came to the surface. On Saturday, January 8, 1994, Kazi told Francis that there was no need to take Katheryne to daycare - he would look after her. When Francis returned, she says, Katheryne was gone and Kazi was there to tell her that he had sent her to Bangladesh - and she wouldn't be back until Francis had her baby. When he was arrested, he told police a different story. With no sign of Katheryne, and with Kazi's story - that Katheryne had disappeared while he was sleeping - impossible to disprove, the police were desperate for a break. It finally came when Kazi's sister, Nita, came forward. She allegedly told investigators that Kazi had Katheryne in his car when he drove her to work that day - a story that completely undermined Kazi's version. But when the case went to trial, she reversed her story completely, and even said that she had lied to the police the first time. With no other conclusive evidence to convict, the jury acquitted Kazi. But by this time, the FBI had joined local police, and they both refused to believe Kazi's innocence. They tracked his every move, and with Francis' permission, monitored her phone. In 1995, agents say, Kazi started making threatening phone calls to Francis. Agents report that he claimed Katheryne was still alive. Further, he postulated that she and Francis were only alive because he let them live, and even bragged about how he had taken on the American justice system and won. He also allegedly said that as soon as he was settled, he would kill Francis and take her newborn child, Brenda. Agents believed that they had definitive evidence against Kazi, but had to move carefully - if Katheryne were still alive, they needed to get that information out of her alleged kidnapper, and simply arresting him might have put Katheryne's life in danger. But then Kazi tried to kill another woman -- and they had to act. In November 1995, police in San Jose, California responded to the scene of a brutal attempt on the life of 22-year-old Theopodine "Theo" Namundjebo. She had been shocked with high-voltage electricity, and beaten on the head with a hammer. Her attacker then attempted to drown her, first in the toilet, and then in the tub. He left her for dead, but against all odds, she survived, and named Misbah Kazi as her assailant. Theo, a Jamaican national, had met Kazi a month earlier at business college, and told him her problems with getting a green card. Kazi said he could help - but for his scheme to work, they would have to pretend to be married. There was also the small matter of a \$500,000 life insurance policy on Theo to make it look legitimate. Kazi, of course, was the beneficiary. Days later, he called 911 pretending to be Theo's cousin in Canada. When the FBI heard the tape, they said there was no question it was Kazi. They acted immediately, putting out an all-border stop and tracing Kazi through his credit cards. He was nabbed trying to get into Canada, and charged with attempted murder. Back in California, Kazi attempted to use Katheryne as a hostage. The price - immunity from prosecution in her kidnapping, a reduced charge for the attack on Theo, and U.S. citizenship. The response - no deal. Officials say that although he may have been able to deliver Katheryne alive, they could not trade one victim's rights for another, and could not allow Kazi to benefit from a crime they say he committed in the past. Kazi was convicted for attempted murder and assault on November 7, 1997. After hearing Theo's emotional plea during sentencing, the judge gave Kazi a life sentence. Prosecutors remained

willing to have his sentence reduced - if he gave them Katheryne's location. But under California law, Kazi had only 120 days to respond. His response - no deal. Agents and Francis are now asking for the public's help. They have received tips placing Katheryne in Reno, Nevada, and New York, but still need someone to come forward with more information. Katheryne has a brown birthmark on her right thigh. Her hair was shoulder-length at time of her disappearance.

**MISSING PERSON ALERT:**

**Mary Francis Hunter**

The FBI, local police, and the Naval Criminal Investigative Service are looking into a case that has no easy answers. The mystery began on September 3, 1996, at a mall in Burlington, Washington. Lt. Derek Hunter and his wife Mary were on their way to the mountains east of Burlington for a day of hiking and target shooting when they stopped at the mall. In their truck were their dog and two handguns. Lt. Hunter told police that he waited in the truck while Mary entered the mall. He reported that when she returned, she was with a man who she introduced as "Tony, Tim, Tom, or something similar." She reportedly said he was an old high school friend. Lt. Hunter says he left his wife with her friend while he went into the mall. He claims that when he returned, the dog, the guns, and his wife were gone. After a search of several hours, he says he returned home. The next day, he told police he returned to the mall only to find their dog. He then called the police. Lt. Hunter claims that he didn't report the disappearance immediately because his wife allegedly has a history of mental instability and had disappeared before. Mary Hunter has white patches on her face, neck, chest, arms, and hands from vitiligo, a skin condition. She wears heavy makeup to cover these patches. Due to this condition, she avoids prolonged exposure to direct sunlight. Although introverted, she is an avid target shooter.

**FEATURE:**

**Hero Cop** -- Each year, Parade Magazine in association with the International Association of Chiefs of Police selects a lawman who has gone above and beyond the call of duty for Top Police Officer of the Year. For his bravery, his calm in the face of death, and his capture of four dangerous suspects, Officer Tom Harwood of Grant Park, Illinois received this year's award. It was 4:30 in the morning when Harwood noticed two cars, a Suzuki and a Mustang, moving into town. The fact that they were traveling close together at a high rate of speed made him suspicious, and he tailed them both. After running a license check on the rear vehicle - the Mustang - he found that there was no record on file. Harwood's suspicions were now at a peak. He decided to pull the Mustang over. There was no way for Harwood to know that inside the cars were five suspected armed robbers. Police now say they were in the middle of a crime spree, and on their way to rob another convenience store. Harwood was in the middle of a very dangerous situation - the Mustang carried three suspects, and the Suzuki, which stopped



further down the block, carried two. All of them were very, very nervous. Harwood approached the Mustang, and asked for the driver's license and registration. This sent a passenger into the glove box, fumbling for something. All of Harwood's attention focused on the passenger's hands - there was no telling what they might be doing. As he watched the glove box closely, he didn't notice the passenger in the Suzuki run from the car and into the night. He also didn't notice the Suzuki bearing down on him until it was too late. Officer Harwood was struck dead-on by the Suzuki. He flew through the air, bounced off the trunk, and landed in the road. The Suzuki, now out of control, slammed into his patrol car. Harwood miraculously retained consciousness, and fortunately retained his wits. But when he tried to climb to his feet, he discovered that his arm was broken. But this was one cop the suspects couldn't stop. On his feet, he approached the Suzuki with his weapon drawn. The driver looked at him as if he had risen from the grave: "Why aren't you dead, you should be dead," his alleged assailant said. With the driver on the ground, and the suspects in the Mustang holding their hands on the dash, Harwood was finally able to call for back-up. Despite the horror of being deliberately run down, despite his shattered arm, injured legs, and severe internal bleeding, Harwood secured the scene and subdued four suspects. The fifth was picked up shortly afterwards. The Suzuki assailant received ten years, and the driver of the Mustang will go to trial later this year.
