The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Tracey Lee Poirer (Escape, Murder)

Pamela Lee Trimble (Escape, Hindering Prosecution, Supplying Contraband) -- It was the most unlikely place to fall in love - the Oregon Women's Correctional Center in Salem. And they were the most unlikely of couples: Tracey Poirer, with a history of violence and crime, heavily tattooed, and serving time for murder; and Pamela Trimble, a husky prison guard. But for Poirer, police say, it was a match made in heaven. It gave her freedom. Poirer was in prison for a brutal murder that took place on July 3, 1990. That night, she was with her then-girlfriend, Tammy Upton, at a local dive called Red's in Roseburg, Oregon. They weren't interested in any male company until they saw the thick wad of bills held by a man named Donald Fish. Donald was a dwarf - or a little person, as he preferred - and had been getting by working for a department store. But the outgoing 4'3" Donald had a big passion for pool, and came into Red's that night looking for a hustle. As he flashed his wad of bills around the pool table, Poirer and Upton took notice. Witnesses say they had bad feelings as they watched Poirer flirt with Donald, who fell right into their trap. They left the bar for a night out on the town, and ended up on the bank of the Umqua River. That's when Donald realized this was not his lucky night. The pair cut him with a knife, took his cash, and stuffed him in the trunk of their car. Donald, wounded but not yet dead, left bloody handprints on the inside of the trunk as he tried to get free. After an hour of driving, the lovers returned to the river to finish the job by bludgeoning him to death. Poirer and Upton were tried and sentenced to life without parole. In prison, Poirer dumped Upton - she reportedly had her eyes set on someone more useful. Her next conquest, officials say, was prison guard Pamela Trimble. Trimble was soon so in love with Poirer, officials say, that when the inmate was transferred to another facility, she gave up her career to follow her. They met frequently in prison, and, investigators claim, soon hatched a bold plan to get Poirer out by having Trimble break in. On the night of August 28, 1998, Trimble allegedly cut through the prison fence and then broke open a window to free her love. The pair then disappeared. Poirer has tattoos of webbing and a cross on her left thumb, two peacocks on her left arm, a wizard on her left shoulder, a butterfly on her right shoulder, a skull, "Harley Ruse", and crescent moon on her back, a peacock and two roses on her left hip, a swastika and "WSP" on her right foot, and the letter "A" on both hands. Both ears are pierced twice. She has bright red hair but

may have dyed and/or cut it. She is a convicted murderer and prostitute, a lesbian, and an alleged heavy drinker and drug user who reportedly prefers heroin. She is fluent in French. Poirer is believed to be traveling with Pamela Trimble. She is aggressive, and violent with extensive criminal record. Poirer is 36, 5'1" and 115 pounds. Trimble may have dyed and cut her hair. The former correctional officer is proficient with firearms and may be disguised as a male, living in Salvation Army shelters. She should be considered armed and dangerous. Trimble is 36, 5'5" and 180 pounds.

Dennis Dean Williams (Possession and Distribution of Methamphetamine) -- On December 1, 1995, officials in Independence, Missouri arrested Dennis Williams and served a search warrant on his home. Twenty hours later, he was released while evidence from the search was tested. Finally, on December 4, 1995, police say they had proof that Williams was manufacturing methamphetamine in his kitchen and garage, and distributing the potent chemical through a tight circle of family and friends. Also confiscated was a Colt Double Eagle MK-11 series 90.45. But when police went to arrest Williams, he had vanished. Although they claim Williams is one of the biggest manufacturers of meth in the midwest, he's only part of the mountain-sized meth problem spreading throughout the United States. Williams, who goes by the nickname Straw, has a tattoo on his right forearm. He may have shoulder-length hair and a full beard. He frequents the Kansas City metro area and is probably manufacturing methamphetamines. Williams is 43, 5'7" and 160 pounds.

David Walker (Murder) -- Henry Lee Campbell was fatally shot in the chest on August 2, 1986. FBI agents have been unable to establish a motive for the shooting, but claim that the man pictured above, David Walker, fired the fatal round during an altercation. The last known sighting of Walker was in 1990 in the Jacksonville, Florida area. Agents say he was then associated with an unknown woman who had born Walker's son, who police believe is now five years old. Walker, whose nickname is "Tiny", has used the aliases Tiny Walker, Dana Walker, and David Bowens. He has a two-inch scar from the tip of his left eyebrow, parallel to his left eye. He wear a mustache and a partial beard. He has been employed as a security guard, cook and construction worker. Walker is 42, 6'4" and 250 pounds.

AMW ALL-POINTS BULLETINS:

John Dennis Grubb (Bank Robbery (5); Parole Violation) -- FBI and local police departments all over the eastern U.S. believe this man is responsible for at least five bank robberies, and may be behind 22 more in at least seven states. He's been convicted before - in fact, he was on parole when this current rash of robberies started. John Grubb, say agents, makes no attempt to disguise himself during robberies, but manages to keep a low profile anyway. His

typical m.o. is to pass a note to a teller, demanding all the large bills in the drawer. Agents say the note often ends with a threat - if they don't comply, they will be shot. Sometimes, witnesses claim, he flashes his 9mm to emphasize this point. Grubb's fresh face may allow him to blend into a crowd, but here's a clue that will make him stand out - acquaintances say he's a neat freak - the kind who would probably even iron his socks. A barmaid who knew him says he would walk the length of the bar and straighten the ashtrays. He also had the habit of marking every program in the TV guide that he planned to watch. Agents hope that with your help, he'll be put in a place where he has plenty of time to watch TV. Grubb, who has used the aliases Gribb, Peyton and Grube, has a surgical scar on his right jaw and a scar on his neck and shoulder. He wears round wire-framed glasses and appears to be left-handed -- he wears a large watch on his right wrist. He has worked as a car salesman. He allegedly carries a 9mm semi-automatic pistol and may wear bullet-proof body armor during robberies. He is a neat freak who does all his own chores and has few friends. He enjoys watching TV sports and reads newspapers daily, but doesn't watch TV news. He frequents small neighborhood bars and drinks Budweiser. He has two prior convictions for bank robbery, armed assault and rape. He may be driving a stolen 1996 aqua/green Ford contour with Ohio dealer tag 1171015, or may instead be driving a mid 80s 2-door light blue Oldsmobile. Grubb is 53, 6'1" and 205 pounds.

Unknown (Murder) --February 2, 1998 was a day of heavy rain in Los Angeles, but Guadalupe Gurrola took his son Andres down to the local auto parts store. Hours later, their mini-van was found ablaze, and when firefighters put out the flames, they found two bodies inside. The 39-year-old father and his 15-year-old son had each been shot several times before they were burned. Witnesses say they saw four male Hispanics running from the vehicle before it burst into flames. Then, police say, the killers were caught on tape as they made cash withdrawals using the victim's ATM card. First, they used a bank ATM, and then another machine at a food store. Guadalupe was described as hard-working and devoted to his family. To take his money, according to police, the thieves took his life, along with the life of his son. Guadalupe is survived by his wife and two children. If you think you recognize any of these men in the photos, please call or email a tip. Suspect #1 may wear a mustache and sideburns. He wore a baseball cap and a shirt with visible letters NTHIEN. Suspect #2 wore a baseball cap. Suspect #3 appeared to have long sideburns and wore a baseball cap. Suspect #4 was bald.

UPDATES:

Margaret Rudin (Murder) -- She's held the dubious distinction of appearing on America's Most Wanted six different times, but she continues to elude capture. On August 29, 1998, AMW made another plea to the nation to bring this fugitive to justice. The tips came in, but the alleged Las Vegas Black Widow slipped through the cop's fingers once again. One

tipster in Phoenix, Arizona knows her face by heart - she photographed it. The tipster works at the Motor Vehicles Department, and took a picture of Rudin for an Arizona State ID. She's a true chameleon. She also has a new alias - Annette Boatright. She had evidently been living at the YMCA and working at a hotel giftshop for three months. The Spartan conditions at the "Y" were a stark contrast to her pre-fugitive lifestyle. When police picked her up, her ID checked out, and she returned to the "Y," called a limo, and checked out. Las Vegas detectives, searching her room days later, found keys with Rudin's late husband's name on them, but she was already gone. Police now believe she's on her way to Guadalajara, Mexico. Police in Las Vegas, Nevada call Margaret Rudin a gold-digging black widow; married five times, she's a professional bride - with each marriage, they say her net worth grew. In September 1987, Rudin married husband number five - wealthy Las Vegas real estate developer, Ron Rudin. Ironically, Margaret became the fifth Mrs. Ron Rudin. For seven years, the Rudins seemed the perfect couple. But on December 18, 1994, Ron mysteriously disappeared. Ron's employees were alarmed and wanted to report him as a missing person. Oddly, Mrs. Rudin insisted they wait a full two days before calling police. For two months, Ron's fate remained a mystery. Then on January 21, 1995, fishermen found a pile of ashes and a skull near Lake Mojave - about 45 miles from Las Vegas. Dental charts revealed that the fishermen had found Ron Rudin's remains. He had been shot in the head four times, decapitated and stuffed into an antique trunk before being set on fire. Now police had enough evidence to search the Rudins' home for evidence. They discovered traces of blood which proved that Ron had been killed in his own bedroom. Police started tailing Margaret Rudin and found some big surprises: the grieving widow skipped her husband's funeral, and misplaced his ashes. She also had a secret boyfriend. Police suspected Margaret Rudin was behind Ron's murder, but they didn't have enough evidence to make a case...until July 21, 1996. On that day, a diver in Lake Mead found a handgun with a silencer, wrapped in several plastic bags. It was the murder weapon. On April 18, 1997, a grand jury indicted Margaret Rudin on charges of murder, but she'd already disappeared. Rudin, who has used the names Margaret Frost, Margaret Mason, Margaret Zumbrunn, Margaret Brown and Margaret Krafbe, likes expensive clothes and jewelry. She often dyes her hair, and has been a blonde, redhead and brunette. She has a mother and sister in Palm Springs, California and relatives in Illinois. Margaret Rudin is 55, 5'7" and 130 pounds. (See Shows #453, #472, #503 and #509, OADs 6/7/97, 11/1/97, 7/18/98 and 8/29/98)

Samuel Sheinbein (Murder) -- An Israeli judge in Jerusalem ruled on September 6th, that Samuel Sheinbein should be extradited to the United States to stand trial, according to a report by the Associated Press. The judge said that Sheinbein does have a right to Israeli citizenship, but because he had not maintained close ties to Israel, he did not have the right to stay. According to reports, Sheinbein's defense has 50 days to appeal the decision. Lucky Severson was there for AMW when the decision was handed down, and says that this usual ruling pleased just about

everyone he talked to, except for Sheinbein's mother, who is now in Israel: "To save his life, I would go to Mars if I had to. Any family would do the same, and I hope they would stand with their son no matter who he is and no matter what he did." Sheinbein's attorney was also displeased and hopes to take the case all the way to the Israeli supreme court. Sheinbein's preference for Israeli justice isn't hard to figure out. Sentences are much lighter there, and prisons are much more convict-friendly. The long appeals process could put off his conviction for months, even years. Sam Sheinbein entered an Israeli court last November. His smirk, caught on camera, seemed to suggest that he enjoyed the limelight as one of Israel's most famous prisoners. The smile of Alfredo Tello, meanwhile, can only be seen in pictures. Alfredo, or "Freddy," was brutally murdered. The way he died was sickening. All of his limbs had been severed, and his entire body had been burned beyond recognition. It all happened in the swank neighborhood of Aspen Hill in Wheaton, Maryland. This is where Sheinbein lived and where Freddy died - just one day after he moved out of his mom's home into his own apartment. On September 16, according to witnesses, Freddie left the pet store where he worked with two friends, Sheinbein and Aaron Needle. He was never seen alive again. Three days later, police got a call. A realtor had been showing a house - and when they stepped inside they were overpowered by a foul stench. When they got to the garage, they found a bag with some sort of fluid leaking out. It was Freddy - his limbless body was stuffed in garbage bags. Nearby, there were more grisly clues - a circular saw and a wheelbarrow. Behind the house, the beginnings of a shallow grave. Police say they were on to Sheinbein almost immediately, following the most obvious of clues - a trail of blood. Investigators say a bloodhound trailed a scent from the garage out across the path to the street where the Sheinbein family lived. It then crossed the street, and reportedly lost the scent right in front of their house. Police searched the Sheinbein garage - and tested it with Luminol, a chemical that makes even small traces of blood glow bright. There were lots of bright spots here, police say. The evidence was allegedly overwhelming, and an arrest was almost certain. But where was Sam Sheinbein? His family said they didn't know. But a few days later, an attorney in Rockville, Maryland informed police that Sheinbein had possibly fled the United States, and was now in Israel. Police say that it was Sheinbein's father who put him on that plane. U.S. officials realized immediately that there were going to be some glitches. Israeli police arrested Sheinbein, but would not return him. The fugitive had claimed Israeli citizenship through his father, who was born there 50 years ago. And according to Israeli law, no citizen who has close ties to Israel can be extradited. This does not sit well with Maryland officials. They say the crime was committed here, and should be tried here. Freddy's mother agrees, saying it does matter where the trial takes place: "They should send him back. He hurt everybody. He hurt my family. He hurt [Freddy's] friends, and especially myself. It makes a difference." The second suspect in the case, Aaron Needle, was arrested and charged, but he also refused to see a judge - he hung himself with his bedsheet in jail the night before his murder trial. CAPTURED:

Patrick McDaniel Adkins, Jr. (Sexual Assault, Parole Violation) -- It's the end of the line for a line-dancing fugitive, wanted in Canada and the United States for multiple rapes and an attempted rape. Thanks to an America's Most Wanted tipster, Canadian police spotted the fugitive at a cowboy bar and captured him just hours later. On August 15, 1998, after Patrick Adkins, Jr.'s profile aired on the crime-fighting show, tips poured in from Regina in Saskatchewan, Canada. Police learned that they could even find Adkins that very night: the convicted rapist was out for a night of line-dancing with his new girlfriend. Police departments in Colorado Springs and Winnipeg, Canada, contacted the authorities in Regina to tell them a fugitive was in their town. The Regina Police Department wasted no time in checking the city's nightclubs for the dancing duo, and found his car outside a country & western club. When he left, police followed, and were able to establish where the suspect was staying. He was apprehended while leaving a residence on August 16. Adkin's new girlfriend wasn't the first to be taken in, unaware of Adkin's violent past. AMW spoke to a Colorado woman who claimed to be Adkin's former girlfriend, and said he always acted like a perfect gentleman. But even she now says that this man is a danger to women everywhere, and belongs behind bars. Adkins has already been to prison for a rape he committed in Colorado. While serving his time, the state tried to rehabilitate him with psychological counseling. In his own handwriting, investigators say he revealed just how much rehabilitation he needed: "Victim #1. I picked her up hitchhiking with the intention of taking her out of town and raping her....Victim #2. I'd followed this woman to her house a few weeks before....Victim #5. I'd made a failed rape attempt earlier in the week and was almost caught. I was bored and wanted to try another one..." Police say this man's depravity was too deep for a 12-year term to correct. It was only a matter of months before he was a suspect again. On April 28, 1997, a Colorado Springs woman was alone in her apartment when she heard a knock on the door. There was a man standing on the other side, who she thought was a maintenance man. "He looked at me," the victim said, "and he smiled and said, 'Oh, I'm sorry I must have the wrong apartment.'" But as soon as she looked away, he crashed through the door and was on her. Police say she became victim number nine. Cops say Lynnette picked Adkins out of a photo line up. But the police were too late to find the suspect. Instead, they claim they found a journal he was keeping as part of his parole requirement. In the journal, police say, he wrote about having ten sexual fantasies and two rape fantasies on the day of the attack. In the words of Detective Jim Jeffcoat, "He was very primed." He also allegedly wrote about how he was on a three-month cycle between rapes. Three months later, in Winnipeg, Canada, police say he showed up at another victim's home. Again, he allegedly used the maintenance man ruse, but this time he was chased off by the victim's brother-in-law. Another Winnipeg woman wasn't so lucky. She reportedly fell for the maintenance man routine in

On July 16, 1998, Antoinette Ross told Isaiver Teague's mother that they were going to the nearby "Valley Gas" station. Antoinette, Isaiver's aunt, made this trip frequently, as the family did not have a phone. It was only five minutes away, but as the hours passed, it became clear that they were not coming back. Fresno police have few leads, but suspect foul play. Isaiver has a light birthmark on the inside of his right arm. He likes to draw. He was last seen wearing a blue tank top, blue and green shorts and tennis shoes. Antoinette has tattoos of Mickey Mouse on the back of her right calf and "R.I.P. SHARK" on her right arm. Her left arm is shorter than her right arm. She likes to play basketball. She has an outgoing personality and is very responsible. She was last seen wearing blue jeans, a bright orange windbreaker and blue tennis shoes. She often wears many rings.

FEATURE:

Meth Labs --Just as the war on drugs was beginning to take a toll on crack, heroin, and cocaine - up popped methamphetamine, and its use is growing at a murderous rate. Methamphetamine - also called "meth" or "crystal meth" is derived from ephedrine or pseudoephedrine. It's easy to get these chemicals in small amounts - they're a key ingredient in several over-the-counter drugs. This drug isn't new - but it's being introduced to new users at an alarming rate. For years, labs in California have been cooking tons of meth, but these days, it just as common to see the noxious drug imported from Mexico. Meth producers have also established themselves in America's heartland. Meth can be smoked, snorted, or injected. Some users call it the sex drug because the initial high is said to be similar to an orgasm. And what

makes it so attractive to users is the fact that this high can last as long as 30 minutes, while the high from crack typically lasts only a few minutes at most. Users report feeling "on top of the world." They feel more sociable, alert, and sexual - like they can do anything. And when this euphoria is coupled with meth's easy availability, it's a short road to addiction for users who thought they were just taking a casual sample. It's also a very short road to insanity. Meth users are notoriously violent and unpredictable. When a tank rolled through a Southern California neighborhood and freeway, it wasn't long before police realized that meth was behind this madness. The driver of the tank, they say, was so "tweaked" that he couldn't remember why he did it. When John talked to U.S. Drug Czar Barry McCaffrey in AMW's Crime Center, McCaffrey gave meth a high priority: "It's probably the worst drug to ever hit America," he said. "It's worse than crack cocaine was in the 80s. It keeps people up for 5 to 15 days, paranoid, their personalities unraveling." If the drug itself is dangerous, manufacturing it can be equally lethal. The chemicals used to make meth are highly flammable and toxic. The recipe is easy to get, and manufacturers - far from being the nation's brightest chemists - are too often unaware of how poor mixtures or high temperatures can cause deadly explosions. McCaffrey claimed that one out of every six meth labs will explode or catch fire, endangering the manufacturers, law enforcement, and innocent bystanders. Officers raiding meth labs have to face these dangers in addition to the labs' owners, who often place traps for intruders. Since meth can be cooked up, with the right equipment, in just about anyone's kitchen, officers also find disturbing scenes of children neglected or abused while their parents are cooking crack.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

James Lawson (Murder) -- The body parts of Cheryl Durkins were discovered at different times by different people in two different states. She had been dismembered and decapitated, probably to hide her identity from those who made these chilling discoveries. The headless, limbless torso was discovered in Ohio's Great Miami River on April 13, 1998, two months after Cheryl disappeared. But the remaining body parts were found by the accused killer's own mother. "I turned the barrel over on it's side and the barrel opened up one of the bags and a hand was in the bag was what I seen," Ellen Peck told AMW in an exclusive interview. But rather than report this grisly discovery in her garage to the police, Peck took it upon herself to save her son from a murder charge by burying Cheryl's body parts "I didn't look when I put them in the grave," she says. "I didn't wanna look. I didn't wanna see the girl's face, and I don't ever wanna see the girl's face, you know." When the girl's torso appeared along the Great Miami River, it was so disfigured and decomposed that many thought it was an animal. But an autopsy confirmed that it was a woman. Lt. Anthony Dwyer of the Butler County Sheriff's Office got to work, checking on missing persons from areas upstream. It wasn't long before they found Cheryl's missing person report. By May, DNA tests confirmed it was Cheryl Ann Durkin, of Middletown, Ohio, who had been found. Word on the street was that Cheryl had fallen into the clutches of a crack habit, and under the sway of alleged crack peddler Jimmy Lawson Police say they knew Lawson well, not just for his suspected role in the drug market, but for his abusive relationships with women. Now, when they started making inquiries, they found rumors all over the street that Jimmy had killed someone. Lt. Dwyer teamed up with the Middletown PD and dragged Lawson in for a round of questions. They couldn't pin him down, but he didn't ease their suspicions, either. On June 5, 1998, they got a search warrant for Lawson's house. What they found was bizarre. Throughout the house, carpet had been ripped up in a way that created a path right to the freshly-painted basement. And when police sprayed the basement with blood-detecting Luminol, they saw why the paint-job had been done. "It looked like something had been slaughtered down there," said Detective Frank Hensley of the Middletown PD. Pieces of the puzzle now fell into place, police say. In a crack-fueled rage, they claim, Lawson had killed Cheryl, then cut off her head and limbs with a power saw. The only pieces that were missing now were the pieces police say Lawson removed. Lawson had vanished, but his mother

sat tight, and strongly denied that she knew anything about the murder. Three months later, she was ready to confess. Apparently, Lawson had hidden Cheryl's body parts in a barrel in her garage without her knowledge. When she found them, all she could think about was how to protect her son. "I'm guilty of being a very loving mother," she said from the jail. "This hasn't changed my feelings toward my son. I love him as much as I ever have, and nothing's gonna change that." Cheryl had a mother as well - and the only thing left to do for her is to bring Lawson back to face a judge. Deputies say Lawson could be riding a motorcycle. Lawson, who has used the alias James Botts, has a scar on his knee from a chainsaw accident. He may wear brown tinted contact lenses, and has blond highlights in his short-cut hair. He may have gained weight. He is attracted to young women 16-19 years old. He may be doing general manual labor, possibly on a ranch or farm. Officials say he may be using cocaine, crack, or amphetamine. He may be driving a red 1991 Honda Nighthawk motorcycle. Lawson is 29, 6'0" and 180 pounds.

Unknown (Murder) -- In August 1998, long before the anyone had recovered from the rash of springtime school shootings, Chicago police stunned the nation by announcing that they had arrested two boys, aged seven and eight, for the murder of an 11-year-old girl. The body of Ryan Harris, a star student and aspiring athlete, had been found bruised and battered in an empty lot near her home in the Englewood district on the south side of Chicago. The details were horrific - she had been suffocated and sexually assaulted. Her panties had been stuffed in her mouth, and leaves had been rolled up and stuffed in her nose. She had been found on July 28, 1998, and police reportedly promised Ryan's mother swift justice. Two weeks later, the two boys were arrested. Police held a news conference, assuring shocked reporters that the boys had confessed to killing her with a rock and stealing her bike. But then lab workers found semen on the girl's panties, and the case unraveled. Soon, charges against the boys were dropped on the grounds that their ability to produce semen at such a young age was "remote at best." Back at square one, police questioned a man they say gave toys to one of the former suspects on the day Ryan was killed. But after three days of questions, and after he passed a lie detector test, they let the man go. Now, police have released two composite sketches of two men they say may have been with Ryan the day she died.

Unknown (Abduction, Rape, Attempted Abduction) -- Someone in South Florida is preying on girls - specifically targeting young black girls. Police and parents fear that a serial rapist may be at work. As far as they know, his crime spree started on July 27, 1998 in Oakland Park, Florida, when he tried to lure a 16-year-old walking home from summer school into his car. She escaped, but a half hour later, he drove his white 1998 Honda Prelude to North Lauderdale and abducted an 11-year-old at gunpoint. He drove her to a parking lot, where he raped her in his car, and then dumped her on the side of the road. The brave little girl ran to a cousin's house and called 911. The suspect then stayed out of sight until, police say, he made another attempt on

August 25, 1998, this time in West Palm Beach. This time the victim was only 9, and he had found another car - a 1997 Ford Escort - which he tried to force her into. This time the victim was lucky - she got away. Police had few clues, so the 11-year-old victim teamed up with sketch artist John McMahon and a new computer program called "Faces." From a database of thousands of facial features, Faces can create billions of combinations, and the finished product is a realistic-looking image. The suspect has thinning hair and is bald on top. He is articulate, and speaks without an accent. He may be Hispanic. He wears casual clothing and has bright white teeth. Because of his access to different vehicles, he may be a car salesman. He may work for himself, or have afternoons off. He carries a gun, possibly a 9mm pistol. The suspect is 35-40, 5'6" and 180-190 pounds.

David Benjamin Creamer (Distribution of Child Pornography) -- Officials say this is a sick man who turned his illness into profit. David Creamer businesses, Profit Group; CD-Disc, Inc.; and CD Disc Direct, Inc. were allegedly fronts for the worldwide distribution of digitized child pornography on CD-ROM and money laundering. Investigators say that Creamer's fronts produced more than 100,000 CD-ROMs in the U.S. and Denmark for world-wide distribution. The subject matter, according to investigators, was disgusting, covering subjects from child pornography to bestiality. A trial date was set for March 10, 1998 after a 23-count indictment was handed down in June 1997. On December 17, 1997, Creamer was due to appear for a pre-trial urine test. He never showed, and hasn't been seen since. Creamer has scars on his face and both legs. He wears prescription glasses and has a pale complexion. He smokes a rare brand of cigarettes -- Sherman Whites. He often wears a full mustache and beard. He is a diagnosed diabetic and may be seeking Gluzipide. He generally wears one-piece jumpsuits. He allegedly carries a .38 in a shoulder holster under his jumpsuit, and should be considered armed and dangerous. He has worked as a handyman. Creamer has prior convictions for conspiracy to receive stolen property. He is fond of Harley-Davidson motorcycles. He may be driving a white 1992 Jeep Cherokee with Arizona plate NGG091. Creamer is 52, 5'10" and 235 pounds.

Nelson Yester (Conspiracy to Distribute Cocaine, Racketeering) -- When federal agencies uncovered an alleged plot to supply Colombian drug smugglers with hard-core ex-Soviet military hardware, agents say Nelson Yester's name was all over it. The amazing story unfolded in the nick of time around a Miami nude bar named Porkey's. Behind a stage draped with sweaty strippers, agents say the club's owner, Russian immigrant Ludwig Fainberg, and alleged drug cartel insiders Nelson Yester and Juan Almeida cooked up a profitable plan. Exotic cold war weaponry, they reportedly realized, could be used to crank up the heat in the war on drugs. This alleged meeting of the minds brought together, perhaps for the first time, Russian Mafia members with connections to the former Soviet military and Colombian cartels, desperate for new ways to get their cargo into U.S. waters. These new modes of transport allegedly included helicopters and airplanes, but the package's main selling point was reportedly a

Tango-class Soviet attack submarine. Capable of underwater speeds of 20 m.p.h., fully-loaded with eight torpedo tubes, and nearly undetectable when submerged, this submarine is a smuggler's dream and the DEA's nightmare. Luckily, the equipment was never delivered. But agents say that meetings took place, and the team was ready to sell to the highest bidder when they were broken up by a long-running investigation. Fainberg was indicted on over 30 counts linking him to the Russian Mafia. Almeida was also arrested and made bail. But Yester, the one agents say was the main figure on the South American side, got away. A master of disguise and fluent in three languages, Yester could be anywhere. Investigators now believe he is traveling under the name Hector Santana with a British passport. Yester has used the aliases Tony Nelson, Hector Santana, and Martinez. He changes his appearance frequently and may wear a mustache or beard. He is a stylish dresser who wears expensive suits, usually without a necktie, and Rolex watches. A former Cuban Air Force pilot, he has also worked in the automobile business. Yester is 37, 6'2" and 200 pounds. (See Shows #1014 and #496, OADs 2/24/97 and 5/23/98)

Haroun Fazil (Murder, Conspiracy to use Weapons of Mass Destruction) -- On September 17, 1998, the U.S. Attorney for the Southern District of New York announced a fourth suspect in the August 7, 1998 embassy bombing in Nairobi, Kenya. The bombing killed more than 250, including 12 Americans. The suspect's name is Haroun Fazil. The suspect is an alleged member of "Al Qaeda," a worldwide terrorist organization led by Usama Bin Laden. The U.S. Justice Department believes that Fazil was trained in explosives in Afghanistan, and has been an active participant in the activities of the Kenyan cell of the organization. Fazil allegedly rented a villa in the vicinity of Nairobi in between May 1998 and August 1998. An alleged coconspirator claimed that the bomb used in the attack was constructed in this villa. Fazil speaks four languages and has allegedly has a host of aliases. Tracking him down will be difficult, but the FBI is confident someone out there can help. Fazil has used the last name aliases Faziul, Abu, and Harun, and first name aliases of Harun, Haroon and Haroun. He may be clean-shaven, or wear a light mustache and/or beard. He is a citizen of Comoros. He often wears baseball caps, dresses in t-shirts, collared shirts and jeans. He is fluent in French, Swahili, Arabic and English. He is described as a serious Muslim fundamentalist. He is very good with computers. Fazil is 24-27 and 5'4"-5'6".

Unknown Suspects (2) (Wanted for Questioning in ATM Robbery) -- It was one of the most brazen robberies ever. On April 7, 1998, at about 4:30 p.m., two suspects walked calmly into an open 7-Eleven in Kansas City, Missouri, and walked out with an entire ATM machine. It wasn't until 10:30 that night that anyone realized it had been stolen. How could this happen? Take a look at the surveillance photos - these suspects took advantage of the trust we have for

anyone in uniform. They told the clerk that they were there to "check" on the machine, and even handed over a phony work order to sign. While one of the suspects made small talk with the customers in line, the other one put the ATM on the store's hand truck and wheeled the machine out into a white van. At 10:30 p.m., police say, the ATM's real caretakers from Loomis Fargo showed up, responding to the silent alarm tripped by the thieves. Police also say that the machine had been chained to the floor, and the suspects either had the key or picked the lock. The bottom half of the machine was recovered a mile away one week later, but the upper half is still missing, along with the cash. The first suspect is 20-30 and 5'7". The second suspect is 2-30 and 5'11".

MISSING:

Courtney Hopkins

Age: 20

Height: 5'4"

Weight: 135 pounds

On the day she disappeared, Courtney Hopkins, according to Syracuse University records, visited the campus library and made an ATM withdrawal in the afternoon. But no other clues have been found that have brought police closer to locating this vanished student. Courtney was last seen at her apartment on the south side of campus, and police say her room shows no signs of forced entry. Courtney's parents believe she never would have run off on her own, as her twin sister, Heather, has been very ill. Courtney needs medication for epilepsy.

UPDATE:

Tracey Lee Poirer (Escape, Murder) -- UPDATE: AMW has learned some new information about this fugitive. Police believe that she and her partner fled to the south after the prison break, and were spotted in San Francisco. Trimble, the prison guard who allegedly aided the escape, is an expert marksman, and is probably carrying a handgun. The women have allegedly talked about robbing banks and convenience stores to make money. One more thing - this odd couple of the criminal justice system actually held a wedding ceremony behind bars before the escape. The marriage isn't recognized by law, but it does make it more likely that the women are together. It was the most unlikely place to fall in love - the Oregon Women's Correctional Center in Salem. And they were the most unlikely of couples: Tracey Poirer, with a history of violence and crime, heavily tattooed, and serving time for murder; and Pamela Trimble, a husky prison guard. But for Poirer, police say, it was a match made in heaven. It

gave her freedom. Poirer was in prison for a brutal murder that took place on July 3, 1990. That night, she was with her then-girlfriend, Tammy Upton, at a local dive called Red's in Roseburg, Oregon. They weren't interested in any male company until they saw the thick wad of bills held by a man named Donald Fish. Donald was a dwarf - or a little person, as he preferred - and had been getting by working for a department store. But the outgoing 4'3" Donald had a big passion for pool, and came into Red's that night looking for a hustle. As he flashed his wad of bills around the pool table, Poirer and Upton took notice. Witnesses say they had bad feelings as they watched Poirer flirt with Donald, who fell right into their trap. They left the bar for a night out on the town, and ended up on the bank of the Umqua River. That's when Donald realized this was not his lucky night. The pair cut him with a knife, took his cash, and stuffed him in the trunk of their car. Donald, wounded but not yet dead, left bloody handprints on the inside of the trunk as he tried to get free. After an hour of driving, the lovers returned to the river to finish the job by bludgeoning him to death. Poirer and Upton were tried and sentenced to life without parole. In prison, Poirer dumped Upton - she reportedly had her eyes set on someone more useful. Her next conquest, officials say, was prison guard Pamela Trimble. Trimble was soon so in love with Poirer, officials say, that when the inmate was transferred to another facility, she gave up her career to follow her. They met frequently in prison, and, investigators claim, soon hatched a bold plan to get Poirer out by having Trimble break in. On the night of August 28, 1998, Trimble allegedly cut through the prison fence and then broke open a window to free her love. The pair then disappeared. Poirer has tattoos of webbing and a cross on her left thumb, two peacocks on her left arm, a wizard on her left shoulder, a butterfly on her right shoulder, a skull, "Harley Ruse", and crescent moon on her back, a peacock and two roses on her left hip, a swastika and "WSP" on her right foot, and the letter "A" on both hands. Both ears are pierced twice. She has bright red hair but may have dyed and/or cut it. She is a convicted murderer and prostitute, a lesbian, and an alleged heavy drinker and drug user who reportedly prefers heroin. She is fluent in French. Poirer is believed to be traveling with Pamela Trimble. She is aggressive, and violent with extensive criminal record. Poirer is 36, 5'1" and 115 pounds. Trimble may have dyed and cut her hair. The former correctional officer is proficient with firearms and may be disguised as a male, living in Salvation Army shelters. She should be considered armed and dangerous. CAPTURED:

John Dennis Grubb (Bank Robbery (5); Parole Violation) -- Following up on a tip to the America's Most Wanted hotline, the FBI and West Virginia State Police say they apprehended fugitive John Dennis Grubb in the early hours of September 13th in Martinsburg, West Virginia. According to reports, Grubb dropped his first name and was known as "Dennis Grubb" to folks in West Virginia. The tipster, who did not have a phone, walked more than a mile to call in the

tip that led to the capture, say officials. FBI and local police departments all over the eastern U.S. believe this man is responsible for at least five bank robberies, and may be behind 22 more in at least seven states. He's been convicted before - in fact, he was on parole when this current rash of robberies started. John Grubb, say agents, made no attempt to disguise himself during robberies, but managed to keep a low profile anyway. His typical m.o. was to pass a note to a teller, demanding all the large bills in the drawer. Agents say the note often ended with a threat - if they didn't comply, they would be shot. Sometimes, witnesses claim, he flashed his 9mm to emphasize this point. Acquaintances say he's a neat freak - the kind who would probably even iron his socks. A barmaid who knew him says he would walk the length of the bar and straighten the ashtrays. He also had the habit of marking every program in the TV guide that he planned to watch. (See Show #511, OAD 9/12/98)

FEATURE:

Stanislav Lunev -- The cold war may be over, but America is more vulnerable than ever. The World Trade Center bombing in 1993 and the recent embassy bombings in Africa demonstrate that the United States is now a top priority for terrorists. Many of these violent terrorists are now being armed and trained by former members of the GRU, the elite military equivalent of the Russian KGB. Colonel Stanislav Lunev was one of the GRU's best spies. Posing as a journalist, he says he worked for four years in Washington to subvert America. He stole vital secrets and military specs from America's armed forces. His target - the National Security Council. His mission - to identify and befriend those he could turn into traitors. Lunev operated brazenly on the streets of the nation's capital. He even used park benches just blocks from the White House to hide stolen microfilm in containers no larger than a nickel. When he needed to move larger and more dangerous stuff, he went to the Virginia woods. There, he constructed fake rocks to stash smuggled weapons, ammunition, and communication devices. But Lunev is no longer the man he once was. After defecting to the U.S., he's spent the past six years briefing the CIA, FBI, and Congress. At a national security hearing, he had to wear a disguise, but he is convinced this risk was worth it. He says now that Russia has fallen into the hands of people far more dangerous than the Communists he once served. The collapse of the Soviet Union does not end the danger. New groups have emerged from Russia, Lunev says, that are more dangerous and more unpredictable than the Communists before them. Along with Russian spies, who Lunev says still target America, the Russian Mafia is now on the scene, and in league with the terrorists. The combination is explosive, and the dangers that lie ahead are critical. Lunev says that the Japanese terrorists who dumped serin nerve gas into the Tokyo subways were trained by the GRU, and America's subways are just as vulnerable. And larger weapons are on the market as well, like these parts to a Russian long-range missile. In 1996 federal prosecutors in Miami foiled a plot by the Russian Mafia to sell a Russian attack

submarine to the drug cartels, and one of the alleged fugitives, Nelson Yester is still at large. Lunev also claims that 100 suitcase-sized nuclear bombs, missing from the Russian arsenal, could now be in the hands of terrorists. His message now for America: "Pay more attention."

STREET SMART:

Sanford Strong's lessons for back to school -- Give your kids a pop quiz with these safety tips before they hit the books this fall:

"When my kids first went off to school, I was pretty nervous about their safety. When the summer is over, lots of parents get nervous, too. But you don't have to worry - if you know the rules. Check these tips carefully - and don't be shy about giving your children a pop quiz to make sure they know how to be safe.

Key check. Morning can be a busy time, but it only takes a second to make sure your child has keys to the house if you won't be there after school. Keys on a necklace are a good idea, but I'm against keys in kid's pockets - they're just too easy to lose.

Privacy is the first step to safety. Don't put your kid's names on his backpack or clothing, or for that matter, on your mailbox or doormat. You don't want to give a stranger your child's name.

Hidden keys. Kids often lose their keys, and it's a good idea to leave a key hidden for them. But too many parents leave them under doormats or potted plants - the first place a burglar will look. Better to leave a key with a trusted neighbor. That neighbor will also be alerted if your children are not home on time.

Keep them away from shortcuts. After school, kids are anxious to get home, maybe a little too anxious. You need to establish a strict safety route home for your kids. Walk around the surrounding neighborhood and school with your kids. There's no better way for a child to understand the what and where of dangerous places than a show and tell with mom and dad. And parents will learn where their children's friends live.

Whether coming or going, children should always be in the habit of locking the door behind them.

Keep snacks at ready. When they get home from school, your kids are going to be hungry. Think ahead, and have plenty of snacks on hand in the house. I can't tell you

how many houses I came to when I was a cop because an unsupervised child started a fire while cooking.

Answering the phone. Train your children to never tell a stranger over the phone that you are not there. A simple turn of phrase, like "She can't come to the phone right now" is much better.

Always keep emergency phone numbers and even your address posted by the phone. It can save precious seconds in a crisis.

Answering the door. A child should never open the door until they are certain who is on the other side. If there is no peephole for your children, a stool or chair should always be near the door so the child can use it to see out the peephole.

Get into the habit of reinforcing these and other safety tips with your children. And remember, street smart kids have street smart parents."

The accused drug lord with the laughable nickname first went to prison for a homicide case when he was still a juvenile. When Williams finished doing his time, he was a young man with a mission; detectives say he set up business making money any way he could - that usually meant drug ripoffs and burglaries. Boobie muscled in on other dealers' territory and methodically rose to the level of drug lord, showing no mercy along the way, say detectives. Boobie seized his authority through force and graphic violence: One crime scene was littered with 99 bullet casings. The Boobie Boys don't sound like a bunch of tough guys, but police say the Boobies alone are responsible for at least 30 murders. So why the name? Boobie? The accused leader of the gang is Kenneth Sorrell Williams. By reputation, he's as mean as a Florida gator, but by nickname, he's Boobie. Boobie has been in serious trouble since he was a teenager. The accused drug lord with the laughable nickname first went to prison for a homicide case when he was still a juvenile. Unknown (2) Armed Robbery -- Las Vegas Metropolitan Police need help identifying two anonymous robbers, who pulled off a brazen heist on December 28, 1997. Police say a short time after midnight, two female workers and a security guard were taking a cigarette break outside a repair shop for slot machines, when two suspects approached them and demanded access to the building. Suspect #1 reportedly held a shotgun on the security guard, while one of the female workers was forced to use her card key to let the two suspects in. Police say the suspects took the workers hostage and were marching them through the building, when the security guard tried to overpower Suspect #1 by grabbing the shotgun. A struggle then ensued and one of the females tried to help the guard, but was shoved away, according to accounts. Detectives say the female workers opened the door to the vault for the robbers as Suspect #2

dragged the security guard into the vault, bound his hands and feet with flex cuffs, and proceeded to acquire the cash. As Suspect #1 watched over the constrained guard, Suspect #2 went to get the cash with the female workers, according to investigators. Detectives say the suspects were seen leaving with two duffel bags filled with hundred and twenty dollar bills. Police believe they took off in a small truck with a camper shell on it. The race of the suspects is unknown. Police think Suspect #1 is a woman and Suspect #2 is probably a man. They wore masks coveralls and were armed with a handgun and either a rifle or shotgun. The male suspect, the only one to speak during the robbery, has a heavy build and "walked like a farmer". The female suspect was skinny, did not talk during the robbery, and carried a shotgun or rifle.

Ramon Antonio Ovalles (Charge: 2 DUI Manslaughter, 3 DUI - Serious Bodily Injury) - Ten-year-old Alan Ajiman had one big birthday request: he wanted to go to Disneyworld. So in December 1997, Alan, his 14-year-old sister, Paola and their parents left their home in Buenos Aires, Argentina for a holiday in Florida. Little did the Ajiman family know that those happy days in the Magic Kingdom would be their last together. On Christmas Day, 1997, the family traveled to South Beach Miami to shop for two days before returning to Argentina. On December 27th, they left for the airport. As the Ajiman's van entered an intersection, police say a drunken Ramon Ovalles, ran a red light and struck the family's van at 60 miles per hour. Ovalles' passenger, 20-year-old Miguel Escobar, was ejected from the car and killed. Ten-year-old Alan died at the scene. Paola suffered severe head injuries. Ovalles' injuries put him in the hospital for two weeks. But on January 16, 1998, he checked himself out of the hospital and disappeared. Paola is undergoing rigorous rehabilitation, but she will never be the same. Of the family's tragedy, Graciela Ajiman says, "The scars that hurt and take time to heal are those of the soul, are those that I don't know if they have a cure." Ovalles often wears a goatee. He is 23, 5'11" and 160 pounds.

Anibal Daniel Gomez (Organized Fraud, Credit Card and Computer Fraud)

Edwin Enrique Comas (Organized Fraud, Credit Card and Computer Fraud) -- ATM means quick, easy cash for most people, but the Metro-Dade Police Department says it also means quick, easy cash for criminals. Police say between November 24, 1997 and February 26, 1998, Anibal Gomez and his partner, Edwin Comas, pulled a new type of scam on numerous ATM machines all around south Florida. The scam takes a two-man team. The first person rigs the ATM to capture a victim's card. The second person approaches the victim after he tries to free his card and offers some helpful advise. But police say it isn't a good samaritan award they're looking for - it's your PIN number and some cold hard cash. Once the frustrated bank customer is gone, the thieves retrieve the card and use the PIN at another nearby ATM to cash in with their newly acquired plastic. Police say Anibal Gomez and Edwin Comas pulled off this scam over and over again all over sunny south Florida. Gomez is 20, 5'11" and 185 pounds. Comas is 29, 5'11" and 150 pounds.

Unknown (Bank Robbery) -- San Diego police are searching for a brazen bank robber who used a rented limousine as a getaway car. The "Bourgeois Bandit" is about 20-25, 6'1" and 220-230 pounds.

Unknown (Murder Of A Police Officer) -- Chris Horner thought he had it made when he made the cut at the Haines City Police Department. An eleven-year career in the Navy had prepared him for law enforcement, and his superiors say he took to police work like a duck to water. His home life was just as happy, with his and his wife's children from a previous marriage making a total of six kids looking to him for support and guidance. But for his widow, Felecia, the world ended on March 3, 1998. Officer Horner started his shift, alone, by checking the cemetery, a known dumping place for stolen cars. His last radio transmission, at 6:38 a.m., revealed that he was stopping to check a dark Crown Victoria without license plates. Five minutes later, he failed to respond to his dispatcher's follow-up call. Officers responding to the scene found Chris on the ground with a bullet wound in his head. With so few clues, investigators are appealing to viewers of America's Most Wanted for even the slightest lead. (See Show #487, OAD 3/28/98)

Christopher Fink (Unauthorized Flight To Avoid Prosecution)

Kyndra Fink (Aggravated Assault, Unauthorized Flight To Avoid Prosecution) -- Police in Utah say 23-year-old Christopher brazenly kidnapped his baby son, David Fink from Primary Children's Medical Center in Salt Lake City on September 19, 1998. Fink claims to be a prophet and calls the toddler his "Christ Child", according to reports. Just five days after custody of little David was taken from his parents, authorities say the hospital agreed to a supervised visit. Witnesses say during a walk through the hospital's lobby, David's mother, Kyndra Fink who had left the building, pulled her faded red Subaru up to the lobby doors. Christopher Fink then grabbed the child and leaped into the awaiting car, say hospital officials. A nurses aide, who had reportedly reached to grab the door of the car, was literally dragged through the parking lot behind the squealing vehicle, as the couple made its get-away. Officials say Baby David is severely malnourished, dehydrated, underweight and needs hospitalization. They say he must be carried everywhere, because he is unable to walk due to an underdeveloped body. Police say the Finks may be hiding in the wilderness because Christopher is a survivalist and avid camper. Kyndra reportedly gave birth to little David in the woods. She is expected to give birth to a second child during the week of September 28, 1998. Authorities believe the couple is headed to Pennsylvania or Ohio, where they are known to have family. Christopher Fink thinks he is a prophet and his baby son is the Christ Child. He may be hiding in the wilderness with Kyndra and their other son, David. He is a martial arts expert, avid camper and outdoorsman who is known to carry guns. Kyndra Fink is nine months pregnant. She is originally from Pocatello, Idaho, and has worked as a massage therapist. When last seen the family was in a faded red Subaru with Utah license plates 126 KHV. The family was last seen in Cheyenne, Wyoming.

Robert Malcolm Jackson (Murder) -- Robert Malcolm Jackson is an accused murderer on the run. There was a time when no one would have suspected Jackson of murder. At Morgan State University in Baltimore, Maryland, Jackson was a bright and serious student. Police say they still don't know what Jackson's motive was, but here's their account of what happened: On June 24, 1998, Robert Jackson met with William E. Gilbert to test drive a 1991 Lexus that Gilbert had advertised for sale in a Baltimore newspaper. Police say Jackson shot Gilbert numerous times, then fled. They say that Jackson didn't steal the car. In fact, they don't believe that Jackson stole anything. Police say Jackson called his girlfriend on July 23, 1998 from Norfolk, Virginia; he phoned again on August 2 from Orlando, Florida. He mentioned that he was headed for Miami and hoped to escape to Trinidad. Jackson nearly always wears a pair of prescription glasses and he has a distinctive tattoo of a British lion on his left shoulder. Jackson, whose nicknames are Sugarshack and Georgie, has used the aliases Malcolm Jackson and R. Jackson. Although he has worn his hair in dreadlocks, it is probably cut short now. He is very intelligent and has worked as a substitute teacher. Jackson is 27, 5'9" and 165 pounds.

Danny Raymond Fry -- On August 28, 1995 Madalyn Murray-O'Hair, her son, Jon and her granddaughter, Robin disappeared from their home in Austin, Texas. To this day, no one know whether they left voluntarily, or under duress. Their half-eaten breakfast was still on the table. Madalyn's medicine was left on the kitchen counter. Their beloved dogs were abandoned. So - it looks like an abduction - right? Well here's the other side of the equation. Missing along with the Murray-O'Hair trio was \$600,000 from the bank accounts of the American Atheists. Police records show that the money was wired to New Jersey, where Helen Johnson, the successor to Madalyn's organization, The American Forum, was living. Though they say Helen has refused to speak about the matter, police say that Jon Murray flew from San Antonio to New Jersey on September 21, 1995. He was accompanied by a man using the alias Conrad Johnson. Could it have been Danny Fry? Or was it a third man? Records indicate that Jon and his accomplice returned to San Antonio on September 22. This is where police believe the Murray-O'Hair clan had stayed since their disappearance. Their cellular phone records show activity in San Antonio throughout September. Police believe they stayed at the Warren Inn. Whether some or all of the family was being kept there as hostages or whether they were staying of their own free will hasn't been determined. A few days after police believe the Murray-O'Hairs arrived in San Antonio, an unidentified person sold the family's Mercedes for \$15,000 - CASH. The transaction took place in a strip mall parking lot - right next to the Warren Inn. Oddly, the Warren Inn is one of the last confirmed locations for Danny Fry. On September 30, Danny Fry phoned his daughter from a pay phone there and told her that he was headed home to Austin. He reportedly had one other message for her: get ready for a shopping spree. One day

James Joseph Semaan -- (Sexual Assault - 2 Counts; Risk to a Minor) -- Police in Danbury, Connecticut haven't seen James Joseph Semaan for 13 years. But they remember him well. Detectives describe Semaan as 'one of the strangest people they've ever met.' A self-proclaimed 'Doctor of Astrology,' he was a marriage counselor who advised his clients based upon celestial indications. He lived in a peculiarly-shaped home which locals called 'the mushroom house.' He rented out rooms to females who he called his 'bees.' Second wife Lynda, held the special title of 'Queen Bee.' Until August 29, 1983, Semaan was just the town eccentric. But on that date, Danbury Police received a call from the Rape Crisis Center. Semaan's ex-wife told them she had discovered that her daughter, Onae - then just 10 years old - and her best friend had each admitted to having been molested by Semaan and Lynda. On September 7, 1983, James and Lynda Semaan were arrested and charged with sexual assault and risk to a minor. They were released on bail and they disappeared before their February 1985 trial. Semaan comes from an influential Lebanese-American family in Connecticut and he still has relatives in the Bridgeport area. Semaan, whose nickname is 'Doctor', has used the aliases James Roe, James Lavin and James Scat. He has a noticeable stutter. Semaan calls himself a 'Doctor of Astrology'. He needs a prescription for his heart condition. He may have tiny scars on his head from cysts removed several years ago. He has large hands and may be somewhat hunchbacked. He typically drives Mercurys and Thunderbirds. He has worked as a moped salesman. He is probably traveling with his wife, Lynda Margaret Semaan. Semaan is 63, 5'9" and 170 pounds.

David Fink

Age: 20 months

Weight: 16-20 pounds

Authorities in Utah say 20-month-old David Fink was kidnapped from Primary Children's Medical Center in Salt Lake City on September 19, 1998. His father, Christopher Fink, claims to be a prophet and calls the baby his "Christ Child", according to reports. Just five days after David was taken away from his parents, authorities say the hospital agreed to a supervised visit. Witnesses say during a walk through the hospital's lobby, David's mother, Kyndra Fink who had left the building, pulled her faded red Subaru (Utah license plates 126 KHV) up to the lobby doors. Christopher Fink then brazenly grabbed the child and leaped into the awaiting car, say hospital officials. A nurses aide, who had reportedly reached to grab the door of the car, was literally dragged through the parking lot behind the squealing vehicle, as the couple made its get-away. Officials say Baby David is severely malnourished, dehydrated, underweight and needs hospitalization. They say he must be carried everywhere, because he is unable to walk due to an underdeveloped body. Police say the Finks may be hiding in the wilderness because Christopher is a survivalist and avid camper. Kyndra reportedly gave birth to little David in the woods. She is expected to give birth to a second child during the week of September 28, 1998. Authorities believe the couple is headed to Pennsylvania or Ohio, where they are known to have family.
