*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Bernardo Martinaj** (Murder) -- It was an insignificant encounter - a group of friends were socializing in a bar, and one of them bumped up against a stranger. He said nothing, but gave them a glare they remember to this day. Then the stranger left. The young friends, residents Long Island, New York, who were in Manhattan for the evening, thought nothing of it. But they say, when they left the bar, they found that the mysterious man hadn't forgotten about it. He was waiting outside, and was on them immediately. At 6'3" and 185 pounds, and welding a knife, the victims never had a chance. Bojan Radulovic bled to death on the sidewalk - one of his friends was stabbed three times, but survived. The job of tracking down the assailant fell to Detective Pete Solerno of the NYPD. At first, all he had was a name - but that was enough to track down a man living on the Upper East Side. But that person had an alibi, and it checked out. Then, the man told Detective Solerno there was a man with a similar name who worked in the area. Solerno found him, but again, this was not the man, and again, the interview gave them another name - and this time, detectives say, the lead was solid. The name they got was Bernardo Martinaj, but by the time they tracked down his address, he had vanished. Now Detective Solerno and the parents of Bojan Radulovic need your help to find Martinaj, and find justice. Martinaj, who uses the aliases Bernard Martinaj and Ismet Shabani, is an ethnic Albanian who lives in Albanian-American enclaves. He is fluent in English, Albanian and French. He has acne scars on his face. He allegedly uses false Social Security number 078-86-3826. He is known to carry a knife. Martinaj is 21, 6'3" and 185 pounds.

**Unknown** (Murder) -- In Las Vegas, Elvis lives on through his numerous impersonators. But these days, his spirit is diminished and the lights on the strip aren't as bright - highly-regarded Elvis impersonator Dana McKay and his girlfriend, Mary Huffman, were killed at home on October 2, 1993. Police say it was a deliberate attack. Mary was the first to come home, the first to be killed. While she was getting her groceries inside, the gunman forced his way in, investigators say, chased her into a back room, and shot her once in the head. Dana came home to a hail of gunfire. Detectives say it was deliberate overkill - someone had a score to settle. They say Dana ran for his life, but couldn't outrun his killer's bullets. The killer or killers then left without taking any jewelry or cash. Dana and Mary were the quintessential Las Vegas

couple. From their home overlooking the strip, they dreamed of taking the city by storm. Dana was called "one of the best" by the tight-knit circle of impersonators, and once got an engagement at the Dunes just based on his striking resemblance to the King. His dreams didn't stop there. He also had a plan to line the strip with his palm trees - acting on a tip that the city would soon be looking for palms, he started bringing in cheap ones from out of state. Mary was a successful businesswoman with a Las Vegas twist - she had also been honored as Ms. Nevada - at age 45. She had gone through a divorce in 1989, but found happiness in the arms of her Elvis look-alike beau. Someone brought that all to an end in 1993 - who would want them dead, and why? Police have investigated their personal and business dealings, and haven't yet found their suspect or suspects. But they say that Dana was involved in a messy break-up with his business partner, Tim Stonestreet. The dissolution of the palm tree business, police say, had Dana worried for his life - he allegedly called police and friends, saying that he had been threatened - that there was a very real possibility that someone was going to kill him. That's when he started keeping a mysterious file with him at all times - that file still hasn't been found. Tim Stonestreet hasn't been charged with any crime, and police have investigated other leads. But after four years, the children of the victims are desperate for answers. ### **F.B.I.'S TEN MOST WANTED LIST:**

**Glen Stewart Godwin (Murder, Escape)** -- In 1980, Glen Stewart Godwin turned on his best friend in a robbery, and the double-cross turned to murder. After stabbing the victim 26 times, he attempted to cover his tracks by dragging the lifeless body to a remote desert location, and there detonated homemade bombs next to the evidence. The attempt failed - instead of incinerating the body, the explosion catapulted it into the night, where it was later discovered. Godwin was convicted and got 26 years to life for his crime. Prison officials say that he wasn't one to play by the rules, so he was soon transferred to what convicts call "the end of the world" - California's infamous Folsom prison. Only a handful of convicts have gotten clear of Folsom's high walls - but that didn't stop Godwin. He carefully examined the security and surroundings, and realized that he could get out by turning the problem on its head - no one could get out of this prison, but what if someone broke in? Godwin enlisted an ex-con by the name of Lorenz Karlic to work his way into Folsom by way of a tunnel running underneath the prison. Folsom was built on a stream that empties into a nearby river - and while the tunnel is secure in one direction, no one was watching as Karlic cleared a path for his friend. In June 1987, the tunnel was ready, and Godwin was away. But Godwin was far from rehabilitated. Just five months after his escape, he was captured in Mexico and charged with possession of 30 grams of cocaine. Once again, he was convicted, and sentenced to seven years at the Puente Grande Federal Prison in Guadalajara. The FBI was in negotiations with Mexican authorities to bring Godwin home when they say he clouded the legal waters by killing a fellow inmate. A short time later, the FBI learned that he had escaped yet again. On December 7, 1996, Godwin was named to the FBI's Ten Most Wanted

list. Agents believe he is still in Mexico, but may have slipped back into California. Godwin, who use used the aliases Dennis McWilliam and Glen S. Godwin, frequents bars and drinks champagne. He is also an alleged marijuana and cocaine user. Godwin is a tennis player, a sharp dresser, and has worked as a model, mechanic, and construction worker. He collects firearms. Godwin is 40, 6'0 and 170 pounds. ### **AMW PUBLIC ENEMY #1:**

**Erick Rodriguez** (Sodomy, Rape, Incest, Endangering a child) -- It was allegedly after a sex education class that a ten-year-old's secret finally came out. Police report that she told her teacher how her father, Erick Rodriguez, "touched her." The teacher called the police, who talked to the girl and headed for Rodriguez's home. There, they found physical evidence of rape in the girl's bedroom - evidence that would later help establish Rodriguez's guilt. Rodriguez was arrested and his daughter and son were taken from their home. The determined prosecutor lined up his witnesses and physical evidence, and was sure he could present an air-tight case. But in the face of all the evidence and the prosecutor's assertion that Rodriguez was a flight risk, bail was set at only \$10,000. Almost a year later, the case finally came before Judge Nicholas Pitaro. The assistant district attorney who argued the case knew it was strong, but he didn't know how strong until he saw the victim take the stand. When she was done, the ADA asked that the suspect be held without bail, or at the very least, be held on \$500,000. The request was rejected. Over a dozen times, as the trial progressed, the prosecutors asked for a higher bond. Each time, it was refused. Judge Pitaro argued that Rodriguez was a first offender, had served in Korea, and saw no evidence that he was a flight risk. Many others disagree, including New York Governor George Pataki, who called the case reprehensible. The day came when Rodriguez's fate was placed in the hands of the jury. That was the day Rodriguez decided to take his fate into his own hands, and left town. Rodriguez was found guilty in absentia and given the maximum sentence allowed under New York law. The prosecutors were proven right, but that's a small consideration - they just want him back so he can serve his time. Rodriguez has a pronounced cleft chin, a birthmark on his left cheek and a receding hairline. He is a US citizen who was born in Nicaragua. He is a quiet loner who likes to read, and enjoys studying biology and related fields. He has worked for and studied the pharmaceutical industry, and has also worked as a cab driver. Rodriguez is 42, 5'8" and 160 pounds. (See Shows #1005, #1006 and #462, OADs 12/9/96, 12/14/96 and 8/16/97)

**"Daisy" Jane Doe** -- On May 7, 1988, a mystery was found floating down the Grand River, just north of Fort Gibson, Oklahoma. A fisherman called in a report of a woman's body in the water, and officers were able to retrieve her. But no one could identify her. She apparently had been drowned with a 28-pound block of concrete tied around her stomach. She was a white female, wearing two rings on her left hand and one ring on her right. She had on a t-shirt with the message: "Love is like a butterfly, it goes wherever it pleases, it pleases wherever it goes." She also had a tattoo of a yellow flower, and with no other name found, she was dubbed "Daisy" Jane Doe. After the coroner completed his examination and a composite drawing of the woman made, she was laid to rest in the Tallaqua Cemetery. Eight years passed, but no lead ever panned out. With all their hopes exhausted, the Tallaqua County Sheriff's Department asked for AMW's help. The first thing to do was take advantage of new technologies and techniques to get a better image of the murder victim. A forensic anthropologist in Oklahoma City, Dr. Clyde Snow, was first brought in to examine the remains and find any additional clues. He pointed out that her teeth were in very good condition - she took care of them and was apparently not a smoker. From her bone structure, she was determined to be about 5'5". The bones in her skull were in a moderate state of fusion - as we grow older, they grow together. This means she was still young - in her late 20s or early 30s. These were good clues, but we still needed a face. Two renowned forensic artists - Betty Gatliff and Karen Taylor - were put on the case, using the victim's skull as a base for their work. Using Dr. Snow's information and a tissue depth chart, they were able to reconstruct the victim's face. The next step was to take the two forensic images and combine them into one. This was done by computer graphic artists, who worked together to create a single 3-D image. Finally, the victim had a face. Somewhere, the victim has family or friends who miss her and still worry about "Daisy." If you have any idea who those people might be, please send a tip. "Daisy" Jane Doe was right-handed and may have had one or two children. She was 20-30, 5'5" and 115 pounds. (See Shows #1005, #1006 and #462, OADs 12/9/96, 12/14/96 and 8/16/97)

**Bronx Jane Doe** -- A pedestrian out for a walk on the evening of February 23, 1998 found the body of a little girl. She had apparently been raped and strangled, and then dumped on the sidewalk in the 2300 block of Valentine Avenue. Police say she had been killed at another location - and the killers chose this quiet block as their dumping ground. Compounding the tragedy, no one knows who she is. She had no ID, and no one has come forward to claim the body. Somewhere, someone knows who she is, but police will need your help to give this Jane Doe a name. Bronx Jane Doe had small scars on her right elbow and lower back, and pierced ears. She was found wearing dark green sweatpants, a dark shirt, flowered bra, white socks and black sneakers. She had long, curly hair. Bronx Jane Doe was 15-19, 5'4" and 110 pounds.

**CAPTURED:**



**Frederick Rudolph Yokum** (Armed Robbery) -- Another fugitive is behind bars thanks to AMW, but this one never even got the chance to see his face on TV. Frederick Yokum was captured thanks to an AMW tip even before the show went on the air. When we learned about Yokum, we knew he would have a place on the show. After serving two prison terms, agents say, Yokum had gone back to a life of crime with the 1991 armed robbery of a Fort Myers, Florida jewelry store. The heist reportedly netted the robbers more than \$750,000. Three of the four were captured and \$15,000 worth of jewelry recovered - but agents say Yokum got away clean. In February 1998, the FBI learned that Yokum had adopted a suburban lifestyle in upstate New York, living under the alias Angel "Joe" Rivera. But when they closed in, they discovered that Yokum was on to them, and had slipped through their fingers. That's when America's Most Wanted reporters started asking questions. While they were researching the case, the word spread, and even before AMW started shooting, an anonymous tipster called the hotline with the information we wanted to hear. AMW called the FBI with Yokum's address in the Richmond, Virginia area. When the FBI showed up on his block, agents say, Yokum tried to make a break, leading them on a chase through the suburbs. Agents say that as soon as Yokum started to accelerate, he hit a school zone, and slowed down to a more moderate speed. Moments later, he ended the chase with a surrender in a convenience store parking lot. It wasn't the first time Yokum's run had ended in the lap of the law - Yokum had even spent some time on the FBI's Top Ten List. Agents say Yokum's life of crime started in the 60s in Miami, Florida. Police say Yokum led a band of thugs, sometimes eleven strong, who raised hell across the city. Whenever they would run short of cash, cops claim, they would just grab some, by force. Home invasion was their specialty, agents say - and on January 7, 1968, the robberies turned deadly. Yokum and his gang barged into a house owned by retired tennis pro Ike Macy and his wife. Macy grabbed his own gun and opened fire. Two robbers were shot, including Yokum, who took one in the belly. Macy was killed in the gun battle, and at the age of 22, Yokum became the youngest fugitive to ever make the FBI's Ten Most Wanted List for interstate flight and armed robbery. Nine days later, he was captured in California. Yokum was not convicted of the murder, but got 99 years for a series of home robberies. Incredibly, he served only 14 years before he was paroled in 1983, and apparently, he wasn't fully rehabilitated - two years into his parole, he was put back in prison for the sexual assault of a child. Four years later, he was again turned loose on society. Agents say Yokum and three others moved in on a Fort Myers jewelry store on September 5, 1991, and held a gun to the manager's head. They smashed the display cases and made off with over three-quarters of a million dollars in merchandise. The FBI was back on Yokum's case, and now credits an AMW tipster for his capture - even though the case never made it to air.

**STREET SMART:**

**Don't let your good deeds go punished: Rules for good samaritans --**

Intervention can mean your own life is on the line - follow Sanford's safety tips to intervene safely. The violent death of good Samaritans trying to intervene - trying to stop a crime - is fast becoming a murder statistic by itself. One of the most frequent ways people are killed is when they try to aid a woman who is being assaulted by a man. It comes naturally to us - the desire to help. But as most cops will tell you, there's nothing as unpredictable and dangerous as a domestic fight. In one case, two co-workers tried to intervene between a husband and a wife. Both co-workers were shot at point-blank range and killed. They thought they were doing the right thing. They were, but they went about it the wrong way. If you want to help, your intervention must be guided by these three "keep" rules:

Keep your distance. Protect yourself. Don't recklessly lose your own life trying to save others.

Keep them in sight. But again, at a distance.

Keep the pressure on. Create a distraction. Noise has the potential to deter a crime going down by bringing attention to passers-by and broadens the crook's crowd-control problem. That has the chance to distract him from his attack. Don't be afraid to escalate the noise. Break windows, set off your car alarm, or even cause a minor collision with a parked car. Remember that a life may be at stake. Don't forget your link to the cops - 911.

If you think this response is extreme, you probably shouldn't try to intervene in the first place. Intervention is always spontaneous - both for citizens and cops. During the first O.J. trial, the deputy sheriff of the court intervened in a burglary of his neighbor's home. He didn't watch out for his own safety and was shot and killed by the suspect. Make decisions beforehand on how to help others - safely. You may stop a violent crime, you may even save someone's life - while remaining safe yourself.

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Joel Vidal Urena** (murder, assault with a firearm, robbery, false imprisonment) -- On October 5, 1996, Steve Kerston was awakened at 5 a.m. by flashlights in his eyes. Four masked men had broken into his family's Cotati, California home. Police say it was Joel Urena and three accomplices. Steve says the men attacked him and then went into his parents' bedroom. The men demanded money, jewels and guns from Mark and Mary Kerston. When the couple insisted that they had none, one of the men went out to the living room and shot Steve in the leg. When the couple still insisted they had no valuables, the men threatened to shoot Steve in the head. Mercifully, they didn't follow through on the threat. Instead, they grabbed whatever they could get their hands on and took off. Urena has scars on his face from a car accident and another scar on his right hand. Although of Hawaiian heritage, he may appear Hispanic. He may be wearing a moustache. Urena may be driving a 80's-90's silver or blue metallic Chevrolet Blazer or a 80's black Chevrolet Astro van. He is 27, 6'0" and 260 pounds. (See Show #472, OAD 11/1/97)

**Margaret Rudin** (Murder) -- Police in Las Vegas, Nevada call Margaret Rudin a gold-digging black widow; married five times, she's a professional bride - with each marriage, they say her net worth grew. In September 1987, Rudin married husband number five - wealthy Las Vegas real estate developer, Ron Rudin. Ironically, Margaret became the fifth Mrs. Ron Rudin. For seven years, the Rudins seemed the perfect couple. But on December 18, 1994, Ron mysteriously disappeared. Ron's employees were alarmed and wanted to report him as a missing person. Oddly, Mrs. Rudin insisted they wait a full two days before calling police. For two months, Ron's fate remained a mystery. Then on January 21, 1995, fishermen found a pile of ashes and a skull near Lake Mojave - about 45 miles from Las Vegas. Dental charts revealed that the fishermen had found Ron Rudin's remains. Police started tailing Margaret Rudin and found some big surprises: the grieving widow skipped her husband's funeral, and misplaced his ashes. She also had a secret boyfriend. murder, but they didn't have enough evidence to make a case...until July 21, 1996. On that day, a diver in Lake Mead found a handgun with a silencer, wrapped in several plastic bags. Rudin, who has used the names Margaret Frost, Margaret Mason, Margaret Zumbrunn, Margaret Brown and Margaret Krafbe, likes expensive clothes and jewelry. She often dyes her hair, and has been a blonde, redhead and brunette. She has a mother and sister in Palm Springs, California and relatives in Illinois. Margaret Rudin is 55, 5'7" and 130 pounds. Oh please, help me." 47-year-old Richard Aderson was a mild-mannered Assistant Superintendent at the Valley Central School District in New York. Driving home on I-84 in his 1995 gray Volvo one evening, Richard had a chance encounter with a killer. It happened on February 5, 1997. At about 5:50 p.m. Richard crossed the Newburgh-Beacon Bridge and paid a toll. According to police and witnesses, a late model green Jeep Cherokee with New Hampshire plates was traveling next to Aderson in the right lane; about three miles past the toll the green Jeep drifted into Richard's lane and sideswiped the Volvo. Both drivers pulled over to exchange information, but something went wrong. An argument broke out. Then the Jeep's driver pulled out an automatic pistol and shot Richard in the chest. As the Jeep roared off, Richard struggled back to his Volvo and used his cell phone to call 911. Though mortally wounded, he gave police a full description of his location and his killer. His dying description, coupled with eyewitness accounts, have given police the information they needed to produce a composite. But the new clues put a possibly fearful and sinister twist on the events of that night. Police have released part of the 911 tape that may shed further light on the identity of Richard's killer. Richard reportedly told the operator that his killer claimed he was a cop. While this information is startling, police caution that they have not drawn any definite conclusions from Richard's dying statement. Police have also learned that the law firm of McLane, Graf and Raulerson of Manchester, New Hampshire, had been making inquiries into the death of Richard Aderson. Police immediately demanded that the law firm provide any information they may have about the identity of the killer, but although an attorney with the firm confirmed that he is representing someone who may know something, he claims attorney-client privilege prevents him from cooperating. Police are still searching for witnesses in this tragic case. The suspect is balding, with remaining hair curly. He may wear, or have recently shaved, a beard. He may wear glasses. ### **FEATURE:**

**Texas Infrared** -- Heat-detecting cameras puts police hot on trails of suspects hiding in the cover of darkness. We're used to seeing the helicopter as an important part of the police chase, but in the near future, we won't always be able to see the helicopter. Cops are trading in high-powered spotlights for infrared cameras in night chases and surveillance. In Ft. Worth, Texas, police have equipped their choppers with the FLIR system - and now they can watch crimes in progress, even in pitch darkness, from a safe and clandestine distance. The forward-looking infrared (FLIR) system picks up suspects' body heat, giving the cops a view they couldn't have with the naked eye. Police on the ground love FLIR - it allows their eye in the sky to pinpoint a target without the suspect being aware that his every move is being watched. Officers B.K. Wilson and Ellis Glascock experienced this first hand when a suspect dumped his car and ran for the brush. He'd hunkered down and covered himself with tall grass - the officers walked by him, and right over him, several times before the FLIR helicopter showed up, and saw his warm glow through the thickets. The suspect was nabbed.

### **STREET SMART:**

**Make your drive a safe one** - tips to keep you and your family alive. Sanford Strong says: "We're about to take a road trip to learn about what you can do to protect yourself from highway crime. Protecting yourself means being prepared. I don't care if my wife and I are planning a two week road trip or an overnighiter, my planning rules don't change. I won't pretend these rules cover every possible problem, but they do reduce my family's risk 80 percent.

Rule one - prepare for possible crises ahead of time - both the big ones and the small ones. That's why I carry replacement belts and hoses that may be hard to find in a small town. I belong to the auto club and most gas company car clubs. When I'm on the road, my cellular phone is always at hand. My wife and daughters call me a worry-wart. That's okay, they've never had a car break down on them.

Rule number two - preparation doesn't end once you're on the road. It only becomes more important. A recent study showed our highways averaged 740 crimes per year involving objects thrown from overpasses. If you don't see the crime developing before the brick or chunk of concrete is coming down, its too late. Here's what I do: As I approach an overpass, I glance up.

If there are people up there, especially juveniles, looking down on the freeway, I switch lanes to the furthest one from them.

Rule number three - avoid areas with heavy graffiti - including painted-over graffiti. If you see a lot of barbed wire on the overpasses, that means trouble. These are all signs of gang activity and that translates into higher incidents of all crimes. If I know an area is gang country, I flat won't drive it at night.

While we can all think logically about what to avoid, logic often isn't our problem. Our emotions are. If you're a victim of highway violence, odds are it's not going to come from gang members, as dangerous as they are, but from another driver like yourself. Cases like the Richard Aderson killing (see above) are becoming more and more commonplace. Roughly 1,500 motorists each year are killed or wounded by highway shootings. So how can we protect ourselves? The most important thing is to leave your "I'll fight for this piece of highway" attitude at home. Don't use your middle finger to communicate with other drivers. In some circles they call this attitude "chilling out," but the bottom line is just calm down. You'll avoid altercations. But what if someone targets you anyway by ramming your car? Keep driving and hold your lane. Don't weave in and out of traffic thinking that you'll be harder to hit. It'll only make it worse. Keep moving at a speed you can control. If you're on a crowded highway, pull over to a crowded area, like a rest stop. Odds are the attacker won't want to call attention to himself. But if you're on a desolate highway, keep going. Never stop and confront anyone, I don't care how right you are. Putting your life on the line against a jerk on the road is wrong. Dead wrong."

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Unknown** (Armed Bank Robbery - 27 counts) -- The FBI says he's not your average bank robber - while many bank robberies are poorly planned, and the perpetrators are quickly caught, this one has eluded authorities since April 1996. And the entire time, he's been very busy - hitting 27 banks in Washington, Oregon, and Utah. Sometimes, he spaces his robberies by several months. Other times, he goes into overdrive - in fall 1997, he hit three different banks in three states in three days. The "Northwest Bank Robber" or "Pacrob," as the FBI calls him, is armed, dangerous, and very professional. He leaves few clues, always picks a bank close to a freeway, and usually makes his getaway in a very fast car. So far, agents say, he has scooped up more than \$420,000 and left dozens traumatized by his aggressive threats. "Don't push any buttons - if the police show up, I'll shoot you all. I don't care, I don't care, I'll shoot you all," one witness reported "Pacrob" told his frightened victims. Another witness, a former Green Beret, came face to face with the bandit, and during their standoff, became convinced that this man means business. The suspect is extremely thin with very pointy facial features. He may wear a goatee and may have bowed legs. He has a fair complexion and is known to wear sunglasses, a baseball cap or camouflage hat as well as zipper-front sweatshirts. He is usually armed with a handgun. He may drive a turquoise Camero or Firebird, black Camero, dark-colored sports utility vehicle, or foreign sports car. The suspect is 25-30, 5'8" and 150-180 pounds.

**Unknown** (Murder) -- In the very first season of America's Most Wanted, ten years ago, ten-year-old Sarah Pryor was featured as a missing child. Finally, in September of 1995, there was a development in the story. Her case is now officially a homicide. On October 9, 1985, Sarah Pryor, who had just moved with her parents to Wayland, Mass., was out exploring her new neighborhood when she vanished. Despite a massive hunt by hundreds of the Pryor's neighbors, and a nationwide appeal by America's Most Wanted, no trace of Sarah was found. However, in September 1995, a man walking his dog just two miles from the Pryor home came across what he believed to be a human skull. The police agreed, and sent the fragment to the US Armed Forces Institute of Pathology in Washington DC. Using the latest forensic techniques, they were able to positively identify the remains as Sarah's by comparing the fragment's DNA to her mother's.

Sarah's parents held funeral services for their daughter on what would have been her 22nd birthday, and achieved some sense of closure about the terrible event. However, for Chief Galvin of the Wayland Police Department, who keeps a picture of Sarah on his desk, there will be no closure until this case is finally solved.

### AMW PUBLIC ENEMY #1:

**Sarkis Peltekian** (Vehicular Manslaughter - 7 counts; Felony DUI) -- On July 2, 1993, police say Sarkis Peltekian had a few drinks, then climbed behind the wheel of his souped-up Chevy Camaro. Roaring down L.A.'s Long Beach Freeway with an alleged blood alcohol level of .10, he lost control of his car. A pickup truck carrying nine teenagers on their way home from the beach was on that same stretch of road. Police say Peltekian's car struck the truck and sent it careening off a concrete overpass. It fell 50 feet and landed in a railroad yard. The occupants of the truck didn't stand a chance. Seven of the teenagers died. Two survived with serious injuries. Peltekian was arrested and charged with 7 counts of vehicular manslaughter, but in less than 48 hours, he was released on \$45,000 bail. He immediately moved out of his apartment and he never returned to his job at a local tire store. Today, he's a fugitive from justice. Peltekian has scars on his back. He was born in Lebanon and speaks fluent Arabic. He wears fancy clothes and enjoys fast cars. He has worked as a car mechanic, tire salesman, and paint salesman. He is the father of a nine-year-old daughter. Peltekian is 37, 5'8" and 200 pounds. (See Show #455, OAD 6/21/97)

**Leocadio Garcia Perez** (Murder, Attempted Murder) -- California's Salinas Valley contains some of the nation's most fertile farmland, attracting tens of thousands of farm workers in search of a brighter future. Fernando Velasco, 34 with a wife and two children, was one of them. Although he had a college degree and training as an accountant, work in his native Mexico was scarce. His family came first, and he moved them to Salinas, where he found a job at a spinach-packing plant. Leocadio Perez worked alongside Fernando, but while Fernando was known as a hard-working family man, Perez was considered a trouble-maker. According to co-workers, Perez was loud and became particularly obnoxious when he began his rants about the coming revolution that would topple the U.S. government. Police say he offended and frightened a number of his colleagues, who reported him to the supervisor. After a series of altercations and complaints by his co-workers, Perez was sent home. He left, but police say he returned the next day with a score to settle. Carrying a 30/30 rifle, officials claim he walked into the plant shouting, over and over, "I'm not going to kill any of the women, only the men." Fernando became the first target for his rage, witnesses claim. He was working the forklift when he was shot. Perez next allegedly leveled his rifle at Juan Frias, and shot him in the back. But when he picked his next target, his rifle jammed. Before the frightened crowd could react, they say, Perez left the building. He hasn't been seen since. Police in Salinas say Perez is the sort of

killer who could explode again, at any time, with the slightest provocation. Perez has a small build and a pencil-thin mustache. He is a loner who likes Mexican country music. He works as a field laborer. Perez is 32, 5'3" and 125 pounds. (See Show #375, OAD 8/5/95)

**Derrick Patrick Walters** (Lewd and Lascivious Behavior with a Child) -- After ten years of marriage to Derrick Walters, Grace Bishop was confronted with a nightmare - her 17-year-old son allegedly told her that he had been molested by Walters, his step-father, for the last five years. Then, prompted by this allegation, Walter's 18-year-old daughter came forward with a horrific tale of her own. She too, agents say, had been sexually abused - since she was eight years old. Officials were shocked to learn that Walters was an elementary school teacher, surrounded by children every day. However, they stress, they have not yet found any further alleged victims. Walters left town when charges were filed against him, and could be in his native Guyana. Grace's nightmare continues - now, agents say, she is also a victim of her husband's abuse. Walters reportedly called her to promise her that he will return to California, and when he does, he allegedly said he will kill her. Walters has tattoos of a libra sign and the words "Grace/Michelle". He has a receding hairline, wears a full beard, and has a crescent-shaped scar on his right cheek. He has a Masters degree and may be working on a Ph.D. He has worked as an elementary school teacher in the Los Angeles area, and as a cab driver in New York City. agents suspect he may be bringing in illegal Guyanan immigrants, and has exported clothing to Guyana to be sold on the black market. Walters is described as intelligent, but lazy. He may have put on weight. Walters is 46, 5'9" and 250 pounds.

**Samuel Sheinbein** (Murder) -- In September 1997, there was a brutal murder in Maryland, just miles from the America's Most Wanted Crime Center in Washington, D.C. Officials say they know who committed the heinous crime, and they know where the fugitive is, but their hands are tied. Why? Because He ran away to Israel, and Israeli officials won't give him back. Sam Sheinbein entered an Israeli court last November. His smirk, caught on camera, seemed to suggest that he enjoyed the limelight as one of Israel's most famous prisoners. The smile of Alfredo Tello, meanwhile, can only be seen in pictures. Alfredo, or "Freddy," was brutally murdered. The way he died was sickening. All of his limbs had been severed, and his entire body had been burned beyond recognition. It all happened in the swank neighborhood of Aspen Hill in Wheaton, Maryland. This is where Sheinbein lived and where Freddy died - just one day after he moved out of his mom's home into his own apartment. On September 16, according to witnesses, Freddy left the pet store where he worked with two friends, Sheinbein and Aaron Needle. He was never seen alive again. Three days later, police got a call. A realtor had been showing a house - and when they stepped inside they were overpowered by a foul stench. When they got to the garage, they found a bag with some sort of fluid leaking out. It was Freddy - his limbless body was stuffed in garbage bags. Nearby, there were more grisly clues - a circular saw and a wheelbarrow. Behind the house, the beginnings of a shallow grave. Police

were on to Sheinbein almost immediately, following the most obvious of clues - a trail of blood. Investigators say a bloodhound trailed a scent from the garage out across the path to the street where the Sheinbein family lived. It then crossed the street, and reportedly lost the scent right in front of their house. Police searched the Sheinbein garage - and tested it with Luminol, a chemical that makes even small traces of blood glow bright. There were lots of bright spots here, police say. The evidence was allegedly overwhelming, and an arrest was almost certain. But where was Sam Sheinbein? His family said they didn't know. But a few days later, an attorney in Rockville, Maryland informed police that Sheinbein had possibly fled the United States, and was now in Israel. Police say that it was Sheinbein's father who put him on that plane. U.S. officials realized immediately that there were going to be some glitches. Israeli police arrested Sheinbein, but would not return him. The fugitive had claimed Israeli citizenship through his father, who was born there 50 years ago. And according to Israeli law, no citizen can be extradited. The Israeli officials say Sheinbein will face a judge, but only in an Israeli court. The law, they say, prohibits them from sending Sheinbein back. This does not sit well with Maryland officials. They say the crime was committed here, and should be tried here. Freddy's mother agrees, saying it does matter where the trial takes place: "They should send him back. He hurt everybody. He hurt my family. He hurt [Freddy's] friends, and especially myself. It makes a difference." **UPDATE:** Israeli courts have determined that Sheinbein is not an Israeli citizen and therefore subject to extradition. Sheinbein has two months to appeal.

### CAPTURED:

**Michael Lee Lawrence** (Armed Robbery, Aggravated Assault) -- Police in Phoenix, Arizona say they dodged bullets and put their lives on the line to catch Michael Lawrence, but once they had the cuffs on him, he made bail and disappeared. Finally, following the fifth airing of Lawrence's feature on America's Most Wanted, a viewer in Inglewood, California called him in. On April 21, 1995, police say Lawrence and two other men held up a K-Mart in Phoenix. A 911 call brought police screeching to the store as the robbers made their getaway. When officers tried to pull the car over, a high-speed chase through Phoenix ensued. When police brought in a helicopter with a high-intensity spotlight to follow the robbers' car, they claim, Lawrence realized he could never get away. He allegedly shattered the back windshield and began firing at the chopper and the police cruisers. The helicopter pulled back, and the patrol cars momentarily lost their quarry. This gave the robbery suspects enough time to stop the car in a residential neighborhood and break up. Two suspects fled on foot, while the driver sped off. When backup arrived, police started evacuating residences in the area and conducted a house-to-house sweep. One family narrowly escaped being taken hostage when their daughter, while waiting for her parents to drive them to safety, noticed a lump under the blankets in the back of their SUV. She quickly reacted, shouting to police that a suspect was in their car, and he was taken into custody.

The getaway driver was finally stopped and arrested, leaving only left Michael Lawrence at large. The man police say had recklessly fired on them just moments earlier was found hiding in a tree. Once surrounded, police say the bold gunman was afraid to climb down. It could have ended there. But Lawrence made bail and took off before trial, enjoying his freedom for over two years. Then an AMW viewer in Inglewood, California noticed Lawrence moving into his neighborhood shortly after the suspect appeared on the June 27, 1998 episode. The address was passed on to the FBI through the Phoenix Police Department. Agents watched the house until they were sure they had their man and arrested Lawrence as he left his apartment. (See Shows #422, #461 and #501, OADs 8/18/96, 8/9/97 and 6/27/98)

**David Scott Ghannt** (Bank Larceny) -- When \$14 million went missing from the Charlotte, North Carolina office of Loomis Fargo, the FBI called David Ghannt, who disappeared at the same time, a prime suspect while his family and friends called him a robbery victim. The FBI says they have now proven they were right all along, and have arrested several of Ghannt's friends at the same time. On Saturday October 4, 1997, Ghannt worked his regular shift - punching out at a little after 6:30 p.m. But unlike every other Saturday night, on this night Ghannt didn't go home to his wife. FBI agents say he waited in the parking lot until his coworkers left, then he returned to the office where he spent an hour loading more than \$14 million into an unmarked company van. Then at about 8 p.m., Ghannt left for the day -- and maybe for good. By Sunday morning, Ghannt's wife, Tammy was in a panic. She hadn't heard from her normally reliable husband all night. She was certain he'd met with foul play; she had no idea he may have been involved in his own foul play. Police found Ghannt's red pickup truck in the Loomis-Fargo parking lot - right where he'd left it. It was then that the company discovered that loot and van were missing. On Monday, agents found the van. It had been abandoned about 10 miles away and there were several million dollars inside it. But Ghannt and about \$12 million are still missing. Working on a hunch that Ghannt didn't work alone, the FBI kept tabs on his friends and associates - and the tabs they ran up. Agents say that Steve and Michelle Chambers moved from their mobile home to a \$635,000 house, and that Michele Chambers celebrated the bank job with a breast job. Another of Ghannt's alleged accomplices went for liposuction. Before long, agents were tapping phones and watching closely. Finally, an affidavit claims, a conversation between Steve Chambers and a Michael McKinney not only located Ghannt's Mexico hideout, but may have saved his life. Agents say that Chambers and McKinney were plotting to have Ghannt killed within a few days of the conversation. Ghannt was arrested in Mexico without incident, and is awaiting trial in Mecklenburg County Jail. Agents hope that as they continue their search of homes and safe deposit boxes, they will recover a substantial amount of the stolen millions. **Nan Farwell** (Forgery - 19 Counts; First Degree Theft - 3 Counts) -- Even 27 different aliases couldn't help an accused thief evade America's Most Wanted viewers. A lot of people

think a career as a public servant is pretty ho-hum and unrewarding. Not Nan Farwell. Police in Spokane, Washington say she took what could have been a very tedious job as a supervisor at the Washington State Department of Licensing and made it a high-stakes adventure. Maybe she longed for a greater challenge, or maybe it was just dissatisfaction with her own palindrome-of-a-first-name. Whatever the cause, Farwell is charged with using her position to create counterfeit driver's licenses using her own photograph with the name, address, and other identifying information of legitimate applicants. Police say Farwell then used the fraudulent licenses to open lines of credit and purchase untold thousands of jewelry and other valuables. In February 1991, Farwell was charged with 27 counts of forgery, theft and misappropriation. But let out on bond, Farwell disappeared without a farewell. She was named one of America's Most Wanted. On January 22, 1997, the AMW hotline logged a tip that placed Farwell in Mexico. The female tipster revealed that she had attended a Mexican university with the fugitive and former public servant. The tipster said that Farwell now went by the alias, Nan Camp and lived in the town of San Miguel de Allende in central Mexico. Under Mexican law, visitors to the country may not use assumed names. When alerted to the law-breaking palindrome's presence in their country, Mexican immigration officials deported Farwell to the border. US officials cheerfully met her there and gave her a ride to the San Diego County Jail to await extradition home to Washington where she'll stand trial. (See Show #326, OAD 7/20/94)

**Simon Dedaj** (2nd Degree Murder - 2 Counts) -- A team of local cops from New York and New Jersey has apprehended a fugitive featured twice on America's Most Wanted. Although they say they received two good tips from the program's viewers, his final capture was not a direct result of their information. Following a strong hunch that Simon Dedaj couldn't tear himself away from his longtime girlfriend, Donna Kelly, police were able to pinpoint his location -- the alleged ruthless shooter couldn't resist a romantic rendezvous at a motel on Route 17 in Ramsey, NJ. On January 31, 1998, police showed up at the hotel in force, with a SWAT team, a helicopter, and police dogs. After taking their stations, they called the motel room where Dedaj was holed up, and demanded an immediate surrender. His interlude interrupted, Dedaj attempted to escape through a window, but was quickly nabbed and taken into custody without further incident. His girlfriend was also arrested and will face charges for hindering Dedaj's apprehension. Police say that on the night of June 21, 1996, two brothers - Simon and Victor Dedaj wandered into Scores, an upscale strip club hidden in the shadows of the 59th Street Bridge in Manhattan. At closing time the brothers were still there...and they were bothering a female bartender. Twenty-five-year-old Jonathan Segal - a waiter at the club - tried to intervene. Police say that's when Simon Dedaj grew violent; he grabbed Jonathan and began choking him. Employees broke up the fight and a 21-year-old bouncer, Michael Greco tried to escort the brothers out of the club. They didn't leave peacefully. Police say they pulled a gun and a knife and attacked and killed both Jonathan and Michael, then fled. In March 1997, Victor Dedaj was arrested at a motel in King of Prussia, Pennsylvania. He had a ticket for a flight to Paris the very

It was a happily uneventful end to a story that shocked the quiet town of Seaside, Oregon. "I'm leaving town. You'll know why in the morning." It was a phone conversation in the dead of night on July 14, 1997, and was the last word from one of two accused thrill-killers before they turned fugitive. Jesse Carl McAllister and Bradley Charles Price worked dead-end jobs and lived a low-rent life. They shared an apartment not far from the beach in Seaside, Oregon. On the night of July 13, 1997, police say that after watching the film "In Cold Blood," the two men chose a new career path - as killers. They allegedly spent the night tossing back beers and wandering the beach - drifting from one campfire party to another. Almost everyone who was on the beach that night remembers the boisterous duo.
