**Alvaro Humberto Ochoa** (drug charges) -- On March 12, 1993, according to the Maricopa County Sheriff's Department, Alvaro Humberto Ochoa, 43, David A. Loparo, 29, Lowell Edward Smith, 38, and Kenneth Laird, 18, escaped from the county jail. Sheriffs say that Ochoa and his accomplices smashed a window inside a cell and climbed out onto a flat roof. The men dropped a bed sheet line to a co-conspirator out on the street. The accomplice fastened a bag to the sheets, and the men yanked it up five floors. The bag contained tools, and other materials to aid in the escape. Using a large rope, the escapees rappelled about 50 feet and rushed to a waiting van. Three of the escapees were caught days later. Ochoa is still on the loose. Police say he is heavily tied with the Cali drug cartel out of Columbia. Ochoa clearly has access to large sums of money. He may have grown a beard. Ochoa is 47, 5'7" and 160 pounds. (See Shows #331, #369, #422 and #461, OADs 9/10/94, 6/10/95, 8/18/96 and 8/9/97)

**Jamie "Six Fingers" Edwards** (murder) -- Jamie Eugene Edwards is wanted by the Stamford, Connecticut Police Department for the 1995 murder of twenty-one-year-old Benjamin Perez, an up-and-coming boxer. Police say Perez was a constant thorn in the side of Jamie Edwards and other drug dealers in the south end section of Stamford. Perez waged a one-man crusade to rid his neighborhood of drug dealers by confronting and identifying them to officers on patrol. Police say on the night of February 4th, 1995, Perez was driving to his cousin's house when he encountered Jamie Edwards on a corner with other dealers and confronted him. Edwards allegedly fired 11 shots from a semi-automatic 9mm handgun into Perez's vehicle, striking him numerous times. Benjamin Perez died at the scene. Perez would have made his professional boxing debut exactly one month to the day after he was murdered. Jamie Edwards is known as "Six Fingers" because of an extra thumb appendage on his left hand. He disappeared after Benjamin Perez was murdered. He may have shaved his head. He may be driving a 325i BMW convertible. Edwards is 28, 5'11" and 220 pounds. (See Show #12, OAD 2/10/97)

**Unknown** (murder) -- On July 3, 1986, firefighters discovered the body of 24-year-old Teresa Dickinson inside her burned-out apartment. She had been raped and strangled, then placed in a closet and set on fire. The killer struck again in the same apartment complex just

three months later, holding a woman captive and raping her for eight hours. Before releasing her, the man forced her to withdraw cash from her bank. His distinctive profile was captured on the bank's surveillance cameras. The suspect has dark brown, graying hair and intense light blue eyes. He has prominent cheekbones and a long straight nose. During the ordeal, he told his victim he was from Connecticut and that his parents had been murdered. Police are seeking the public's assistance in identifying the suspect. **Mario Pallango (Sexual Battery of a Child)** -- When the eldest daughter of Mario Pallango's girlfriend turned nine in 1992, her life was turned upside down. That was when, police say, Pallango decided she was old enough to rape. Repeatedly, she was made to engage in sexual acts with both Pallango and her mother, according to police. Investigators also maintain that Pallango continued the abuse when the mother was away from their home in Margate, Florida. Three years later, officials continue, the girlfriend's second daughter turned nine, and was similarly physically forced to engage in lewd sexual acts with Pallango and his girlfriend. Now, both girls have been separated from their mother, who is in police custody and has had her parental rights terminated. Pallango, however, disappeared from the Margate area on March 30, 1998. Detectives believe he may be hiding in Orlando, Florida. Pallango, who has used the alias Marco Antonio Diaz, is a native Ecuadorian who speaks English with a Spanish accent, but may pretend to only speak Spanish. He wears prescription eyeglasses, smokes cigars, and drinks Budweiser beer (1-2 six packs a day). Police believe he is no longer driving a car. He may be staying in short term housing. Pallango works as a electrician. If questioned he may say he is fleeing tax evasion charge. Pallango is 49, 5'6" and 270 pounds. (See Show #491, OAD 4/25/98)

**Unknown (murder)** -- Nebraska authorities have the face of Leah Rowlands' killer caught on tape, but they need the public's help in identifying the murderer. Rowlands was working as a cashier at a gas station convenience store in Cozad, Nebraska on March 10, 1997. At 10:30am, a man in a red Pontiac Grand Am pulled up and pumped gas. He was barefoot, and the legs of his dark sweatpants were pulled up to his knees. After filling up, he entered the store area, grabbed some items from the store shelves, then forced Rowlands to empty the cash register. He forced her to lay on the floor, then shot her. Authorities believe the man knew he was been photographed, but didn't care. The suspect may be a smoker; he wore dark sweatpants, a dark hooded sweatshirt, and a dark leather bomber-style jacket. The getaway car was a red two-door Pontiac Grand Am with very shiny chrome wheels. He is in his 20's, 6'0"-6'1" and approximately 200 pounds. (See Show #455, OAD 6/21/97)

**Unknown** (Murder, Robbery, Aggravated Assault) -- At 2 am on May 7, 1998, a man climbed to the second floor balcony of an apartment in Philadelphia's Center City and forced his way in through a sliding glass door. Inside the apartment 23-year-old Shannon Schieber was preparing a bath. Police believe she must have heard a noise, and left the bathroom to investigate. Wrapped in a towel she was utterly defenseless when she encountered the intruder. No one can be certain exactly how long Shannon's ordeal lasted. She was assaulted, raped and strangled. A neighbor heard Shannon's screams and called police. They arrived and knocked on the door, but tragically, when no one responded to their knock, they left. The next day, when Shannon didn't show up for a lunch date, her brother became concerned and went to her apartment. He discovered his sister - her nude and battered body told the story of her painful struggle. The killer stole several items: 100 compact disks, a JanSport backpack, a silver necklace with a cubic zirconia pendant, A Canon Elph camera, and a hand-carved set of inkpens which Shannon's father had lovingly made for her. These could prove to be the killers' undoing. The Cannon Elph camera had serial #0357381. (See Show #514, OAD 10/3/98)

**Robert Malcolm Jackson** (Murder) -- Robert Malcolm Jackson is an accused murderer on the run. There was a time when no one would have suspected Jackson of murder. At Morgan State University in Baltimore, Maryland, Jackson was a bright and serious student. Police say they still don't know what Jackson's motive was, but here's their account of what happened: On June 24, 1998, Robert Jackson met with William E. Gilbert to test drive a 1991 Lexus that Gilbert had advertised for sale in a Baltimore newspaper. Police say Jackson shot Gilbert numerous times, then fled. They say that Jackson didn't steal the car. In fact, they don't believe that Jackson stole anything. Police say Jackson called his girlfriend on July 23, 1998 from Norfolk, Virginia; he phoned again on August 2 from Orlando, Florida. He mentioned that he was headed for Miami and hoped to escape to Trinidad. Jackson nearly always wears a pair of prescription glasses and he has a distinctive tattoo of a British lion on his left shoulder. Jackson, whose nicknames are Sugarshack and Georgie, has used the aliases Malcolm Jackson and R. Jackson. Although he has worn his hair in dreadlocks, it is probably cut short now. He is very intelligent and has worked as a substitute teacher. Jackson is 27, 5'9" and 165 pounds. (See Show #513, OAD 9/26/98)

### CAPTURED:

**Romel Valentino White** (Child Molestation) -- A man who picked on a child is so childish himself, that deputies say he went on the run with his parents. Romel Valentino White is wanted by the Sacramento California Sheriff's Department Child Sexual Abuse detail for 30 counts of child molestation. Deputies say the victim was White's own nephew. The boy told deputies that White had sodomized him many times over a seven year period. The alleged abuse started when the boy was six and continued until he was 13. Three years later, at the age of 16,

White's nephew found the courage to turn him in. On September 23, 1996, Romel White was arrested, but a judge let him out on bond. The case took a strange twist. Deputies say White's parents tried to bribe his victim - their own grandson; they offered him cash to change his testimony at the trial. He refused and the DA's office charged Willie White and Joan Mouton with dissuading a witness from giving testimony, inducing false testimony, and conspiracy. But the law wasn't about to disrupt this tight family circle. On May 5, 1997, Romel White, still out on bail, and his parents fled Sacramento together. In early September, the trio was spotted in Laurel, Mississippi where Willie White has relatives. In September 1997, White's mother, Joan Mouton was caught in San Bernadino, California while allegedly attempting to pass a bogus travelers check. Then, thanks to an alert America's Most Wanted viewer, Willie White was captured in Pittsburg, California. Demonstrating again how the Whites will cover each other's darkest sins, Willie was found at his aging mother's house after the FBI and Pittsburg Police followed a viewer tip. The same tipster continued to feed authorities information about Romel White. White was found in Mexico -- tutoring Mexican school children. He was extradited to Sacramento to stand trial. **Kenneth Sorrell Williams** (Armed Robbery, Conspiracy to Traffic Cocaine) -- Miami-Dade Police are engaged in a dangerous showdown with well-armed soldiers in a multi-gang drug war. It's a war with over 100 casualties; and too often innocent citizens are the victims. Investigators say most of the violence can be attributed to a ruthless gang which goes by the street name, The Boobie Boys. Doesn't sound like a bunch of tough guys, but police say the Boobies alone are responsible for at least 30 murders. So why the name? Boobie? The accused leader of the gang is Kenneth Sorrell Williams. By reputation, he's as mean as a Florida gator, but by nickname, he's Boobie. Boobie has been in serious trouble since he was a teenager. The accused drug lord with the laughable nickname first went to prison for a homicide case when he was still a juvenile. When Williams finished doing his time, he was a young man with a mission; detectives say he set up business making money any way he could - that usually meant drug ripoffs and burglaries. Boobie muscled in on other dealers' territory and methodically rose to the level of drug lord, showing no mercy along the way, say detectives. Boobie seized his authority through force and graphic violence: One crime scene was littered with 99 bullet casings. The gang's signature weapon were AK-47s - a firearm so deadly that the victim is literally pulverized. And when the Boobies were squeezing the trigger, police say everyone in sight was fair game. Five-year-old Michael Frasier was sitting on his mother's lap in her boyfriend's car when the police say the Boobies opened fire on the boyfriend. No one in the car survived. That ruthless style pushed Boobie's empire beyond Miami. DEA agents now say the Boobie Boys have business outlets through most major cities in Florida, into Georgia, through the Carolinas, into Virginia and as far north as Detroit. They believe he's establishing trade in Las Vegas. In February 1998, police were able to tie the Boobie Boys to actual murders and put together an iron-clad case. Now most gang members are either dead or in custody, but Kenneth 'Boobie' Williams and one of his chief hitmen, Leonard 'Bo' Brown are at large. Williams, who also goes by the nicknames "Black Boy" and "High-Tech", has used the aliases Keith Williams and Kevin Miller. He has scars on his stomach from gunshot wounds, and scars on his knees and lower right leg. He hangs out in strip clubs and frequently shows up at boxing matches in Las Vegas. He drives rental cars with dark-tinted windows, and changes cars often. Williams is 28,

5'8" and 165 pounds. (See Shows #513, #515 and #5116, OADs 9/26/98, 10/10/98 and 10/31/98)

**Shad Daniel Armstrong (Murder)**

**Russette Anne Medina (Murder)** -- Armstrong and his girlfriend Rusty Medina have been charged with the 1998 murder of Farah Armstrong, Shad's sister, and her fiance Frank Williams, in the Arizona desert outside of Tucson. Pima County Sheriff's deputies say that on June 15, 1998 the bodies of Farah and Frank were found buried together in a shallow grave in Shad's back yard. They had been shot. Homicide detectives believe that Farah Armstrong was considering turning in her brother for notifying or cooperating with the police regarding Shad's fugitive warrants for concealing stolen property, burglary, and parole violation in Oklahoma and Texas. Shad found out and killed her. Police believe Rusty helped clean up the trailer. Authorities believe Shad and Rusty left Tucson in Farah's Ford Ranger pickup, but think the couple sold it in Tijuana, Mexico. Authorities have tracked the couple to San Diego, Tijuana, Colorado, Oklahoma and Michigan. Deputies say friends and family are worried about the safety of Rusty and the children. Shad Armstrong has used several aliases, including Daniel "Danny" Armstrong, Daniel "Danny" Charles Majors, Charles Majors and Shad Majors. He has three 3" by 2" squiggly black lines tattooed on the right side of his head, and other tattoos on his arms and fingers. He has a stocky build and a ruddy complexion. He is sometimes mistaken for Native American. He sometimes shaves his head or wears a short buzz cut. He has been described as a "sweet-talking con artist", and is known to hang out in topless bars. He has impersonated a US Marshal in the past. Armstrong is 25, 6'0" and 220 pounds. Medina, who is traveling with two children and an infant, may be working or collecting welfare. She is 21, 5'4" and 25 pounds.

**Unknown (Murder)** -- The Nashville country music scene will never be the same; Skull is dead. David "Skull" Schulman was the so-called and widely-loved "Mayor of Printer's Alley," a title he earned by operating one of the best-known clubs in Nashville, Skull's Rainbow Room. The Rainbow Room was lined with photographs of Skull posing with country music's elite--Tanya Tucker, Dolly Parton, Waylon Jennings, Willie Nelson. Skull, 81 years old when he died, opened the Rainbow Room in the 1940s, and jump-started the careers of numerous country celebrities. When the hit show "Hee-Haw" moved to Nashville, he was adopted as a cast member. When he wasn't on the set wearing his overalls or entertaining his club's patrons, he could be seen walking his poodle Sweetie down Printer's Alley. But on January 21, 1998, Skull's long life was suddenly taken from him by an unknown attacker. At 4:30 p.m. that day, the freshly-shaved Skull was picked up by a cab in front of Leonard's Manor Barber Shop and dropped off at his club. An hour and a half later, a cigarette vendor found Skull lying on the floor of his club. He had been cut six times, and his throat slashed. Police found evidence of a fight, but also found that Skull still had his wallet, with more than \$140. Skull hung on to life until 3:10 a.m. During his struggle, Tanya Tucker visited the hospital, and sang "Farther Along" to the dying man. Now, she and the rest of Skull's many friends want a suspect to be named and captured. It is a crime, they say, that shouldn't go unsolved. The unknown suspect spent time in Nashville in January and February 1998. He may be a homeless drifter who lives in shelters and hangs out in nightclubs. He could be working as a bouncer and may be familiar with country music. (See Show #502, OAD 7/11/98)

**Charles "Chase" Bracket** (first degree murder) -- In the fall of 1988, Bracket and his crew took over the drug trade at a housing project in New Haven, CN. To set an example, he and his partner allegedly killed a small local dealer, Kevin Moody, 18 years old. Bracket and his partner then fled to N.Y. where two months later his partner was killed by rival drug dealers, a murder which was avenged by Bracket when he allegedly killed the two rivals. Claiming to have been born in England, he has a slight Jamaican accent. Police say he is a major drug dealer with operations in Manhattan, Brooklyn and New Haven. Known to roll marijuana into hollowed out cigars, he despises cocaine users. He carries his beeper at all times, doesn't eat red meat, likes to drink Asti Spumonte and hangs out at discos. He has black hair, a moustache, brown eyes and is 37, 6'1" and 230-240 pounds.

**Linda Mae Crouch** (Aiding a Fugitive Felon)

**Roger Crouch** (Child Molestation, Fugitive Warrant) -- According to detectives with the Bedford County Sheriff's office, 46-year-old Roger Crouch is wanted for two counts of taking indecent liberties with a child. He was to appear in court in December but never showed. Instead, he took off on December 10th with his 20-month-old son Travis and his 36-year-old wife Linda Mae, who is wanted for aiding and abetting her husband's escape. Crouch is driving a two-tone blue 1985 four-door Ford sedan with Virginia tags YYU 6234. Roger Crouch, a habitual offender who doesn't even possess a driver's license, works as a grounds keeper for golf courses, and as a mechanic. Linda Mae Crouch has a habit of tilting her head to the right while walking. Both Crouches smoke and drink. Roger Crouch is 46, 5'8" and 186 pounds. Linda Mae Crouch is 36, 5'7" and 125 pounds. (See Below)

**Juan Gabriel Valenzuela Reyes** (Attempted Murder, Robbery) -- Juan Reyes is wanted in Oregon by the Multnomah County Sheriff's office for the 1998 robbery and attempted murder of Telena Carrasco. In early October Reyes and Telena got into a car accident. When exchanging information, Telena noticed Reyes did not have the necessary licensing and insurance. When she confronted him with this, cops say he offered to repair her vehicle and drive her back and forth to work. Telena agreed on the condition that Reyes turn over his vehicle title to her until her car was returned. But Reyes never intended to fix Telena's car. On October 7, 1998 Reyes picked her up at work, drove her to an unincorporated part of Multnomah County where he shot her in the chest and stole her purse, thinking that it had his car's title in it. Deputies say Reyes drove off and left Telena in the middle of the road to die. Telena wrapped a coat around her chest to stop the bleeding and flagged down a passing motorist. Telena survived, but Reyes is still out there. Reyes has two fresh puncture marks on the nape of his neck from a broken beer bottle. He has used the aliases Julio Ruiz Neri and Juan Reyes Valenzuela. He has a slight accent. He likes to buy, repair and sell used cars. Reyes may work as a short-order cook, dishwasher or waiter. Reyes is 23, 5'6" and 140 pounds.

**Melvin Menendez-Menendez (Escape)**

**Israel Rivera-Sanchez (Escape)** -- Menendez and Sanchez are wanted by the USMS Puerto Rico Task Force for the 1994 escape from a prison facility in Bayamon, Puerto Rico. On April 11, 1994, Menendez, Sanchez and eight others escaped from a maximum security facility in Bayamon, Puerto Rico, by tunneling through to freedom. Menendez was serving a 30 year sentence for second degree murder, weapons charges, kidnapping and robbery. Sanchez was serving 37 years for robbery, aggravated assault, and second degree murder. Menendez has unknown tattoos on his back and right leg. He speaks Spanish, and may have a moustache. Menendez is 27, 5'7" and 150 pounds. Sanchez also speaks Spanish, and may have a moustache and goatee. Sanchez is 32, 5'9" and 160 pounds.

**AMW ALL-POINTS BULLETINS:**

**Unknown (murder)** -- Authorities are seeking the public's help in solving a mass murder case. On January 8, 1993 an unknown man walked into a restaurant, pulled a gun, and killed the two owners and five employees execution-style, calmly stopping to pick up all the shell casings. He took \$1000 in cash before turning off the power inside the restaurant and disappearing. Evidence shows that he was tall, at least 6'0", and he left footprints from a Nike basketball shoe between size 12 1/2 and 14. Police were unable to trace the fingerprints he left. On February 16, 1997 a similar murder/robbery took place in Nashville. During a second crime in Nashville, the gunman ran out of bullets and used a knife on the remaining employee, who survived by playing dead. Police believe the same person may be responsible for all three crimes. New technology has enabled authorities to lift fingerprints from the original crime site. No suggested changes. (See Show #1023, OAD 5/10/97)

**Alan William Golder (Kidnaping, Robbery, Burglary, Larceny)** -- If you discovered Alan Golder in your house, you might think he had stepped out of the pages of GQ Magazine. In reality, he recently stepped out of prison, and officers hope he will be returning soon. After his feature aired on AMW, a man came forward who may be able to help - the suspect's own brother. Golder's younger brother came forward after seeing Golder's profile on AMW, a profile that filled him with concern. He says that Golder is a danger to himself and others because he simply can't stop committing crimes - he is a jewel addict, the brother claims. The only happy end to this story, the brother told AMW, would be if Golder turned himself in. Well-tanned and well-toned, Golder has made quite a name for himself, allegedly ripping off homes of the rich and famous while mixing comfortably with the rock stars and executives of the Sunset Strip crowd in Los Angeles. He even had an author interview him for a biography as he served time in prison

for murder. But since he was paroled, he has, officials say, returned to what he knows best - burglary. In 1978 Golder allegedly used two accomplices - Boonlert Thanarakol and Surajit Sae Sow - to rob a home in Old Brookville, New York. The robbery left the homeowner dead, and a trail of evidence led directly to Golder, who was convicted and sentenced to 15 years to life. Paroled in 1996 after 16 years behind bars, Golder told his parole officer that he wanted to be a jeweler, bartender, or a fitness trainer, but no one would hire him. Before long, police say, he was underground again, and back at work. Golder is now wanted for over 70 robberies in New England that have allegedly netted him more than a million dollars in cash and jewels. Described as slick, fearless, and cunning, Golder reportedly only strikes when residents are home and alarms are off. While the unsuspecting victims are away from the bedroom, police say he climbs their outside walls with the agility of a chimp, enters the bedroom, loads up with valuables, and escapes undetected. After a string of robberies in Greenwich, Connecticut were reported nationwide, other police agencies came forward with similar crimes. But by then, Golder had apparently slipped away to celebrate his own cunning. Police nationwide are on the lookout for Golder, but they aren't the only ones. Apparently, Golder ratted out some of his organized crime connections when he was taken down for the Old Brookville murder to get a reduced sentence, and they'd like a piece of him as well. But even with all this attention, officials believe that Golder is probably cocky enough to be hiding in broad daylight. He apparently loves the way he looks, and spends a great deal of time in Gold's Gyms and tanning salons. At night, he frequents nightclubs, strip bars, and high-profile parties. He has allegedly convinced himself that crime pays, and it will be up to the police and concerned citizens to prove him wrong. Golder has used the aliases Alan William Kulp and Thomas A. Williamson. He may have "Alan" tattooed between his knuckles. He has a large scar on his right biceps from tattoo removal. He allegedly uses girlfriends as getaway drivers. Golder is a bodybuilder who has worked as a personal trainer and has been a member of Gold's Gym. He frequently changes identity, may have had plastic surgery and may wear a goatee. Golder is 43, 5'9"-5'11" and 175 pounds. (See Shows #487 and #491, OADs 3/28/98 and 4/25/98)

**Eugene Anthony Linder** (Murder) -- When Eugene "Geno" Linder first came to Las Vegas, he decided it was the town for him. After years of seeking the limelight in Detroit and Los Angeles, he had finally discovered a city where the party never stopped. Police say Linder rented a house he couldn't afford, bought a BMW, and attempted to go into business designing clothes. When that didn't pan out, police say he targeted high-end exotic dancers, more for their money than their physique. But the long Las Vegas nights took their toll on Linder's body, mind, and wallet. Police say he became increasingly violent, and came to their attention in 1996, when he allegedly tried to choke his girlfriend during an argument in front of her house. The charges were dropped. One morning in 1997, Linder woke up, hung-over and burnt-out, and decided to take a long look at himself. He turned on his video camera and began creating his own 12-step

program with the ambitious title "My 30 Day Plan for Perfection." He thought that by taping his transformation, he could help others. But police say he stumbled along the way. As the downward spiral of Linder's life grew tighter, he met Devi Ives under unusual circumstances. Linder was visiting a beauty salon to enhance his appearance with inch-long acrylic fingernails, and overheard Devi talking about problems with her Mercedes. He offered to help, and gradually worked his way into this attractive 34-year-old divorced mother's life. Weeks after she started dating Linder, Devi disappeared. Five days later, her body was discovered in the desert. After that, police say they received a tip from a former girlfriend of Linder's who claimed he had confessed the murder to her. Police found signs of a struggle in Devi's bedroom, and concluded that after a fight, Linder had strangled her. "Perfection is inside you," Linder claimed on the tape. "You must let it grow. You must cultivate it and let it spring forth. Believe me, it's growing as we speak." Police say Linder has missed his chance at becoming a perfect person, but would love to see him become a model prisoner. Linder has used the aliases Geno and Mario. He wears a perfectly-trimmed beard and moustache. He is a flashy, meticulous dresser who wears inch-long acrylic fingernail extensions and makeup. He may work as an exotic male dancer or escort, and used to work for professional boxer Thomas "Hitman" Hearns. He is a flamboyant talker who claims to be in the entertainment business, and has worked in retail and clothing design. Linder is 42, 6'0" and 175 pounds. (See Show #505, OAD 8/1/98)

**Mikelle Biggs**

According to detectives with the Mesa Police Department, 11-year-old Mikelle Biggs disappeared from her neighborhood Saturday, January 2, 1999. **CAPTURED:**

**Bertha Marie Keene aka Theresa Grosso - (Murder, Escape) --** Back in 1969, Bertha Keene was a 21-year-old stripper with a wild side. On Friday, September 26, she and two friends went out for a good time in her home town of Baltimore, Maryland. The women made the rounds, tossing back liquor all night long. Keene later claimed she'd also taken LSD. When the party girls reached the last club, the bouncer demanded ID. Incensed, Keene pulled a handgun from her purse and shot him dead. Keene was tried, convicted, and sentenced to the Maryland Correctional Institute for women, but prison bars didn't tame the wild cat. She escaped three times. Each time she tripped up on the outside and was caught and returned. On the third try, she ran to Florida, where she befriended a man named William Palm. He was so smitten that he moved to Maryland, and a home just outside the prison walls. Finally, on August 30, 1979, Bertha Keene made her fourth and final escape. No one was surprised when Palm disappeared with her. Out on the run, the couple married and had a child. But running took its toll and they separated in 1995. Palm eventually surrendered, but charges against him were dismissed and today he's raising the couple's teenage son. As for Bertha Keene, she took off and never looked back. She mentioned to an acquaintance that she'd been featured on AMW; the man told his son,

who informed the FBI. The authorities set up a drug deal sting in which she was captured without incident. Bertha Keene has been returned to the prison from which she escaped the last time, but now she's in an isolated cell where she will finish serving out her life sentence. **Timothy David Young** (Failure To Appear, Rape Of A Child) -- Nashville Metropolitan Police are looking for 24-year-old Timothy David Young. Police say Young was supposed to appear in court on January 11, 1999 for trial on seven counts of rape of a child, but instead disappeared. Police say the charges stem from incidents in 1996 and 1997 when Young allegedly raped three boys. Amazingly, Young worked as a youth services officer for the state's Department of Children's Services between the time he committed the crimes and the time he was charged. Police fear Young may have left town with 13-year-old Jerrod Love, who is missing, and fear for Jerrod's safety (see below). Young has a history of cross-dressing and may be dressed as a woman. He may be wearing red-tinted braided shoulder-length hair extensions, possibly in a ponytail. He may have a moustache. He is known to frequent gay bars. He knows how to use computers and likes to explore on the internet. He may be traveling in a 1985 Dodge Turbo 600 two-door convertible with a black body and tan top, and temporary Tennessee tags. Young is 24, 5'10" and 160 pounds.

**Jennifer Arlene Gibbs** (Escape) -- These four inmates from the Midland County Jail escaped on January 2, 1999 at approximately 9am. Deputies say the three men overpowered one deputy in the maximum security area and took her jail keys. They then made their way down two flights of stairs to the booking area of the jail. There, cops say, they assaulted one deputy by spraying a fire extinguisher in his eyes and threatened another guard with a homemade device that resembled a zip gun. The two deputies were then handcuffed and locked in a holding cell. Deputies say a female inmate named Jennifer Gibbs was using a phone in the booking area and saw the escape. The three men took Gibbs with them out of the jail. The four escapees then took off in a black 1998 Toyota RAV-4. Police have learned that Gibbs, Boyer and Smith are now traveling in a red minivan and were last seen in North Carolina. According to authorities, Dobschensky is responsible for over 140 robberies in central Michigan with the last year. He has

a mole on his nose and a heart tattoo on his chest. He has curly hair which he may have straightened or dyed black. Smith was awaiting sentencing from a recent conviction of first degree criminal sexual misconduct. He has a mustache, but may have shaved his beard and cut his hair short. He has a scar on his left leg. Smith is 30, 5'8" and 160 pounds. Boyer was in jail awaiting trial for assaulting a police officer. He was also serving time for breaking and entering. He has severe acne scars, and several tattoos, including "IGD" with an arrow going through it on his right hand, "13 1/2" on his left arm, "FLB" on the back of his upper left arm, and a pentagram with two pitchforks and tail on his left calf. Police describe him as immature with a "Napoleon complex", someone who needs to prove himself to everybody. He likes to talk gang jargon and "dresses right" -- he rolls up his right sleeve or tucks his right pant leg into his socks in imitation of gang style. He has a buzz cut. Boyer is 18, 5'8" and 160 pounds. When last seen, all three men were wearing blue jeans and white t-shirts. Gibbs was in jail waiting trial for breaking and entering, and armed robbery. She has a scar on her right hand, and tattoos of a dot on her right hand and a heart on her stomach. She is described as very moody, and likes to show off her body. Gibbs is 18, 5'9"-5'10" and 130-145 pounds.

**Unknown (Murder)** -- In September 1997, a hunter preparing for deer season in Asheville, North Carolina, stumbled across a ladies wristwatch deep in the woods. He stooped to pick it up and scanning the area, he discovered some bones. At first he thought nothing of it; wild animal carcasses are common in the wilderness. But next the hunter saw a horrific sight: some of the bones were wrapped in tattered clothing. These were human bones. We now know this was the remains of 50-year-old Judith Smith. Police are hoping for answers in a case that has only questions. All we know is that sometime in April 1997, someone killed Judith Smith and buried her in a shallow grave in the woods of Asheville. The rest of the story only compounds the mystery. That April, Jeff and Judith Smith started on a trip from Boston to Philadelphia, where Jeff was attending a pharmaceutical conference. Judith had never seen the city of brotherly love, and was looking forward to a day of sightseeing. But right away, they ran into problems. Jeff says that Judith reached Boston's Logan Airport before discovering she had forgotten her ID. They wouldn't let her on the plane, so she said she would take a cab home and get on a later flight. At 9:30 that night, Jeff says they met at the DoubleTree Hotel in the Center City neighborhood of Philly. He says they ate pizza in the hotel room, and went to bed. The next morning, Jeff continues, he left her in the room as she was getting ready to shower. Jeff was due back around five. He says he never saw Judith again. That night as the hour grew late, Jeff called the Philadelphia Police Department to search for his missing wife. They found not a single clue, and the longer they searched, the more suspicious detectives became that they were

being led on. Jeff Smith knows that his story is suspect, and thinks the cops' suspicions are "ludicrous." But Philadelphia detectives are holding on to their doubts. "Personally," says Detective James Sweeney, "I don't feel she was here in Philadelphia." Detectives haven't found anyone on the plane from Boston who remembers seeing Judith. Two witnesses remember seeing Judith at the DoubleTree - but police call these witnesses unreliable because the timing of their sightings just doesn't fit Jeff's story. Detectives couldn't find any of Judith's dirty laundry in the hotel. They didn't find any of Judith's personal effects on the bathroom sink, except for a bag of curlers. Some of Judith's clean clothing was hanging in the hotel room closet, but a female detective and a female photographer each doubt that a woman placed them there. In their opinion, no woman would hang her dresses the way police found them. After the Philly cops wrapped up their investigation, Jeff started his own. He obtained lists of homeless shelters, hospitals, and social service agencies. He made up 10,000 flyers and even got an 800 number in an effort to find out what had happened to his wife. Eventually, he did. A doctor in North Carolina saw one of Jeff's flyers and realized that an unidentified body in Asheville could be Judith's. Dental records confirmed his hunch. Judith had been located, but this discovery only raised more questions. There is no record of Judith traveling to Asheville by plane or rental car. Witnesses in the small town - at a motel, at a shop - remember seeing her in town, apparently enjoying herself. But locals maintain that the remote location where she was discovered is the last place a visitor would go. No buses travel to the area, no cabs extend their service that far out. The only nearby structure is a cabin owned by shop owners in the town where Judith was spotted. Clues at the crime scene included tennis shoes, a blanket, food wrappers, sunglasses, a blue and black backpack, a book, a water bottle, and a cereal box. Investigators believe that Judith, and maybe a companion, came out to this location to spend the day. The blue and black backpack is especially interesting - Judith's backpack, which she traveled with for years, was red. Also at the crime scene, investigators found a pair of sunglasses. Could they be the killer's? They're made by Bolle and retail for at least \$100. Judith's family says they aren't hers and she'd be unlikely to spring for such an expensive pair. Police believe the sunglasses could belong to either Judith's killer or someone who witnessed her murder. There are several unsolved riddles for law enforcement in this case: Did Judith ever make it to Philadelphia? How did she get to Asheville? Whose backpack was found at the scene? Why would she come to Asheville in the first place? And finally, why would anyone kill her? Police are hoping an America's Most Wanted viewer can provide even the smallest scrap of evidence - it may mean another mystery solved. (See Show #504, OAD 7/25/98)

**Unknown** (Murder or Accidental Death) -- The world-famous Vidocq Society is named in honor of Eugene Francois Vidocq, a fascinating 18th century French detective who was a confidante of writers Victor Hugo and Honore Balzac. Headquartered in Philadelphia, the

Vidocq Society has 82 members -- one member permitted for each year that Vidocq lived. Members come from 17 US states and 11 countries. They take on the toughest cases - and crack them. Now AMW has joined forces with Vidocq to help solve a cruel and troubling mystery. It's a case that began on February 24, 1957 -- a bitter cold Philadelphia morning. In a desolate and rural area there was an unofficial dump - a place where anyone and everyone left the detritus of their lives. Most mornings it was household garbage or rusty car parts. On this morning, it was The Boy in the Box. One of the first detectives on the scene was Detective Sam Weinstein. All these years later, he's still haunted by the vision of the tiny, malnourished boy. His nude body had been wrapped in an Indian blanket and placed in a cardboard box. In an effort to find his identity, detectives tenderly dressed the tiny boy in a typical outfit and photographed him, hoping the simulation of life might help someone recognize him. The entire city of Philadelphia was touched by the boy's plight, but no one ever came forward to identify him. The boy's death could have been accident...or murder. Only the perpetrator can know for sure. To this day, his identity and his cause of death remain a complete mystery. Here are the primary clues: His age can only be guessed at - he had a full set of baby teeth and may have been 3 - 6 years old. His heritage was most likely north western European or Scandinavian. He had never been inoculated with any of the vaccinations most children his age received. He had been circumcised and had scars in the groin and ankle area that were indicative of some type of transfusion or other medical treatment. The boy was badly malnourished and his body was covered in bruises. He had marks around his head -- as though a strong adult may have pressed in his forehead. One of his hands looked as though it had been soaking in water. Forensic technicians call the wrinkling the 'washer woman' effect. Though he was nude, he seemed quite clean, as though he'd just been bathed. His nails were cut very close. His hair too had been recently cut quite short. Each meager clue was carefully followed. The Indian-pattern blanket in which he was wrapped had been manufactured in North Carolina. It was a fairly typical and common blanket for the time. The cardboard box in which he was found had held a bassinet from J.C. Penney. Many detectives speculate that whoever abandoned the boy at the dump, found the box there. They feel it's unlikely that the box was brought to the dump with the body. So why wasn't the boy buried, or hidden more effectively? Some Vidocq members believe that the trash dump area held some symbolism for whomever left the boy there. It's possible that the dump was a staging area - the perpetrator wanted the boy to be found, but didn't want the boy to be identified. Was it a stranger or his own parents who left him there? Some Vidocq members believe it was his own parents. They speculate that the boy was a 'problem' for the family from the start. His body indicates ongoing health problems - either through natural illness or as a result of abuse. This theory operates on the basis that the extremely short hair and nails may have been some sort of punishment. Maybe that punishment went too far and a strong hand holding the boy by the head literally squeezed the life out of the him - that theory explains the contusions on his forehead, but what about the washerwoman effect on his hand? Was the boy washed after death? A sort of

burial preparation? Or did he die in water? One theory: as a cruel punishment, someone forced the boy to sit in a bathtub far too long. On a cold February night, a skinny toddler could quickly die of exposure in cool water. Because the possibility of a connection to the parents seems so strong, Vidocq member, Frank Bender created a bust of how the boy's father may have looked. Bender is the forensic sculptor behind the bust of John List - the infamous killer from New Jersey who took the lives of his entire family. The bust is based on the facial features of the boy and drawn from Frank's decades of experience and well-honed instinct. It's a shot in the dark, but maybe after all these years someone will recognize this man. If the boy's identity is learned he will at least have a name on his headstone and maybe the mystery of his death will be solved. On November 4, 1998 the Philadelphia police exhumed the boy's body from Potter's Field to obtain a DNA sample. Police say the boy's DNA will be compared to the DNA of any suspects who are identified in the future. The boy's DNA may also be compared to possible family members of the boy. The boy was reinterred on Veterans' Day, November 11, 1998 at the Ivy Hill Cemetery. (See Show #514, OAD 10/3/98)

**Paul Carpenter** (Murder, Attempted Robbery, Carjacking, Sexual Assault) -- Paul Carpenter is wanted for the murder of a German tourist who was gunned down during a street robbery in Santa Monica, California. On October 12, 1998, detectives say Carpenter and three accomplices tries to rob fifty-year-old Horst Fietze, his wife, and two traveling companions near Loews Santa Monica Beach Hotel. As his horrified wife and friends watched, Horst was shot and killed during a struggle with the robbers. Three of the suspects, including the admitted gunman, have been apprehended but Carpenter is still on the run. Carpenter is also a wanted man in Spartanburg, South Carolina. On January 19, 1996 he was charged with sexually assaulting a thirteen-year-old girl. Carpenter was arrested but posted bail and fled. When he resurfaced again in April 1998, Spartanburg Sheriff's investigators say Carpenter carjacked a man at gunpoint, pistol-whipped him, then shot at the terrified motorist as he jumped from the vehicle and ran for his life. Then investigators say Carpenter stripped and torched the car. Carpenter is considered armed and extremely dangerous. Carpenter has used several aliases, including Jason Anderson, Paul Talar, Jhon Tlor, Lamar Johnson, and John Anderson. He wears his hair in dreadlocks, just above shoulder length. He is a member of the Rollin 30's Harlem Crips street gang. Police say he both uses and deals in marijuana and other drugs. Anderson is 21, 5'9" and 150-160 pounds.

**Unknown** (Bank Robbery) -- The FBI is looking for a bank robber described as calm,

congenial, armed, and dangerous. As this suspect enters the bank, he appears to be the most pleasant customer to grace the teller's window. Often, he discusses opening an account for a business, opening an account for his wife, or just getting some change rolled. Once the tellers are charmed and off-guard, out comes a black semi-automatic pistol. After this point, there's no need for him to be polite. Agents say that this robber has ripped off eleven banks in as many cities, all within 200 miles of Kansas City, Missouri. Banks in Kansas, Nebraska, and Missouri have met with his dubious charms. He always carries a plastic grocery store bag, which he typically hands to the trembling teller. His travel patterns and demeanor suggest a traveling salesman who has found a lucrative sideline. So far, no one has been shot, but after he was surprised in Web City, Missouri when a customer walked into a robbery in progress, he forced the customer to the floor. These sort of unexpected surprises will, agents say, lead to someone getting hurt or killed. The suspect has a medium build, wears his hair short or clean cut, has a neatly-trimmed mustache and wears wire-rimmed glasses. He wears a thick gold wedding band on his left ring finger, and usually sports a baseball cap, wind breaker, sweat shirt, khaki pants, and loafers. He carries a cellular phone clipped to his pants or belt. He appears knowledgeable about construction and small business. The suspect is in his mid-30's to early 40's, 6'2"-6'3" and 220-230 pounds. **MISSING:**

**Jerrod Deshawn Love**

Age: 13

Height: 5'4"

Weight: 120 pounds

Thirteen-year-old Jerrod Deshawn Love has been missing from Nashville, Tennessee since January 11, 1999. Police say he never showed up at school that day and fear he may be traveling with 24-year-old Timothy David Young, an accused child molester on the run (see above). Police know Jerrod and Young had a close friendship, and aren't sure whether Jerrod went with him willingly or not. Jerrod has hazel eyes and a slight gap between his two upper front teeth. He loves wrestling and watching wrestling on TV, and likes to play basketball and run. When last seen, he was wearing black jeans, a brown and white striped shirt, a yellow coat, white sneakers a gold chain and a black backpack. He may be traveling in a 1985 Dodge Turbo 600 two-door convertible with a black body and tan top, and temporary Tennessee tags.

**CAPTURED:**

**Jeffrey Scott Durham** (Armed Bank Robbery, Grand Theft, Resisting Officer) -- Jeffrey Durham is wanted for a string of bank robberies that are remarkable for their precision timing, and frightening for the high-grade military style hardware used by the suspects. So far, police say, Durham has successfully robbed five banks and attempted a sixth. Police and the FBI fear, with each robbery growing more violent than the last, that it is only a matter of time before Durham's weapon claims a life. According to officials, Jeffrey Durham has been promoting himself in the criminal underworld for most of his life. Allegedly starting with small-time burglary and auto theft, police say that by 1992 he had his eyes on bigger prizes - and had an unusual scheme for getting them. Police in Florida claim that he was one of the boldest thieves they have ever seen - scaling the outside walls of million-dollar condos and making off with the goodies inside. Even after an informant fingered Durham, even after constant surveillance was established, the cops still couldn't catch him in the act. Durham, they allege, had connections that allowed him to run the plates on undercover cars. Once their cover was blown, Durham would actually taunt the officers watching him. Eventually, the cops had enough, and were able to put him away for possession of stolen property. He was convicted and sent to prison, but, officials claim, he was far from learning his lesson by the time he got out. His next career move, they say, would take him out of low-profile robberies and directly into the spotlight. Allegedly taking his inspiration from the Robert DeNiro role in the movie "Heat," Durham reportedly partnered himself with a man named Lloyd Clayton for the bank heists. Police say the pair always arrived in a stolen van and armed themselves with AK-47s. They then reportedly donned boots, gloves, masks, and a flight suit, and completed the uniform with FBI jackets to serve as a distraction in case the real authorities showed up. Once at the bank, witnesses say their timing never faltered. Clayton would allegedly watch the door and the clock while Durham reportedly jumped the counter and stuffed his bags. The operation never took more than 55 seconds, with the Clayton allegedly keeping a close watch on the time. If the patrons didn't move fast enough, witnesses say, the robbers would immediately start letting loose with their powerful guns, injuring tellers behind the counter. But robbing banks wasn't the only way Durham got attention. Authorities say that after his second robbery, he found time to make an appearance on the "Jerry Springer Show", for an episode about men who fall for transsexuals. Durham was one of those men. His appearance on the show was a brazen act, considering that he was allegedly again on the wrong side of the law, but perhaps he thought nothing could go wrong. Finally, following a September 5, 1997 robbery in St. Petersburg, Florida, something went wrong. One of the tellers slipped a dye pack in with the money, and tainted the entire score. Thinking he could pass this dirty money, Clayton reportedly used it to pay a cab in Clearwater, Florida after a night of heavy partying. This led police directly to his hotel room, where he was arrested. They say he later confessed to his part in the robberies, and fingered Durham. But the most disturbing piece of

information he told police was that Durham is determined and driven to never go back to jail. He claims anyone who tries to stop Durham will spark a firefight, and Durham will keep firing until he is free or dead. Durham was finally tracked down to Covington, Kentucky, where the FBI says he was living with a girlfriend and her child. Durham was one step ahead, but agents say he left behind plenty of evidence - two AK-47s, masks, and more dye-stained money. From Covington, agents claim, Durham moved on to Florence, Kentucky, where he allegedly stole a Green Ford Explorer from a dealership, using a fake ID to get a test drive, and made his getaway complete. After the profile reaired last December, a tipster informed authorities that Durham was using the alias John Pettry. An explosion in Durham's private arsenal sent him to the emergency room in Santa Barbara, California with third-degree burns, where he checked in as Pettry. The suspicious ER nurse called police. Even after being identified, he attempted to bribe the police to allow him out of the hospital. (See Shows #491 and #521, OADs 4/25/98 and 12/12/98)

**UPDATE:**

**Christina Williams** -- The body of Christina Williams was discovered earlier this week, just a short distance from her home. At 7:45 PM on Friday, June 12th, a witness observed a frightened girl sitting in a late-70's or early-80's light gray car, identified as either a Mercury Monarch or a Ford Granada. Two males were also in the car. Later, the witness saw a flier about the missing girl, and realized that the young female in the car was Christina Williams. The men spotted in the car closely matched composite sketches of the two suspects. The first witness to come forward was a woman who claimed that she was jogging in the area on June 12 at about the same time Christina left home, and was verbally accosted by two Asian men in their 20s riding in a older-model four-door car. She described the color as gray, or perhaps painted with gray primer. The car bore an old-style California plate, with a blue background and gold letters. Police and FBI consider these two men suspects in her disappearance. The second witness has confirmed the jogger's observations of the suspects and the car. Based on these sightings, police have released the following descriptions of the suspects: The heavy-set suspect has dark brown hair, cropped short on the sides and with a half-inch flat-top. He has pudgy jowls, a shiny sheen to his skin, and a reddish skin tone, as if he has a sunburn. The suspect with slight build has dark brown hair, olive skin tone, red blemishes on his lower cheek, prominent cheek bones and a slight mustache. His hair, worn gelled and unkempt, falls over his face. Christina Williams left her parents' home at 7:30 p.m. on Friday, June 12, 1998 to walk her dog. At 8:15 p.m., Christina's mother discovered the dog by itself near the residence. Christina, however, was nowhere to be found. At 8:30, Christina's father called the Presidio of Monterey Police (POMP). Over that first weekend, the FBI, POMP, Monterey County Sheriff's Office, concerned

**Jeffrey Vincent McGee (Murder)** -- Police say that on the morning of January 20, 1999 Villa Rica Police Captain Robbie Bishop was shot and killed during a drug interdiction stop along interstate I-20 in Carroll County, Georgia, west of Atlanta. McGee fled the scene in a black Chevrolet Blazer, with New York tags, but police say the vehicle was recovered in Birmingham, Alabama later that day. Police believe McGee boarded a plane that stopped in Houston, Texas where he transferred to another plane that made stops in El Paso and San Antonio before landing in Los Angeles. Police recovered McGee's luggage in LA and in it discovered a bullet-proof vest. McGee has a scar on his left arm and a discolored left ear. He has used several aliases, including Travis McGee, George V. Harrison and Jeffrey Harrison. Authorities say he should be considered armed and dangerous. McGee is 32, 5'6"-5'8" and 140-150 pounds.

**Unknown (Murder)** -- At least one, possibly two or more men are wanted for the murders of 77 women in Juarez, Mexico. Almost 200 women have disappeared or have been found dead in the desert outside of Juarez, just south of the U.S. border, near El Paso. A suspect is under arrest for the murders: Abdul Latif Sharif, an Egyptian chemist who recently moved to Juarez from Texas. But subsequent to his arrest, more women were killed. Evidence led police to a Mexican gang called "rebeldes" or rebels. Police theorize that Sharif may have paid the gang to continue to kill women while he was in jail in order to indemnify himself. Even after the rebel gang was put behind bars, other women have been killed, leading police and experts to believe that there are others acting as copycats in the area. The victims are all Hispanic, with dark hair, eyes and complexion. They are strangled, sometimes with their own belts or shoelaces; sometimes their hands are bound. The women have been raped and tortured; some have had their left breasts bitten. Some have had their left shoes removed. The victims have been found buried in shallow graves.

The two companies were fierce competitors in the lucrative custom-lowrider car parts supply industry. On the morning of March 3, 1997 one of the men entered Lowrider Hydraulics and asked to see the owner. When sixty-year-old Leonard Miller walked out to the counter he was gunned down. The hitmen implicated David and Ruben Lopez as the men who had hired them to kill Steve Miller. Before police could arrest them, the Lopez brothers packed up their families and disappeared from Long Beach. Both brothers have used the surname Ramirez. David Lopez has a stocky build and long, flowing hair. He is married to Clara Elena Lopez; they have four children. David Lopez is 38, 5'4" and 176 pounds. Ruben Lopez wears a goatee and has long flowing jet-black hair. He is described as a workaholic. He is married to Margaret Elaine Lopez; they also have children. Ruben Lopez is 42, 5'8" and 180 pounds.

**Timothy David Young** (Failure To Appear, Rape Of A Child) -- Nashville Metropolitan Police are looking for 24-year-old Timothy David Young. Police say Young was supposed to appear in court on January 11, 1999 for trial on seven counts of rape of a child, but instead disappeared. Police say the charges stem from incidents in 1996 and 1997 when Young allegedly raped three boys. Amazingly, Young worked as a youth services officer for the state's Department of Children's Services between the time he committed the crimes and the time he was charged. 

He has used several aliases, including Travis McGee, George V. Harrison and Jeffrey Harrison. Authorities say he should be considered armed and dangerous. McGee is 32, 5'6"-5'8" and 140-150 pounds. **Hazel Leota Head** (Murder, Arson) -- Hazel Leota Head is wanted for the murder of Charles Barker on September 2, 1998 in Benton, Louisiana. Barker was shot in the back of the head as he sat at his trailer counter. Police found a murder weapon and say physical evidence points to Hazel Head. Hazel had met Barker at a local casino under the name Deianna Ray. She subsequently moved in with him. When Barker's body was found, his cash and his car were

gone. Upon further investigation, police found that there was an outstanding warrant for Hazel's arrest in Nebraska, where she is accused of burning down a boyfriend's trailer. Police also learned that Hazel has a history of moving around. She has been married multiple times, to as many as ten different men. She has lived all across the country. Head has many aliases, including Hazel Morgan, Willow Shields, Hazel Foley, Kelly Morgan, Hazel Spurbeck, Hazel Haynes, Hazel Vincent, Deianna Ray, Hazel Woodman, Hazel Fautch, Treasa "Tess" Jean Coyle, and Treasa "Tess" Venable. She has a noticeable gap between her front teeth. She is a smoker and drinker, favoring vodka. She often works as a waitress, and hangs out a truck stops, often traveling with truckers. She frequents casinos and places personal ads looking for men. Head is 49, 5'2" and 120 pounds.

**John Milton Feiga, Jr. (Grand Theft Auto, Murder)** -- In 1995, John Feiga and Erica Richardson met, dated, and eventually Feiga moved into Erica's new suburban Tampa home in Valrico. Feiga is described as a smooth talker, a ladies man who showered Erica with flowers, love notes and gifts. But his hidden dark side soon came out and Erica's family said Feiga became possessive and violent. He was arrested twice for battery and Erica filed a restraining order on him in 1996. On December 8, 1997, Erica's mother, Imogene Richardson, called her daughter who worked as the manager of the Valrico Wal-Mart pharmacy. Imogene was told Erica didn't come to work and hadn't called. Imogene went to her daughter's home. The blinds were shut and no one answered the door, but when she peered into the kitchen window, Imogene said she saw blood and a knife. Erica's body was discovered in the hallway next to the kitchen. Detectives say she was stabbed 62 times. Erica was thirty-three years old at the time of her death. Detectives said Feiga was missing and so was Erica's Honda. Two weeks later, Erica's car was found in a hospital parking lot in Lafayette, Louisiana, about 60 miles north of New Orleans. Coincidentally, Feiga grew up and still has family nearby in a tiny town called New Roads. Feiga has an outstanding warrant for his arrest for grand theft auto, and detectives want to question him about Erica Richardson's murder. Feiga has a pierced left ear and may have shaved his head. He has several tattoos, including "Feiga" on the back of his left hand, "John" on his left leg, and "JF" on his left forearm. He has worked at the Tampa Electric Company power plant as a technician. Feiga is 38, 5'10" and 183 pounds. (See Show #522, OAD 12/19/99)

**Tibis Kneipp (Murder)** -- Kneipp is wanted in the 1998 strangulation, stabbing and beating murder of 23-year-old Nicole Holm in her Fort Collins, Colorado home. Detectives say Nicole was making phone calls from various pay phones around Ft. Collins early in the morning of September 9, 1998. She was trying to get money to help bail her boyfriend out of jail. Around 2:00am, surveillance video captured Nicole and Tibis Kneipp in a 7-11 and again at 3:19am in another 7-11. Later that morning, a prowler was reported in Nicole's neighborhood. Kneipp was found in the area but later released by police when the caller could not positively ID

him. The following day, when Nicole's boyfriend was released from jail, he returned to the apartment he shared with Nicole and found her beaten, strangled and sexually assaulted. Days later, police filed charges against Kneipp but he had already fled. Kneipp has used several alias, including Tibis Knoop, Tibis Gambs, and Scott Samles. He has several tattoos, including "FEAR" on the knuckles of his left hand, a bracelet on his left wrist, a heart with a sword on it on his left knee, the letters "CI" with a marijuana leaf on his left knee, a half fish-half bird on his left ankle, and face with a blank expression on his left arm.. Kneipp is very thin and may have taken on the "gothic" look with long black hair, but he changes his appearance frequently. He is bisexual, reportedly into bondage, sadism and masochism, and is suspected of another rape in Ohio. He is intelligent, articulate, cunning and manipulative, but has bi-polar disorder and is mentally unstable. He frequents coffee houses, alternative night clubs and 24-hour restaurants. Authorities say he drinks, smokes, and uses various drugs. Kneipp is a musician who plays keyboards; he has also worked as a temporary laborer, sprinkler installer, vacuum cleaner salesman, waiter, cook, at a printing company and as a backhoe operator. Kneipp is 23, 6'2" and 140 pounds.

**Unknown (Murder)** -- In the small, peaceful town of Portageville, Missouri, residents were kind and trusting - most never even locked their doors. But on May 11, 1998 an unthinkable crime turned that all around. Tony Scherer returned home from the fields to find his wife Sherry and his 12-year-old daughter Megan dead. Megan had been sexually assaulted. Police say that there were no signs of forced entry - that the killer probably took advantage of the trust that runs through small communities like Portageville to get inside the house. Perhaps he asked for directions, perhaps he said he wanted to use the phone - but all along his intention was to kill two innocent strangers. A break in the case came shortly after the gruesome discovery, and was provided, police say, by the killer himself. On the same evening, only 30 miles away in Dyersburg, Tennessee, a man in a dark-colored van pulled up to the trailer of local woman to ask her for directions. Suddenly, he drew a gun and shot her. Luckily, she survived, and police matched the bullets from the two crimes. The Dyersburg victim and other residents in the area were able to work with a forensic artist who sketched the face of this cold-blooded killer. Police say that this unpredictable man is probably looking for his next victim. He has been described as soft-spoken, and witnesses say he doesn't appear threatening. He may ask for directions, he may ask for help in locating a friend, but he should be considered extremely dangerous. The suspect may be wearing thick prescription glasses, and may be a construction worker. He has a slight build, and was last seen driving a mid-80's dark colored America-made van. The suspect is about 5'5" tall. (See Show #496, OAD 5/23/98)

**Unknown (Murder)** -- The Memphis Police Department is looking for the driver of a white, light grey, or light blue bob truck with the word "advantage" written in red lettering on the

side. Police believe the driver of this truck is responsible for the death of Patricia Woodall. Police say on January 4, 1999, the driver of this bob truck struck Patricia Woodall while she was standing on a median attempting to cross an intersection. The truck struck her at a high rate of speed and then fled. Patricia was pronounced dead at the scene.

**Monte Kim Miller** -- Miller is not wanted by the police for any crimes. Israeli authorities fear he may attempt to bring about serious acts of violence. Miller believes he will be shot dead in the streets of Jerusalem sometime just before the millennium. He is well-funded and living on the money of his eighty-plus followers, who mysteriously cut off all family ties on October, 1998. Miller uses biblical threats to extort money from his followers and from non-believers. Miller leads a group called Concerned Christians, and talks of himself as God, frequently making religious threats. He wears glasses and usually dresses very casually. Miller always goes by "Kim", never by "Monte", and answers to "The Lord Your God". He is 46, 6'4" and 190 pounds.

### AMW ALL-POINTS BULLETINS:

**Dennis Nathaniel Rabbitt** (Forcible Rape - 41 counts) -- Rabbitt is wanted for 15 rapes in and around St. Louis, Missouri. Just this week, Rabbitt has been identified as the "South Side Rapist" who has been attacking and raping women since 1988. Since September 1988, an unidentified masked man has been beating and raping women in middle to upper middle class areas of Missouri and across the Mississippi River in Collinsville, Illinois. Because 10 out of the 20 plus attacks happened in south St. Louis, media ad dubbed the attacker the "South Side Rapist". In October 1998, St. Louis City Police were called in when a man was seen breaking into a house. Eyewitnesses placed a van registered to Rabbitt leaving the scene of the break-in. When the cops brought Rabbitt in for questioning, they thought he fit the physical description of the South Side Rapist. To prove it, they needed a DNA sample. Rabbitt agreed to have his mouth swabbed for the sample. Within twenty hours of the break-in, police had failed to charge Rabbitt with the breaking and entering, so they had to release him. They also couldn't hold him while they waited for DNA results. Rabbitt took advantage of the delay and went on the run. He was last seen on November 7 at a motel in Joplin, Missouri. On November 10, the DNA results were returned and positively identified Rabbitt as the South Side Rapist. Rabbitt, whose nickname is "Bunny", has used the aliases Mike Mathis, Richard Fuedner, and Diego. He is a former marathon runner whom police say would jog to and from his assaults, but he has put on considerable weight. He is a fanatical sports fan, especially Missouri University football, and an avid gambler. He has worked as an asbestos remover. He may be driving a faded red 1985 Datsun Sentra. Rabbitt is 42, 5'11" and 260 pounds. (See Shows #518 and #520, OADs 11/14/98 and 12/5/98)

**The Mystery of James Hughes** -- Investigators in Mobile County, Alabama are trying to figure out the circumstances behind the 1995 mysterious death of welterweight boxer James Hughes. Sheriff Jack Tillman says that on July 24, 1995 Hughes had reverted to his old addiction, crack cocaine. He says that Hughes cashed checks at five locations around Mobile, possibly to buy drugs. Tillman says that at 9:00am the following morning, Hughes was captured on surveillance tape at a local bank withdrawing \$100. After that, cops suspect he drove to an area of town known as "The Bottom", a seedy area known as a drug hangout. By noon on July 25, 1995, police found Hughes' red pickup truck by a set of railroad tracks in The Bottom. Hughes was gone. For twelve days cops searched for the body, before finding it on August 6, 1995, in a marshy area by the railroad tracks. Due to decomposition, the autopsy was undetermined so investigators do not know whether Hughes was murdered, died due to a drug overdose or anything else.

**Mark Donald Hoosier (Sexual Assault On A Child)** -- The FBI is looking for Hoosier, an accused pedophile wanted on child molestation charges in Colorado. In 1980, Melissa Guthrie married Hoosier. When they divorced twelve years later, their daughter Audrey came forward and told her mother that Hoosier had molested her since she could remember. Finally, in 1994, charges were filed against Hoosier around the same time he was due to earn his Master's Degree in aviation. When he didn't show up for graduation, an UFAP warrant was issued. He was arrested in 1996 attempting to reenter the United States but later that year he fled before a court appearance. Once again, an UFAP warrant was issued. Through investigations, agents have learned Hoosier has molested numerous children including his own sister. Agents also have learned that Hoosier has defrauded a Tulsa bank and his mother out of \$9,000. To this day, his mother doesn't believe he is guilty. Agents believe he is in Canada, the site of one of his reported molestations. Hoosier has used the aliases Dan Kirby and Jeffrey Hartung. He has a tattoo of a naked angel on his left shoulder. He has a receding hairline and usually wears a goatee. Authorities describe him as sexually compulsive, a man who tries to establish relationships with single mothers with young daughters aged 5 to 12. He does not physically threaten his victims, but rather convinces them that the sexual relationship is proper. He acts extremely religious when he wants to control his compulsions. Hoosier loves the outdoors, and is very mobile -- he can pack up and leave within 24 hours. He is charming and intelligent. He is an aviation fanatic who may be working as a pilot or plane mechanic; he has also worked as a caretaker at a motel. Hoosier is 39, 6'1" and 190 pounds.

According to investigators with the Tacoma Police Department, two-year-old Teekah Lewis disappeared Saturday, January 23, 1999 from the New Frontier Lanes bowling alley in Tacoma, Washington. That night, Teekah was last seen around 10:15pm as she was playing in the arcade section of the bowling alley just a few feet away from her family. Teekah's mother, Teresa English, says she looked away for just one minute and then discovered her daughter was gone. So far, an intensive search has turned up no concrete leads in the case. Detectives have no suspects. The FBI has been brought in on the case. Teekah is a shy and quiet child who loves candy. When last seen, she was wearing a green "tweety bird" sweatshirt, white sweatpants, black and white "Air Jordan" sneakers and was carrying a clear purse with a fish design and a shoulder strap.

**CAPTURED:**

**Roderick Natile** (Murder) -- The New Orleans Police Department says Natile shot and killed 41-year-old gospel singer Raymond Myles on October 11, 1998. Witnesses told police that Myles left his townhouse at around 10pm, dressed casually in silk shorts, a t-shirt and sandals. Police say that Myles was spotted in the St. Bernard housing project where he grew up around 11pm. Myles was found dead around 11:30pm at the corner of Chartres and Elysian Field Avenues. Myles' car, a white 1998 Lincoln Navigator, was found two days later abandoned two miles away near Bruxelles and Industry Streets. Myles was a well-known gospel singer in the New Orleans area, and was recently praised by Billboard Magazine as being on the brink of success. He had released three well-received albums, "New Orleans Gospel Genius Vol. 1", "A Taste Of Heaven", and "Heaven Is The Place", and was the choir director at Abramson High School. Myles was an outspoken anti-violence advocate and often sang at crime victims' funerals. When Natile realized police were closing in on him, he surrendered. (See Show #516, OAD 10/31/98)

**UPDATES:**

**Philip Noel Johnson** (robbery, kidnapping) - On Saturday, March 29 armored car driver Johnson reported to work as usual, then proceeded to tie up two coworkers and emptied a vault

of \$20 million. Johnson, a loner, had worked as an armored car driver for ten years. On August 21 an alert Customs Inspector in Brownsville, Texas became suspicious when Johnson tried to cross the border under an alias, and he was arrested. However, the money was still missing. Authorities believed Johnson stashed it somewhere between Jacksonville, Florida and Ashville, North Carolina. The cash was found in a storage locker near Ashville. Last week Johnson was sentenced to twenty-five years in federal prison. (See Shows #1020, #456 and #466, OADs 4/19/97, 6/28/97 and 9/20/97)

**John Stephen Huggins (murder)** -- On June 10, Carla Larson drove her 1995 white and grey Ford Explorer to a local market where she purchased her lunch. She never returned to her office. Witnesses reported that they had seen a strange man drive Larson's car out of a wooded area. Two days later, her body was found. Her jewelry and her car were missing. A unique gold pendant, comprising the letters C and R with a small diamond, was one of the pieces missing. The car was found June 26 in Cocoa Beach, Florida. It had been set on fire, perhaps in an attempt to obliterate clues. AMW viewer Angel Huggins realized that the suspect police were seeking was her estranged husband John Huggins. During a vacation to the Kissimmee area, John disappeared for a time; when he returned he was driving Carla Larson's white Explorer. Angel called AMW and turned in her husband. Detectives located Huggins in Maryland where he was in jail on petty theft charges. After he was extradited to Florida, Huggins began confessing -- not to the murder of Carla Larson, but to a string of bank robberies. However, Carla Larson's missing jewelry has been found and police say they can positively link it to Huggins. Huggins is currently on trial. (See Shows #456 and #468, OADs 6/28/97 and 10/4/97)

**Alis Ben "Joe" Johns (murder)** -- Police say that Johns was out drinking and cruising back country roads with his girlfriend, Beverly Guerher and his friend Tommy Stewart. An argument erupted and police say Johns killed Stewart, then disappeared into the woods. Five months later Johns murdered an elderly farmer and stole his truck, then kidnapped Guerher. A week later another woman was found murdered. On April 7, two Missouri State Water Patrol officers located Johns and Guerher at a vacant hunting cottage near Lake Of The Ozarks, where Johns was shot in a confrontation with authorities before being apprehended. Last Thursday a jury sentenced Johns to death. (See Shows #1016, #1017 and #1021, OADs 3/15/97, 3/22/97 and 4/26/97)

### **FIGHTING BACK:**

**Thomas Gordon Jones (murder; armed robbery)** -- This criminal is the only fugitive of a 5-member gang responsible for the death of State Senator Alva Brumfield. Jones was on the run

for nearly 25 years. Authorities found him living in Houston under the name Paul Joseph Banks. Brumfield's daughter, Julia Sims, is waging a campaign to bring Jones to justice: although he has been in custody for more than two years, he has yet to go to trial. (See Shows #214, #265, #354 and #1016, OADs 5/15/92, 4/23/93, 2/27/95 and 3/15/97).
