Robert Leach attacked a young girl, then beat and strangled two women to death in their home. After he killed the women, he stole their truck. Tibis Kneipp was wanted by the Fort Collins, CO police for the murder of twenty-three year-old Nicole Holm. After AMW profiled him three times, a tipster called in and Kneipp was caught in Guatemala. An unknown suspect brutally murdered Elaine Dardeen, her newborn daughter, and her 3-year-old son in their Illinois home. Then, police say the suspect drove her husband Keith to an undisclosed location and murdered him as well. Keith's body was found in a field 15 miles away from the Dardeen home. Railroad killer Rafael Resendez-Ramirez was wanted by authorities in several states. On July 12, 1999 he turned himself in. Authorities say thirteen-year-old Nicholas Barclay disappeared from San Antonio, TX, on June 13, 1994. He had been playing basketball with some friends. AMW shows video of one of the biggest police takedowns in San Diego, California.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Unknown (Bank Robbery) B On June 2, 1999, a man dressed as a priest robbed a bank in Davis, California. At 9:07am on Wednesday, June 2, a man posing as a priest entered a US Bank in Davis, California. He was dressed in a black shirt with a white collar, a grey sports coat and was carrying a bible. The ABible Bandit@ approached the teller and handed her a note claiming there was a gun in his bible. After the teller read the note, the bandit opened the book which had a hollow cutout that revealed a small semi-automatic pistol. The ABible Bandit@ demanded money and the teller handed it over. FBI agents and police believe the suspect hid in some nearby bushes and then fled the area. The suspect has a stocky build and was clean shaven. He may wear wire framed glasses. The suspect is 40-50, 5'8" and 220 pounds.

Unknown (Murder) -- In the small, peaceful town of Portageville, Missouri, residents were kind and trusting - most never even locked their doors. But on May 11, 1998 an unthinkable crime turned that all around. Tony Scherer returned home from the fields to find his wife Sherry and his 12-year-old daughter Megan dead. Megan had been sexually assaulted. Police say that there were no signs of forced entry - that the killer probably took advantage of the trust that runs through small communities like Portageville to get inside the house. Perhaps he asked for directions, perhaps he said he wanted to use the phone - but all along his intention was to kill two innocent strangers. A break in the case came shortly after the gruesome discovery, and was provided, police say, by the killer himself. On the same evening, only 30 miles away in Dyersburg, Tennessee, a man in a dark-colored van pulled up to the trailer of local woman to ask her for directions. Suddenly, he drew a gun and shot her. Luckily, she survived, and police matched the bullets from the two crimes. The Dyersburg victim and other residents in the area were able to work with a forensic artist who sketched the face of this cold-blooded killer. Police say that this unpredictable man is probably looking for his next victim. He has been described as soft-spoken, and witnesses say he doesn't appear threatening. He may ask for directions, he may ask for help in locating a friend, but he should be considered extremely dangerous. The suspect may be wearing thick prescription glasses, and may be a construction worker. He has a slight build, and was last seen driving a mid-80's dark colored America-made van. The suspect is about 5'5" tall. (See Shows #496 and 527, OADs 5/23/98 and 1/30/99)
Nelson Yester (Conspiracy to Distribute Cocaine, Racketeering) -- When federal agencies uncovered an alleged plot to supply Colombian drug smugglers with hard-core

ex-Soviet military hardware, agents say Nelson Yester's name was all over it. The amazing story unfolded in the nick of time around a Miami nude bar named Porky's. Behind a stage draped with sweaty strippers, agents say the club's owner, Russian immigrant Ludwig Fainberg, and alleged drug cartel insiders Nelson Yester and Juan Almeida cooked up a profitable plan. Exotic cold war weaponry, they reportedly realized, could be used to crank up the heat in the war on drugs. This alleged meeting of the minds brought together, perhaps for the first time, Russian Mafia members with connections to the former Soviet military and Colombian cartels, desperate for new ways to get their cargo into U.S. waters. These new modes of transport allegedly included helicopters and airplanes, but the package's main selling point was reportedly a Tango-class Soviet attack submarine. Capable of underwater speeds of 20 m.p.h., fully-loaded with eight torpedo tubes, and nearly undetectable when submerged, this submarine is a smuggler's dream and the DEA's nightmare. Luckily, the equipment was never delivered. But agents say that meetings took place, and the team was ready to sell to the highest bidder when they were broken up by a long-running investigation. Fainberg was indicted on over 30 counts linking him to the Russian Mafia. Almeida was also arrested and made bail. But Yester, the one agents say was the main figure on the South American side, got away. A master of disguise and fluent in three languages, Yester could be anywhere. Investigators now believe he is traveling under the name Hector Santana with a British passport. Yester has used the aliases Tony Nelson, Hector Santana, and Martinez. He changes his appearance frequently and may wear a mustache or beard. He is a stylish dresser who wears expensive suits, usually without a necktie, and Rolex watches. A former Cuban Air Force pilot, he has also worked in the automobile business. Yester is 40, 6'2" and 200 pounds. (See Shows #1014 and #496, OADs 2/24/97 and 5/23/98)

Unknown (Murder) B Fairfax County police are looking for a white male, possibly of Middle Eastern descent, who may know something about the triple homicide of Fraud, Dorothy and Lee Taima. He is the last known person to see the family alive and, according to witnesses, was in the house at the time of the murders or minutes before. On May 26, 1999, Dorothy Taima was home when this man came to her house. Witnesses say that around 10:00pm that night, Dorothy paged her 16-year-old son Leigh and asked him to come home. She told Leigh that a friend of his father's was in the house and she felt uncomfortable. Leigh returned home around 10:00pm. Neighbors heard gunshots at 10:45pm but never called authorities. On Friday, May 28, 1999 Leigh's friends went looking for him because he wasn't in school. When they arrived at the house they saw the bodies and called police. Police say the three of them, Fraud, Dorothy and Leigh were shot multiple times in the upper body. Police are investigating all theories. Fraud Taima was an international businessman and dealt frequently with Iraqi officials and businessmen. Police are trying to determine if the Taima family was killed as a result of a bad business deal. The suspect is in his 50's, clean shaven, with a short to heavy build.

Enrico Ponzo (Attempted Murder, Conspiracy to Distribute Cocaine) -- For more than 40 years the Mafia in Boston operated under the tight control of godfather Raymond Patriarca, Sr. When he died in 1984, the mob in Boston spun out of control. As ruthless men fought for control, blood began to run. The violence escalated at breakneck speed, and the FBI says an up-and-coming mobster named Enrico Ponzo eagerly joined in the murder and mayhem. Ponzo's accused of the attempted murder of "Cadillac" Frank Salemme, the murder of Richard Devlin and of conspiring to murder 12 others. Ponzo's alleged crime spree reached critical mass in September 1994. He was traveling with mob associate Michael Romano, Jr., and the pair was stopped by a flat tire. As Ponzo went for help, Romano Jr. was gunned down. Romano Sr., police say, then conspired with Ponzo to take his revenge on small-time gangster Joseph Souza, who was hit in a phone

booth in East Boston. As the mobsters fell like dominoes, law enforcement did the best they could to stop the flow of blood. On April 18, 1997, the FBI issued a 40-count indictment against 15 accused mobsters in Boston. Enrico Ponzo is the only man still at large. Agents say he should be considered armed - and very dangerous. Ponzo is 30, 5'8" and 160 pounds. (See Shows #1021 and #496, OADs 4/26/97 and 5/23/98)

John Ruffo (Failure To Appear For Service For Sentence) -- John Ruffo is wanted by the FBI and the U.S. Marshals Service for bank fraud, money laundering, wire fraud, and conspiracy. Ruffo and associate Ed Reiners developed an elaborate scheme which defrauded more than 10 banks of 350 million dollars. Reiners, a former employee of Phillip Morris, went to several banks and pretended that he was in charge of a top-secret project for the tobacco company. Ruffo was in charge of purchasing computers for this phantom Aproject@. Reiners and Ruffo used the money that they borrowed from the banks to invest in the stock market, but lost miserably. Over the course of two years, the Aproject@ grew and grew. Nine U.S. and international banks were on board. The con men met with vice presidents from these banks, convincing them to hand over hundreds of millions of dollars to the bogus operation. The plan unraveled when an official from a Japanese bank called Phillip Morris and asked for Reiners. He was shocked to hear that Reiners hadn't worked there in almost three years. The con men were arrested and convicted. Reiners is currently serving a sixteen and a half year sentence. On November 9, 1998 Ruffo failed to surrender as scheduled at a federal prison in Fairton, New Jersey. Later that day, Ruffo's rental car was found at JFK airport. Ruffo has numerous aliases, including Joseph Paul Russo and Bruce Gregory. He has an obvious cleft in his chin and needs glasses or contact lenses. He is a cop buff, loves the FBI and Aespionage@, and is described as a loner and secretive. Ruffo is 44, 5'5" and 170 pounds. (See Show #529, OAD 2/13/99)

James Vincent Sullivan (Murder) -- James Sullivan is wanted for murder by the Atlanta Police Department and the Georgia Bureau of Investigation in the contract killing of his wife, Lita McClinton Sullivan. Police believe on Friday, January 16, 1987 at approximately 8:15am, Phillip Harwood, a hitman hired by Sullivan, rang the doorbell of Lita's condominium in the Buckhead community of Atlanta. When she opened her front door Harwood, posing as a flower delivery man, shot her in the head with a 9mm semi-automatic pistol, killing her instantly. Lita and Sullivan were involved in a turbulent divorce which entailed a large settlement of money on Lita's behalf. At the time of the murder Sullivan resided in Albermarle, North Carolina and was not considered a suspect. However, Phillip Harwood was arrested a short time later and confessed that Sullivan had indeed hired him to murder Lita. When Sullivan found out Harwood had been arrested he fled to Costa Rica before police could obtain an arrest warrant. In April 1998 police finally obtained an arrest warrant but Sullivan was nowhere to be found. Police know Sullivan still has a home in Costa Rica, but they believe he could be anywhere in the world. Sullivan is frugal to the point of being miserly, but he likes to live the lifestyle of a millionaire. He likes to hang out at bars and resorts frequented by the rich and famous. Sullivan is 58, 5'10" and 125-165 pounds. (See Show #528, OAD 2/6/99)

AMW ALL-POINTS BULLETINS:

Paul Carpenter (Murder, Attempted Robbery, Carjacking, Sexual Assault) -- Paul Carpenter is wanted for the murder of a German tourist who was gunned down during a street robbery in Santa Monica, California. On October 12, 1998, detectives say Carpenter and three accomplices tried to rob fifty-year-old Horst Fietze, his wife, and two

traveling companions near Loews Santa Monica Beach Hotel. As his horrified wife and friends watched, Horst was shot and killed during a struggle with the robbers. Three of the suspects, including the admitted gunman, have been apprehended but Carpenter is still on the run. Carpenter is also a wanted man in Spartanburg, South Carolina. On January 19, 1996 he was charged with sexually assaulting a thirteen-year-old girl. Carpenter was arrested but posted bail and fled. When he resurfaced again in April 1998, Spartanburg Sheriff's investigators say Carpenter carjacked a man at gunpoint, pistol-whipped him, then shot at the terrified motorist as he jumped from the vehicle and ran for his life. Then investigators say Carpenter stripped and torched the car. Carpenter is considered armed and extremely dangerous. Carpenter has used several aliases, including Jason Anderson, Paul Talar, Jhon Talor, Lamar Johnson, and John Anderson. He wears his hair in dreadlocks, just above shoulder length. He is a member of the Rollin 30's Harlem Crips street gang. Police say he both uses and deals in marijuana and other drugs. Carpenter is 22, 5'9" and 150-160 pounds. (See Shows #525 and #526, OADs 1/16/99 and 1/23/99)

Chester Leroy Todd (murder) -- Todd, an ex-convict who spent 15 years in prison for murder, left a Denver bar with 27-year-old Sherri Majors on March 16. Majors' body was found in an alley two days later. She had been beaten and strangled. When Todd learned homicide detectives wanted to talk to him, he fled. His abandoned truck was found in Sioux City, Iowa, and contained crucial evidence linking him to the crime: Sherri Majors' blood. Police are investigating whether Todd may be responsible for several other unsolved murders. Todd might be working as a long-haul trucker. He fancies himself a guitar player and may be working as a musician. He also enjoys gambling and frequents casinos. Todd is 55, 5'10" and 200 pounds. No suggested changes. (See Shows #421, #453 and #526, OADs 8/11/96, 6/7/97 and 1/23/99)

UPDATE:

Unknown (Murder) -- On April 4, 1997, 10-year-old Anthony Martinez was abducted at knife point from an alley behind his home in Beaumont, California. For two weeks, the entire community held their breath. Then on April 19, news finally came - Anthony's body was found about 70 miles away in a remote desert area in the Indio Hills. His hands and feet had been taped together. Police say that the abduction was so bold and brazen that someone out there must have seen or heard something that could help law enforcement track this disturbing killer. Anthony was playing with several friends when a thin white male with a mustache approached and asked the children in a soft but distinctive sing-song voice if they'd seen his lost cat. The stranger showed a photo of a cat and as the children gathered to look, he pulled out a knife and grabbed Anthony. The abductor threw Anthony into a white 4-door compact car with recent California plates and sped off. The suspect is a white man with a thin build who's between 25 and 35 years old. He has striking blue eyes and he "sings" his words as he speaks. Because of the remote location of the body, investigators believe the killer is familiar with the area. From the tape that bound his young victim, investigators were able to obtain a partial thumbprint - but so far this clue has not matched any print in the database. (See Shows #1019, #1020 and #496, OADs 4/12/97, 4/19/97 and 5/23/98)

CAPTURED:

Francis Joseph Riley (Armed Bank Robbery) -- FBI agents are looking for a bank robber who likes to blend in. His methods and manner, however, are unmistakable.

As he walks into a bank, he looks just like any other well-dressed businessman on his lunch break from work. But "Tierob," as agents call him, seems to think his work is making large withdrawals at gunpoint. Tierob has so far hit at least 20 banks in 19 cities with alarming regularity. Agents remark that he seems to think he is just going in to cash his paycheck. He waits in line like any other customer, but when he reaches the teller, he hands her a note and shows his shiny pistol. His notes ask for a specific amount of money - usually in the range of \$5,000 -- and demand that the teller wait a specified number of seconds before sounding the alarm. Agents fear that Tierob may be growing bored with his work and professional demeanor. During recent robberies, he has grown more threatening, and on one occasion, he spun his pistol like a roulette wheel, and dared the teller to grab it. Following the initial broadcast, an anonymous tipster gave authorities "Tierob's" name: Francis Joseph Riley. Riley has a history of bank robbery going back nearly thirty years. Tipsters led authorities to a motel in Sedona, Arizona where he was captured on May 8, 1999. (See Shows #488 and #490, OADs 4/4/98 and 4/18/98)

STREET SMART

Highway Hunters -- Rest stops dot the highways of the US, from Maine to Southern California. They provide a needed break for millions of drivers every day, but they also provide criminals with an easy place to find their next victim. These predators are highway hunters. Here are some key rules for everyone to follow:

-If you stop at a rest area at night, make sure the brush near the parking or facilities is completely cleared back. Make sure the area is well lit - it should look like daylight. If it isn't cleared and well lit, don't stop.

-When at a rest stop, stick to the parking lot and the facilities. Don't wander off to the trees, shrubbery or gardens - not even to walk your dog.

-Don't ever allow your children to go into the restroom alone, play while you nap, or "go explore." (Of course these are rules for every public place.)

PROFILE OF A VICTIM

If you're a woman, the scum in society see you as an easy target - highway hunters are no different. A woman traveling alone and not paying attention to her surroundings is most vulnerable. A highway hunter who cases rest stops watches for women who are alone, or alone with children. They'll generally follow their targets out of the rest stop, then look for an opportunity. The two most common ruses: Play "good Samaritan" and get you to pull over for a supposed flat tire; impersonate a cop and get you to pull over. Sadly, many women are fooled by these tricks and fall prey to rapists.

MAKE YOURSELF LESS VULNERABLE

-Before you get in your car, do what a cop does - take a look around. Look for anything that doesn't belong...like someone who stares at you in a way that makes you feel uneasy.

-Once you're in your car, keep paying attention and always check your rear view mirrors - like a cop, watch your back. Did someone who was staring at you also pull out behind you? If they did, trust your gut instincts and double back into the rest area. Make sure there are lots of people around - someplace where you'll be safer and a predator won't want to stop.

WHAT IF A HIGHWAY HUNTER TARGETS YOU OUT ON THE ROAD?

-What if a car pulls up beside you and the driver motions to you that you have a flat tire? Don't let anyone trick you. Do YOU feel as though you have a flat tire? Do you hear a problem with your car? If you don't - don't stop.

If you do feel as though your car actually has a problem, go ahead and pull over - but DON'T get out of the car. Keep the doors locked and the engine running. If the person who motioned you off the road stops and tries to help, tell them you have everything under control. And remember - even with a flat tire, you can drive in an emergency. If he tries to force his way into your car, drive off. If you do have a flat, it will be bumpy ride, but you'll be safer.

-What if someone claiming to be a cop tells you to pull over? How do you tell a real cop from an impersonator? Remember, impersonators rarely have a "marked car" or a uniform. They'll often flash a badge or a gun, or yell out their window that they're a cop. Ask yourself this question, "What are the odds that a "plain clothes" cop would be out on this highway, flashing a badge or a gun and wanting to talk to me?" A real plainclothes cop will call for a marked cruiser to come make a traffic stop. Don't stop for a guy in an unmarked car flipping his badge at you through the window.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Terry McIntyre (Sexual Assault, Robbery) B From January 19, 1998 to the present, an unknown black male has robbed and assaulted female clerks at twenty-two shoe stores and dollars stores in the Kansas City area. Police have positively linked Terry McIntyre to one of these robberies/assaults and say he is a suspect in the rest. The assailant hides in the store until closing time and pistol-whips the female clerk, demanding cash. He then fondles her breasts, thighs and buttocks. He is described as verbally abusive, and he is getting bolder with each robbery. The suspect has already shot two victims in the Kansas City area. He has been seen leaving the crime scene in a variety of cars including a red 2-door Saturn or Camaro, a white/powder blue 80's Caprice with Dayton Silver wheels, and a black Ford pickup truck. Although police cannot positively identify McIntyre in all the instances they believe he is the most likely suspect and are looking to question him. McIntyre has a medium scar in the center of his chest, a small scar beside his left eye and another on his right knee. He wears thick-rimmed black tinted glasses and sometimes wears a thin mustache. McIntyre is 39, 5'7" and 162 pounds.

James William Kilgore (Possession of Explosives) -- In the 1970's Kathleen Soliah and her boyfriend James Kilgore joined the Symbionese Liberation Army (SLA). The SLA was a terrorist group best known for kidnaping heiress Patricia Hearst, who later joined them. In May of 1974 six members of the SLA were killed during a shootout with the police during which the house in which they were hiding caught fire. Despite the fire, they refused to surrender. After the shootout, only three members of the group were left: William and Emily Harris, and Patricia Hearst. The group needed new members, and they were soon joined by Kathleen Soliah and James Kilgore. Soliah and Kilgore played a major role in the SLA's next wave of terror. In August 1975 three patrol cars blew up in San Francisco. In her memoir Patricia Hearst admits helping plant one of those bombs. The SLA then moved their campaign to Los Angeles. After a pipe bomb failed to detonate under a police cruiser parked outside a Sunset Strip Restaurant, the LAPD ordered an inspection of every patrol car in the city. Several bombs were found before they exploded. A month later, the FBI closed in on the SLA in San Francisco, capturing the Harrises and Hearst. However, Kathleen Soliah and James Kilgore eluded the authorities. Soliah was recently captured in Minnesota. Kilgore has been on the run for 25 years. There is a \$25,000 reward for information leading to his arrest and conviction. Kilgore is an accomplished athlete, skilled at basketball and golf. He has worked on a sports book. He has two children, but nothing is known about their

mother. He has also worked as a house painter and a cook. Kilgore is 51, 5'10" and 175 pounds. (See Shows #542 and #547, OADs 5/15/99 and 6/19/99)

Unknown (Murder) B Police in Ina, Illinois are looking for the killer or killers who murdered the Dardeen family. On November 16, 1987 someone entered the Dardeen family trailer on a farm on the outskirts of Ina, Illinois. The perpetrator(s) beat Peter Dardeen, age 3, his mother Elaine Dardeen and her unborn child to death. They then kidnapped Keith Dardeen 29, and drove him to another location in the family car. Police arrived at the scene two days later when family and friends voiced concern that they had not heard from the Dardeens. Upon entering the trailer they found the bodies of Peter, Elaine, and her new born baby girl. Police believe Elaine gave birth during the assault and the child was also beaten. Right away officials started looking for Keith as a suspect. But the next night, a mile south of the house, hunters found Keith=s body in a soybean field. There were three bullets in his head and his penis was chopped off. His car was found a mile up the road, completely wiped down. Police are baffled because the perpetrator(s) left no evidence except a baseball bat that was completely fingerprint-free. The only other clue is a suspicious man seen in the area wearing military fatigues and a beard.

Alan Lee Echols (Murder) -- Alan Echols is wanted for the murder of his best friend and coworker, Ron Nichols. Echols fell in love and had an affair with Ron=s wife Billie. Echols became so obsessed with Billie that he began plotting Ron=s murder to get him out of the picture. On October 12, 1990 Ron Nichols took Billie out to dinner at Bonanza and dancing at club 95. Echols was waiting at Club 95. When Ron went out to his car to retrieve Billie=s ulcer medication, Echols attacked him, stabbing him 61 times. Eight days later Echols was captured and confessed to the murder. He was found guilty of first-degree murder, which carries a mandatory life without parole sentence, but was then released on bond to await sentencing. He never showed up in court again. Echols has a long scar on his outer right thigh from a car accident, and another on his knee from the insertion of a metal pin, and limps slightly as a result of the accident. He has pockmarks on his jaw area from acne. Echols is very shy and doesn=t like crowds. He embarrasses easily, turns beet-red when embarrassed and pale white when worried. He has a habit of running his hand through his hair from his forehead back, and often uses the expression ATell me that=s wrong@. He wears button-down plaid shirts, jeans and cowboy boots. He loves cars, especially Ford Mustangs, and may attend summer car shows. He likes fixing up cars to sell and enjoys racing remote-control cars. He also collects baseball cards. Echols is 34, 6'2" and 155 pounds. (See Shows #202, #229, #329 and #415, OADs 2/28/92, 9/4/92, 8/20/94 and 6/29/96)

Ronald Singletary (Murder) B Singletary is wanted by the Wilmington, Delaware police department for the murder of 21-year-old Wayne Reaves. On March 9, 1998, Reaves was standing on the street talking with friends. At approximately 9:30pm, a white minivan pulled up to Reaves and his friends, and a gunman opened fire. Witnesses later identified Singletary as the gunman. Police say the shooting was provoked by an earlier verbal altercation between Singletary and a third party about drug turf. The third individual was one of the people Reave was talking with when the shooting occurred. Police believe the third person, not Reaves, was the intended target of the drive-by. Singletary has used the alias Ronald Wagner and the nickname APhilly Ron@. He is a disc jockey. He is known to carry guns and wears bullet-proof vests. Singletary is 29, 5'9" and 210 pounds.

UPDATES:

Sandy Murphy (Murder)

Rick Tabish (Murder) -- On September 17, 1998 Las Vegas casino owner Ted Binion's 26-year-old girlfriend, former topless dancer Sandy Murphy, came home and found Ted dead in their Las Vegas home. There was an empty bottle of Xanax lying by him, and police say there was heroin paraphernalia found in the bathroom. Everyone assumed Ted's years of fast living and his battle with heroin addiction finally caught up with him, but the coroner ruled the death undetermined. Two days after Ted died, sheriffs in Pahrump, 65 miles outside of Las Vegas, discovered three men digging up a huge underground vault. Inside the vault was over four million dollars worth of silver bars and coins. That previous July, Ted had buried the silver. One of the men unearthing the silver was 33-year-old Rick Tabish. Tabish was a former employee of Ted Binion's and he was reportedly having an affair with Ted's girlfriend, Sandy. Obviously, the circumstances surrounding Ted Binion's death were suspicious. On March 18, his death was officially ruled a homicide. Since the original broadcast, both Murphy and Tabish have been arrested and charged with the crime. (See Show #542, OAD 5/15/99)

William Bradford Bishop, Jr. (Murder) -- Bishop is wanted on five separate counts of murder in connection with the bludgeoning deaths of five members of his family at their home in Bethesda, Maryland. On March 2, 1976, a Forestry Service employee from Tyrrell County, North Carolina responded to the scene of a fire and found the bodies of the Bishop family -- Brad Bishop's wife, mother, and three sons -- buried in a shallow grave. A shovel found at the burial site was traced to a hardware store in Potomac, Maryland and the gas can to a Bethesda, Maryland Sears store. On March 8, 1976 police in Montgomery County investigating the family disappearance found the murder scene. Bishop's fingerprints were matched to those on the gas can. The family's station wagon, used to transport the bodies, was found abandoned near the Elkmont Mountain Campground, just outside Gatlinburg, Tennessee. New information from State Department files indicates that Bishop may have fled with the help of a female accomplice, who may have been on parole from a North Carolina prison. Bishop likes to work out several times per week. He is a strong skier, plays tennis, and is fond of hiking and the outdoors. He is an amateur pilot and enjoys riding motorcycles. He reads extensively and may keep a diary or journal. He is described as intense and self-absorbed, and may be subject to violent outbursts. He may seek psychiatric care for depression or anxiety, and may suffer from insomnia. He likes a neat and orderly environment. He trained as a military intelligence officer, and is well versed in economic analysis and self-hypnosis. He speaks fluent Italian, Serbo-Croatian, Spanish and French. He drinks scotch and wine, and is known to enjoy spicy foods. Bishop is 61, 6'1" and 180 pounds. After AMW aired an age-enhanced bust of Bishop, a viewer gave authorities a prime tip, but didn't leave his or her identity. Authorities want to talk to this person again. MISSING:

Kathlyn Elizabeth Poirier

Age: 19
Weight: 115 pounds

Height: 5'4"

Investigators are searching for Kathlyn Elizabeth Poirier, who was abducted in Moose Lake, Minnesota by an unknown man. Poirier was abducted at approximately 11:30pm on Wednesday, May 26, 1999 from D.J.'s Expressway, a combination Conoco station and Subway sandwich shop on Interstate 35. Poirier was the only employee working at the time. A video surveillance tape captured the abduction on film. The tape revealed an unknown man as he wrapped his hands around Poirier's neck and forced her out of the store. Witnesses came up with a composite of a suspicious man seen in the area when Poirier was kidnapped. He is described as a white male in his late teens or early 20's, with a slim build and strawberry blond curly hair. He wore a New York Yankees jersey with number 23 on the back, light colored pants and walking or gym shoes. He drove a dark colored pickup truck with an extended cab. When last seen, Kathlyn AKatie@ Poirier was wearing a white short sleeve t-shirt with a Minnesota State Lottery emblem on the left shoulder, black and white Nike cross trainer pants, a silver hoop and black ball navel ring, two silver hoops earrings in her right ear and two silver hoops plus another hoop on the upper side of her left ear. She has a scar on her left inner arm from surgical staples used to repair a broken arm, and a large tattoo in black and red on her lower back. She has shoulder-length brown hair. On June 23, 1999 50-year-old Donald Blom was charged with Poirier's kidnapping. Although authorities say Blom has a long history of sex convictions, he is maintaining his innocence. To date, Kathlyn Poirier is still missing. However, unidentified human remains have been found on Blom's property. (See Shows #545 and #547, OADs 6/5/99 and 6/19/99)

Nicholas Patrick Barclay

Age: 18

Height: 4'8" (at time of disappearance)

Weight: 80-85 pounds (at time of disappearance)

Nicholas Barclay disappeared from his hometown of San Antonio, Texas on June 13, 1994. He vanished after playing basketball with some friends. Nicholas was 13 years old at the time. For three long years there were virtually no leads in the case. Then in October of 1997, the case took a strange turn. San Antonio police got a call from a man in Linares, Spain saying Nicholas Barclay was there at a youth shelter. He said Nicholas had come there after escaping from a sex ring of kidnapped children, enduring years of physical and sexual abuse. Shortly afterwards, Nicholas's sister flew to Spain to bring her brother@ home. Back in San Antonio, the story quickly began to unravel. The San Antonio FBI got involved in the case, and in February of 1998, they fingerprinted ANicholas@. The fingerprints later revealed that this man claiming to be Nicholas Barclay was really Frederic Bourdin, a Frenchman with a criminal history. Bourdin was arrested and pleaded guilty to charges of passport fraud and perjury. Now authorities are still left with one baffling question: what happened to the real Nicholas Barclay?

Nicholas Barclay has an AX@ tattooed on his left hand, a AJ@ on his right shoulder, and ALN@ on the inside of his right ankle.

CAPTURED:

Tibis Kneipp (Murder) -- Kneipp is wanted in the 1998 strangulation, stabbing

and beating murder of 23-year-old Nicole Holm in her Fort Collins, Colorado home. Detectives say Nicole was making phone calls from various pay phones around Ft. Collins early in the morning of September 9, 1998. She was trying to get money to help bail her boyfriend out of jail. Around 2:00am, surveillance video captured Nicole and Tibis Kneipp in a 7-11 and again at 3:19am in another 7-11. Later that morning, a prowler was reported in Nicole=s neighborhood. Kneipp was found in the area but later released by police when the caller could not positively ID him. The following day, when Nicole=s boyfriend was released from jail, he returned to the apartment he shared with Nicole and found her beaten, strangled and sexually assaulted. Days later, police filed charges against Kneipp but he had already fled. Following the initial broadcast, a friend of Kneipp=s told AMW that Kneipp was in Mexico, but once again he had fled before authorities could locate him. Using the alias Thomas Gambbs, Kneipp fled to Livingston, Guatamala. A local woman heard of Kneipp=s bragging about being involved in a murder. To keep an eye on him, she hired Kneipp to read fortunes in her restaurant, then checked him out on the AMW website. She called the US Embassy, which sent authorities to Livingston who captured Kneipp as he was tending his employer=s garden. Because Kneipp had no passport, Guatamala extradited him to the US for trial. (See Shows #527 and #528, OADs 1/30/99 and 2/6/99)

James Joseph Semaan -- (Sexual Assault - 2 Counts; Risk to a Minor) -- Police in Danbury, Connecticut haven't seen James Joseph Semaan for 13 years. But they remember him well. Detectives describe Semaan as 'one of the strangest people they've ever met.' A self-proclaimed 'Doctor of Astrology,' he was a marriage counselor who advised his clients based upon celestial indications. He lived in a peculiarly-shaped home which locals called 'the mushroom house.' He rented out rooms to females who he called his 'bees.' Second wife Lynda, held the special title of 'Queen Bee.' Until August 29, 1983, Semaan was just the town eccentric. But on that date, Danbury Police received a call from the Rape Crisis Center. Semaan's ex-wife told them she had discovered that her daughter, Onae - then just 10 years old - and her best friend had each admitted to having been molested by Semaan and Lynda. On September 7, 1983, James and Lynda Semaan were arrested and charged with sexual assault and risk to a minor. They were released on bail and they disappeared before their February 1985 trial. Authorities found James and Lynda Semaan in Connecticut where they are awaiting trial. (See Show #513, OAD 9/26/98)

Angel Maturino Resendez (aka Rafael Resendez-Ramirez) (Wanted for Questioning) -- Resendez-Ramirez is wanted for questioning regarding the 1997 murder of Chris Maier in Lexington, Kentucky. He is also wanted for questioning in several other homicides, all committed near railroad tracks. In the early morning hours of August 29, 1997, 21-year-old University of Kentucky student Chris Maier and his girlfriend ASarah@ were attacked as they walked along the railroad tracks. Lexington-Fayette police say Resendez-Ramirez bludgeoned Chris, and beat and raped Sarah. Both were left for dead but Sarah managed to escape to a nearby house. In the last few weeks the VICAP computer linked the Maier murder to the string of recent murders in Texas. The first murder in Texas was in 1998. Dr. Claudia Benton was killed in her West University Place, Texas home, which was a few hundred years from the railroad tracks. Sometime on the evening of December 16, 1998 someone broke into Dr. Benton=s house, assaulted her sexually and stabbed her to death. Her assailant took her red Jeep Cherokee which was later found in a parking lot in San Antonio, Texas. The next murder occurred on May 2, 1999 in Weimar, Texas, also near the railroad tracks. Weimar police say in the early morning hours of May 2, someone broke into Pastor Skip

and Karen Sirnic=s house and brutally bludgeoned the sleeping couple with a sledgehammer. After Skip and Karen were killed, the suspect stole their red Mazda pickup truck, which was later found in San Antonio, Texas. Police were able to match DNA found at the Sirnic=s home to DNA found at the home of Dr. Benton. Also, fingerprints found at the Benton crime scene matched those of Rafael Resendez-Ramirez. On Friday, June 4, 1999 the body of Josephine Konvicka was discovered in her Schulenburg, Texas home which is about 3 2 miles from the Sirnics. Fayette County sheriff=s deputies say the 73-year-old was also bludgeoned. Ramirez=s fingerprints were found in the house. Then on Saturday night, June 5, 1999 the body of 26-year-old Noemi Dominguez was found in her Houston bedroom by her brother after she failed to show up at a family function in Dallas. Houston police say she was also killed by a fatal blow to the head. Investigators believe she had been dead since late Thursday or early Friday. Dominguez=s white 1993 Honda Civic was missing. It was found abandoned in Del Rio, Texas, near the bridge to Mexico. DNA and fingerprint evidence link the Dominguez murder to Ramirez. The bodies of 80-year-old George Morber and his daughter Carolyn Fredrick, 52, were found on June 15, 1999 in his home in Gorham, Illinois, 100 yards from the railroad tracks. George was shot in the head with a shotgun and Carolyn was bludgeoned. Morber=s truck was stolen and found the next day in a school parking lot in Cairo, Illinois, about 60 miles south of Gorham. Authorities say Resendez-Ramirez=s fingerprints were found in the truck. One of Resendez= relatives called the AMW tip line, which started the surrender negotiations. The family convinced Resendez that Mexican bounty hunters were closing in on him, and that his best course would be to turn himself in. Resendez surrendered to authorities on the bridge between El Paso, Texas and Mexico. (See Shows #534, #545, #546, #547 and #548, OADs 3/20/99, 6/5/99, 6/12/99, 6/19/99 and 6/26/99)

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

AJunior@ (Murder)

ADavid@ (Murder) B Two unknown men are wanted for questioning in the 1999 murders of Diana Lynn Algar and Jose Julian Molina in Wapwallopen, Pennsylvania. On Monday July 19, 1999 the bodies of Diana Algar and her friend Jose Molina were found in Algar=s trailer. The two had been shot, execution style. Various items, including a stereo, had been stolen from the trailer. Written on the wall in mascara were the letters CFH. Algar=s light blue 1987 Dodge 600 with Pennsylvania plate BXE-4817 is missing. A witness at the campground told police she saw two young men with Algar the day before. She also provided the only names for the two that she remembered, David and Junior. The investigation led police to a truck stop on Rte. 80, where surveillance video caught the two men asking a clerk about finding a ride to Georgia just moments before Algar is seen approaching the same counter. AJunior@ is described as tall with a muscular build and shoulder-length hair that is shaved underneath. He was wearing a Cleveland Indians baseball cap. He may be carrying a wallet with a chain on it. He smokes Marlboro cigarettes. He may have a two-year-old son. AJunior@ is approximately 20 and 5'9". ADavid@ has a thin build and a buzz cut. He has either a tribal hand or barbed wire tattoo. His left nipple is pierced with a neon green tomahawk. He was wearing a shirt with a Cleveland Indians logo on it and black Nike sneakers. He smokes Camel cigarettes. He may have a one-year-old son. ADavid@ is approximately 21, but may be younger, and 5'7"-5'8". The men may be traveling to the Woodstock festival in Rome, New York, or to Valdosta, Georgia.

Trung Thanh Pham (Arson)

Tu Minh Truong (arson) B Trung Thanh Pham and Tu Minh Truong are wanted by the ATF for the 1997 firebombing of a home which resulted in the death of a 9-year-old girl. In November of 1996 Tahn Lam hired Trung Pham to kill Tri Tran because Tri Tran was dating Lam=s ex-wife. After two unsuccessful attempts to shoot Tri Tran, Pham decided to firebomb Tri Tran=s house. On January 7, 1999 Trung Pham and his associates Tu Truong, Quach Pham (no relation) and an unidentified man drove to Tri Tran=s house around 2:00am. When they arrived at Tri Tran=s house Quach Pham remained in the car while Trung Pham and Tu Truong ran up to the house and threw firebombs through the

dining room window. The fourth unidentified assailant is believed to have doused the house and porch with gasoline before the attack to hinder escape. The intended target, Tri Tran, escaped but his nine-year-old niece, Hein Tran, suffered third- and fourth-degree burns over 90% of her body and later died. The day after the fire Tahn Lam, the man who originally hired Pham to kill Tri Tran, paid Pham the remainder of the money he owed him, \$5,000. He then paid the other participants \$500 each. Tahn Lam was later arrested and is presently in jail awaiting trial. Quach Pham plead guilty to participating in the firebombing and was sentenced to nine years. Tu Truong and Trung Pham are on the run. Pham is believed to have fled the Sacramento area in late 1997. He is believed to be traveling with his girlfriend, My Hang Ngoc Cao. She may be working as a manicurist. He could be working as a deck hand on commercial fishing boats in Florida or anywhere along the gulf coast. Sources also indicate that Pham and Cao may be traveling to Alaska to seek employment again as a commercial fisherman. Pham has a large tattoo of AVietnam@ on his back, and a tiger on his upper arm. He commonly wears a mustache and a goatee-like beard. He is an avid gambler who frequents Vietnamese coffee shops and pool parlors, and associates with Vietnamese gang members. Pham is 24, 5'5" and 140 pounds. Truong has an estranged common-law wife and a son in Sacramento. He is 22, 5'1" and 100 pounds.

Carmine J. Galante (Murder) B On the night of April 3, 1999 Bill Manolis, a freshman at St. John's University, went out to celebrate his 18th birthday with friends. Manolis and his friends ended up at the Kee Nee bar in Bay Ridge, Brooklyn. According to several witnesses, Manolis had an argument with Carmine Galante's girlfriend. Galante's friend came to her aid and he and Manolis exchanged loud words. One of Manolis' friends broke up the heated exchange and Manolis bought everyone drinks to smooth things over. A few hours later, Galante's friend and girlfriend left the bar. Then the friend called Galante and told him what happened. The friend returned to the bar with Galante at 3:45am. Galante immediately charged Manolis and plunged knife into his chest. Manolis died from his injuries at the hospital. After the stabbing, Galante and his friend ran out of the bar and drove away in a 1997 tan Toyota Camry. The car was later recovered on 84th Street in New York. Carmine Galante was named in honor of his uncle the boss of the Bonanno crime family. The elder Galante was gunned down by rival gangsters on July 12, 1979 while he lunched on the outdoor patio of a Bushwick, New York restaurant. Carmine Galante has a tattoo on one arm, and distinct eyebrows that almost come together in the center. He usually wears jeans and sneakers, and baseball caps. He likes to work out. He has worked as a pizza delivery boy. He is hot tempered, and should be considered armed and dangerous. Galante is 23, 5'7" and 180 pounds.

Dirk Avron Vanvelzen (Burglary, Weapons Charges) B Dirk Vanvelzen is wanted for a series of commercial burglaries which occurred in the greater Seattle, Washington area between 1996 and 1998. Vanvelzen targeted over thirty businesses which sold high value items such as expensive artwork, computers, audio/video equipment and jewelry. Vanvelzen has a small scar on his forehead. He has used countless aliases, including Patrick Lee Hopson, Michael Gordon Rasumssen, Kelly Jorgensen, Seth Jacob Rosen, Douglas Edward Henderpender, Jeremy David Estes, Olden O. Howard, Michael D. Iverson, Steven Thomas Jorgensen, Steven D. Kloppenburg, Gabriel Enrique Mayorgin, Roberness Mittelstadt and Lance S. Russell. He is clean shaven with long, wavy hair. He wears contact lenses or wire-framed round glasses. He wears a fanny pack around his waist with a gun in it, and is known to carry

.45 or 9mm handguns. He likes wearing expensive designer clothing, eating at fine restaurants and staying at expensive hotels. He fancies himself a ladies man, and carries large amounts of cash. He brags about his computer knowledge and claims to own a computer company. He loves to play on the Internet. He is athletic, and enjoys backpacking, mountain climbing, rock climbing, mountain biking, running and aerobics. He is very conceited and egotistical. Vanvelzen is 27, 5'11" and 165 pounds.

William Alexander Zepeda (Murder, Armed Robbery) B Georgia authorities say Zepeda shot and killed two employees of a northeast Atlanta restaurant in April 1998. Zepeda, along with brothers David and Joaquin Arevalo, planned a robbery of the Tanner=s Restaurant in Lawrenceville. Since David worked there and Joaquin used to work there, they already had knowledge of where the money was kept and how to get at it. Just before 9:00am on April 6, 1998 police received a call saying someone had been shot in the restaurant. Police arrived and found 32-year-old Marc Ratthaus and 32-year-old Adolfo Gonzalez in the restaurant. They had each been shot once, execution style. Police interviewed the Arevalo brothers who said that Zepeda had been the triggerman. All three were charged with murder. While the two brothers are awaiting trial, Zepeda is on the run. Zepeda has used the aliases Hernan Ernesto Mejia and Nernesto Mejia. He has a tattoo of a woman=s face on his left biceps. He is a native of El Salvador, and police believe he may be trying to blend into a Hispanic community. He may be driving a late 1980's Nissan Sentra or Toyota Camry four door, either gray or silver, with Georgia plates 598 FYL. Zepeda is 25, 5'9" and 175 pounds.

Robert Clarence Bramlett (Rape, Possession of Child Pornography, Other Sex Charges) B Robert Clarence Bramlett is wanted for the rape of two girls in Oklahoma city, Oklahoma. Bramlett was a good friend of their family during 1996 and 1997 and was alone with the 7- and 8-year-old sisters on approximately twelve occasions. On November 11, 1997 the parents of the two girls went to the grocery store. While they were gone Bramlett went to their house and knocked on the door. Terrified that Bramlett would harm them again, the girls did not answer. When the parents returned home a few minutes later, Bramlett was gone and the girls were crying hysterically. This is when the parents learned that their children had been raped and molested by Bramlett on several different occasions. Oklahoma police believe that Bramlett has left the state. According to his friends and family, Bramlett used to say, AIf I ever get in trouble, I=ll hide in south Texas.@ Bramlett has tattoos on his left arm and upper right arm. He has used several aliases, including Thomas Joe Smith and Robert Bramblett. He smokes cigarettes and is a cocaine user. He was once a truck driver and his favorite hobby is fixing up old cars. He is into adult and child pornography. Bramlett is 52, 6'2" and 220 pounds.

AMW ALL-POINTS BULLETINS:

Ninderjit Singh (Murder) B Poonam Randhawa, 18, and Ninderjit Singh were dating and it appears that Singh may have been jealous of Poonam=s relationships with other people. On the afternoon of January 26, 1999 Poonam was in her car with two of her friends. They were stopped at a traffic light when Singh approached Poonam=s car and knocked on the window. Poonam rolled down her window and spoke with Singh. Following the conversation Poonam got out of the car and followed Singh to his vehicle. Poonam got into the back seat and Singh got into the front passenger seat. Singh=s accomplice drove off. Shortly after driving off Singh turned around and shot Poonam in

the head, killing her. Poonam=s body was dumped in an alley. On the very day of the killing, Singh made his way to Seattle where he purchased a one-way ticket to Los Angeles. Singh arrived in LA on the evening of January 26, 1999 but hasn=t been seen since. Singh, who goes by the nicknames ABeera@ or ABira@, has used the alias Ninderjit Soos. Although he has lived in Canada since 1993, his English is limited. He has family and friends in the Punjabi communities in Van Nuys, California and Southall, Middlesex, England. He has worked in a gas station, in construction, and delivering vehicles for car dealers. Singh is 21, 5'9" and 160 pounds.

Ronald Thomas Fleming (Rape of a Child) B The FBI and the Michigan State Police are looking for a fugitive who may be appearing in a theater near you. Ronald Thomas Fleming is an amateur writer, actor and producer who is also a child molester. Fleming had been getting away with his crimes for years until his wife accidentally came across pornographic photos of young boys in their home computer. Fleming denied the photos were his and explained that he inadvertently receives this type of photo over the Internet. His wife did not believe his story and decided to keep an eye on him. Eventually she found a diary that Fleming was keeping. In it he described his infatuation with a thirteen-year-old neighborhood boy. Fleming=s wife became concerned about her own eight-year-old son from a previous marriage. When she questioned the child he confirmed that Ron had molested him. Police arrested Fleming in August of 1997 and under questioning he confirmed the child=s story. Fleming also told police where they could find additional child pornography in his computer. Police felt that Ronald Fleming was extremely cooperative so they charged him with Rape of a Child and released him to await trial. But within days Fleming disappeared and has not been seen since. In September of 1997 police found his abandoned car in Toledo, Ohio. Fleming wears prescription glasses. He loves soap operas, won=t miss AThe Guiding Light@ or AAll My Children@, and is trying to sell a soap opera he has written. He collects comic books and writes amateur comics. He works and volunteers for amateur theater productions. He has sold and worked with computers, and has also worked as a bagel baker. He usually hangs around playgrounds or school yards. Fleming is 32, 5'6" and 140 pounds.

Astarte Davis-Rice (Escape) -- On August 7, 1998 Astarte Davis-Rice escaped from the minimum security Federal Prison Camp in Dublin, California by simply walking off the grounds. Davis-Rice has an extensive criminal history of embezzlement, fraud and forgery. Police suspect she may have had her common-law husband, James Rice, killed in the Virgin Islands, but don't have enough evidence to charge her. James Rice's body has never been located (see below). She has left a trail of several male victims she has scammed, who were all in the real estate or development field. Davis-Rice has used many aliases, including Peggy Tyler Morris, Esterbelle White, Peggi S. Morris, Peggi Stahlcap, John Henry, and Astarte Rice. She is youthful and has had plastic surgery on her breasts, stomach, eyes and face. She is always well-dressed and manicured, calm and confident with a charming personality, and considers herself part of the "neat and elite crowd". However, she does not look people in the eye. She has worked as a bookkeeper/accountant, and has three sons: Loyal, Noble and Regal. Rice-Davis is 66, 5'7"-5'8" and 140 pounds. (See Show #517, OAD 11/7/98)
