The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Unknown -- Georgia Moses was forced to grow up fast - maybe too fast. With her mother emotionally handicapped and her father absent, Georgia, 12, was the only one available to care for her sister. People who knew her from the Boys and Girls Club in Rohnert Park, California, say she was a survivor, that she never complained, and took her circumstances as a chance to grow stronger. She was the glue that held her family together - shopping, cooking, looking after the meager social security checks. But she was also determined to have fun. On the evening of August 13, 1997, she headed over to a friend's house to spend the night. Georgia's friend says that she hadn't been there long before she received a call on her pager. Georgia said the page was from a man who lived in San Francisco, a man who she barely knew. He said he wanted to see her, and had driven up from the city to take Georgia to a party. The girls walked up the street to a gas station to call him, but when they arrived, the man was already there. That's when Georgia's friend started to feel uncomfortable - he looked too old for Georgia to be hanging out with. She asked if Georgia was sure she wanted to do this, and Georgia said she was sure she really wanted to go to this party. Georgia's friend paged her later to let her know it was okay to spend the night. She got a call back from the mysterious man's cellular phone - it was Georgia. She said she might be back later, but wasn't sure. Then a man's voice told her to get off the phone. That was the last she heard from Georgia. Georgia's badly decomposed body was found on August 22, 1997, in Petaluma, California. Police say she had been murdered, and know that their only hope of solving this case lies with the strange man who picked her up that night. The mysterious man had a mustache and may wear glasses. He is described as heavyset, chubby with a round face. He drove a white, four-door compact, possibly a Honda. He wore his hair cut short. The unknown man is 25-30, 6'2" and 200 pounds.

Jonathan Tampico (Possession of Child Pornography, Sex Offender) -- Jonathan Tampico is wanted for possession and distribution of child pornography and for failing to register as a sex offender. In April 1989 Jonathan Tampico was investigated by police in Livermore, California for molesting his neighbor's ten-year-old son. One month later, Tampico

was in Thailand where police say he was involved with a boys orphanage. Thai police picked Tampico up and gave him a one-way ticket back to the US. On April 20, 1990 Tampico was sentenced to 6 years in prison, but on October 2, 1992 he was released on parole. At first, he tried to settle in Tacoma, Washington, but disclosure laws let the citizens know that the convict was on the way, and a public outcry drove him out. Tampico then returned to Fremont and a high-tech job. But he seemed to care little for changing his ways. In fact, police claim, he continued his membership with the North American Man-Boy Love Association (NAMBLA), a twisted organization that promotes an agenda of free and legal sex between grown men and young boys. It was only a matter of time, according to police, before the remorseless rapist victimized another child. In the fall of 1995, Tampico was arrested for violating his parole. Following his arrest, Fremont, California police found a stockpile of child pornography allegedly stashed in Tampico's storage locker - over 500 books and magazines, 8mm films, 16mm movies, Polaroids, and around 500 homemade videos. To top it all off, Tampico, a computer expert, had all the equipment he needed to spread this filth all over the internet. Police now believe that Tampico was at the center of a child pornography distribution ring. The investigators who had to catalog all this material were so disturbed their department called in a psychiatrist to help them cope. But even though the prosecutor claimed Tampico was caught red-handed, his NAMBLA lawyer found a technicality that got him back on the streets. His attorney claimed that Tampico should have been off parole on September 11, 1995, the day before he was arrested for violating parole. In February, 1996, after months of legal procedures, Tampico walked away from San Quentin. Tampico is still charged for the cache of kiddy porn allegedly found in his storage locker. Although his lawyer has fought these charges tooth and nail, the court finally decided Tampico would have to face the music. But by then, he had disappeared. The legal drama continued when Tampico was arrested in College Station, Texas in July 1997. Due to confusion over the validity of his warrant, he was released before he could be successfully extradited back to California to face his charges. Police there want Tampico to stand trial. Tampico, whose internet nickname is "Laser John", has used the alias Philip Oliver. He has a receding hairline, a mustache, and sometimes wears a long beard. He is an amateur sailor and enjoys the sea. A brilliant laser engineer, computer programmer and photographer, Tampico worked on the topsecret "Star Wars" project. Tampico is 48, 5'5" and 150 pounds.

Romel Valentino White (Child Molestation) -- A man who picked on a child is so childish himself, that deputies say he went on the run with his parents. Romel Valentino White is wanted by the Sacramento California Sheriff's Department Child Sexual Abuse detail for 30 counts of child molestation. Deputies say the victim was White's own nephew. The boy told deputies that White had sodomized him many times over a seven year period. The alleged abuse started when the boy was six and continued until he was 13. Three years later, at the age of 16, White's nephew found the courage to turn him in. On September 23, 1996, Romel White was

arrested, but a judge let him out on bond. The case took a strange twist. Deputies say White's parents tried to bribe his victim - their own grandson; they offered him cash to change his testimony at the trial. He refused and the DA's office charged Willie White and Joan Mouton with dissuading a witness from giving testimony, inducing false testimony, and conspiracy. But the law wasn't about to disrupt this tight family circle. On May 5, 1997, Romel White, still out on bail, and his parents fled Sacramento together. In early September, the trio was spotted in Laurel, Mississippi where Willie White has relatives. In September 1997, White's mother, Joan Mouton was caught in San Bernadino, California while allegedly attempting to pass a bogus travelers check. Then, thanks to an alert America's Most Wanted viewer, Willie White was captured in Pittsburg, California. Demonstrating again how the Whites will cover each other's darkest sins, Willie was found at his aging mother's house after the FBI and Pittsburg Police followed a viewer tip. Now only the man accused of monstrous crimes against a child remains at large. Police believe he was in Pittsburg, California, when his pop was caught, but has now fled for the California-Mexico border. Romel White has a slender build. He usually drinks beer daily and smokes Marlboro cigarettes; relatives say he also smokes marijuana. He has worked as a clerical aid in law firms. White is a member of the North American Man/Boy Love Association. He is 28, 5'10" and 165 pounds. (See Shows #466 and 481, OADs 9/20/97 and 1/24/98)

MISSING CHILD UPDATE:

Christina Williams

Age: 13

Height: 5'3"

Weight: 80 pounds

New information has come to light, thanks to an observant witness in the Presidio of Monterey Annex, California. At 7:45 PM on Friday, June 12th, the witness observed a frightened girl sitting in a late-70's or early-80's light gray car, identified as either a Mercury Monarch or a Ford Granada. Two males were also in the car. Later, the witness saw a flier about the missing girl, and realized that the young female in the car was Christina Williams. The men spotted in the car closely matched composite sketches of the two suspects. Christina Williams left her parents' home at 7:30 p.m. on Friday, June 12, 1998 to walk her dog. At 8:15 p.m., Christina's mother discovered the dog by itself near the residence. Christina, however, was nowhere to be found. At 8:30, Christina's father called the Presidio of Monterey Police (POMP). Over that first weekend, the FBI, POMP, Monterey County Sheriff's Office, concerned neighbors, and volunteers from the Polly Klaas Foundation conducted an extensive search of the area. Posters

were distributed, and the media got involved with extensive coverage. Still, no sign emerged. The first witness to come forward was a woman who claimed that she was jogging in the area on June 12 at about the same time Christina left home, and was verbally accosted by two Asian men in their 20s riding in a older-model four-door car. She described the color as gray, or perhaps painted with gray primer. The car bore an old-style California plate, with a blue background and gold letters. Police and FBI consider these two men suspects in her disappearance. The new witness has confirmed the jogger's observations of the suspects and the car. Based on these sightings, police have released the following descriptions of the suspects: The heavy-set suspect has dark brown hair, cropped short on the sides and with a half-inch flat-top. He has pudgy jowls, a shiny sheen to his skin, and a reddish skin tone, as if he has a sunburn. The suspect with slight build has dark brown hair, olive skin tone, red blemishes on his lower cheek, prominent cheek bones and a slight mustache. His hair, worn gelled and unkempt, falls over his face. A \$20,000 reward is offered for anyone giving information leading to the recovery of Christina Williams. She was last seen wearing striped shirt, blue jeans, blue rubber sandals and a black Raiders jacket. (See Shows #500 and 501, OADs 6/20/98 and 6/27/98)

UPDATES:

Alan Pilon (Murder, Aggravated Assault, Carjacking) -- Alan "Monte" Lamonte Pilon is suspected of being one of the gunmen who began to terrorize police and citizens along the Utah-Colorado border on Friday, May 29. Of the three men who allegedly set off a massive manhunt along the Utah-Colorado border, Pilon has been named as the most anti-government. Pilon has allegedly been linked to the Four Corners Patriots, a secretive paramilitary organization. He also reportedly had a strong grudge against the IRS for a \$1,500 debt. Pilon hails from Dove Creek, Colorado, where he lived a pretty typical life, although some claimed that he hung out with a tough crowd and, according to the Durango Herald, the mayor of Dove Creek recalls Pilon getting into trouble for allegedly breaking into the junior high school and stealing electronics. Pilon is known to wear thick, wire-rimmed glasses. He may walk with a limp due to ankle injuries from a motorcycle accident. He was last seen wearing camouflage clothing. He may be armed with automatic weapons. He has worked as a construction worker. Pilon has a history of anti-government views and was convicted of DUI in Durango, Colorado in 1992. Pilon is 30, 6'1" and 220 pounds. In early July authorities deliberately set fires in the wilderness area where Pilon and McVean are believed to be hiding out, in hopes of driving the two men out into the open. This was unsuccessful, but the men were spotted again just this week. (See Shows #498 and 499, OADs 6/6/98 and 6/13/98)

Jason Wayne McVean (Murder, Aggravated Assault, Carjacking) -- Jason Wayne McVean is suspected of being one of the gunmen who began to terrorize police and citizens along the Utah-Colorado border on Friday, May 29. Officials still have no idea where McVean is hiding out, but they have learned some details about his past, details that are so normal they make the current events even more mysterious. McVean has had only minor altercations with the law prior to the current manhunt. After he dropped out of high school, he was arrested for underage consumption of alcohol, driving a motorcycle without eye protection, and first-degree criminal trespass, according to the Durango Herald. Relatives say that McVean lived in a camper-trailer south of Durango. He seemed quiet and reserved, working as a welder for his father's family business. Everything seemed normal to his family, leading one relative to conclude that he must have fallen in with the wrong crowd. Neighbors say that McVean had only occasional visitors, but mostly kept to himself. Unless all of McVean's friends and relatives missed something, McVean's alleged involvement in the terrifying events of May 29 can only be described as an out-of-character explosion. McVean may have a beard and mustache. He was last seen wearing camouflage clothing. He may be armed with automatic weapons. He has worked as a construction worker. McVean is 26 and 6'2". In early July authorities deliberately set fires in the wilderness area where Pilon and McVean are believed to be hiding out, in hopes of driving the two men out into the open. This was unsuccessful, but the men were spotted again just this week. (See Shows #498 and 499, OADs 6/6/98 and 6/13/98)

Mark Jay Allen (Armed Robbery, Escape, Carjacking) -- Mark Jay Allen was sitting in a Greenville, South Carolina jail cell on May 23, 1998, awaiting trial for the armed robbery of two U.S. Post Offices. Marshals say that he was determined that he would never see trial and jimmied his lock to make his escape. At 10:20 that night, a 56-year-old woman was kidnapped at a car wash by a man who drove her in her own car a short distance before dropping her off. He kept her money as well as her car, and the terror she experienced during that short drive led to a heart attack, officials say. She is currently hospitalized. Less than two hours later, marshals say, Allen robbed a Waffle House in Jefferson, Georgia, about 50 miles away. Just down the road, police recovered the stolen car at a Day's Inn on Interstate 85. Allen, who has used the aliases Justin, Marc, Albert, and Josh, has a tattoo of Harley Davidson wings on his right forearm. He is an alleged cocaine user who served 10 years in Georgia State Prison for robbery. Allen is 30, 5'10" and 165-170 pounds.

Unknown (Murder) -- The Nashville country music scene will never be the same; Skull is dead. David "Skull" Schulman was the so-called and widely-loved "Mayor of Printer's Alley," a title he earned by operating one of the best-known clubs in Nashville, Skull's Rainbow Room. The Rainbow Room was lined with photographs of Skull posing with country music's elite--Tanya Tucker, Dolly Parton, Waylon Jennings, Willie Nelson. Skull, 81 years old when he

died, opened the Rainbow Room in the 1940s, and jump-started the careers of numerous country celebrities. When the hit show "Hee-Haw" moved to Nashville, he was adopted as a cast member. When he wasn't on the set wearing his overalls or entertaining his club's patrons, he could be seen walking his poodle Sweetie down Printer's Alley. But on January 21, 1998, Skull's long life was suddenly taken from him by an unknown attacker. At 4:30 p.m. that day, the freshly-shaved Skull was picked up by a cab in front of Leonard's Manor Barber Shop and dropped off at his club. An hour and a half later, a cigarette vendor found Skull lying on the floor of his club. He had been cut six times, and his throat slashed. Police found evidence of a fight, but also found that Skull still had his wallet, with more than \$140. Skull hung on to life until 3:10 a.m. During his struggle, Tanya Tucker visited the hospital, and sang "Farther Along" to the dying man. Now, she and the rest of Skull's many friends want a suspect to be named and captured. It is a crime, they say, that shouldn't go unsolved. The unknown suspect spent time in Nashville in January and February 1998. He may be a homeless drifter who lives in shelters and hangs out in nightclubs. He could be working as a bouncer and may be familiar with country music.

CAPTURED:

Kevin Earl Jackmon (Murder, Kidnapping, Assault) -- New Bedford, Massachusetts, April 26, 1998 - that evening, a local McDonald's turned into the scene of a tense hostage situation and a brutal murder. The night manager, Jodi, was there, and six months pregnant. DeMarco Traynum was there, and never left. Police say that Kevin Jackmon was also there, and was responsible for the terror of that evening. At 8:45 p.m., two men suddenly burst through the restaurant's doors and ordered everyone's hands up in the air. The customers, Jodi recalled, were stricken with fear as they, along with the staff, were forced into the back office. Jodi was then allegedly ordered by Jackmon to get the cash from the registers, which she did willingly. She thought they would leave once their pockets were full. But someone spoiled their plans with a 911 call, a report that a man was in McDonald's with a "big gun." As a patrol car rolled into the parking lot, Jackmon reportedly returned to the back office with Jodi. As the cops entered the building, they suddenly came under fire. They fell back, and waited for SWAT and hostage negotiators to arrive. What no one realized at the time, police say, was that Jackmon had accidentally killed his partner, DeMarco Traynum, in the shoot-out. They report that he panicked, and with his partner dead, started looking for hostages to go. He allegedly selected Jodi and another worker, Carla, and forced them out of the restaurant. Jodi claims that as soon as the police saw Carla coming out the door, they started firing, but stopped when they realized Jackmon was using them to make his escape. Shortly after he sped off with the two women, back-up arrived, ready for a long stand-off. What they didn't realize, and what the hostages

inside didn't realize, was that there was no one holding them. The man who had kept them at gunpoint now lay dead on the floor, out of sight. For over 15 tense minutes, the hostages cowered in the back office, until one crawled around the corner and saw Traynum's leg. Even then, he wasn't sure he was safe until he poked it with a broomstick. Jodi and Carla, meanwhile, were being driven three hours south, to the Bronx, New York. Finally, they claim, after Jackmon stopped to make a few phone calls, he escorted them to a motel, where he tied them up and left. Before long, the pair worked their way out of their bonds, and pulled the fire alarm. Jackmon's car was later found abandoned in Apex, North Carolina. A tip from an AMW viewer led police to Jackmon's apartment in Raleigh, North Carolina, where he was captured without incident. (See Show #499, OAD 6/13/98)

Darren Henderson (Armed Bank Robbery) -- "I want to tell him. He need to give it up. Get out of what you're doing and get yourself straight. And stop robbing those banks, leave that money alone. It's not yours!" was the message from Little Richard to the "Wig Bandit," a Little Richard look-alike who police say borrowed the calm and cool of one of America's rock legends to walk away with bags of cash from at least four different banks in New Orleans. America's Most Wanted aired the story of the hair-raising robber for the second time on March 21, 1998. and received a call from an unlikely source. An anonymous AMW viewer said he'd overheard an acquaintance brag about robbing banks. The braggart's name: Darren Henderson. His current location: The AmeriWest Suite Hotel in Las Vegas. Agents watched the hotel, and moved in on Henderson and his girlfriend, Ann Thompson, as they left their room. The couple was arrested, but Thompson was released the next day. Meanwhile, agents say they discovered some cash in Henderson's rental car which was covered with tell-tale marking dye, suggesting it came from one of his bank jobs. But the story started out so strangely that it was bound to be anything but a routine capture. Agents say that Thompson flew back to New Orleans after she was released, and returned to the house where she and Henderson lived. Agents say that when she returned, she was assaulted by a man who knew that Henderson was keeping money in the house, while she maintained that she was injured when she fell down a flight of stairs. When the FBI arrived, she wouldn't allow them in without a search warrant, but when they returned, agents claim, she had been fighting with her stepfather and ended the argument by brandishing a shotgun. She then proceeded to barricade herself in the house, and the standoff lasted until 10 p.m., when she finally surrendered to FBI agents and the New Orleans SWAT team. Inside the Henderson residence, agents claim they found more dye-stained cash, and a sweater and suit that match the outfit worn by the Wig Bandit. As the investigation widens, agents say that they may link Henderson to more robberies. (See Shows #482 and 486, OADs 1/31/98 and 3/21/98)

Willie White (Dissuading a Witness From Giving Testimony, Inducing False Testimony, Conspiracy) -- A man who picked on a child is so childish himself, that deputies say he went on the run with his parents. Romel Valentino White is wanted by the Sacramento California Sheriff's Department Child Sexual Abuse detail for 30 counts of child molestation. Deputies say the victim was White's own nephew. The boy told deputies that White had sodomized him many times over a seven year period. The alleged abuse started when the boy was six and continued until he was 13. Three years later, at the age of 16, White's nephew found the courage to turn him in. On September 23, 1996, Romel White was arrested, but a judge let him out on bond. The case took a strange twist. Deputies say White's parents tried to bribe his victim - their own grandson; they offered him cash to change his testimony at the trial. He refused and the DA's office charged Willie White and Joan Mouton with dissuading a witness from giving testimony, inducing false testimony, and conspiracy. On May 5, 1997, Romel White and his parents fled Sacramento together. In early September, the trio was spotted in Laurel, Mississippi where Willie White has relatives. Shortly afterwards, Joan Mouton was arrested in San Bernardino, California, where she had tried to pass a bogus traveler's check. Now, thanks to an alert America's Most Wanted viewer, Willie White is behind bars. Demonstrating again how the Whites will cover each other's darkest sins, Willie was found at his aging mother's house after the FBI and Pittsburg, California Police followed a viewer tip. STREET SMART:

Protecting your children from molesters -- For two years, Debbie Mahoney was in the dark. Meanwhile, her ten-year-old son was allegedly being heartlessly raped by her next-door neighbor, Jonathan Tampico (See Above). When Debbie learned what was happening to her boy, she asked him why he didn't tell her. His response: "Mom, you always told me that if people tell you things in private, that you should keep their confidence." Debbie will never forget that day, when her advice was used against her and her son by an alleged child-raping monster. She is now determined to defend other children from her son's fate. Acting through her organization, Safeguarding our Children - United Mothers, or "SOC-UM," Debbie teaches parents how to spot warning signs in their children's behavior. She even took her message before a Senate committee on child molesters and the ploys they use to ensnare young children. As Debbie told me, there are warning signs in children that too many parents misinterpret. A child who is being molested often starts spending more time than usual alone - either in their bedroom or in the bathroom. They may take frequent showers or baths, trying to cleanse themselves. They may suddenly start bedwetting or leaving small amounts of blood on towels, sheets, or undergarments. Often a victim of molestation will try to hide or discard items with blood on them. Is your child suddenly reluctant to be around people he or she used to be comfortable

with? Relatives, coaches, teachers, neighbors? Are excuses suddenly being made to no longer take part in particular activities that used to be fun? This could be a sign that a molester is at work. Extremes in behavior such as out-of-the-ordinary tantrums and tears may be warning signs. If your protective instincts and your heart tell you that something is wrong, don't quit when your child says "I don't want to talk about it." When a child is being molested, the tantrums and the tears are a sign to you, saying, "help me not have to do that anymore." The best way to educate your kids about molestation is to talk about it and be candid. Tell them what it is and who does it. Make sure they understand that molesters criminals who hurt children. Then demonstrate with role-playing. Show your children how a molester might begin. A hand on the leg left too long, rubbing their back in a way that makes them uncomfortable, unwanted hugging and kissing. This is essential training for your children to recognize what they have never experienced, and to trust their instincts. If they feel that way, they should yell "no" and run to someone they can trust. They should never stay. Role playing gives a child a point of reference that they can later draw upon. Talking about molestation is the first step. Role-playing is the experience that protects.

1988

Stephen Sidney DeLorenzo (Assault with Intent to Murder, Escape) -- Love turns to murder all too often - we all know the story of the jealous ex-boyfriend who can only cope with a break-up from the butt end of a gun. America's Most Wanted has featured these sad stories countless times, but "Linda's" story is special - she survived. Stephen DeLorenzo was already acquainted with violent ends to affairs when he started dating Linda - he had served time for assaulting three different women after their relationships ended. One woman even received a broken neck from his vicious attack. But on the evening of March 18, 1977, DeLorenzo brought a firearm into the volatile mix of obsession and jealousy. That night, he showed up unexpectedly at Linda's house in Broxton, Massachusetts while she was preparing dinner for her roommate and her date. She attempted to send him away, but DeLorenzo tried to play cool, saying that he was just there to fix her car. After closing her hood, he came inside to report his findings. Linda then told him plainly that he should go. That was enough to set DeLorenzo off. He pulled his .22 caliber revolver and shot Linda four times - twice in the head. DeLorenzo left her for dead, but was captured in New Orleans and sentenced to 14 to 20 years for his attempt on Linda's life. He was only three years into his prison term when he made a daring escape. On May 4, 1987, prison officials found a dummy in his bed, the bars of his cell pried open, and a rope fashioned from bed sheets dangling from his window. Since then, he has been spotted by AMW viewers in San Francisco, San Diego, and Phoenix, Arizona. DeLorenzo, who has used the aliases Andrew Dixon, Jim Benson, and Kerry Heisley, is a weightlifter who has tattoos of a panther on his right arm and a skull on his left arm. He has chronic dental problems. He works in shipyards and frequents prostitutes. He works in shipyards and metal shops. He may be riding a motorcycle,

and is probably armed with a .375 caliber handgun. DeLorenzo is 49, 5'11" and 205 pounds. (See Shows #17, #26, #106, #107, #146, #178 and #314, OADs 5/29/88, 7/31/88, 3/18/90, 3/25/90, 1/11/91, 8/30/91 and 4/30/94)

1989

Joe Sinnott Edwards (Murder - 2 counts) -- On January 20, 1983, police say that Joe Edwards finally snapped. His years of institutional life, mental illness, and drug abuse had taken their toll, they claim, but the ones to pay with their lives were the ones who had offered him a loving home - his adoptive parents. Robert Edwards, an ex-green beret, was found shot in his car parked in a shed near his home. Former schoolteacher Marcia Edwards was killed in her kitchen with two shots to the head. Joe Edwards was born into misfortune. His single mother soon abandoned him, and he was left to the care of the state of Illinois. He lived with four different foster families before he reached the age of 12. He wasn't happy with any of them and expressed his anger by setting fires or destroying property. Finally, he was sent to the Salem Children's Home in Flanagan, Illinois. According to an essay he wrote at the time, this home was the worst of all. Now, authorities say, his destructive behavior turned inward - Joe started sniffing glue. But in 1977, hope for Joe appeared in the form of Rob and Marcia Edwards. Family members say that the couple believed that love would cure Joe's troubled past. It wasn't long before they discovered how wrong they were. Violence entered the house with Joe - he even took a swing at his adoptive mother during an argument. In 1978, he was accused of vandalism. In 1979, the Edwards had to face Joe's latest plea for help - a suicide attempt. Joe's parents had their son undergo a comprehensive psychiatric examination. The result: no matter how hard they tried, Joe might never return their love. They saw him spinning out of control, and on the advise of school officials, they sent him to the Dakota Boys Ranch in Minot, North Dakota. It wasn't long before he was expelled for allegedly using drugs and stealing a truck for a joyride. Joe left the care of his family, and struck out on his own. For two years, Joe and his parents had no contact. But people who knew Joe claimed that his parents were very much on his mind. After the murder, police found impressions on a note pad on the kitchen table that revealed an unfinished message written by Marcia: "Joe and friend mad, abusive threats...." There was no doubt in the minds of investigators or among Robert and Marcia's relatives: their act of kindness had killed them. That was more than 15 years ago. Now, forensic artist Frank Bender has created a bust of what Edwards may look like today, in his 30s. Edwards may have a tattoo of a cross between his thumb and forefinger. He has scars on his left wrist, right inner forearm and right biceps from his suicide attempt, and warts on both hands. He has a penetrating, distrustful stare. He is a diagnosed schizophrenic, and an alleged marijuana, cocaine, and prescription medicine abuser. Edwards, a skilled swimmer, enjoys the ocean and is fascinated with sharks and marine biology. He also sketches well. He may be working in construction, and is believed to carry firearms.

Edwards is now 34, 5'10" and 165 pounds. (See Shows #56, #118 and #153, OADs 3/12/89, 6/17/90 and 3/1/91)

1990

Dennis Melvyn Howe (Murder, Sexual Assault) -- As darkness fell over Toronto, Ontario on January 23, 1983, Lynn Keenan knew something was wrong. She had reluctantly let her seven-year-old daughter Sharin go down to the park after making her promise that she would be home by nightfall. Her creeping suspicions deepened when her husband returned from a quick search of the park empty-handed. Police responded immediately, covering the area with flashlights, questioning residents, and announcing the disappearance over a loudspeaker. Days passed, and there was still no sign of Sharin. Then, on February 1, 1983, two detectives questioned local residents who recalled seeing Sharin walking into a nearby neighborhood with a middle-aged man. They canvassed the boarding houses in the area, and eventually found that one resident hadn't been seen since Sharin had gone missing - Dennis Melvyn Howe. The detectives searched the empty apartment and made a discovery that would change their lives forever. Sharin's body was stuffed in the refrigerator. She had been strangled and sexually assaulted. Investigators soon learned that Howe had racked up a total of 15 years behind bars for violent attacks on three women and a teenage girl. He had been released under supervision. Now, he was gone. The horror of Sharin's murder left a broad wake. Sharin's parents never recovered from the tragedy and eventually divorced. One of the detectives who discovered Sharin's body never recovered from the sight, and later committed suicide. Howe is still at large. How has used the aliases Ralph Ferguson, Jim Myers, Michael Burns and Wayne King. He has a small 1/2-inch scar below his chin, a bulbous nose and weathered complexion. He has a markedly hairy chest and arms. He is left-handed, with crooked little fingers. He has a small gap between his yellowed front teeth. He chain-smokes Players unfiltered cigarettes, holding the cigarette between his ring and middle fingers. He likes to line up the cigarette butts in a neat line. Howe drinks Molson Export ale, likes country-western music, and has a deep, braying laugh. He has a quick, jerky walk, uses the term "turkey" frequently, travels by bus and stays in flop-houses and hostels. Howe is 57, 5'9" and 165 pounds. 1991

Alvara Israel Alvarado (Murder - 3 counts; Attempted Murder) -- In 1988, Amanda Alvarado moved her three children from Los Angeles to Portland, Oregon. She gave only one reason to move - her husband. He had reportedly grown increasingly violent and jealous, his temper always ready to explode. Alvarado's jealousy, Amanda's relatives say, now turned to

obsession. He hunted her down and found her living in the same complex as her cousin, Otto. Now, he reportedly convinced himself that she was sleeping with her cousin, and became even more determined to get her back to Los Angeles. Amanda moved, had her car repainted, and covered her tracks. Meanwhile, Alvarado was cruising the streets, peeking in backyards, and calling her relatives. Finally, he returned to Los Angeles to execute a scam he knew would lead him to his wife. Alvarado contacted Amanda's sister, Gloria, in a panic. He told her that Amanda was sick in the hospital, and they drove up together. Even though her sister wouldn't lead Alvarado directly to Amanda, he got enough information to carry through the next stage of his plan - getting her back. The determined husband allegedly rented a U-Haul to move Amanda and her belongings back to L.A. Then, police say, he acquired a gun to make sure she couldn't refuse. On August 15, 1989, he burst through Amanda's door to find Amanda watching T.V. with Otto, her sister, and a friend. Police say it was Otto's presence that made him abandon his plan. He allegedly flew into a jealous rage, cutting down his wife, her cousin, and her sister in a barrage of bullets. The friend managed to escape, while the children were there as their father killed their mother before their eyes. Paramedics and police were on the scene quickly. As Otto's life slipped away, he reportedly told police who had pulled the trigger - Alvaro Alvarado. Hours later, Otto, Amanda, and Gloria were dead. Alvarado, who has used the aliases Luis Medina and Alvaro Alvarado-Olivas, walks slowly, almost shuffling. He wears flashy clothes and gold chains, and frequently wears baseball caps. He smokes Marlboro Gold 100's and enjoys Mexican food. He has worked as a truck driver. He has a quick temper and may carry a Smith & Wesson 9mm pistol. Alvarado is 34, 5'5" and 195 pounds. (See Shows #179, #285 and 325, OADs 9/6/91, 9/14/93 and 7/23/94)

1992

Sophie David (Murder) -- Sophie David appeared to be the essence of international sophistication. Her exotic Ethiopian beauty was complimented by an English accent; a history of residences in Ethiopia, Paris, and Los Angeles; and clothes that wouldn't have been out of place on a supermodel. But police believe she may now be an international fugitive who packs a gun in her waistband and swallows whole the men who fall into her clutches. Police were already familiar with Sophie David before she allegedly gunned down her boyfriend on an LA street. Months earlier, she had summoned them for help. Police now say that when her husband accused her of having an affair, she accused him of beating her and had him arrested. The charges were quickly dropped, and finally the couple divorced. As it turned out, Sophie allegedly confided in a friend that she had been seeing someone - the unfortunate Fekade Ashine, also an Ethiopian national. It wasn't long before Fekade was arrested for beating her, and again the charges were dropped. Police say that while Fekade accused Sophie of attempting to possess him body and soul, she accused Fekade of playing the part of a jealous, violent boyfriend. They

ended the relationship, and, following Ethiopian custom, chose a close friend to witness their separation. They chose Sophie's close friend, Belle Aklilu, to witness. She told police that as the couple met with her, Fekade accused Sophie of threatening his life if he ever cheated on her. She allegedly backed up her threat with her handgun, pointed right at Fekade. By the end of the meeting, both parties had agreed to go their separate ways, but police say Sophie went back on her promise. Investigators say that as Fekade walked to work, Sophie approached him in her car. When he walked away, they maintain, Sophie calmly walked up to him and planted two bullets in his skull. The suspect then casually strolled back to the car and drove away. Investigators say she has fled for Ethiopia, but could return to the United States at any time. David's original Ethiopian name is Hirut Dawit; she has also used the aliases Enanu David and Sophie Dawit. She speaks with an English accent, and usually wears dark sunglasses and gloves. She is an avid clothes shopper, carries large amounts of cash, carries a mobile phone, drives rental cars and frequents expensive hotels. She is an amateur photographer who has also worked as a hairdresser and a nurse. She is known to have used dating services. She is nervous and has trouble sitting still. 1993

Heather Tallchief (Bank Larceny) -- In 1992, FBI agents say Heather Tallchief met published jailhouse poet Roberto Solis in San Francisco. He'd recently been released on parole after serving 23 years for the murder of a Loomis Armored, Inc. driver during a botched robbery. Despite his shady past and an age difference of 27 years, the two were soon living together in Mexico. It was here, agents maintain, that Solis hatched a plan to take Loomis yet again, with Tallchief's help. He allegedly convinced the striking Tallchief to get a job with Loomis in Las Vegas, even though she didn't drive and had never fired a gun. Despite her complete lack of experience, Tallchief was soon driving an armored car on a lucrative route on the Vegas strip. Meanwhile, agents say, Solis rented a warehouse and set up a chartered jet. On October 1, 1993, Tallchief's co-workers left her with the car as they serviced the cash machines at the Circus Circus Casino. They say that when they returned, Tallchief, the armored car, and \$3.15 million were gone. Tallchief reportedly posed as a severely handicapped woman to make the rental of the chartered jet look legitimate. From Vegas, the pair allegedly flew to Denver. A week later, the FBI was looking for them in Miami, where they say they intercepted two false passports carrying the fugitives' pictures. From there, the trail went cold. Agents now suspect that the couple may have taken an early retirement in the Caribbean or South America, and may be raising a family. Heather Sonny Tallchief is a native of the Seneca Tribe. She wears her hair long, sometimes in a ponytail. She has multiple piercings -- 13 holes -- in her left ear and wears a nose ring. She also wears fake eye glasses. She may be carrying a handgun. Vickie Ann Nash (Murder) -- Vickie Ann Nash, according to friends, was a wild woman who couldn't be tamed. Three husbands tried, and three husbands failed. It was while she was going through divorce proceedings in 1979 that she met Gary Cooper. Nash and Gary, an alleged drug dealer, shared a number of common interests, say police. Their swinging world was reportedly one of frequent sex with multiple partners, uppers, downers, television, and chess games. Nash was soon living with Gary at his home in Southeast Houston, and seemed to be having the time of her life. But inside, friends say, her life was crumbling. The drugs and the divorce were taking their emotional toll. It was only a matter of time before she snapped. Police say she finally did just that on the night of October 26, 1979. While driving with Gary on the Gulf Highway, the couple reportedly argued over money Nash claimed Gary owed her. Gary grew sick of the argument, and shoved her out of his van. He told her never to come back. She didn't listen. After hitching a ride back to Gary's place, she discovered he wasn't alone. He had bedded down with 22-year-old Donna Jean Cleveland, only one of his many conquests. Police say Nash greeted the pair with two of Cooper's handguns, and let them feel her jealousy and rage. On November 19, 1979, Nash was indicted on two counts of murder. She's been on the road for nearly 20 years, but police still hope she will be brought in to pay for her alleged crimes. Nash has used the last names Kinginger, Woodby and Kindinger. she has an inch-long scar on her forehead from an auto accident, and her nose has been broken. She has three children from two prior marriages. She is fond of animals, and an avid chess and pool player. She is reportedly bisexual, and has a history of drug and alcohol abuse. She is also a very good marksman. Vicki Nash is 46, 5'3" and 125 pounds. (See Show #329, OAD 8/20/94)

1995

Fernando Reynoso (Murder) -- Maria Borges had a twin sister, a husband, and two children, all living in Brooklyn. She also had a close friend and confidant in Lucy Cuevas, and encouraged her to come dancing on May 29, 1994. That night, after she dropped Lucy off at her apartment, someone doused Maria with gasoline and set her on fire. As she died painfully in the hospital, police say she named her killer - Fernando Reynoso. Maria knew Reynoso, but didn't know much. He dated her best friend Lucy, but spoke seldom and kept his eyes lowered. Maria never thought Lucy and Reynoso were a good match, and it's possible, police say, that when Lucy broke things off with Reynoso, the rejected lover blamed Maria. Police say that after Maria dropped Lucy off following their night out, Reynoso flagged her down as she drove home. He

was carrying an empty gas can, and asked for a ride to the station - his car's tank was empty. Once he had filled his can, police say Reynoso then allegedly dumped the contents on Maria as she sat in her car, lit a match, and left her to burn. Six months later, Lucy received a call from Reynoso. He reportedly called the incident an accident, and promised to turn himself in. That was the last anyone has heard of him. Reynoso, who has used the aliases Arturo, Batista, Brito and Meija, has a scar from an alleged bullet wound on kneecap and a pierced left ear. He is a Dominican national who speaks very little English. He wears non-prescription glasses and makes noticeably poor eye contact. He has curly hair worn short and shaved in back, and a small black mustache. Reynoso walks with a marked slouch. He smokes Newport cigarettes and drinks Heineken, Guinness, and other imported beers. Police suspect he is a crack cocaine user. He is also very quiet. Reynoso is 34, 6'1" and 150 pounds. (See Show #368, OAD 6/3/95)

1996

Dudley Vincent Forbes (Murder, Assault, Forcible Confinement) -- Fate delivered Dudley Vincent Forbes into the world on February 14, 1962. But this natural born Valentine is a loser in love. Somewhere in Canada a woman is in deep cover; she calls herself Lorna and she'll stay in hiding until Forbes is caught and locked up. She once dated him, but she says when the romance turned abusive she broke it off. That's when Toronto Police say Forbes turned into a violent stalker. On February 13, 1993, Lorna arrived home to discover Forbes hiding inside her apartment. Police say Forbes pounced on her with a knife, and in a vicious frenzy he delivered 13 slicing blows, missing her heart by two inches. It took 198 stitches to put Lorna back together. After that attack, police say they believe Forbes fled Canada. But he didn't forget about Lorna; on September 17, 1994, he returned and found her in a Toronto nightclub. At first Forbes tried to bully her into leaving the club with him. When he failed, he stalked out in a fury. Police say he grabbed a 9mm handgun from his car, then stood outside the club and watched Lorna through a window; when Forbes opened fire Lorna instinctively ducked. She was one of the lucky ones that night. Two innocent bystanders were killed and four others were wounded. Today Lorna shoulders guilt for the tragic fate of those unsuspecting clubgoers. And she lives in fear that Forbes will once again return. Police say that until Forbes is caught and brought to justice, Lorna's life will be in danger. Forbes, who goes by the nicknames Dewey and Do-Do, and has used the alias Vincent ford, has scars on his right foot from reconstructive surgery. He is a Jamaican national who speaks with a distinct accent. He is soft spoken, and has a receding hairline. He likes to play soccer and dominos. He has worked as a forklift operator, cook and clerk, and also holds a welder's certificate. Forbes is 35, 6'0" and 175 pounds. 1997

Margaret Rudin (Murder) -- Police in Las Vegas, Nevada call Margaret Rudin a gold-digging black widow; married five times, she's a professional bride - with each marriage, they say her net worth grew. In September 1987, Rudin married husband number five - wealthy Las Vegas real estate developer, Ron Rudin. Ironically, Margaret became the fifth Mrs. Ron Rudin. For seven years, the Rudins seemed the perfect couple. But on December 18, 1994, Ron mysteriously disappeared. Ron's employees were alarmed and wanted to report him as a missing person. Oddly, Mrs. Rudin insisted they wait a full two days before calling police. For two months, Ron's fate remained a mystery. Then on January 21, 1995, fishermen found a pile of ashes and a skull near Lake Mojave - about 45 miles from Las Vegas. Dental charts revealed that the fishermen had found Ron Rudin's remains. He had been shot in the head four times, decapitated and stuffed into an antique trunk before being set on fire. Now police had enough evidence to search the Rudins' home for evidence. They discovered traces of blood which proved that Ron had been killed in his own bedroom. Police started tailing Margaret Rudin and found some big surprises: the grieving widow skipped her husband's funeral, and misplaced his ashes. She also had a secret boyfriend. Police suspected Margaret Rudin was behind Ron's murder, but they didn't have enough evidence to make a case...until July 21, 1996. On that day, a diver in Lake Mead found a handgun with a silencer, wrapped in several plastic bags. It was the murder weapon. On April 18, 1997, a grand jury indicted Margaret Rudin on charges of murder, but she'd already disappeared. Rudin, who has used the names Margaret Frost, Margaret Mason, Margaret Zumbrunn, Margaret Brown and Margaret Krafbe, likes expensive clothes and jewelry. She often dyes her hair, and has been a blonde, redhead and brunette. She has a mother and sister in Palm Springs, California and relatives in Illinois. Margaret Rudin is 54, 5'7" and 130 pounds. 1998

Eric Robert Rudolph (Causing the Death of a Person, Use of an Explosive) -- This week the FBI announced a recent sighting of Eric Robert Rudolph near Andrews, North Carolina. He reportedly appears thinner, has grown something of a beard, and now wears his longer hair in a ponytail. Agents say that Rudolph stole a truck and a six-month supply of food, and then abandoned the truck near a thickly-wooded area of North Carolina. Agents say that Eric Robert Rudolph was seen on January 29, 1998, fleeing the scene of the bombing of the New Woman All Women Clinic in Birmingham, Alabama. Immediately after the bomb went off, witnesses saw a man wearing a wig running from the site. Three witnesses saw his truck pull away, and were able to provide a description and a license plate number. The truck was traced to Rudolph, but he had already made his escape. Agents say Rudolph's bomb was loaded with nails - a bomb

designed not just to damage property, but to kill and maim. It did both: Birmingham Police Officer Robert "Sandy" Sanderson lost his life. Nurse Emily Lyons was severely injured by the homemade shrapnel - she lost her left eye, lost some of the sight in her right eye, and suffered several broken bones and burns. Despite speculation that Rudolph has been close to extremist groups, friends of Officer Sanderson can't view his death as part of a political action. Even though Sanderson was moonlighting as a security guard for a family planning clinic, they say he was outside of the abortion controversy - that he was just doing his job: enforcing the law. Rudolph is also wanted for questioning in a series of deadly Atlanta bombings: the 1996 Centennial Olympic Park bombing that killed one and injured more than one hundred others, an attack on an abortion clinic in January 1997 that injured seven, and a February 1997 attack on a gay nightclub. Authorities confirmed that they are investigating similarities in the construction of Rudolph's alleged bomb and the others. In particular, they're investigating a possible match between the nails in the Birmingham bomb and those in the Atlanta bombs. Rudolph has been described as a mysterious and reclusive man from the rugged mountains of North Carolina. Though agents believe it's likely that he's taken to the wilderness to hide, they're confident that the new \$1 million price on his head will make it hard for Rudolph to hide for long. Rudolph, who has used the alias Bob Randolph, has worked as a carpenter and spent 18 months in the U. S. Army. He has a reputation for anti-government views. He is estranged from family. He is an experienced woodsman and completed army survival training. Rudolph is 31, 5'11" and 150 pounds. David Connel Cox (Rape, Murder) -- It took twelve years, two determined detectives, and a feature on America's Most Wanted, but the man who killed 14-year-old Naomi McMahill was finally brought to justice. He thought he had the perfect alibi, he thought he had covered his tracks, but an America's Most Wanted viewer proved him wrong. February 24, 1981 - the body of a young woman was found dumped on the side of a road outside Pendleton, Oregon. Her body revealed the terror of her last living moments - she had been raped, strangled, and pistol-whipped. She carried no ID. No one came forward to claim her body. The mysterious story of her short life was closed in an anonymous gravesite. It took five years of extensive work to discover her identity. But the dedication of Detective Phil Arnold of the Oregon State Police and a nationwide computer system finally identified the girl. She was Naomi McMahill, a runaway. Who she was with, and why she was killed, remained a mystery. Detective Arnold, felt his elation over identifying the dead girl quickly pass as the new information brought no new leads. Five years later and two hundred miles away, at the Multnomah County, Oregon, Sheriff's

Office, Detective Jim McNelly received the first tip in the case. A woman who called herself Pat called the homicide unit in an attempt to clear her conscience. She claimed she was a long-distance trucker with her husband in 1981 when they pulled over to pick up a young hitchhiker. Then, while Pat drove, her husband climbed in the sleeper where the girl was resting and killed her. After he did his crime, he stuck his head back into the cab and announced that the young girl was dead. "I don't know why," he reportedly told his wife, "I just have to do this every so often. It helps relieve the tension." McNelly was certain the information was good. But he couldn't get his fearful witness to give her real name or the name of the killer. McNelly didn't even have a victim. Hoping for a lead, he sent a teletype to thousands of officers across the western U.S. When Detective Arnold in Pendleton, saw the teletype, he knew that he was back in the game. Now the detectives had some good information, and needed to take it public. They needed to find Pat. That's when they brought the case to America's Most Wanted, hoping a viewer could help. The call they were waiting for came in immediately. A tipster from Sacramento, California, told the AMW hotline that his secretary had related a story that matched Pat's. She had heard about the 1981 murder from a co-worker. Detectives were convinced that this co-worker was Pat, still trying to relieve her conscience. It wasn't long before Pat was traced to Carson City, Nevada. Detective McNelly introduced himself to her outside her home, saying "I've been looking for you for two years." She answered, "I was hoping you'd forget who I was." But she cooperated, naming her ex-husband - David Cox - and handing over his Sacramento address. The detectives staked out his house, and arrested the shocked Cox when he appeared. Cox thought he had the perfect alibi - the detectives found him claiming severe disability, using a wheelchair, and wearing a hearing aid. He played up these disabilities during the trial, hoping to convince the jury that he was physically incapable of this crime. The rug came out from under his defense when police found a videotape of Cox washing his van - his crutches resting nearby. The tape had been made by a neighbor who suspected Cox of defrauding the system. The jury took less than an hour to convict. (See Shows #294, #296 and #372, OADs 11/16/93, 12/7/93 and 7/15/95)

CURRENT CASES:

Unknown (Kidnapping) -- The suspect wore a blue floral smock and green scrub pants. Police say she entered the University Medical Center in Jacksonville, Florida, and went to the room of Kamiyah Mobley's 16-year-old mother just hours after the baby had been born. Then, police say, the unidentified woman walked away with the infant. Neither has been seen since. Kamiyah was born with diseases that require medication and has distinctive marks on her buttocks. When last seen, Kamiyah Mobley was wearing a white t-shirt and wrapped in a blanket with pink and blue stripes. She was only eight hours old at the time of the abduction. Kamiyah is 1'9" long and 8 pounds. The suspect is 30-35, 5'5" and 150-160 pounds.

Brian Scott Mayhorn (Statutory Rape, Questioning in Abduction) -- Sometime between the evening of July 13, 1998, and the morning of July 14, 1998, three children - Amanda Palmer, Wayne Palmer, and Tyler Brown - disappeared from a motel in Ohio. Police would like to talk to Brian Scott Mayhorn. Mayhorn, wanted by the FBI for allegedly molesting his daughter, had reportedly moved back to Minerva a year ago to be closer to her. Agents say he had been living in a motel run by the grandmother of the three missing children. The children's mother left them alone for a few hours on the night of July 13. When she returned, she went straight to bed, never suspecting that they could have been taken. When she awoke, they were gone. Mayhorn has recently shaved his mustache. He has a history of assault and spousal abuse. He may be driving a 1991 Blue Chevrolet Cavalier with Ohio plates AWP 5818. Mayhorn is 31, 5'8" and 142 pounds.

A mother put her three children to bed in their grandmother's motel in Minerva, Ohio on July 13, 1998. She went out for a few hours that night, and when she returned, never thought she had to check in on her children. The next morning, all three were gone. Local police and the FBI would like to talk to Brian Scott Mayhorn about the abductions. Mayhorn, additionally wanted by the FBI for allegedly molesting his own nine-year-old daughter, had reportedly moved back to Minerva a year ago to be closer to her. Agents say he had been living in the same motel from which the children disappeared. When last seen Tyler was wearing baggy lime-green shorts, a long-sleeved light blue denim shirt, and black and white low-top tennis shoes. Wayne's hair is

shaved close and he has freckles on his face. He was last seen wearing black and blue low-top tennis shoes, blue shorts with black trim, and a blue shirt. Amanda usually wears her hair at shoulder length. She was last seen wearing black sandals, a pink tank top with white lace or white flowers around neck and pink stretch cotton shorts. The children may be traveling in a 1991 Blue Chevrolet Cavalier with Ohio plates AWP 5818.

CAPTURED:

Trevor Mitchell (Shooting with Intent to Kill, Assault and Battery) -- The tip that came in to America's Most Wanted after Trevor Mitchell's feature turned a manhunt around. Officials had suspected that the fugitive had fled south to Mexico, but a call came in from north of the border - from Montreal, Canada. The FBI joined forces with Canadian officials, and found that Mitchell had been working in construction around Winnipeg, Manitoba. Then came another tip from an alert viewer - Mitchell was working with a band of traveling roofers in Quebec. As the net closed, Mitchell made a critical error. He called a friend back in Winnipeg, but didn't know that friend had seen AMW and had already chosen sides. The friend dialed "*69" after hanging up with Mitchell. Then he passed the phone number to the RCMP. The number led police to a motel just over the river from Montreal in Brossard, Quebec. When police there learned that Mitchell was in their town, they sent in the perfect man to draw him out. Danny Lopez worked part-time as a constable with the police department, and part-time as a construction worker. He lured Mitchell into the open with a promise of work, and drove him down the road where police surrounded the car and cuffed their man. Back in Wilburton, Oklahoma the Murphy family began to realize they could again have a normal life. Mitchell is accused of entering their house in the early morning hours of August 17, 1997 on an assassination mission. His alleged target -CEO of Kiamichi Electrical Co-op Dan Murphy. When Dan took over Kiamichi, he reorganized management, which ruffled feathers of longtime manager Luther Mitchell. In the early morning hours of August 27,1997 - the day before a big board meeting - Cindy and Dan awoke to the sounds of someone breaking into their house. Police say that these two home invaders were James Strickland and Luther's son, Trevor Mitchell. Their alleged attack was clearly well-planned - they cut the Murphys' phone lines and carried two shotguns and an ax handle wrapped with bicycle chain. But Cindy and Dan were prepared as well - weeks before, Dan had a bad feeling and asked Cindy to keep her gun close. As Cindy and Dan crept through their own house, police say they met up with Strickland and Mitchell. Dan was quickly taken down by a ruthless blow to the head from the ax handle. Cindy, who was just behind Dan, started firing. She emptied her gun, but only one of her shots found a home in Mitchell's jaw, police say. Strickland then saw how serious the situation had become, and left the house as Cindy went back to the bedroom for more ammo, thinking of her daughter. As she hid the baby under the bed, she could hear shotgun blasts - what police now call the sound of Mitchell pumping birdshot into Dan's prone body. When she emerged from the bedroom, Mitchell was gone and Dan was bleeding profusely in the hall. Thinking the attackers were still in the house, Cindy left through the bedroom window and crawled through a ditch to a nearby house. She had to visit two houses before someone finally called 911, but a rapid response by paramedics and an airlift to a Tulsa hospital miraculously saved Dan's life. Strickland was captured days later and pleaded guilty to the attack. Although Luther was fired for insubordination, police never linked him to the attack on Dan and Cindy. Strickland is serving a twenty year prison term, and police are confident Mitchell will soon join him. (See Show #494, OAD 5/9/98)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Eric Robert Rudolph (Causing the Death of a Person, Use of an Explosive) -- The massive manhunt for Eric Robert Rudolph continues around the town of Andrews, North Carolina. So far, agents have discovered scattered clues - garbage with his fingerprints and a truck they say he stole and abandoned - but Rudolph himself remains hidden in the thick forest. Inspired by the million-dollar reward, bounty hunters have descended on the area as well, but no one wants to see Rudolph behind bars more than Felicia Sanderson, a widow and mother of two. Her husband, Officer Robert "Sandy" Sanderson was killed by a bomb placed outside a women's clinic in Birmingham, Alabama - a bomb agents say was planted by Rudolph. It took guts, but Felicia traveled to the Smokey Mountains where her husband's killer is believed to be hiding out. She's there to lend her support to the hundreds of investigators working the case. She even used a local radio broadcast to send her plea to the community. Felicia knows that some groups sympathize with Rudolph on political grounds - that they say he was doing "God's work." In response, she doesn't mince words: "God didn't have anything to do with murdering Sandy. Eric Rudolph done that all by himself." Agents say that Eric Robert Rudolph was seen on January 29, 1998, fleeing the scene of the bombing of the New Woman All Women Clinic in Birmingham, Alabama. Immediately after the bomb went off, witnesses saw a man wearing a wig running from the site. Three witnesses saw his truck pull away, and were able to provide a description and a license plate number. The truck was traced to Rudolph, but he had already made his escape. Agents say Rudolph's bomb was loaded with nails - a bomb designed not just to damage property, but to kill and maim. It did both: Birmingham Police Officer Robert "Sandy" Sanderson lost his life. Nurse Emily Lyons was severely injured by the homemade schrapnel she lost her left eye, lost some of the sight in her right eye, and suffered several broken bones and burns. Despite speculation that Rudolph has been close to extremist groups, friends of Officer Sanderson can't view his death as part of a political action. Even though Sanderson was moonlighting as a security guard for a family planning clinic, they say he was outside of the abortion controversy - that he was just doing his job: enforcing the law. Rudolph is also wanted for questioning in a series of deadly Atlanta bombings: the 1996 Centennial Olympic Park

bombing that killed one and injured more than one hundred others, an attack on an abortion clinic in January 1997 that injured seven, and a February 1997 attack on a gay nightclub. Authorities confirmed that they are investigating similarities in the construction of Rudolph's alleged bomb and the others. In particular, they're investigating a possible match between the nails in the Birmingham bomb and those in the Atlanta bombs. Rudolph has been described as a mysterious and reclusive man from the rugged mountains of North Carolina. Though agents believe it's likely that he's taken to the wilderness to hide, they're confident that the new \$1 million price on his head will make it hard for Rudolph to hide for long. Rudolph, who has used the alias Bob Randolph, has worked as a carpenter and spent 18 months in the U. S. Army. He has a reputation for anti-government views. He is estranged from family. He is an experienced woodsman and completed army survival training. Rudolph is 31, 5'11" and 150 pounds. (See Shows #483, #485, #487, #494, #498 and #503, OADs 2/21/98, 3/14/98, 3/28/98, 5/9/98, 6/6/98 and 7/18/98)

Mark Jay Allen (Armed Robbery, Escape, Carjacking) -- Mark Jay Allen was sitting in a Greenville, South Carolina jail cell on May 23, 1998, awaiting trial for the armed robbery of four U.S. Post Offices. His surroundings weren't new - Allen had spent eleven years in prison for armed robbery in the state of Georgia, and had only been released in January 1997. Deputies with the U.S. Marshals Service say that he decided not to take his chances at the trial and jimmied his lock to make his escape. Deputies say that Allen didn't waste any time getting back on the job. At a car wash in Greenville, the suspect allegedly waited for a helpless victim to come along, and found her - a 56-year-old woman who suffered from a heart condition and carried oxygen bottles. Police say Allen took her hostage just past 9:00 p.m. As Allen drove, the victim says, she started to suffer chest pains, and told him she was about to have a heart attack. She was released, but claims Allen kept her money and her car. Less than two hours later, marshals say, Allen robbed a Waffle House in Jefferson, Georgia, about 50 miles away. The next day, deputies claim they made out his face in a surviellance video, robbing a supermarket in Georgia. It looks to officials like a crime spree is just getting underway. Deputies are especially concerned over a statement Allen allegedly made after he was captured and sent to the Greenville jail - that if he had been armed when he was arrested, he would have started shooting. Now that he's back on the loose, officals feel that no police officer who crosses his path is safe. Allen, who has used the aliases Justin, Marc, Albert, and Josh, has a "Harley Davidson" wings tattoo on his right forearm. Allen is 30, 5'10" and 165-170 pounds. (See Show #502, OAD 7/11/98)

Tom Curtis (Armed Robbery) -- From November 1996 to November 1997, police say nineteen armed robberies by two teenage gunmen rocked the businesses of northeast Portland, Oregon. Each time, the cops reportedly heard the same story - two gunmen, one black, one white, would burst through the doors, pulling on ski masks as they pulled out their guns. As

police collected witness reports, they realized that these two were not the usual suspects. They were clean-cut, wore fashionable clothes, and sometimes, in the midst of the robbery, were polite to their victims. The investigation, however came up with no names until one of the alleged robbers made a serious mistake. On November 15, 1997, police received a call from a restaurant that had just been robbed. As the bandits pulled away in their stolen car, police say, one of them tucked his pistol into his pants, accidentally pulled the trigger, and sent a slug straight through his testicles. Shortly afterwards, 911 got a call from a panicked young man who claimed his buddy had been shot by a gang. The cops didn't buy the victim's story, and announced two suspects to a shocked community. They were two of the most respected students at the prestigious Grant High School - homecoming king Ethan Thrower and student body president Tom Curtis. Police arrested Thrower the day before the senior prom. Days later, Curtis left his comfortable home to begin life as a fugitive. He has been charged with three of the robberies and is a suspect in the remaining 16. Police say their ongoing investigation may lead to more suspects. Police say Curtis lived on the streets, and found a friend who would hide him in his home. But the law was always one step behind. The popular class prez didn't come in from the cold until his classmates went to sunny Mexico for the senior trip, and they weren't surprised when he joined them. Out of 37 students, no one thought of turning him in. Some even allegedly gave him money. Now police believe Curtis could be anywhere between Portland and Mexico. He's also an eagle scout, and could have taken to the hills. While some classmates still call him a good kid, police are hoping that someone who knows him will realize it's not kid's play to hold a gun to someone's head, and will send this fugitive back to Portland in shackles. Curtis may wear a goatee and sideburns, and may wear prescription glasses. Police claim he may have suicidal tendencies. He may have ADD. He often wears baggy blue jeans and tshirts. Curtis is 18, 5'9" and 135 pounds.

Unknown (Murder) -- Sharon Moskowitz probably never had time to react. She had taken a sick day from her job at the Japanese Embassy in Washington, DC, and was returning from the health food store at around 2:30 p.m. on January 21, 1997. She didn't know that while she was away, two suspects had broken into the townhouse where she rented a room. At 2:45, the townhouse owner returned home to find Sharon tied down and strangled. He immediately called the police, who were on the scene in minutes. The tragic story was pieced together at the crime scene. Police say Sharon was probably attacked the moment she stepped inside. She was first tied up, then killed. The killers then callously treated themselves to her groceries as she lay dead in the next room. Sharon was 25, and had only come to Washington weeks before to start a new life. Now that life was over. Crime scene technicians went over the townhouse in painstaking detail. Witnesses were found in the neighborhood - someone had seen two young men loitering in the alleyway, checking out houses. One of them was wearing a sweatshirt with the letters "PITT." As police worked the crime scene, they say the suspects parted ways. One suspect, the

one with the sweatshirt, apparently made a stop at a gas station in southeast Washington where he ran Sharon's credit card through the pump and bought a dollar's worth of gas. Police say he was just testing the card, getting ready for a shopping spree that would last late into the night. Police say they have records of the credit card being used in three supermarkets throughout the city, but the suspect wasn't stocking up on food. According to the police, a common way to turn a stolen credit card into cash is to buy groceries for someone else, and have them pay you in bills. The thief puts a hundred dollars on the card, and the shopper pays the thief fifty. A simple scam - both parties win. When police retraced the charges on the card, they found plenty of witnesses who saw "Pitt" shopping with various customers. In the end, he charged around \$600 before giving up. But at one supermarket, police got a break - they had a security camera, and got a man on tape, signing his name on a receipt and wearing a sweatshirt that read "PITT." In spite of these leads, the suspect still hasn't been identified. His face continues to haunt the detectives who saw Sharon lying face down in her home. They want every set of eyes out there to be looking for this man - if you've seen him, please call. The suspect, who wears very thick prescription glasses, is 30-40, and 5'6".

Unknown (Murder) -- David Holt, assistant manager of the Sam's Club store in Augusta Georgia, was a 45-year-old father of two sons. On June 21, 1998, someone killed this loving husband, devoted father, and dedicated employee - and the safe at Sam's Club was found empty. Police in two states are working on this horrific crime, and are asking for your help. David left work just past midnight on Sunday, June 21 with a fellow employee, who drove off with his wife. No one knows what happened next, but police say David was forced to re-enter the store and turn off the alarms. They later discovered the store safe cleaned of cash, and the security video missing. David was then taken in his own car on a ride to the nearby Fifth Street Bridge, which leads into Aiken County, South Carolina. The car was then set afire, with David in the trunk. The fire department was left to make the grizzly discovery. David has been honored by his employees with a large memorial inside the store, while Wal-Mart corporation has offered \$100,000 for information leading to an arrest and conviction and established a fund for his children's education. Meanwhile, Sheriff's departments on both sides of the state line are asking for your help.

Brian Scott Mayhorn (Statutory Rape, Questioning in Abduction) -- Sometime between the evening of July 13, 1998, and the morning of July 14, 1998, three children - Amanda Palmer, Wayne Palmer, and Tyler Brown - disappeared from a motel in Ohio. Police would like to talk to Brian Scott Mayhorn. Mayhorn, wanted by the FBI for allegedly molesting his daughter, had reportedly moved back to Minerva a year ago to be closer to her. Agents say he had been living in a motel run by the grandmother of the three missing children. The children's mother left them alone for a few hours on the night of July 13. When she returned, she went straight to bed, never

suspecting that they could have been taken. When she awoke, they were gone. Mayhorn has recently shaved his mustache. He has a history of assault and spousal abuse. He may be driving a 1991 Blue Chevrolet Cavalier with Ohio plates AWP 5818. Mayhorn is 31, 5'8" and 142 pounds. (See Show #503, OAD 7/18/98)

Unknown (Kidnapping) -- The suspect wore a blue floral smock and green scrub pants. Police say she entered the University Medical Center in Jacksonville, Florida, and went to the room of Kamiyah Mobley's 16-year-old mother just hours after the baby had been born. Then, police say, the unidentified woman walked away with the infant. Neither has been seen since. Kamiyah was born with diseases that require medication and has distinctive marks on her buttocks. When last seen, Kamiyah Mobley was wearing a white t-shirt and wrapped in a blanket with pink and blue stripes. She was only eight hours old at the time of the abduction. Kamiyah is 1'9" long and 8 pounds. The suspect is 30-35, 5'5" and 150-160 pounds. (See Show #503, OAD 7/18/98)

Unknown (Murder) -- In September 1997, a hunter preparing for deer season in Asheville, North Carolina, stumbled across a ladies wristwatch deep in the woods. He stooped to pick it up and scanning the area, he discovered some bones. At first he thought nothing of it; wild animal carcasses are common in the wilderness. But next the hunter saw a horrific sight: some of the bones were wrapped in tattered clothing. These were human bones. We now know this was the remains of 50-year-old Judith Smith. Police are hoping for answers in a case that has only questions. All we know is that sometime in April 1997, someone killed Judith Smith and buried her in a shallow grave in the woods of Asheville. The rest of the story only compounds the mystery. That April, Jeff and Judith Smith started on a trip from Boston to Philadelphia, where Jeff was attending a pharmaceutical conference. Judith had never seen the city of brotherly love, and was looking forward to a day of sightseeing. But right away, they ran into problems. Jeff says that Judith reached Boston's Logan Airport before discovering she had forgotten her ID. They wouldn't let her on the plane, so she said she would take a cab home and get on a later flight. At 9:30 that night, Jeff says they met at the DoubleTree Hotel in the Center City neighborhood of Philly. He says they ate pizza in the hotel room, and went to bed. The next morning, Jeff continues, he left her in the room as she was getting ready to shower. Jeff was due back around five. He says he never saw Judith again. That night as the hour grew late, Jeff called the Philadelphia Police Department to search for his missing wife. They found not a single clue, and the longer they searched, the more suspicious detectives became that they were being led on. Jeff Smith knows that his story is suspect, and thinks the cops' suspicions are "ludicrous." But Philadelphia detectives are holding on to their doubts. "Personally," says Detective James Sweeney, "I don't feel she was here in Philadelphia." Detectives haven't found anyone on the plane from Boston who remembers seeing Judith. Two witnesses remember

seeing Judith at the DoubleTree - but police call these witnesses unreliable because the timing of their sightings just doesn't fit Jeff's story. Detectives couldn't find any of Judith's dirty laundry in the hotel. They didn't find any of Judith's personal effects on the bathroom sink, except for a bag of curlers. Some of Judith's clean clothing was hanging in the hotel room closet, but a female detective and a female photographer each doubt that a woman placed them there. In their opinion, no woman would hang her dresses the way police found them. After the Philly cops wrapped up their investigation, Jeff started his own. He obtained lists of homeless shelters, hospitals, and social service agencies. He made up 10,000 flyers and even got an 800 number in an effort to find out what had happened to his wife. Eventually, he did. A doctor in North Carolina saw one of Jeff's flyers and realized that an unidentified body in Asheville could be Judith's. Dental records confirmed his hunch. Judith had been located, but this discovery only raised more questions. There is no record of Judith traveling to Asheville by plane or rental car. Witnesses in the small town - at a motel, at a shop - remember seeing her in town, apparently enjoying herself. But locals maintain that the remote location where she was discovered is the last place a visitor would go. No buses travel to the area, no cabs extend their service that far out. The only nearby structure is a cabin owned by shop owners in the town where Judith was spotted. Clues at the crime scene included tennis shoes, a blanket, food wrappers, sunglasses, a blue and black backpack, a book, a water bottle, and a cereal box. Investigators believe that Judith, and maybe a companion, came out to this location to spend the day. The blue and black backpack is especially interesting - Judith's backpack, which she traveled with for years, was red. Also at the crime scene, investigators found a pair of sunglasses. Could they be the killer's? They're made by Bolle and retail for at least \$100. Judith's family says they aren't hers and she'd be unlikely to spring for such an expensive pair. Police believe the sunglasses could belong to either Judith's killer or someone who witnessed her murder. There are several unsolved riddles for law enforcement in this case: Did Judith ever make it to Philadelphia? How did she get to Asheville? Whose backpack was found at the scene? Why would she come to Asheville in the first place? And finally, why would anyone kill her? Police are hoping an America's Most Wanted viewer can provide even the smallest scrap of evidence - it may mean another mystery solved.

John Lezell Balentine (Capital Murder) -- Early Wednesday morning, January 21, 1998, police in Amarillo, Texas received a report of gunshots in a normally peaceful neighborhood. A patrolman was on the scene immediately, but when he arrived, everything was quiet. The one thing he noticed, however, was a man walking quickly down the street, looking over his shoulder. The officer decided to question him. The man reportedly gave the name John Lezell Smith, and claimed he was walking home from Wal-Mart, several miles away. The more the officer questioned him, the more suspicious the officer became. Finally, the officer conducted a search, and allegedly found a .32 caliber Winchester round in the man's pocket. But

there was no sign of a crime, and no reason to hold him. He walked free. Police now say that man was John Lezell Balentine, and that he was walking away from the first triple homicide in Amarillo in more than 60 years. Three boys, all teenagers, all shot with .32 caliber rounds, were discovered in the afternoon on the same street where "John Smith" had been spotted hours earlier. Police say someone had entered their house and killed them, coldly and deliberately, while they slept. Police say they learned from family members and acquaintances that John Lezell Balentine had been harboring a grudge against one of the dead boys ever since his relationship with that boy's sister had turned sour. A search of Balentine's residence allegedly uncovered a receipt for .32 caliber ammunition, and by questioning Balentine's other girlfriend. police say they were able to trace his travels by bus to Albuguerque, New Mexico. But from there, the trail turned cold. Balentine has used the aliases John Smith, John Rowe, and Bob Boker/Broker. He has a diagonal scar above his upper lip, and a scar between his eyebrows across the uppermost bridge of his nose. He has worked as an auto mechanic or carpenter, and has a reported history of burglary, robbery, battery, carnal abuse. Balentine frequently uses fictitious social security numbers. He is 31, 5'10" and 155-170 pounds. (See Show #501, OAD 6/27/98)
