Joe Cunningahm and Joe for South Carolina, Joe Cunningham's gubernatorial campaign committee, authorizes the South Carolina Democratic Party/Joe for SC to coordinate and air advertising on his behalf solely concerning the South Carolina's governor's race.

The advertising will include a positive appearance of Joe Cunningahm (his voice or likeness that is either identified or readily identifiable). The advertising will state in the disclaimer that it is "authorized by Joe Cunningham."

Accordingly, the advertising will constitute a candidate "use" of your station's facilities and is therefore entitled to the "lowest unit charge." 47 U.S.C § 315(b)(1); 47 C.F.R. §§ 73.1941(b) and 1942(a).
