- Bills shall be received monthly and shall be due payable within ten (10) days from day of invoice. Eighteen percent (18%) interest per annum will be charged on delinquent accounts.
- Station shall have the right to cancel this contract upon default by advertiser in the payment of bills and other materials breach. Upon cancellation all broadcasting done hereunder and not paid shall become immediately due and payable at the earned rate. Advertiser shall pay all attorney's fees in the event legal action is necessary to enforce this agreement or any of the terms thereof.
- Contract subject to termination by advertiser upon thirty (30) days prior written notice.
- Political and entertainment advertising-cash in advance.
