On behalf of CBS Corporation (“CBS”), this is to notify you that, pursuant to Section 325 of the Communications Act of 1934 as amended, Section 76.64 of the FCC’s rules, the letter agreement dated June 1, 2010, as may be amended from time to time (the “Letter Agreement”) between CBS Corporation and Comcast Cable Communications, LLC, and Section 11 of the Retransmission Consent Agreement annexed as Exhibit D to the Letter Agreement, as may be amended from time to time (the “RCA”), CBS hereby elects, on behalf of the television stations listed on Exhibit A and owned directly or indirectly by CBS (“O&O Stations”), the retransmission consent option with respect to carriage of the broadcast signals of such O&O Stations (“Signals”) on all Systems (as defined in the Letter Agreement) which operate within the DMA of an O&O Station for the 2018-2020 election period. 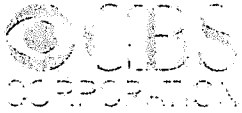

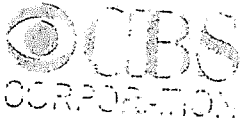
