Vertical, guyed, shunt-excited, steel radiator of uniform cross section 92.7m (106.8°) in height (92.7m overall) with a six bay FM antenna side mounted near the top and utilizing a folded unipole feed. Theoretical Efficiency: 31.7 mV/m/kW at one km; Restricted to 304.17mV/m/kW at one km. Ground system consists of 120 equally spaced buried, copper radial 79.2m in length.
