The Wage and Hour Division of the United States Department of Labor is agency responsible for enforcing federal labor laws. Any person, regardless of immigration status, has the right to receive payment for hours worked. Construction companies, senior care, restaurants, and warehouses are workplaces where employers often take advantage of migrant workers, according to statistics. Misclassification occurs when an employer treats a worker who is an employee as an independent contractor. Misclassifying employees as independent contractors is a serious problem because employees may not receive the minimum wage and overtime pay or other benefits and protections to which they are entitled under the law.

Passed by the General Assembly in 2021, Anton's Law allows the public to access police misconduct records. But the Montgomery County Fraternal Order of Police (FOP) filed a lawsuit seeking to prevent Montgomery County from releasing records made public under the law, and asking the judiciary to rewrite the law to prevent the release of records that the General Assembly said should be public.

The 34th edition of the Annie E. Casey Foundation's Kids Count describes how the country's lack of affordable and accessible child care negatively affects children, families and U.S. businesses. The report shows how children and youth of color are a long way from having a fair opportunity at success, despite the incremental progress the nation has made over the years. The report standardizes assessments of 12 indicators representing indicators of well-being from cradle to career and converts them into a scale ranging from 0 to 1,000. Asian and Pacific Islander children have the highest index score at 771, followed by white children at 697 and children of two or more races at 612. The scores of children who are Latino (452), American Indian or Alaska Natives (418) and Blacks (386) are considerably lower.

The first step to a good financial year is setting achievable goals, like paying off debt, saving for a significant investment, or building an emergency fund. Breaking goals into smaller steps, assigning deadlines, and setting achievable goals will allow us to reach goals. One idea is to automate the money you shouldn't spend by automatically transferring it to a savings account each month. Additionally, examine your monthly expenses and look for areas where you can cut costs, whether canceling unnecessary subscriptions, preparing meals at home instead of eating out, or taking advantage of deals and discounts. Another effective strategy is the 50/30/20 rule, where we allocate 50% of our income to basic needs, 30% to personal expenses, and 20% to savings. Adjusting these ratios according to needs can help maintain financial balance and achieve financial goals.

Virginia Coalition of Latino Organizations (VACOLAO) will host a press conference to advocate for Latino and immigrant community education programs and civil rights this Tuesday, January 23. The purpose of the press conference is to outline VACOLAO advocacy priorities during the session of the General Assembly, like health coverage for all VA's children, increasing the number of teachers for English Language Learners, restoring \$10 million in state scholarship funding to students ineligible for federal aid/grants, anti-rent gauging, extending the validity of VA's Driver Privilege Card. VACOLAO will be tracking these other legislative proposals: Removing the term "Alien" from the Virginia Code, and requiring every employer to enroll in the E-Verify program.

U.S. Citizenship and Immigration Services (USCIS) announced last Tuesday, January 30, the implementation of a final rule that increases the fees for some immigration procedures, which, according to a statement, will facilitate more efficient and timely processing. The agency covers 96% of its operating expenses with immigration service fees. USCIS has faced a constantly increasing workload and criticism due to delays in immigration procedures in recent years. According to a statement issued by the agency, after an exhaustive review, the costs associated with immigration procedures are considerably below the total operating cost. For the first time in more than seven years, USCIS is updating its fees to meet the agency's needs and to provide more timely decisions.

The Internal Revenue Service announced that Monday, January 29, will officially begin the nation's 2024 tax season, accepting and processing 2023 tax returns. The IRS expects more than 128.7 million individual tax returns filed by the April 15, 2024, tax deadline. Although the IRS will not officially begin accepting and processing tax returns until January 29, taxpayers do not need to wait until then to start preparing their taxes if they will use software companies or hire tax professionals. For example, most software companies accept electronic filings and hold them until the IRS is ready to start processing them later this month.

A healthy sexual life can positively influence mental and emotional health, while issues related to sexual health can have negative effects on a person's psychological and emotional state. People diagnosed with HIV can experience stress and tension with family members; and revealing HIV status to sexual partners may lead to revelations of infidelity, sexuality, or intravenous drug use. Partners should get tested for HIV. The sooner a person get tested the sooner can get support. Prince George's County Health Department provides services for HIV diagnosis and treatment, and mental health.

Reforest Montgomery is a program that favors and promotes reforestation in Montgomery County. Through this program, trees are planted in forests throughout the county in addition to programs aimed at neighborhoods, parks, and homeowners. The Forest Conservation Fund finances the replacement of forest trees and lost canopies in certain areas around the county. The Free Tree program is open from February 1 and will close on February 8. Residents living in Equity Forest Areas with limited resources and whose first language is not English are a priority. Those interested can choose trees from the species offered on the website. A second application will open in February. The trees are free and include tree planting through contractors working for Montgomery County.

February 7 is National Black HIV/AIDS Awareness Day to acknowledge how HIV disproportionately affects Black people. Black Americans represent 14% of the U.S. population, but 40% of new HIV infections, with black women accounting for 54% of all new HIV diagnoses in women. Black women, cis- and transgender, face additional barriers due to sexism, preventing access to HIV preventative treatments like PrEP, testing services and medical care. The National HIV/AIDS Strategy designates Black women as a priority population, compelling federal agencies and other stakeholders to focus resources to support them.

The 2024–2025 Free Application for Federal Student Aid (FAFSA) form is now available. The form can be completed to request financial aid to help pay for higher education between July 1, 2024 and June 30, 2025. The 2024–25 FAFSA form expands the selection criteria for receiving federal student aid, including Pell Grants, and provides a streamlined user experience. Approximately 7.3 million low-income students will be eligible for Federal Pell Grants due to updates to student aid calculations. Additionally, applicants may skip up to 26 questions, depending on their individual circumstances. Some applicants may be able to answer as few as 18 questions, which could take less than 10 minutes.

Only twenty percent of people with disabilities, including those with autism, are employed, despite having the skill set and desire to work. Workplace Inclusion Now (WIN) is an Autism Speaks workforce development program for employers, job seekers and community members committed to promoting diversity in hiring and creating an inclusive workplace culture in which not just autistic adults, but all employees can thrive.

CASA will hold on Friday, February 9, will hold a press conference and rally to urge the Prince George's County Council to pass a fair and permanent Rent Stabilization law before April 16. Rent Stabilization is a policy that prevents landlords from hiking up the rent over a certain percentage each year, matching inflation costs. The policy keeps rent affordable and predictable for tenants from year to year. For example, a 3% rent stabilization policy means that a landlord can only raise the rent by 3% of the current amount each year. If a tenant pays \$1,000 per month in rent in 2024, the landlord can only raise the rent to \$1,030 per month in 2025, maximum. Prince George's County rent stabilization law ends on April 16, 2024: that means after this date, a landlord can raise the rent as high as they please.

There are three strong methods to prevent HIV transmission: condoms, medication to manage HIV but also to prevent the transmission to another person, and the pre-exposure prophylaxis (Prep) medicine that reduces the chances of getting HIV from sex or injection drug use. When taken as prescribed, it is highly effective for preventing HIV. Prep medication is provided by prescription to the person without HIV. Prep medication is a personal choice, and it creates a strong third method of protection from HIV. Prince George's County Health Department provides Prep medication, services for HIV diagnosis and treatment, and mental health.

Mary's Center is inviting the community to participate in the *All of Us* Research Program to help build one of the most diverse health databases in history. They welcome Latino participants from all backgrounds and help with the registration process. Researchers from NIH will use the data to learn how the biology, lifestyle, and environment affect health. The purpose in the future is find ways to treat and prevent diseases.

The consequences of Covid-19 continue to be a burden for some small businesses. However, there is optimism in greater growth, and resilience is one of the main characteristics of Latino entrepreneurs. Like a credit card, with no plastic, a business line of credit comes with several benefits, and it is not usually as expensive as a business credit card. A business line of credit gives access to a predetermined amount of money that businesses can borrow from on an asneeded basis. Instead of receiving an upfront lump sum, an entrepreneur has access to a revolving line of credit. It's similar to a credit card, but a business line of credit tends to come with much higher credit limits. As with a credit card, you can use it to make cash withdrawals or transfer funds to your business checking account.

Newly released Federal Trade Commission data show that consumers reported losing more than \$10 billion to fraud in 2023, marking the first time that fraud losses have reached that benchmark. It marks a 14% increase over reported losses in 2022. Consumers reported losing more money to investment scams—more than \$4.6 billion—than any other category in 2023. That amount represents a 21% increase over 2022. The second-highest reported loss amount came from imposter scams, with nearly \$2.7 billion in losses reported. In 2023, consumers reported losing more money to bank transfers and cryptocurrency than all other methods combined.

Many college FAFSA due dates have priority deadlines, meaning students should submit their FAFSA form before that date to receive the most money. Many colleges have this date marked on their financial aid web pages. In addition to federal financial aid, each state has funds for student financial aid. The Maryland Dream Act became law on December 6, 2012, and applies to all future semesters, starting with the 2013 winter session and beyond. The law allows Maryland high school graduates who are undocumented immigrants, U.S. citizens, and other statuses the opportunity to qualify for the lowest tuition rates at their public colleges and universities upon meeting eligibility requirements and submitting required documentation.

The Social Security Administration (SSA) updated the agency's Equity Action Plan. The plan is issued in response to an Executive Order signed by President Biden on January 20, 2021, directing all federal agencies to pursue a comprehensive approach to advancing equity for all, including people of color and other people who have been historically underserved, marginalized, and adversely affected by persistent poverty and inequality. The updated Equity Action Plan focuses on ensuring that language does not create barriers to applying for benefits and accessing services; reduces outstanding Income Security program underpayments (SSI), evaluates the root causes of the payments incorrect; and increases awareness about survivor benefits, especially among people disproportionately affected by COVID-19.

The Florida Education Association is the state's largest professional employee association, with 120,000 members, and represents PreK-12 teachers, educational staff professionals, higher education professors, and graduate assistants. New statistics about teacher vacancy numbers show that halfway through the school year, there are still 4,096 instructional vacancies announced in Florida schools and 3,457 support staff vacancies, for a total of 7,553 vacancies across the K-12 education system. The shortage includes classroom assistants, English Language Teaching (ELL) paraprofessionals, and bus drivers. Due to ongoing shortages, there has also been a year-over-year increase in core courses such as English, reading, science, and math taught by teachers not certified in that field.

Through the lens of a dozen real-life stories of men, women, and children who have been caught in the (sometimes literal) crossfire of our nation's patchwork immigration policies, García Hernández uses data, statistics, and common sense to present a case for a new, less punitive system that would work better for all nation, and save taxpayers in the U.S. millions. In the book, the author makes a powerful case for divorcing immigration law from criminal law, including abolishing so-called immigration crimes (such as crossing and re-crossing the border "illegally").

The United States Citizenship and Immigration Services (USCIS) has announced that fees for a range of immigration-related applications and services will increase on April 1, 2024, according to their final rule. This change comes as part of the agency's ongoing efforts to cover the costs of its operations and reflect inflationary increases in the cost of processing immigration applications. The final rule is the result of a comprehensive fee review, as required by law, and follows the January 2023 publication of a notice of proposed rulemaking. The review concluded that the current fee schedule falls far short of recovering the full cost of agency operations, including the necessary expansion of humanitarian programs, federally mandated pay raises, additional staffing requirements, and other essential investments.

Prince George's County Parks and Recreation Department hires new employees to work during the 2024 summer season. The county also announced three job fairs to hire young people and adults who want to work during the summer on March 16, March 30, and April 20. The National Highway Traffic Safety Administration reminds all parents and caregivers of children of the importance of using a car seat. As parents or caregivers, we must be sure that children are in the correct seats, installed, and buckled correctly. There is a law in all fifty states that children from birth to thirteen years old must travel in the back of the car. Buckling up is an effective measure a parent can take to protect children in a crash. According to statistics, car crashes are one of the causes of death of minors. Every 32 seconds in the United States, a child was involved in a traffic crash. A total of 863 children under 14 years of age in 2021 died in traffic accidents, and 40 percent were not buckled up.

The Union of Concerned Scientists wrote a scientific report titled Invisible Threat, Uneven Impact, in which they assessed the health risks from more than 100 commercial sterilizers emitting ethylene oxide in the United States and Puerto Rico. A DOL spokesperson announced the Whistleblower Protection program that protects workers against retaliation from a bad employer. He also mentioned that immigration status is not a limitation to complain to the Department of Labor. This Hispanic Heritage Month, the US Department of Labor is raising awareness among Hispanic workers about the Whistleblower Protection Program. Workers have the right to notify a supervisor or employer of a hazardous condition, report a workplace injury or illness, refuse to perform a dangerous task, or request an inspection at the workplace by OSHA. If an employer has retaliated against a worker, the worker must file a retaliation complaint with OSHA within 30 days of the alleged adverse action.

In 2023, the American Academy of Pediatrics published its "Clinical Practice Guideline for the Evaluation and Treatment of Children and Adolescents with Obesity." The guideline recommends considering metabolic and bariatric surgery (MBS) for obesity when medical or lifestyle treatments are not sufficient for youth with class 3 obesity or class 2 obesity with co morbidity including obstructive sleep apnea, type 2 diabetes, idiopathic intracranial hypertension, gastro esophageal reflux or hypertension. A guest expert in bariatric surgery spoke about the eligibility of adolescents for bariatric and metabolic surgery, how to recognize this condition, and the need to undergo surgery.

While no states grant undocumented immigrants the right to vote in state elections, more than a dozen municipalities nationwide allow undocumented immigrants to vote in local elections. D.C. residents with no U.S. citizenship will be able to vote in local elections for the first time starting in 2024. Voting requirements will remain the same for citizens and non-citizens. Voters have to be 18 years old by the time of the general election, must have lived in D.C. for at least 30 days before the election, and cannot claim voting residence in any other U.S. state or territory.

ISSUE: Supplemental Security Income (SSI)

The Supplemental Security Income (SSI) is a federal government benefit that provides monthly payments to children and adults with disabilities who have low income and few resources. It helps to pay for basic needs like food, clothing, and shelter. Individuals must apply and qualify to receive this money. The Social Security Administration has achieved its goal in 2023 to increase SSI applications by 25 percent, helping eligible people access critical benefits. As part of its core mission, SSA continues its SSI campaign to reach people in "underserved cities and communities" in the U.S. who have shown a high decline in SSI applications during the pandemic and after.

Dr. Hector Colon Rivera, spokesperson for the American Psychiatric Association, shared the results of a survey that shows that Americans are more open to talking about substance use disorder and behavioral addictions and are also more open to asking for help in case of having to assist a family member. Dr. Colón said that the concept of substance abuse has changed by the term substance use disorder, conceptualized as the use of any substance for more than twelve months. When it comes to behavioral addictions, whether gambling, pornography, or exercise, for example, when it becomes an obsession or compulsion, it becomes an addiction. Once these obsessive behaviors affect work, sleep, temperament, family, or daily activities, it can be considered a behavioral addiction, much like substance use disorder.
