The station has identified the following as significant issues and concerns to our listeners and community during this quarter:

Section II. Responsive Programs This station broadcast programming dealing with the above-referenced issues as follows:

1. Increase in Crime:

7/6/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Court documents are revealing more information regarding the deadly domestic shooting inside a Ewa Beach home late last week. According to reports, 24-year-old Josiah Garcia shot his mother in the face, killing her on Friday, July 1st. Garcia called 911 to report the shooting. Police say he was compliant when they arrived and pointed officers inside the home to his mother's body.

7/12/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii Attorney General Holly Shikada has joined the attorney generals of 20 other states in support of new federal regulation of ghost guns. Ghost guns are often made from kits and don't have serial numbers, making it almost impossible for law enforcement to track them down. People who have ghost guns usually get them without undergoing background checks as well. But, the new federal rule requires buyers to pass background checks before buying a ghost gun kit they can assemble at home. Supporters believe this will make ghost guns easier to trace and will make life more difficult for gun traffickers.

There's new information about a stabbing that left a couple wounded in Waipahu on Saturday morning. Prosecutors say a woman broke into her ex-boyfriend's home, grabbed a knife from his kitchen, and stabbed him in the head and arm as he slept. She also allegedly stabbed his new girlfriend several times when she tried to stop the attack. Arriving police officers found two large knives soaked with blood. The woman is facing first and second-degree attempted murder charges. Court records show the woman attacked her ex just three days after their two-year relationship ended.

7/14/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) County prosecutors across Hawaii are calling for stricter penalties for politicians and public figures who are convicted of white collar crimes. At a State House Commission meeting yesterday, prosecutors from Honolulu, Maui, and Kauai County asked for mandatory prison time for these types of convicted criminals. This is an effort to weed out corrupt public figures in the state. Recommendations made would bring Hawaii closer to federal guidelines where bribery and corruption crimes generally result in jail time.

A 19-year-old will be spending the rest of his life behind bars in connection to a brutal stabbing at Kahala Beach in 2020. A jury had already convicted Erik Willis of second-degree attempted murder after he stabbed 17-year-old Melia Kalahiki 15 times. On top of the life sentence without the possibility of parole, Willis must pay over 80-thousand-dollars in restitution to the victim.

7/19/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A former Big Island housing official has pleaded guilty to taking almost two-million-dollars in kickbacks. On Monday, 55-year-old Alan Rudo admitted to conspiracy to commit

honest services mail fraud. Between 2006 and 2018, Rudo was a housing specialist for the Office of Housing and Community Development. He took the money between 2014 and 2021. He secretly sold land and housing credits to three co-conspirators, who have not been publicly identified by prosecutors. He faces two decades behind bars and a quarter-million-dollar fine. Sentencing happens in October.

7/21/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Honolulu police are investigating after a woman was stabbed to death on the H-3 Freeway in Kailua. The woman in her 30's was stabbed Wednesday evening, and the suspect, a man in his 30's, is hospitalized in serious condition. Both the man and woman were stabbed several times. It's unclear if the man's injuries were self-inflicted, or caused by the woman. A witness says the stabbing happened on the side of the freeway, and the man was tackled by a good Samaritan.

A man is being sentenced to 40 years in prison for trafficking two teenagers. Marquis Green was arrested in 2013 in connection with the sex trafficking crime but wasn't sentenced until Wednesday -- nearly nine years later. Judge Rowena Somerville gave Green 20 years for first degree sexual assault and 20 years for sex trafficking in prison terms that will run back to back. Honolulu Prosecutor Steve Alm said the sentence will ensure the public's safety and serve as a warning to other traffickers.

Police are investigating a series of 55 burglaries that have happened in Oahu since March. Officials say the burglaries are mostly smash-and-grab style, with the thieves throwing rocks through windows or doors before stealing money and merchandise. Several people have already been arrested in connection to the crimes, but police believe there's a larger group of organized individuals behind the thefts. The investigation is ongoing, but Police Chief Arthur Logan released a statement saying they are investigating a few other people they believe to be involved.

7/22/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The woman who was stabbed to death on the H-3 Freeway on Wednesday evening was allegedly killed by her husband. Family members also say the woman was pregnant. Witnesses called 911, reporting the man was standing on the side of the road, stabbing the woman repeatedly. Witnesses pulled over and restrained the man. He was able to get away, but was eventually caught by police. Police say the man is a Marine stationed at Kaneohe Marines Corps Base Hawaii. After stabbing his wife to death, he allegedly used the same knife to injure himself.

Police are launching an attempted murder investigation after a man's hand is allegedly cut off with a sword overnight in Waikiki. According to a report from Hawaii News Now, the 46-year-old suspect attacked another man after an altercation between the two escalated. Officials say the incident unfolded around midnight at a 7-Eleven. The victim was transported to the hospital in critical condition. The unnamed suspect is in police custody and the investigation continues.

7/25/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Marine Corps officials were aware of domestic disputes involving the couple at the center of last week's deadly stabbing attack on the H-3 Freeway. Officials from Marine Corps Base Hawaii in Kaneohe say they offered law enforcement intervention and counseling to the 27-year-old military wife, and her 29-year-old U.S. Marine ex-husband accused of stabbing her to death. Citing police sources, the Star-Advertiser reports the woman was stabbed on the side of the

freeway with a Gerber Suspension multi-tool. It has a dozen tools, including knife blades, a saw, scissors, and screwdrivers. The suspect remains hospitalized after allegedly stabbing himself with the same weapon.

A man accused of chopping another man's hand off with a sword at a 7-Eleven store in Waikiki has been charged with attempted murder. The 46-year-old suspect remains behind bars on 400-thousand-dollars bail after Friday morning's incident. Police say, the suspect, an employee of the convenience store, and the victim got into some sort of dispute before the employee pulled out the sword. A witness tells Hawaii News Now the two men have had altercations inside the 7-Eleven in the past.

7/26/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A man from Waipahu is facing federal charges on suspicion of going on a spending spree with phony checks. The Secret Service says the crimes happened in December of 2020, but they didn't arrest the man until last week. Investigators say he used three counterfeit cashier's checks to buy a Land Rover, and post bail for three acquaintances who were locked up at Oahu Community Correctional Center. One of the checks was in the amount of 760-thousand-dollars. That was the exact bail amount for a man being held in OCCC after being accused of a deadly hit and run in Wahiawa a few weeks earlier.

7/27/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Federal officials claim a couple who lived quiet lives in Kapolei for several years are actually Russian spies. The man and woman were arrested during a raid last Friday. Government records show they stole the identities of dead babies in Texas in the 1980's, then used the identities to receive social security cards, passports and driver's licenses as American citizens. They face charges related to identity theft, lying on passport applications, and conspiracy to commit crimes against the United States.

A former Marine who was stationed at Marine Corps Base Hawaii in Kaneohe is accused of associating with a Neo-Nazi group and plotting violent attacks. Federal prosecutors say, while serving at the base, Corporal Matthew Belanger was secretly planning to commit mass murder and sexual assaults to "decrease the number of minority residents" in the United States. Belanger was allegedly part of a far-right Neo-Nazi group called Rapekrieg. He is now behind bars in Hawaii after being arrested in New York last month.

7/28/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The fallout continues from the arrest of a couple accused of secretly operating as Russian spies in Hawaii. Now, the attorney for the woman arrested last week says a photo of her client in an authentic KGB uniform isn't what it appears. She claims the woman wore the outfit of the former Soviet spy organization for fun at a friend's house. Her attorney says the woman and her husband have nothing to do with Russia, and the outfits they were photographed in don't even belong to them.

The Marine accused of stabbing his estranged wife to death on the H-3 Freeway has been indicted on second-degree murder charges. The 29-year-old man is being held behind bars on a million-dollars bail. Court documents say his 27-year-old wife was stabbed several times in the

neck, chest, and left temple, and had several more lacerations to other parts of her body. Friends and relatives say the woman was also pregnant when she was killed. The suspect is accused of stabbing and badly injuring himself with the same weapon he used in the alleged murder. There's yet another internet scam to beware of in Hawaii. Scammers are sending people messages in Olelo Hawaii. Experts say the people on the other end of the conversations likely don't speak the language, but are using translator apps to give the illusion they do. They're doing it to gain their victims' trust. One man who was targeted via Instagram direct message said he knew something was up because there were grammatical errors, similar to scams written in English that originate from a foreign country.

8/1/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Honolulu police continue to investigate an apparent murder-suicide in Waikiki. A man and woman, both in their 60's, were found dead in an apartment on Friday night. Investigators believe a 64-year-old woman stabbed a 66-year-old man to death, then overdosed on prescription medication.

8/2/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The lawyer for a 28-year-old man accused of attacking a 70-year-old man in a road rage incident on Oahu's north shore claims his client acted in self-defense. The suspect, Daniel Aikau, was arrested last Friday, then released pending further investigation, even though the attack was caught on surveillance video. The victim's family says Aikau is getting special treatment because of who his family is. His father is Clyde Aikau, and his uncle is the late legendary big wave surfer Eddie Aikau.

8/9/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The gun scare that sent beachgoers in Waikiki into a panic may have been the result of a drug deal. Police were called after witnesses spotted the 27-year-old man holding a gun on the beach Sunday afternoon. Police arrived and tackled him to the ground. A witness tells Hawaii News Now that, moments before that happened, she was near the suspect and heard him arguing with a drug dealer. At that point the suspect allegedly opened a backpack and started grabbing the handle of his gun.

A 75-year-old Hawaii man has been arrested for the brutal cold case rape and murder of a teenager in California four decades ago. Gary Ramirez was arrested at his Makawao home last week. He is expected to appear in court for extradition proceedings on Wednesday. Authorities said once extradited, Ramirez will be arraigned on murder, kidnapping and rape charges. Authorities said the killer left behind both his blood and bodily fluid.

A man is arrested following a reported terroristic threatening incident in Chinatown last night. According to investigators, the suspect threatened a group of people with a machete during an argument on North Beretania Street. A security guard in the area told police the suspect ran into the street and was struck by a car. No other injuries were reported. No word yet on the suspect's identity and current condition, and the investigation continues.

8/11/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm)
HPD officials are voicing concern following back-to-back assaults against law-

enforcement officers over the past week on Oahu. Authorities say the first happened Friday when an officer was injured while trying to arrest a suspect on a DUI charge. The second reportedly happened Sunday when a suspect assault an officer while he was being placed into the back of a patrol car. Officials say HPD has recorded roughly 35 assaults on officers since the beginning of the year.

Honolulu police have identified a man who allegedly hit someone with his car and threatened others with a machete. The suspect is 30-year-old Trevor Guttman. He's been arrested and held on suspicion of terroristic threatening and police are opening an attempted murder investigation after Monday nights attacks. Authorities believe Guttman intentionally struck someone with his car, then later threatened a group of people with a machete. Both incidents were reported just before ten p.m. in Chinatown.

8/12/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A newly released video appears to show OnlyFans star and murder suspect Courtney Clenney has a history of domestic violence. Surveillance video released yesterday from an incident involving Clenney [[klenn-ee]] and her boyfriend, Christian Obumseli [[oh-bum-sell-ee]]. In the video recorded six months ago, the social media model apparently assaults Obumseli in an elevator at their apartment complex in Florida. The 26-year-old Clenney was arrested this week in Hawaii for allegedly stabbing Obumseli to death in April, two months after the elevator incident, but her lawyer claims it was self-defense.

8/16/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Another state employee has been arrested on suspicion of stealing from the base yard at Daniel K. Inouye International Airport. It marks the fourth such arrest amid a 16-month-long investigation. An airport engineer who was arrested in March is facing second-degree theft charges. He's worked for the Department of Transportation's Airports Division for five years. The Hawaii Attorney General's Office raided the base yard last year and arrested two employees on suspicion of second-degree theft. None of the four suspects have been charged yet.

Police are investigating a possible kidnapping of a 12-year-old girl in Ewa Beach. Police say the incident happened on Friday at around 2:15 p.m. Investigators said two male suspects tried to take money from the girl and take her against her will. She also told authorities she was touched sexually. As of now, no arrest have been made and no additional details about the suspects were given.

8/17/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Detectives are investigating a third arson at a business in Honolulu in the past couple weeks. Someone intentionally set fire to Central Pacific Rebuilders at about nine o'clock Monday night. The business owner had to hurry out once he realized there was a fire. He runs the business on the ground floor of the two-story building, and lives upstairs with his wife and four kids. The owner believes the fire was started by homeless people setting the nearby bushes ablaze, adding this is the second time they've damaged his shop. The owner and his family now have to stay in a hotel.

Two Honolulu police officers involved in a suspected brutality case in 2020 have hired criminal defense lawyers. This comes as they await possible federal charges. The officers were responding to a burglary call in the Kaimuki area in June of 2020. Officer Corey Morgan is seen on several body camera videos, including his own, shoving a suspect's head into a shelf, then punching him. The violence appears unprovoked, based on the videos. The man suffered broken bones and other injuries to his face that required stiches. A second officer who was at the scene has also hired a criminal defense lawyer.

8/22/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Honolulu police believe Friday night's shooting that left a 24-year-old woman dead at a bus stop in Chinatown was targeted, and not a random attack. The woman and her husband had been arguing with a man. Police say the argument escalated, then the man pulled a gun and opened fire. The woman died in a hospital on Saturday morning. The suspect, meanwhile, is still on the loose.

8/23/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A reckless driver is accused of causing a head-on crash that killed two people and critically injured two more on Oahu's north shore. Police say the pickup truck driver was weaving in and out of traffic on Kamehameha Highway near Gunstock Ranch on Monday afternoon, then hit a Hyundai Elantra head-on. Two people in the Hyundai were killed and another is in critical condition. The suspect driver is also in critical condition with several broken bones. He's now being investigated for negligent homicide and manslaughter.

For the second time, a couple accused of working as Russian spies while living in Kapolei have had their request for bail denied. On Monday, a U.S. District Court judge said the man and woman could flee prosecution, and should be detained ahead of their trial. In making the ruling, the judge did not consider the Russian spy aspect of their case. The couple is accused of stealing the identifies of dead children on the mainland more than 30 years ago, then using them to live double lives as American citizens.

8/24/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Big Island police are investigating after an officer shot a man in Hilo. The man, who witnesses say was cutting himself with a knife, was approached by police at about four o'clock Tuesday afternoon. He ignored commands to drop the knife, and made a quick move toward officers, prompting one to open fire. The man was shot in the lower body. He's still in the hospital but is expected to make a full recovery. No officers nor bystanders were hurt.

The 24-year-old woman who was shot and killed at a bus stop in Chinatown last weekend was four months pregnant at the time of her death. Family members revealed that information Tuesday, after a 58-year-old man was arrested on suspicion of murder and gun crimes. The woman and her husband got into an argument with a man late Friday night. Then another man showed up and allegedly shot the woman in the head. She died in a hospital the next day.

8/31/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii is seeing an increase in small devices that can turn handguns into machine guns. The Hawaii office of the Bureau of Alcohol, Tobacco, Firearms and Explosives says there are more Glock switches turning up. The illegal devices are the size of a quarter, and even if it isn't

attached to a gun, just getting caught with one can lead to a decade in prison. It converts a semiautomatic pistol into a fully automatic one. With a Glock switch attached, a shooter can fire 15 rounds from a handgun in four seconds.

9/1/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Honolulu police are on the hunt for three men who posed as DEA agents when robbing a home in Kapahulu. A man, who was staying at his friend's house on Sunday night, says he heard a knock, and someone shouting "DEA, open the door!" When the man didn't open the door, the robbers kicked it in three times, knocking it down. The three men barged in wearing ski masks and jackets, and were looking for a safe. The victim was held on the ground and had his phone and wallet stolen, while the other two suspects ransacked the house. The man says the suspects threatened to shoot him.

9/2/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A family is seeking justice after their two dogs were shot and killed by their neighbor on West Oahu. The owners told Hawaii News Now earlier this month their Australian Shepherds Bindi and Dutch were chasing a mongoose and ran onto a neighboring property. That's when they heard gunshots and yelping, and ran over to find their dogs lying on the ground. The neighbor allegedly claimed the dogs were disturbing his horses, so he shot them.

9/9/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Honolulu police are investigating two sexual-assault cases reported in Kalihi since the beginning of the month. Department sources say the first report came in last Saturday when a 20-year-old woman told police she had been sexually assault by an unknown male shortly after 1 a.m. The second incident reportedly happened late Wednesday night. The 19-year-old victim in that case says she was walking home when she was assaulted in public stairwell by two adult males. No arrests have been made in either case.

The founder of the far-right Hawaii Proud Boys chapter and co-founder of the online group called "Murder the Media" is facing time behind bars for his role in last year's Capitol riot. That's because Nicholas Ochs of Honolulu pleaded guilty after admitting he and another man threw smoke bombs at police officers. The 36-year-old could go to prison for more than four years when he's sentenced in December.

9/13/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Prominent Big Island doctor Rudy Puana has been sentenced to seven-and-a-half years in prison for his role in the Kealoha scandal. Prosecutors were pushing for between 15 and 20 years. Back in April, Puana was found guilty of 38 drug counts. He used his privileges as a doctor to get people drugs like fentanyl and oxycodone.

9/14/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Three suspects previously convicted of beating a hotel security guard in Kona in 2018 will get a new trial. A retrial was granted after the state Court of Appeals ruled the prosecution violated the rules of the first trial by using video of the security guard in the hospital. The video was shown following testimony about his condition, and the court says that presented the potential of unfair prejudice. Two of the suspects were convicted of attempted second-degree

murder and were serving lifetime prison terms. The other was sentenced to a decade in prison for first-degree assault. In 2020, the security guard died as a quadriplegic. No date for the new trial has been set.

9/16/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The businessman at the center of the largest bribery case in Hawaii's history has formally been charged by federal officials. Milton Choi, the owner of H20 Process Systems, was charged with a single count of bribery on Thursday. Choi is also accused of paying two-million-dollars in bribes to former Maui wastewater official Stewart Stant. Stant, a former Director of Environmental Management for Maui County, was also charged on suspicion of receiving bribes. Choi is the same businessman who bribed ex-state senator J. Kalani English and ex-state representative Ty Cullen. Both resigned after they were caught and pleaded guilty to bribery charges as well.

9/19/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A good Samaritan is getting praise for helping rescue a kidnapped 15-year-old girl in Downtown Hilo. Mikella Debina was found in good health on Saturday afternoon. The man accused of kidnapping her Friday afternoon was arrested. On Saturday, the man took Debina into Café Pesto in Downtown Hilo, after she convinced him she was hungry. A restaurant host recognized her as the girl featured in an AMBER Alert, and rushed her to the back of the restaurant, where he called police, and she admitted she'd been kidnapped. Witnesses say the suspect tried to convince people Debina was his daughter.

9/20/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The man accused of kidnapping a 15-year-old girl from a beach on the Big Island has been charged with several felonies. On Monday afternoon, the 53-year-old was charged with two counts of kidnapping, along with first-degree sexual assault, terroristic threatening, robbery and meth trafficking. He's being held behind bars on two-million-dollars bail and is due in court this morning. The man was arrested Saturday afternoon, a day after allegedly abducting the girl at knifepoint at Anaehoomalu Bay.

The businessman at the center of a bribery scandal that brought down three of Hawaii's public officials has pleaded guilty in federal court. On Monday, Milton Choy pleaded guilty to a single count of bribing a former Maui wastewater official. That man, Stewart Stant, also pleaded guilty to accepting bribes. Choy paid about two-million-dollars to Stant between 2012 and 2018. In return, Stant sent 56 non-bid contracts toward Choy's company, H20 Process Systems. Choy will be sentenced in January and faces up to a decade in prison. Choy was also involved with the

9/21/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) There are new details about the alleged kidnapping of a 15-year-old girl on the Big Island. The 52-year-old man accused of abducting the girl from a beach last Friday was allegedly carrying zip ties, made her smoke crystal meth several times, and kept her shackled in a bus overnight. That's all according to new court documents released Tuesday. The man was arrested Saturday, after the girl was rescued by a good Samaritans at a café in Hilo. The girl was

abducted after she and her boyfriend were robbed at knifepoint by the suspect at Anaehoomalu Bay.

A man is back behind bars after allegedly escaping police custody and hopping into a running car. The 29-year-old was initially arrested Tuesday morning, on suspicion of violating a temporary restraining order. Authorities say he escaped in the afternoon, while being transported to Queen's West Oahu Medical Center. The man ran away from the officer who arrested him, got into a waiting car, and disappeared. That was, until Tuesday night, when he was found in Ewa Beach and arrested again. The man is now facing an escape charge as well.

9/22/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The man accused of kidnapping a 15-year-old girl on the Big Island has now been indicted by a grand jury. On Wednesday, the 52-year-old man was indicted on eleven counts, which include kidnapping, sex assault, and terroristic threatening. Hawaii County police officers revealed some new details about the case in court. The girl was kidnapped after the suspect allegedly robbed she and her boyfriend at knifepoint last Friday. A police sergeant says the boy had been restrained with plastic zip ties, and clothing was taped over his face and mouth. The suspect was arrested and the girl was saved after they walked into a café in Hilo on Saturday afternoon.

The man accused of brutally murdering a woman on the Big Island last week has been indicted on murder charges. A judge has also ordered him to undergo a mental health examination. The woman was found dead on a property in the Hawaiian Beaches Subdivision. Police say she was badly beaten and her hands and feet were bound. The man is due back in court on October 25th.

9/23/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A man from Waipahu is facing federal weapons charges after a huge stash of illegal ghost guns was recovered from his home. The man is accused of keeping two-dozen ghost guns and illegal parts. Homeland Security agents and Honolulu police officers served warrants on his home and car on Monday. Court records show they found and recovered long guns, pistols, silencers and hundreds of rounds of illegal ammunition. The man is due in court today. Federal prosecutors are planning to ask a judge to keep him behind bars without bail, arguing he presents a danger to the community, and is a flight risk.

Honolulu police have an attempted murder case going following a shooting in Kalihi. A group of men were fired at late Wednesday night. No suspects nor motives have been named. No one was hurt and no one has been arrested either.

9/27/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Federal officials are warning of rainbow-colored fentanyl being distributed on the Big Island. In a drug threat bulletin officials said a large quantity of the pills were found in a shipment that was recently smuggled in, along with a powdered form of the substance. The deadly drug is made to look like candy and can be 50 times more potent than heroin.

2. Coronavirus Pandemic:

7/7/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii could be in for yet another surge of COVID-19 cases. That's according to state epidemiologist Doctor Sarah Kemble, who says she and her colleagues at the state Department of Health have been keeping track of two subvariants of the original Omicron variant. Both subvariants are spreading on the mainland, accounting for higher case and positivity numbers in recent weeks. But, there's hope. Kemble says the most recent case surge in Hawaii was driven by the Omicron variant, so there might already be a good deal of immunity built up among the population. But, reinfections are also common.

7/8/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Omicron subvariants are making up a larger percentage of COVID-19 cases in Hawaii. Together, the B-A-Four and B-A-Five subvariants account for nearly a fifth of the variants circulating statewide. B-A-Four represents six-percent of test samples collected between June 5th and June 18th. B-A-Five represents 13-pecent of test samples. The amount of B-A-Four cases has increased by more than threefold from the last two-week testing period, while the amount of B-A-Five cases is up by more than fourfold. B-A-Two and its subvariants make up the rest of the variants spreading throughout the islands.

7/13/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) In addition to dropping its indoor mask mandate, the Department of Education is also changing its quarantine rules on August 1st. If students are exposed to COVID-19 at school, the DOE will no longer recommend they go home to quarantine. Instead, all students in their classroom will be recommended to wear masks. Students exposed to coronavirus at home are still recommended to quarantine at home for five days, then return to school with a mask on for days six through ten.

7/14/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Omicron B-A-Five subvariant is spreading more in Hawaii and on the mainland. B-A-Four and Five now make up at least a fifth of the coronavirus variants circulating in Hawaii. B-A-Five is also now the dominant variant in the U.S. It's making up 65-percent of new cases, as of Saturday. All four of the state's major counties have identified cases of this latest highly contagious variant.

7/22/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The highly contagious BA-Four and BA-Five coronavirus variants are becoming more common in Hawaii. The state health department says, together, the Omicron subvariants now make up 47-percent of the variants circulating on the islands. Test samples from COVID-positive patients were collected for two weeks, through July 2nd. Lab tests show BA-Four accounts for eight-percent of the cases, while BA-Five makes up 39-percent of them.

7/27/22– Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 23 additional coronavirus deaths and 4,075 new cases in the past seven days. That compares to 4,329 cases and 13 additional deaths in the previous week. The latest number brings the statewide total since the start of the pandemic to 325,944. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,571.

8/2/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) More than 12-hundred of Hawaii's public school classrooms are poorly ventilated, posing a heightened COVID-19 risk. The state Department of Education says one-thousand-261 classrooms have limited access to fresh air from outside because they rely on air conditioning to keep cool. A contractor investigated those classrooms and later found 377 of them have concerning levels of carbon dioxide, which is a sign of unhealthy air ventilation. Keiki are back in those classrooms this week, and unlike last school year, masks are now optional.

8/3/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 21 additional coronavirus deaths and 3,689 new cases in the past seven days. That compares to 4,075 cases and 23 additional deaths in the previous week. The latest number brings the statewide total since the start of the pandemic to 329,633. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,592.

8/5/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The B-A-Five Omicron subvariant is now the dominant strain of coronavirus in Hawaii. It now makes up at least 68-percent of new cases in the state. The Hawaii Department of Health's latest variant report, released Wednesday, also shows the B-A-Four Omicron subvariant makes up nine-percent of new cases

8/11/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) State health officials are reporting 14 deaths linked to COVID-19 over the past seven days in Hawaii. That figure reportedly boosts the state's cumulative, coronavirus-related death toll to one-thousand-606. During the same, seven-day period, authorities say three-thousand-189 new infections were recorded, most of which were logged on Oahu.

8/12/22– Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Hawaii Department of Health is following the CDC's lead in loosening COVID-19 guidelines. In fact, they're the least strict guidelines in nearly two-and-a-half years of the pandemic. Health officials say six-feet of social distancing is no longer as necessary. And, not everyone who comes into contact with an infected person needs to quarantine anymore. People who come into contact with someone who's tested positive no longer need to quarantine for five days if they're without symptoms. That includes students.

8/17/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 13 additional coronavirus deaths and 2,696 new cases in the past seven days. That compares to 3,189 cases and 14 additional deaths in the previous week. DOH said the average positivity rate is 10.7%. The latest number brings the statewide total since

the start of the pandemic to 335,518. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,619.

8/18/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii's key COVID-19 metrics continue trending downward. On Wednesday, the Department of Health reported this week's seven-day new case average is 404, down from 452 last week. It's the fourth straight week the seven-day new case average has dropped. The state's average positivity rate is also significantly lower this week. It's down from 12-point-four-percent to ten-point-seven-percent. It's the third straight week that metric has improved. And, an average of 136 people on the islands have been hospitalized with COVID each day during the past week.

8/24/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 13 additional coronavirus deaths and 2,219 new cases in the past seven days. That compares to 2,696 cases and 13 additional deaths in the previous week. DOH said the average positivity rate is 10.7%. The latest number brings the statewide total since the start of the pandemic to 337,737. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,632. The state continues to issue its COVID data on a weekly rather than daily basis.

8/31/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 12 additional coronavirus deaths and 1,777 new cases in the past seven days. That compares to 2,219 cases and 13 additional deaths in the previous week. DOH said the average positivity rate is 8.6%. The latest number brings the statewide total since the start of the pandemic to 339,514. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,644.

9/12/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The bivalent COVID-19 vaccine booster shot is now being offered at The Queen's Medical Center West Oahu. About 500 doses of it were given at a drive-through clinic on Sunday. People can also get their flu shots at the clinic. Both the Pfizer and Moderna bivalent COVID-19 vaccine boosters were recently approved by the CDC and FDA.a bivalent vaccine targets more than one strain of virus.

9/14/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii on Wednesday reported 10 additional coronavirus deaths and 1,343 new cases in the past seven days. That compares to 1,215 cases and 11 additional deaths in the previous week. The latest number brings the statewide total since the start of the pandemic to 342,072. Meanwhile, the additional fatalities bring the state's COVID death toll to 1,665.

9/16/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) All four major counties in Hawaii are now in the CDC's green or low community level for COVID-19. Honolulu and Maui Counties were moved from the yellow to green level on Thursday. Kauai and Hawaii Counties were already there. The metrics used to determine community levels include COVID case rates per 100-thousand people, the rate of COVID-

related hospital admissions, and the percentage of hospital beds occupied by COVID patients. In May, all four counties were in the orange or high community level for a time.

Starting today, the masks can come off at the University of Hawaii at Manoa. Masks had been required to stay on in classrooms, confined educational spaces and shared labs. But, U.H. officials say they changed their guidance after consulting with medical and public health experts, and after reviewing the latest federal and state guidance. U.H. President David Lassner says the mask mandate can be reinstated if COVID-19 conditions worsen again.

9/27/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Hawaii's tourism economy could be getting a fall boost from across the Pacific. Hong Kong lifted all of its COVID-19-related travel restrictions on Monday. On October 11th, Hawaii's biggest international travel partner, Japan, will do the same. Japan will do away with its standing daily arrival cap. Visitors from 68 different countries will be able to get into Japan without a Visa, as they did before the pandemic started. A noticeable difference in Hawaii's arrival numbers isn't expected until the end of the year or beginning of next year.

3. Navy Fuel Leak:

7/1/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Navy has finalized its report about last year's fuel leaks at its Red Hill storage facility, which led to thousands of people getting sick after using their tap water. The Navy's report, released by the state health department Thursday, says the underground fuel spills were preventable, and the result of "cascading failures." The report also says as much as five-thousand-gallons of diesel jet fuel spilled into the Navy's public drinking water system last year. Investigators say there were several major issues at Red Hill, including a culture of procedural noncompliance, poor training and supervision, no "ownership" about operational safety, and a flawed investigative process.

The U.S. Navy says mistakes were made at one of its fuel storage facilities in Hawaii that lead to tap water becoming contaminated. An investigation report says around six-thousand people in the area have been treated for nausea, headaches and other illnesses because of tainted water. The investigation found multiple mistakes and mismanagement at the storage facility caused fuel to leak into Pearl Harbor's tap water, poisoning thousands and forcing military families to leave their homes.

7/6/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Honolulu Board of Water Supply says the city's aquifer is contaminated. According to the recent report, multiple fuel components, including petroleum, diesel, oil, and more, have dissolved into the ground water and are likely moving with the aquifer. Per an announcement

this week, the board is seeking a new water source for a well. Meanwhile, the Navy is reporting potentially 54-hundred gallons of fuel unaccounted for after last year's Red Hill fuel spill.

7/18/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The state Department of Health will reject the Navy's plan to defuel the troubled Red Hill fuel tanks, saying it isn't detailed enough. The Navy is promising to safely remove 104-million-gallons of fuel from the World War Two-era underground storage facility, and have it done by the end of 2024. But, the DOH's Deputy Director Kathleen Ho, who is an environmental attorney, says it's tough to say exactly how long defueling can and will take, because the Navy's plan is missing several needed details.

7/20/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) State lawmakers are now bashing the Navy about its plan to defuel the aging tanks at Red Hill. At a legislative briefing, held Tuesday, many lawmakers said the plan was missing key details and dates. Last week, the state Department of Health had a similar reaction, and said it will reject the defueling plan, as presented. The Navy doesn't expect defueling to finish until at least the end of 2024. About 104-million-gallons of jet fuel are stored underground at the World War Two-era facility.

8/3/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Navy's water system appears to still be tainted with fuel, even though it was deemed safe. University of Hawaii researchers recently tested water that the Navy declared safe to drink, and found traces of jet fuel in it. The Navy and Hawaii Department of Health first announced the water was free of fuel on March 18th. The new findings were released Tuesday morning, in a press release, and on a data dashboard on the UH website. But, within just a few hours, both pages were removed from the university's public website. A planned news conference to announce the findings was also cancelled.

8/5/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) There are new public health concerns after the Board of Water Supply detected petroleum contamination in a groundwater monitoring well in Moanalua Valley. The well is about 15-hundred-feet southeast of the Red Hill fuel storage facility. Unlike the Navy, it's the first time the BWS has ever detected contamination in one of its testing wells. The BWS also found traces of polycyclic aromatic hydrocarbons in the well. Those are the chemicals found in gas and crude oil and they could cause cancer. However, the chemical levels are low and below the EPA action level. The state Department of Health and the EPA say there's no current health emergency. The BWS is also not planning any immediate changes to how it operates the civilian drinking water system.

8/10/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) A new report says there were serious warning signs about eleven hours before the May 6th, 2021 fuel spill at Red Hill. A Navy Red Hill log from that day, which was redacted from public reports, was recently provided to the Star Advertiser. The 20-thousand-gallon fuel spill happened at 6:10 p.m., but at 7:26 a.m., alarms started sounding within Red Hill's Automated Fuel Handling Equipment program. The log says the alarms went off all day. There were "lower-level" notification and "warning" alarms, along with dozens of "critical" alarms.

8/29/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) the Board of Water Supply is reminding Honolulu's restaurants to only serve water if customers ask for it first. The water-saving rule has been in place for 30 years now. Restaurants that don't follow it could be fined 50 bucks for each violation. The reminder comes after the BWS asked customers to reduce their water use by ten-percent for the summer. Supply is more limited after the utility shut down three of its wells following the Navy's Red Hill fuel leak.

9/8/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Navy is now planning to defuel the Red Hill fuel tanks by July of 2024. The Navy issued a revised plan with a new timeline Wednesday afternoon. Defueling was initially planned to finish six months later. The Department of Defense's last Red Hill defueling plan, released June 30th, was criticized by state officials for being too vague and lacking substance. The D-O-D says it shaved six months off the timeline after determining certain activities could be done at the same time to speed up the process.

9/13/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The Honolulu Board of Water Supply is looking for places to drill at least three new wells. They must be outside of the contamination zone caused by the Red Hill fuel leak. They'll replace another three wells that were shut down last year as a precaution, because of their proximity to Red Hill. The Halawa Shaft, Halawa Well, and Aiea Well are still shut down today, to keep contamination from spreading. The water they provided went to taps in Honolulu, Aiea, and Halawa. The BWS says replacing them won't be a quick process. It'll take a minimum of five years at best to bring a new water source online.

9/19/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Rear Adm. John Wade will serve as commander of a joint task force overseeing the defueling and permanent closure of the Navy's Red Hill fuel facility. the Department of Defense announced the creation of the Joint Task Force Red Hill earlier this year, saying that the commander's sole responsibility will be to ensure the safe and expeditious defueling of the underground tanks. U.S. Sen Brian Schatz said in response that shutting down the facility can not be delayed.

9/20/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Rear Admiral John Wade will be in charge of the Navy's efforts to defuel the Red Hill storage facility. On Monday, Wade was named the commander of a joint task force overseeing the defueling and permanent closure of the facility, which has been around since World War Two. The Department of Defense created Joint Task Force Red Hill earlier this year. It listed the commander's only responsibility as ensuring the safe and quick defueling of the underground tanks, which were the source of fuel leaks in May and November of 2021.

9/26/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) The EPA is releasing a long list of violations at the Navy's Red Hill fuel facility after touring the site earlier this year. The federal report came in response to thousands of military families getting sick from contaminated water caused by a leak at the fuel storage facility.

Violations include lack of a spill response plan and failure to operate the system in line with good engineering practice. Meantime, the Navy is working to remove over 100-million-gallons of fuel from Red Hill, which could take through July of 2024.

9/27/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) U.S. Secretary of Defense Lloyd Austin is coming to Hawaii to tour the underground Red Hill fuel storage facility. Austin is expected to leave Washington D.C. tomorrow, and first visit California. After that he'll go to Hawaii, where he plans to tour the facility, and meet with key allies in the Indo Pacific. Austin will have a meet-up with Rear Admiral John Wade, who has been put in charge as commander of the joint task force responsible for emptying the Red Hill fuel tanks.

9/28/22 – Newscast (30 sec. 6am, 7am, 8am, 9am, 10am, 11am, 12pm, 1pm, 2pm, 3pm, 4pm, 5pm) Emptying the Red Hill fuel tanks will cost the federal government at least 280-million-dollars. That's the estimate from the Pentagon. Next month, crews will start taking jet fuel out of pipelines before repairing them and the tanks. Then the process of safely removing 104-million-gallons of fuel can start. Defueling is now expected to start in July of 2024.
