Dear Mr. Kahl:

Pursuant to Section 614 of the Communications Act of 1934, as amended, and Section 76.64(f)(4) of the rules of the Federal Communications Commission, this will inform you that Television Station KJWP, Wilmington, Delaware (the "Station") will commence operation as a new television station in the Philadelphia, Pennsylvania DMA on or about November 18, 2013.

PMCM TV, LLC, the licensee of the Station, hereby elects mandatory carriage of the Station's television signal pursuant to Section 76.56(b) on all cable systems operated by RCN Telecom Services, LLC or its subsidiaries and affiliates serving the Philadelphia DMA, including those set forth on Exhibit A hereto, for the election period ending December 31, 2014. The Station is licensed to Wilmington, Delaware, which is located in New Castle County, Delaware and is part of the Philadelphia, Pennsylvania DMA. The Station therefore is entitled to elect mandatory carriage on your system(s) under the rules of the FCC. Pursuant to Section 76.57 of the FCC's rules, PMCM TV, LLC requests carriage of the Station on Channel 2, its over-the-air channel number.
