CALCULATION OF TRANSMITTER POWER OUTPUT (TPO): THE 0.049 KW (-13.09 DBK) FIGURE IS BASED ON CONSIDERATION OF A TRANSMISSION LINE ATTENUATION OF 2.41 DB (57.4%). GIVEN AN ANTENNA POWER GAIN OF 8.91 (9.5 DB), A TPO OF 0.049 KW PRODUCES THE AUTHORIZED ERP OF 0.25 KW (-6.0 DBK).
