KHCA, Inc. ("Licensee"), licensee of FM station KHCA, Wamego, Kansas (Facility ID No. 34525) ("KHCA"), submits this letter in response to the Commission's EEO audit letter dated October 30, 2023 ("EEO Audit Letter"). KHCA is Licensee's only station, and there are no other stations in KHCA's employment unit.

As of this time and as of the date of the EEO Audit Letter, Licensee has no full-time employees. Therefore, Licensee is subject to the Small Station exemption in Section 73.2080(d) of the Rules because it has fewer than five full-time employees.¹

There are no pending or resolved complaints involving KQMO or any other station in the SEU, and there are no time brokerage agreements for KQMO or any other station in the SEU.

In accordance with Section 73.3527(e) of the Commission's rules, a copy of the EEO audit letter and this response will be placed in WKMO's Online Public Inspection File.
