## POLITICAL DISCLOSURE STATEMENT

### RADIO STATION WFSR AM/WTUK FM

The rates attached and marked "Political Rates" are the station's best, good faith determination of the prevailing lowest unit rates for political "uses" (spots which feature the candidate's voice and are controlled, sponsored or approved by the candidate or the candidate's authorized campaign committee). Such rates will be offered to qualified candidates during the period September 03, 2018, through November 07, 2018, for political advertisements, including those spots sponsored by independent political action committees or for non-candidate "issues" advertising, and announcements are sold to candidates or their authorized campaign committees at times other than during the prescribed pre-election periods are sold at regular prevailing commercial rates; time sold on the station at conventional commercial rates is generally subject to rate card structure. Please contact our Sales Office for availabilities and current selling levels. A current commercial rate card is attached. All rates are net to the station.

Spot time (fixed, non-preemptible) is available in 30 and 60 second announcements for the price indicated for each 30 and 60 second announcement. The 30 and 60 second bottom rate for WTUK FM, per announcement is: \$4.00 per 30 second announcement - seven (7) days a week and \$7.00 per 60 second announcement - seven (7) days a week. The 30 and 60 second bottom rate for WFSR AM, per announcement, is: \$4.00 per 30 second announcement - seven (7) days a week and \$7.00 per 60 second announcement - seven (7) days a week - \*(for all time periods other than News, and drive times whose rates are listed at the end of this disclosure.) These prescribed "lowest unit rate" purchases are the most favorable rates available for which the candidate receives, by law, during the period September 03, 2018, through November 07, 2018.

The spots in "lowest unit rate" will be available for purchase on individual basis by federal candidates and by candidates for non-federal office to the extent that time is being sold for non-federal offices. Please contact the Sales Manager for further information. Program time is also available; please contact the Sales Manager to discuss availabilities and cost. Generally, the earlier an order is placed, the greater the scheduling options available. The station also offers time to commercial sponsors based on audience delivery and will discuss rates with a candidate for political announcements on this basis, if requested.

Under the station's policies, unless otherwise specifically noted herein, spots not run because of technical problems will be rescheduled as a "make good", if time is



available, or a credit will be given, after consultation with the sponsor. The station cannot guarantee the time placement of "make goods", but will use its best efforts to accommodate the needs of the candidate.

In the event that the station sells advertising time during the prescribed "lowest unit rate" pre-election periods for a particular amount and class of time in a particular time period at a rate which is lower than the rate charged a candidate for a "use" (as defined above) of the same amount and class of time in the same time period, the station will afford the candidate the benefit of the lower rate by means of a rebate or a credit against future purchases, as determined by the candidate.

All legally qualified federal candidates are entitled to reasonable access to the station's facilities for the purchase of time once an election campaign has begun. While the station retains the ultimate discretion to determine that amount and location of time sold to meet the needs of federal candidates, the station will consider any such requests for time and be available to make reasonable accommodations with respect to such requests in light of all relevant circumstances applicable to the candidate and the station. Purchases of time for both federal and non-federal candidates may be subject to the "equal opportunities" rights of opposing candidates in accordance with federal law.

All political orders are to be accompanied by a signed and completed Agreement Form for Political Candidates, and an acknowledgment of the receipt of this disclosure statement. Unless the candidate, the candidate's campaign committee or the candidate's agency has established an acceptable credit history with the station and has agreed to assume full responsibility for all air time and production charges pertaining to the candidate, net cash payment must be received one (1) day in advance of the broadcast of the first announcement scheduled in any contract. Announcements for independent political action committees or issue advertising must be paid in full in advance at the time that an order is placed. All announcements must comply with all sponsorship identification requirements of federal law; if proper identification is not incorporated in the spot, the station reserves the right to supply the appropriate announcement within the scheduled time for the spot. All spots require a minimum of five (5) days cancellation notice.

All ads for all offices must include sponsorship ID information which fully and accurately identifies the person or entity which paid for the announcement (or the station will add a sponsorship ID within the candidate's message). \*The rates for specified Newscast and drive times will be:

On both WFSR AM and WTUK FM Newscast rate cost is \$12.00 (net) per each 30 second announcement - this rate applies to
