- 03/06/16 SISTER SIMONE CAMPBELL is one of several sisters highlighted in the book IF NUNS RULED THE WORLD. She's a lobbyist, attorney, and advocate for social justice. Sister Simone organized the now famous NUNS ON THE BUS tour where Catholic Sisters traveled through 9 states protesting federal budget cuts to help the working poor. She's funny and smart!
