CARRIAGE ELECTION STATEMENT

**WFMZ-TV Allentown PA**

In accordance with the FCC's carriage election rules, and except as noted below, WFMZ-TV hereby elects must-carry on all MVPDs in the Philadelphia, PA DMA for the 3-year carriage cycle beginning January 1, 2021 and ending December 31, 2023. For the MVPDs on which WFMZ-TV is electing must carry, WFMZ-TV is not changing any of its elections for its current channel positions.
