

## WGVK POST-FILING RENEWAL PUBLIC NOTICE

### **Text of Renewal Public Notice:**

On May 25, 2021, Grand Valley State University, licensee of station WGVK, RF Channel 5, Kalamazoo, Michigan, filed an application with the Federal Communications Commission for renewal of its broadcast license. Members of the public wishing to view this application or obtain information about how to file comments and petitions on the application can visit [publicfiles.fcc.gov](http://publicfiles.fcc.gov), and search in WGVK's public file.

### **Broadcast Instructions:**

The above public notice must be broadcast at least once per week (Monday through Friday) for four consecutive weeks, for a total of six (6) broadcasts, with no more than two broadcasts in a week. Broadcasts made in the same week may not air on the same day. The first broadcast shall occur no sooner than the date the FCC releases public notice of the acceptance of the license renewal application, and no later than the fifth business day after the release of the FCC's acceptance public notice (I will advise you when the FCC's public notice occurs). All of the broadcasts must air between the hours of 7:00 a.m. and 11:00 p.m. local time, Monday through Friday. For stations providing a multicast, the public notice needs to be broadcast only on the station's primary over-the-air program stream (*i.e.*, the stream with the most listeners). It is not required to provide the public notice on every individual stream broadcast. Television stations must use a visual with the full text of the on-air announcement when the announcement is orally presented.

### **Certification of Broadcast Public Notice:**

Within seven (7) days of the last broadcast of the public notice announcement, you must place in your station's online public inspection file a statement certifying compliance with the public notice broadcast requirements that includes the dates and times the on-air announcements were made. I suggest you include with the certification the text of the public notice announcement as broadcast, but it is not required. A sample certification is attached, though you can come up with your own form of certification as long as it has the required information. In uploading the certification to your online public file, you should upload the document to the "Local Public Notice Announcements" folder under the "More Public Files" part of your online public file.
