Section 3: Supplemental (Non-Vacancy Specific) Recruitment Activities Undertaken by WDWGWPWZWZAXWRMT

[Description. of the activities.]

WDWGWPWZWZAXWRMT stations perform initiatives designed to comply with outreach recruiting. Steve Roberts, General Manager and David Perkins, Operations Manager are members of the management team responsible for coordinating these efforts.

An internship program has been established and during the reporting period, Ahmad Stallings, a high school student at Rocky Mount Preparatory School participated. His internship period included the entire second semester of the 2015-2016 school year. Our stations partnered with this area charter school and joined in their own internship program which placed students throughout businesses in the community. The school wanted the participating students to experience every aspect of their assigned business. Ahmad's duties included production assistance, live remote set up, and office duties. Ahmad was supervised by Operations Manager David Perkins.

WPWZ Program Director Derrick Alston supervised two interns during this period. Josh Ranson, a student at Barton College in Wilson fulfilled his college internship duties from February 1, 2016 through May 30, 2016. Chadae Joyner is currently enrolled in our summer internship program. She is a student at Winston-Salem State University. Their duties included downloading of syndicated shows, filling out affidavits, and editing assistance on commercials.

October 22, 2015: First Media Radio hosted a job fair at our offices in Rocky Mount. We promoted this through a heavy commercial schedule and four people scheduled appointments between the hours of 4 and 6pm. Group interviews were conducted by General Manager Steve Roberts, Operations Manager David Perkins, and Senior Account Executive Paul Handley.

March 5, 2016: General Manager Steve Roberts and Operations Manager David Perkins attended the Wilson Business Expo. Resumes were gathered at this event and brief interviews were conducted.

April 27, 2016: General Manager Steve Roberts and Operations Manager David Perkins attended the Greater Wilson Area Job Fair hosted by the Wilson County Department of Social Services. Resumes were gathered at this event and brief interviews were conducted.

July 14, 2016: First Media Radio co-sponsored the Best Career Fair in Raleigh, NC. We supported this with a heavy commercial schedule on all four of our radio stations.

July 19, 2016: General Manager Steve Roberts and Operations Manager David Perkins attended the Wilson Business Expo

with booth space set up with the purpose of hosting a First Media Radio Job Fair. Resumes were gathered at this event and brief interviews were conducted.

General Manager Steve Roberts and Operations Manager David Perkins meet quarterly to review job opening applications/resumes that are received and EEO procedures.

In addition, a radio announcement airs two times daily on each station asking recruitment sources that wish to be informed of station job openings to contact the stations.
