

## **POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS**

The following contains instructions for the broadcast of post-filing renewal announcements for Sinclair's New Bern, NC station. Pre-filing announcements are no longer required. Included with these instructions are the text of the post-filing announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired (**October 23, 2020**). If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

### **Post-filing Renewal Announcements for WCTI-TV, New Bern, NC, Facility ID 18334**

**The following post-filing renewal announcement must be read over the air on the station's primary programming stream on each of the following days: August 3, August 16, September 1, September 16, October 1, and October 16, 2020.**

**Of these six airings:**

- 1. At least three of the announcements must be aired between 6:00 P.M. and 11:00 P.M.**
- 2. At least one announcement must be aired between 9:00 A.M. and 1:00 P.M.**
- 3. At least one announcement must be aired between 1:00 P.M. and 5:00 P.M.**
- 4. At least one announcement must be aired between 5:00 P.M. and 7:00 P.M.**

**"On March 23, 2013, WCTI-TV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until December 1, 2020.**

**Our license will expire on December 1, 2020. We have filed an application for renewal with the FCC. A copy of this application is available for inspection at [www.fcc.gov](http://www.fcc.gov). It contains information concerning the station's performance since WCTI Licensee, LLC acquired the station on September 1, 2017.**

**Individuals who wish to advise the FCC of facts relating to our renewal application, and to whether this station has operated in the public interest, should file comments and petitions with the FCC by November 1, 2020.
