A Russian inland passenger plane carrying 28 people lost contact on the Kamchatka Peninsula in Siberia on Tuesday (6th). It is believed that it has crashed into the sea. The cause is yet to be investigated. Aviation authorities said that the search team found the wreckage of the crashed passenger plane on the Pacific coast. Officials said that the An-26 twin-propeller passenger plane carrying 22 passengers and 6 crew members was originally scheduled to fly from Petropavlovsk-Kamchatsky, the largest city on the Kamchatka Peninsula, to the town of Palana in the peninsula, but did not report at the scheduled time. The Russian news agency reported that there were 22 passengers on board, including 1 to 2 children, and the mayor of Parana.

As of Tuesday (3rd), there were another confirmed 136,000 new COVID-19 cases in the U.S. While President Biden criticized some Republican governors for refusing to abide by public health guidelines and hindering the fight against the epidemic, the Mayor of New York, De Blasio, announced that patrons must hold a certificate of COVID-19 vaccination completion before they can enter restaurants, gyms and commercial premises, setting a precedent in the United States. In addition to the increase in the number of confirmed cases, data from the U.S. Department of Health and Human Services showed that China recorded nearly 56,000 hospitalizations for the first time on Monday (2nd), the most since February this year. The number of hospitalizations in Florida and Louisiana both broke records. In the past week, Florida and Texas accounted for one-third of the number of new cases in the country. Florida earlier issued an order prohibiting students from wearing masks, and Texas imposed fines on masks. Biden pointed out that some governors were unwilling to do the right anti-epidemic. Measures, they should let companies and schools decide their own policies, he said: "I said to these (Republican) governors... if you don't plan to help, at least don't get in the way."

Topic: Australia ditched submarine purchase deal with France

Australia cancelled the purchase of 12 diesel-electric submarines deal with France and switched to order 8 nuclear submarines from the United States, an act which affected Australia's free trade agreement negotiations with the European Union. An EU official said on Tuesday (21st) that the submarine contract turmoil has made relevant trade negotiations more complicated and delayed the progress of the negotiations. Australian Prime Minister Morrison said that he will not hold bilateral talks with French President Macron during the UN General Assembly, and believes that there is an appropriate time for the two parties to meet. Australia and the European Union were originally scheduled to start a new round of negotiations on a free trade agreement on the 12th of next month. Australian Trade Minister Dan Tehan hopes that the negotiations will be held as scheduled. However, the Chairman of the International Trade Committee of the European Parliament and German European Member Bernd Lange pointed out that Australia's cancellation of the submarine contract is equivalent to an invasion of European interests, and pointed out that trust issues have arisen, and some member states have proposed that trade agreements require more protection. It will prolong the negotiation time.
