Daryl Morey, general manager of the Houston Rockets of the US (NBA) team, has previously posted on Twitter to support Hong Kong’s anti-revision demonstrators. Morey’s tweet has since been taken down from the post and apologized for the behavior, but the incident still caused the team and the NBA league to fall short on public opinion in China. Morey’s previous tweets included a picture that read “Fight For Freedom / Stand With Hong Kong”, a phrase which in recent months showed in repeated slogans in demonstrations in Hong Kong against amendments to fugitives regulations and then against the government. Morey’s tweets caused widespread criticism from fans, sponsors and business partners in mainland China. Chinese mainland TV stations and online streaming platforms have stated that the Houston Rockets games will no longer be broadcast live and all cooperation will be suspended.

Topic: City Council vows to crackdown on Parking Placard abuse

New York City Council held a second General Assembly in November this year and voted to pass a series of related laws such as banning the sale of flavored e-cigarettes, ensuring the safety of construction workers, and severely punishing the abuse of privileged parking cards (Placard) use. The law that severely punishes the abuse of privileged parking permits requires a six-month pilot program to allow New York City Police Department (NYPD) to evaluate the violations of the use of privileged parking permits in 50 locations on a weekly basis. On common issues/violations such as city government vehicles obstructing bicycle lanes, bus lanes, sidewalks, and fire hydrants, etc., the New York City Police will step up enforcement efforts against these locations and require the New York City Department of Investigation (DOI) to investigate and issue reports. The City will also target fake counterfeit parking permits. Fine has been increased from \$ 250 to \$ 500; use of a privileged parking permit that violated the rules more than three times had to be revoked.

The Special Committee of the French National Assembly has amended the "Anti-Waste Law" to oppose "excessive consumption" to prohibit "Black Friday" promotions. At this time, the French "Black Friday" sale promotion is in full swing. Relevant lawmakers said that this consumption model is "non-environmental and anti-social". They suggested that "Black Friday" ads be classified as "aggressive business practices," with a maximum penalty of 2 years and a fine of 300,000 euros. The amendment will be submitted to the National Assembly for voting on December 9.
