The White House said that after the passage of the US\$1.9 trillion new crown bailout bill, President Biden is planning to substantially increase federal taxes for the first time in nearly 30 years, aimed at funding the next economic stimulus plan. Biden is considering increasing the corporate tax rate levied by the federal government from the current 21% to 28% and expanding the scope of inheritance tax. The federal individual tax rate for individuals with an annual income of more than US\$400,000 will also be increased, and the capital income tax rate for individuals with an annual income of up to the threshold of US\$1 million will be increased.
