According to reports from Reuters and the British Broadcasting Corporation (BBC), a New York judge authorized Manhattan District Attorney Alvin Bragg to release the indictment against Trump in a document unsealed on Friday (March 31). It's unclear when he will make an announcement. An indictment is a formal written charge of a crime against a defendant. Trump is facing a lawsuit believed to be related to a hush money he paid porn star Stormy Daniels during his 2016 presidential campaign. He is the first former president in U.S. history to face criminal charges. Trump stands firm on his innocence.

The well-known sports leisure brand Lululemon's branch in Peachtree Corners, Georgia, was robbed by two men wearing masks at the end of April this year. The two clerks who managed to stop the thieves were fired after the robbing incident, causing controversy. Lululemon CEO Calvin McDonald said in an exclusive interview with CNBC news channel that the decision to fire these two employees will not change because they (the employees) have violated the rules that personal safety should be put first. McDonald said that Lululemon has a zero-tolerance policy on how to deal with theft, and has strengthened training for employees, "Why? Because we put our work team and customers' personal Safety is paramount". As for the loss from the robbery of the branch, McDonald said: "Those are just merchandise.". CNN reported that three men were arrested after the robbery.
