Two endangered North Atlantic right whales have turned up dead off the east coast in the past two months, one of them off of Tybee Island. Scientists have been worried about the species. There are about 360 whales remaining. Boats, fishing gear and other hazards persist off the east coast says Julia Siner, a marine scientist with Oceana, an organization that is dedicated to protecting and restoring the world’s oceans.

After a natural disaster renters receive less assistance than homeowners, based on a study by Georgia Tech’s Brian An. It is extremely hard for renters to prove their damages. The new study has found that it is harder for renters to relocate and to get help to move, especially with the squeeze of rising costs and when the available housing stock is low.

Georgia prisons are full and understaffed. There are now almost 51,000 people incarcerated by the state of Georgia – the highest number in 15 years. Meanwhile, the number of Georgia correctional officers is at its lowest this century, and reports of violence inside Georgia prisons have continued to spike since the start of the COVID-19 pandemic. GPB’s Grant Blankenship reports that on Crossover Day at the Capitol advocates for family members of people in prison plan to go to the Capitol to get legislators to understand how they say the civil rights of the people they love are violated.

The first rough estimate of the 2024 number of unsheltered homeless in Macon is something like three times higher than the estimate from the 2022 count. *United to End Homelessness* is hiring a number of part-time social workers to keep these numbers fresh in between federally mandated counts.

The U.S. Postal Service says its managers are aware of concerns that some Georgians have over mail delays and reports of undelivered mail, with a general primary coming up on May 21<sup>st</sup>. March 4<sup>th</sup> was the first date that voters could request an absentee ballot for the primary and requests must be returned by May 10<sup>th</sup>. Secretary of State, Brad Raffensperger spoke with GPB's Pamela Kirkland to share his thoughts about the problem and what actions voters should take to minimize delays.
