## **WKNC-FM Post-Filing Announcement**

On November 25th, 2011, WKNC-FM was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until December 1st, 2019.

Our license will expire on December 1st, 2019. We have filed an application for renewal with the F-C-C. A copy of this application is available for public inspection at w-w-w dot f-c-c dot gov. It contains information concerning this station's performance during the last eight years prior to December 1, 2019.
