LIN License Company, LLC (“Licensee”), licensee of television station WKBN-TV, Youngstown, Ohio (the “Station”), located in the Youngstown, Ohio DMA, hereby gives notice to Comcast Cable Communications, LLC that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC’s Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC’s rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. This election of retransmission consent is for the period January 1, 2015 through December 31, 2017.
