Events or information must be submitted by a not-for-profit organization or non-profit agency. Events or information should provide a service or benefit to the community, listeners and/or members. Message must pertain to the Baton Rouge area and its residents. Non-Profit organizations should submit all requests in writing 2 - 3 weeks in advance. Acceptance of a PSA does not guarantee usage on-air and the number of times a PSA airs cannot be guaranteed. Remember PSA's should benefit the public at large, announcements promoting church attendance or requesting donations cannot be considered. No editorial comments are to be included. No prices may be mentioned in your announcements. Events must be free and open to the public. Cannot contain "call to action" (e.g. "... call now", "... go to the ...", "volunteer your services").
