In return for said service, the Advertiser agrees that PAYMENTS are to be made to Radio Station O Town Communications, Inc. (Ottumwa Radio) upon receipt of statement. Any balance not paid by the last Sunday of the month shall bear interest at the rate of 1 1/2% per month until paid in full.

The station shall reserve the right to pre-empt any broadcast, or any promotion thereof, covered by public interest convenience or necessity. The station will attempt to reschedule such pre-empted announcements or programs of sponsor the same broadcast day, or if that is not possible, as soon as possible thereafter. In the event a program or announcement cannot be rescheduled, the station will notify the sponsor and the broadcast will be considered cancelled without affecting rate, discounts, or rights provided under this contract, except that the advertiser (sponsor) shall not be required to pay for the cancelled broadcast.

If legal proceedings are brought to collect on this contract, O Town Communications, Inc. (Ottumwa Radio) shall be entitled to collect all reasonable costs and expenses of suit, including but not limited to, reasonable attorney's fees. Further, the parties agree that venue for any suit on this contract shall be in Wapello County, Iowa.
