

**OWNED TELEVISION STATIONS  
CHILDREN'S TELEVISION ACT  
COMMERCIAL LIMITS AND WEB SITE RULE COMPLIANCE CERTIFICATION  
(LOCAL, SYNDICATED AND RESCHEDULED NETWORK PROGRAMS)**

The following locally-produced, syndicated or rescheduled network programs, which were produced and broadcast primarily for an audience of children 12 years of age and under, were broadcast by station KGO-TV 7.1 during the **4TH QUARTER 2010.**

The number of commercial minutes actually broadcast in such programming was no more than 10:30 per hour on weekends and 12 per hour on weekdays.  
In the case of a half-hour "island" of such programming, the number of commercial minutes did not exceed 5:15.
