Pursuant to Section 614 of the Communications Act of 1934, as amended, and Section 76.64(f) of the rules of the Federal Communications Commission, this will inform you that for the period from January 1, 2009, to December 31, 2011, Television Station WIDP, Guayama, Puerto Rico, elects mandatory carriage of its television signal pursuant to Section 76.56(b) on your cable system serving the following communities in the Puerto Rico, Designated Market Area ("DMA"):



Station WIDP is licensed to Guayama, Puerto Rico, which also is within the Puerto Rico, DMA. Station WIDP therefore is entitled to elect mandatory carriage on your system.

Station WIDP's analog signal is on Channel 46, and its digital signal is Channel 45. Under the Commission's rules, Station WIDP is entitled to positioning on cable channel 46. Please be advised that in the event Station WIDP does not deliver a good quality over-the-air signal to your cable system's headend, Station WIDP hereby commits to paying the cost of delivering a good quality signal through an alternative means of delivery.
