To Whom It May Concern,

I had been attempting to upload the required paperwork for political ads purchased by “Mike Bloomberg for President” since 3:30pm on 3/3/20, when we received the order. However, the FCC Online Public File website was down until this afternoon, 3/4/20. The political ads began airing today.

I attempted to login to the FCC website at least a dozen times with no luck. I took screen shots of the FCC website indicating the site was down; two of those screenshots are included here. (It’s difficult to read but the screenshots are time-stamped. The first one is 9:01pm on 3/3/20, the second one is 10:41am on 3/4/20.)

Early this morning, I called FCC Licensing Support and was told the website was “experiencing technical difficulties” and they were not sure when it would be fixed. The case number for my call is 714152.

Later this morning, Mr. Bloomberg suddenly ended his campaign, and all political advertising. The commercials stopped airing on our radio station and a revised contract was written. Meantime, the FCC website was fixed. I was able to log in around 2:00pm on 3/4/20 so all the appropriate paperwork has been posted to the station’s Online Public File.
