ARTICLES OF INCORPORATION

(Under Chapter 1701 of the Ohio Revised Code)
Profit Corporation

The undersigned, desiring to form a corporation, for profit, under Sections 1701.01 et seq. of the Ohio Revised Code, do hereby state the following:

FIRST. The name of said corporation shall be POSITIVE RADIO GROUP INC.

SECOND. The place in Ohio where its principal office is to be located is 505 South Division St.
Union City, Darke County, Ohio.
(city, village or township)

THIRD. The purpose(s) for which this corporation is formed is:

In furtherance and not in limitation of the general powers conferred by the laws of the State of Ohio, and the objects and purposes herein set forth, it is expressly provided that this corporation shall also have the following powers:

To apply for, to own, operate or lease standard radio (AM) stations and/or (FM) frequency modulation broadcast stations; to purchase, acquire, hold, convey, lease, mortgage or dispose of property, real or personal, tangible or intangible;

To borrow money and issue promissory notes; to do any or all of the things herein set forth to the same extent as natural persons might or could do and in any part of the world, as principals, agents, contractors, trustees, or otherwise alone or in company with others.

The foregoing shall be construed both as objects and powers and the enumeration thereof shall not be held to limit or restrict in any manner the general powers conferred on this corporation by the laws of the State of Ohio.

FOURTH. The number of shares which the corporation is authorized to have outstanding is:
