RE: Notification of Network Non-Duplication Rights

Dear Linda,

Journal Broadcast Corp., licensee of television station WGBA-TV licensed to Green Bay, WI, (the "Station"), located at 1391 North Road, Green Bay, WI 54313, hereby gives notice to DIRECTV that it is affiliated with the NBC Television Network, and that the Station holds the right to invoke protection against satellite importation of duplicate programming carried either by a nationally distributed superstation or by a station carried pursuant to § 76.54 of the FCC's rules, into a geographic area described by the zip codes listed below that encompass the zone of protection for the Station, as specified by the FCC's rules. These rights are effective immediately and they remain in effect until December 31, 2013.

The Station's network protection shall apply with respect to all NBC Television Network programs, in any and all formats (whether digital, analog or otherwise), including those programs broadcast by the Station during the time periods set forth below. These time periods may be subject to change. In addition, the Station holds network nonduplication with respect to other programming that is not regularly scheduled but which is aired by the Station. These network non-duplication rights apply with respect to all NBC Network programs during the times that they are broadcast on the Station.
