**Pre-Filing Announcement Text**

ON DECEMBER 8, 1997, KSSI WAS GRANTED A LICENSE BY THE FEDERAL COMMUNICATIONS COMMISSION TO SERVE THE PUBLIC INTEREST AS A PUBLIC TRUSTEE UNTIL DECEMBER 1, 2005. OUR LICENSE WILL EXPIRE ON DECEMBER 1, 2005, 2005. WE MUST FILE AN APPLICATION FOR RENEWAL WITH THE FCC ON OR BEFORE AUGUST 1, 2005. WHEN FILED, A COPY OF THIS APPLICATION WILL BE AVAILABLE FOR PUBLIC INSPECTION DURING OUR REGULAR BUSINESS HOURS. IT CONTAINS INFORMATION CONCERNING THIS STATION'S PERFORMANCE DURING THE LAST EIGHT YEARS. INDIVIDUALS WHO WISH TO ADVISE THE FCC OF FACTS RELATING TO OUR RENEWAL APPLICATION AND TO WHETHER THIS STATION HAS OPERATED IN THE PUBLIC INTEREST SHOULD FILE COMMENTS AND PETITIONS WITH THE FCC BY AUGUST 1, 2005. FURTHER INFORMATION CONCERNING THE FCC'S BROADCAST LICENSE RENEWAL PROCESS IS AVAILABLE AT (address of the station's studio) OR MAY BE OBTAINED FROM THE FCC, WASHINGTON, D.C. 20554.

## **Pre-Filing Announcements for Radio Station KSSI**

Your broadcast license(s) will expire December 1, 2005. The FCC requires that applications for license renewal must be filed no later than four months prior to the expiration of the license, or August 1, 2005.

As part of the license renewal application process, an applicant must broadcast announcements over the station that provide notice of the application filing and invite comment from the public.

### **Required Schedule**

The "pre-filing announcements" must be broadcast two months prior to filing the renewal application on the first and sixteenth day of these two months. Thus, KSSI must broadcast "pre-filing announcements" on the following four dates:

June 1, 2005  
June 16, 2005  
July 1, 2005  
July 16, 2005

At least two of the announcements must be broadcast between 7 a.m. and 9 a.m. and/or 4 p.m. and 6 p.m. For radio stations that do not operate between 7 a.m. and 9 a.m. or between 4 p.m. and 6 p.m., at least two pre-filing announcements must be broadcast during the first two hours of broadcast operation.

### **Record Keeping**

These announcements should be added to your written program log. Exact times and affidavits should be prepared and the "copy" notarized. After all announcements have been aired, you should send me the exact times, affidavit and "copy" and I will place it all into your Public Inspection File.
