In the August 19, 2022 EEO audit letter, station WZEE(FM), Madison, WI (Fac. ID No. 41980) was identified for an EEO audit. Pursuant to paragraph 5(c) of the EEO audit letter, I am writing to ask for additional guidance on whether a response is required. WZEE(FM)'s most recent license renewal application was granted on November 20, 2020 (see file no. 0000119238). WZEE(FM) is part of a station employment unit that also includes WIBA(AM), Madison, WI (Fac. ID No. 17384); WIBA-FM, Sauk City, WI (Fac. ID No. 17385); WMAD(FM), Cross Plains, WI (Fac. ID No. 50055); WTSO(AM), Madison, WI (Fac. ID No. 41973); and WXXM(FM), Sun Prairie, WI (Fac. ID No. 17383). The license renewal applications for all of the other stations in WZEE(FM)'s SEU were also granted on November 20, 2020.
