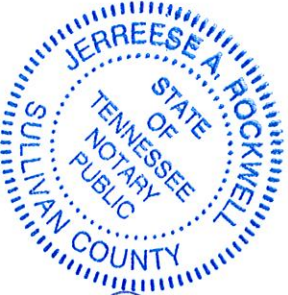

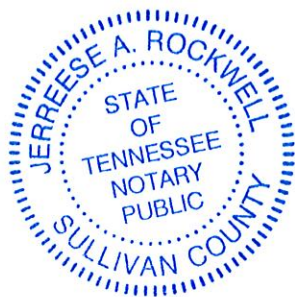
PRE-FILING ANNOUNCEMENT

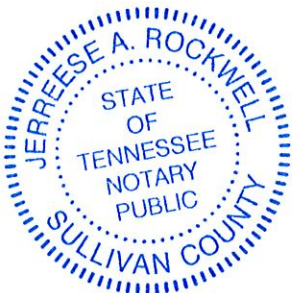
