

## **PRE-FILING AND POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS**

The following three pages contain instructions for the broadcast of the pre-filing and post-filing renewal announcements for Sinclair's Cape Girardeau, Missouri station. Included with these instructions are the texts of the two types of announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired or by **December 23, 2013**. If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

### **Pre-filing Renewal Announcements for KBSI(TV), Cape Girardeau, Missouri, FAC ID 19593**

**The following pre-filing renewal announcement must be read over the air on each of the following days: August 1, August 16, September 1 and September 16, 2013. Of the four airings, at least two of these announcements must be broadcast between 5:00 P.M. and 10:00 P.M.**

**Text:**

"On January 18, 2008 KBSI(TV) was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until February 1, 2014.

Our license will expire on February 1, 2014. We must file an application for license renewal with the FCC by October 1, 2013. When filed, a copy of this application will be available for inspection at [www.fcc.gov](http://www.fcc.gov). It contains information concerning the station's performance over the last eight years.

Individuals who wish to advise the FCC of facts relating to our renewal application, and to whether this station has operated in the public interest, should file comments and petitions with the FCC by January 2, 2014. **Post-filing Renewal Announcements for**  
**KBSI(TV), Cape Girardeau, Missouri, FAC ID 19593**

The following post-filing renewal announcement must be read over the air on each of the following days: October 1, October 16, November 1, November 16, December 1 and December 16, 2013.

Of these six airings:

1. At least three of the announcements must be aired between 5:00 P.M. and 10:00 P.M.
2. At least one announcement must be aired between 9:00 A.M. and 1:00 P.M.
3. At least one announcement must be aired between 1:00 P.M. and 5:00 P.M.
4. At least one announcement must be aired between 5:00 P.M. and 7:00 P.M.
